- 4. Malinowski's stay on the Trobriand Islands framed the self-conceptualization of Western anthropology to a large extent. Discuss in the context of the portions of *Argonauts of the Western Pacific* that you have read.
- 5. How does Peter Carey turn his own ignorance and romanticism about "the real Japan" into the text of Wrong about Japan?
- 6. Discuss the challenges of field work with reference to *any one* of the following case studies which you have encountered in *Fieldwork Live!*:
 - a. The Tebhaga peasants' movement
 - b. Contemporary theatre in Manipur
 - c. Muharram elegies
 - d. Grassroots queer activism in West Bengal
 - e. Indigenous (including DNT) community theatre
- 7. Attempt an analysis of the following conversation, using the methodology and conventions of conversation analysis that you have learned.
