The actual irrigation potential through all the present major and medium schemes is only 12 lakh hectares, whereas the SSP alone will provide irrigation facilities to 19.24 lakh hectares. Further the projects will provide safe drinking water to 8,215 villages and 155 urban centres.

Vyas pointed out that under the Sardar Patel Participation Water Conservation Scheme around 10,000 check dams are being constructed and this shows that rain water harvesting is not being overlooked by the government

the government. Gujarat, though known as an industrial state, uses around 40 per cent of its power for agriculture. "The farmer needs water not power and if the agriculture sector presently utilises 2100 MW of power it is a great loss elsewhere. To provide 2,100 MW of power, counting transmission losses, etc," the minister said, "power stations generating 6000 MW will have to be set up. The cost of this will be a staggering Rs 33,000 crore at present day costs and this alone justifies the coming up of the Sardar Sarovar Project.

The Minister added that the SSP was no inter-state project where out of the 1,450 MW power generated, Madhya Pradesh is to get 57 per cent, Maharashtra 27 per cent and Gujarat about 16 per cent.

The delay in the dam's completion has however kept the canal network unhindered.


For the residents of the drought-affected areas in Gujarat and Rajasthan, the Supreme Court's verdict on the Sardar Sarovar Project could well be the final solution to their water woes, says VIPIN PUBBY

VEN as Booker prize winner Arundhati Rov was waxing eloquent at the Cannes film festival about the "terrible things" happening to the millions of people adversely affected by the Sardar Sarovar Project, the common refrain among the droughtaffected people in Saurashtra, north Gujarat and Kutch, besides Raiasthan, was that she could at least pay a visit and see for herself the plight of the millions in the sun-baked areas.

With the Supreme Court completing the final hearing and reserving its judgment on a petition filed by the Narmada Bachao Andolan (NBA), all eyes are now on the final verdict expected in a few months. The dam's

construction has been held up since about a year pending the petition, though construction of power houses and the canal network is underway. The apex court had halted the dam's construction in 1995 at a height of 80.3 metres. Subsequently, under an interim order in February 1999, it had allowed the dam's height to be raised to a height of 85 metres.

For residents of the area reeling under the worst drought in a century, the million-dollar question is, will the Narmada waters reach them by the next summer. Officials say that once the Supreme Court gives the green signal, the waters should reach the parched land in six months, although it may take another year-and-a-half



for the project to be completed. This would include completion of powerhouses to generate 1,450 MW of elec-

However, for the residents of 8,215 villages and 136 towns in Saurashtra, North Guiarat and Kutch and 131 villages in Barmer and Jalore districts of Rajasthan who are to benefit from the Narmada waters, the power generation can wait. Although the area has gone through 24 droughts during the last 76 years, this has been one of the worst ever droughts for them.

With the total failure of the mon-

area, which even otherwise receives a scanty rainfall of upto 400 mm, the situation this year is grim. The total available storage in 135 dams of Saurashtra and Kutch has been reduced to less than two per cent, that too in just three dams. The ground water table is depleting at a phenomenal rate of about one metre per month. It is now rare to find water at less than 1,000 feet and the success ratio of handpumps has been reduced to about 50 per cent.

Besides, the salinity ingress has advanced to six kilometres from the

soon last year in the drought-prone

coastline and the advancing Rajasthan desert is threatening to take more areas into its grip.

The Narmada water project, initially conceived by Sardar Patel in

1946 and revised to its present shape in the eighties, is being awaited anxiously by the Gujarat government and those likely to henefit.

While dam's height has gone up to 85 metres, the officials say that a minimum height of 110 metres is required for water to flow into the main

canal. The canal head powerhouse has already been completed and work is on at full steam for the main powerhouse. Over 95 per cent of the main canal has been completed and work is on to complete a distribution network of about 66,000 kilometres of sub canals. It is the world's largest irrigation canal with a capacity of 40,000

The project, the largest of its kind in Asia, is aimed at irrigating 18 lakh hectares of land in Guiarat and 0.75 lakh hectares in Rajasthan. It has a catchment area of 88,000 square kilo-

However, the NBA claims that the figures regarding benefits from the dam 'e exaggerated. The organisation b eves that 3,20,000 people would b rectly affected (as against the Gujarat government's claim of 40,709 families) and asserts that the dam would indirectly, but adversely, affect one million people in Madhya Pradesh. Those opposed to the dam call it "anti-people and anti-environment", while Gujarat's Narmada and Major Irrigation Projects minister says the project is "only anti-drought, antidisparity and anti-despair....". He claims that liberal and scientific ways have been formulated for the rehabilitation and re-settlement of the affected persons while the NBA stresses on the plight of these people. The claims and counter claims have been debated over the years.

But while the state government has been giving the impression that the flow of the Narmada waters was the panacea for all problems, the fact is that large areas of Saurashtra currently reeling under the drought are not going to benefit from the Narmada waters, as these do not fall under the command irrigation area of the proposed canal network.

Thus the worst affected districts of Rajkot, Jamnagar, Junagadh, Amreli and parts of Surendernagar and Bhavnagar will continue to face a similar

situation if the government does not take effective alternative measures. Authorities say these areas have a topography of a reversed bowl and cannot be connected with the canal.

Multiplicity of departments and agencies dealing with the problem of water shortage in Gujarat, play of politics which have led to stalling of various water projects and lack of a longterm perspective planning for rain water harvesting in the drought-affected areas has led to the situation turning from bad to worse each year.

Unfortunately, due to its over-dependence on Narmada waters, the state government had been neglecting other schemes to improve the situation. Nearly 80 per cent of its irrigation budget is earmarked solely for the Narmada project at the cost of other smaller and long-term measures. There is little evidence of any improvement even though the government claims that thousands of check dams have been constructed and measures were being taken to harvest rain water. As per a government admission, nearly 43 per cent of power in the state is used for digging deep bores and drawing out water in the state.

Yet, those likely to benefit from the Narmada waters are eagerly looking forward to the verdict of the Supreme Court, which has held hundreds of hearings and has 80,000 pages to study before coming out with its judgment.

His demands reek of Tamil chauvinism. Is southern brigand Veerappan looking beyond ransom and amnesty at a political future in Tamil Nadu? Gabriel Vaz reports from Bangalore

it seems, does Veerappan. Under normal circumstances, it would be difficult for Karnataka and Tamil Nadu to see eye to eye on anything at all starting with the Cauvery issue. But thanks to the antics of the infamous sandalwood smuggler, the two states have been working hand in hand for the past three weeks.

Ever since the fateful Sunday night of July 30 when Koose Muniswamy Veerappan (55) kidnapped Kannada film icon Rajkumar — and three others from his farmhouse in the Gajanur district in Tamil Nadu (just across Karnataka's borders) the two state governments have been under a

He had no choice. The effect of this masterfully timed yet sensational kidnap was such that for close to two weeks schools and colleges, bars, pubs and liquor shops remained closed in many parts of the state. The entire Kannada film industry decided to observe a voluntary bandh till the return of the 'Annavaru' (elder brother), as the thespian as reverentially known.

Fuelled by the initial emotional outbursts of thousands of Rajkumar fans and stoked by the violence and vandalism that followed in its wake, the kidnapping brought alive fears of another Tamil-Kannadiga ethnic clash. Obviously, memories of the 1991

OLITICS, they say, makes areas, over the Cauvery dispute tribunal's interim award, are difficult to erase.

The result: both state administrations swung into action to avert what could easily have turned into much more than a law and order problem. As Krishna shuttled between Chennai and Bangalore, he and Karunanidhi spent most of their time strategising, scouring for documents, holding closeddoor parleys with senior ministers and trusted officials in their respective states. With the focus on Veerappan, though, governance

was relegated to the back-burner. As the film industry downed its shutters and work came to a standstill in several commercial and industrial enterprises, Bangalore's bottomline took a beating. The loss of revenue as the city's famed pubs closed shop and the consequent decline in the arrival of tourists and businessmen have hit hotels hard. Add to that the production slowdown in IT enterprises and the revenue loss works out to a whopping Rs 300 crore.

Meanwhile, India's most notorious outlaw, more diabolic and sinister than others of his ilk, is still calling the shots. The joint emissary of the two governments and editor of Tamil biweekly Nakkeeran, R Raja Gopal — who has so far met the dreaded bandit six times in his forest lair — has left again to plead for Rajkumar's release. But so far he hasn't had much luck. "I have achieved only 25 per cent success," he admits. "I will consider my mission a 100 per cent success only after I secure the release of the hostages.'

So what makes Veerappan different from others in the rogues gallery. Going by painstakinglyprepared police dossiers, he has killed at least 138 people, including 32 riots in Bangalore and surrounding policemen and 10 foresters;

poached 2,000 elephants for ivory estimated to be worth roughly Rs 25 crore) cut and smuggled sandalwood valued at Rs 100 crore.

Carrying a reward of Rs 40 lakh - Rs 20 lakh each by the two state governments — he has some 135 cases are pending against him (59 in Karnataka and 79 in Tamil Nadu). The elite special task forces (STFs) that were constituted by the two governments and the operations by the centrally-deputed Border Security Force (BSF) to nab the elusive brigand have drained the exchequer of Rs 180 crore. Quite apart from the hole he has

burnt in the treasury pockets, the reason why Veerappan is so dangerous is the finesse with which he seems to be crossing the thin line that divides a common criminal from an awe-inspiring anti-hero. Already the tribals and other villagers living in the secluded 60odd hamlets along the thickly-Karnataka-Tamil NaduKerala border consider him their very own Robin Hood as much for his ruthlessness as for

his generosity. And with his latest

antic, that stature could easily

acquire a political hue as well. In the past, Veerappan seemed to be guided by his own self-interest. Whenever he resorted to abductions, he would invariably make demands for hefty ransom - ranging from Rs 3 crore to a mind-boggling Rs 1000 crore — and grant of amnesty, guaranteed by both state governments and

of India. But, this time round, Veerappan has been studiously silent on the ransom and amnesty front in the four audio/video cassettes he has sent from the forest so far. Instead, he has listed 14 demands, most of them pertaining to a pan Tamil agenda that should put even the most chauvinistic Tamil leader to shame. "I saw a big change in Veerappan," said a perplexed Gopal after his return from the forests. "He behaved like a dictator. And he is definitely in the compa-

Naturally, any Dravidian party like Pattali Makkal Katchi (PMK) or Pudiya Tamizhagam (PT) - that is in cohorts with Veerappan will be able to reap rich political divi-

Unsurprisingly, Veerappan's political check-mate has put Tamil Nadu in a tizzy. Karunanidhi's arch-foe and AIADMK supremo Jayalalitha has flayed both chief ministers for spinelessly caving in before a criminal and has asked them to guit to pave the way for an army operation under President's rule to put an end to the Veerappan menace. For good measure, she has also demanded that her favourite ex-police chief Walter Isaac Dawaram be put in charge of joint STF operations to nab the brigand, conveniently forgetting that both she as CM and Dawaram as her DGP had achieved precious little earlier.

Unlike Tamil Nadu, the political scene in Karnataka is placid with almost all political parties standing solidly behind Krishna. After all, elections in Karnataka are four years away and none of the parties stand to gain if Rajkumar comes to harm. Besides, several chief ministers — from Veerendra Patil to former Prime Minister H D Deve Gowda - have had little success dealing with the bandit.

The situation is fraught with so many intangibles that almost everybody — from Rajkumar's family to sundry stars and starlets and Krishna himself — seem to have rediscovered God. Short of divine intervention, the only hope is Gopal's negotiating skills. Any action against the brigand, jointly by the two states, separately or with Central assistance, will have to wait until Rajkumar is safely back home. But one thing's for sure, this could be the first move in a well-thought-out gameplan to restructure the bandit's image.

The reel bad guy

The good-bad lines are getting more and more blurred in popular cinema

n the one hand there is Veerappan who is metamorphosing from dacoit to activist, after five decades of crime. But more alarming is the transformation that's taking place on the outside. Rajkumar, in his taped message after weeks of captivity, confesses 'his (Veerappan's) path is good...some of his demands are exalted.' Gopal, the journalistturned-official emissary insists: "He has changed a lot. His approach and attitude have changed. He declares himself a Tamil extremist and talks about convening an inspection committee to take decisions. He even quotes Che Guevera." The CMs of Tamil Nadu and Karnataka are actually conceding to most of his demands and are apologetic about those they cannot concede. But more importantly, there is the hairdresser Shivarama Bhandini who is currently specialising in a new hair-cut -- a Veerappan moustache on the back of the head.

Now when did we hear that last. When Dev Anand unleashed the wewant-a-Dev-puff-hairdo voodoo; when Rajesh Khanna dressed up the nation in Guru kurtas; when Amitabh Bachchan lent the baritone edge to the vox populi; and now, when Hrithik Roshan has sent it into the gym, to acquire designer biceps and abs. Obviously, somewhere down the line, Veerappan is crossing over - from forest brigand, killer and crook to activist and anti-hero. Not a difficult feat, going by popular cinema which has always serenaded the anti-hero.

Popular culture's predilection for the 'khalnayak as nayak' became more pronounced in the 1990s, with the concept of pure evil and pure good being replaced by the idea of the bad-is-good hero. This was starky different from the anti-hero - the good-bad guy - immortalised by Amitabh Bachchan in the 1970s and 1980s. Despite his anti-hero stance, the legendary Vijay Verma (the role Bacchan replayed time and again since Deewar) was never all bad. Ideologically, he never transgressed the value system.

A definition of this anti-hero can be found in the blockbuster Sholay where the Thakur (Sanjeev Kumar) says: "Woh (Dharmendra and Amitabh) badmash hain, lekin bahadur hain. Khatarnak hain, is live khatron se khelna jante hain. Burre hain, magar insaan hain' (They are crooks, nevertheless they are brave. They are dangerous because they know how to play with danger. They are bad, yet they are human). Juxtaposed against these good-bad guys was the all-bad guy, Gabbar

Singh. Popular cinema in the '70s offered no justification for his evil. A heartless brute, he had to be annihilated for the sake of social harmony. But that was then.

not only found a place for dacoits in sane society, it deified them too, as in the case of Bandit Shekhar Queen, Kapur's ode to the female dacoit. This ethical amorphousness on screen was merely a reflection of what was happening in society itself where anti-social

ments were entering Parliament, criminals were winning elections from jails, corruption in high places was going unpunished and Harshad Mehta was accorded the sobriquet of the Big Bull, despite being allegedly guilty of a mega buck scam. In the new millennium, the grey areas between good and bad seem to be growing wider, with larger-than-life icons being investigated for charges of match-fixing, without actually affecting the game of cricket. Hence the importance of films like Vaastav or Satya, which lionise figures like Bhikhu Mhatre (Manoj Bajpai) and imbues the underworld with warmth, camaraderie and compassion too. Going by the cinematic truth, it seems absolutely possible that Veerappan might make this transition from villain to hero without a hitch. After all evil in popular cinema is gradually being divested of its negative shades and characters like Dr Hannibal Lecter (The Silence of the Lambs), Ballu Balram (Khalnayak), Bhikhu Mhatre (Satya) have been accoladed as heroes and winners. Doesn't seem strange if Veerappan is too: accoladed and accepted, in new colours and a new role.

Help tide over drought, PM appeals to people

NEW DELHI, APRIL 23. The Prime Minister, Mr. A.B. Vajpayee, today appealed to the people to contribute generously to the National Fund for Calamity Relief to enable the Government to meet the severe drought conditions in several States, especially Gujarat and Rajasthan, admitting that funds released to affected States were inadequate.

Both the Congress(I) and the CPI today issued strong statements — the Congress(I) charging that the drought had come when the farmers and the poor people were already reeling under the impact of increase in the prices of food and fertilizers and the CPI warning there were famine-like conditions in many districts. The CPI also demanded an all-party meeting to discuss the grave scenario.

The Prime Minister is expected to make points on how the Government has tackled the situation through a reply to the debate tomorrow itself even as BJP sources indicated that it would like to keep the issue "above politics".

Later in the week, the Lok Sabha is also expected to debate the recent increase in prices of petroleum products and the cuts in subsidies of food and fertilizers, an issue which has been agitating the National Democratic Alliance

The Prime Minister's appeal pointed out that more than five crore people had been affected by the drought. "In village after village, hunger stalks men, women and children," while cattle were affected because of lack of water and fodder.

The Union Government has already released some funds to the States to help meet the situation. "However, given the severity of the drought" and the need to find food for a large number of people and fodder for cattle, "these funds are inadequate." Mr. Vajpayee said that each person can help in the situation by making a contribution "no matter how

small the amount". He noted that people had contributed generously towards relief for those affected by the super cyclone in Orissa last year, and he was sure that they would now come forward to "lend a helping hand to (their) brothers and sisters in Gujarat and Rajasthan".

Government sources indicated that relief money had already been released to Gujarat and Rajasthan, the worst affected states: nearly Rs. 88 crores has been released to Gujarat this month in two instalments of Rs 43.7 crores each, and Rs. 112 crores have been given to Rajasthan also in two instalments. Many other States, including Tamil Nadu, Andhra Pradesh, Karnataka, Orissa and Assam had received one instalment of relief money.

In Gujarat, the drought is said to be the worst in a century, and in the desert State of Rajasthan, the drought has made worse a condition which is chronic in many of its districts. This year 26 of the 32 districts are reported to be badly affected that the Chief Minister, Mr. Ashok Gehlot, is himself touring the villages. In Gujarat, the Chief Minister, Mr. Keshubhai Patel, has nominated Ministers in the State Government to oversee the relief work in specific districts.

The Prime Minister was certain that with help from all the difficult challenge would be overcome. The Prime Minister's Office will be coordinating the relief work with the Ministry of Agriculture and the Ministry of Food and Civil Supplies.

NEW DELHI/JAIPUR, April 23. — While Mr Atal Behari Vajpayee today described the drought conditions in Gujarat and Rajasthan as "severe" Rajasthan government today said it was not alarming. Gujarat government officials also underplayed the situation saying though there was a drinking water crisis, no death had been reported.

In a broadcast to the nation, the Prime Minister put the fig-ure of those affected in Gujarat, Rajasthan and some other parts of the country at 50 million. He appealed to the people to contribute to the National Relief Fund.

But the Rajasthan government, which has so far been claiming the worst drought in the state ever, today took a U-turn, saying drought situation there was merely a "media hype" and the situation was not that serious.

This assessment comes only a week after the Rajasthan Chief Minister, Mr Ashok Gehlot, met the Prime Minister in New Delhi to seek special central assistance, claiming that famine-like conditions were prevalent in the state.

It seems the state has chosen to take two separate stands one to highlight the severity of famine when it comes to taking assistance from the Centre, and one to term reports on drought as media hype when it

Rain relief

AMBAJI (Gujarat), April 23. Heavy showers last night brought relief to millions affected by the drought here and in other north Gujarat areas. Unconfirmed reports said the town recorded 30 to 35 mm of rainfall accompanied by gusty winds. In many places, the downpour was greeted by people who offered puja in temples. - UNI

A senior official in the Chief Minister's office denied any information of cattle deaths or "huge migration of people" from the drought-hit districts. "All this is routine affair and there's nothing very special this year", he said.

The official says: "Rajasthan had a bumper crop this year and the state doesn't face any crisis situation". On govern-ment records, no cattle died of starvation in Rajasthan.

The state government is at the receiving end for its failure to solve the water and fodder problems. The relief works, which should have been started well before last December, were started last month only. A severe water crisis is prevalent in most villages in west Rajas-

than. And, though the state government has opened fodder depots, the villagers have no money to pay for the fodder.

The state public health minister had admitted that the government could not start relief works in time because of paucity of funds and due to "other priorities". Interestingly, while Mr Gehlot demanded Rs 1,144 crore from the Centre to carry on the drought relief works, he has decided to spend only about Rs 400 crore on relief work.

Meanwhile in Gujarat, the entire state was reportedly reeling under an unprecedented drought-like situation. State government officials, however, said though there has been a severe drinking water crisis, there has been no report of any death due to that.

In New Delhi, the crisis management group under the ministry of agriculture today briefed the Minister for Agriculture and Rural Development, Mr Sundarlal Patwa, on the drought conditions. The meeting hardly focused on mitigating the sufferings of the affected people. "The meeting was all about to prepare the minister to face Parliament which will hold a special debate on drought tomorrow", officials said.

The figure of 50 million is based on an estimate by the state governments. The crisis management group has no authentic figure of those affected or statistics to estimate the extent of relief needed.

WATER CRISIS

ONE OF NATURE'S scourges is making its periodic visitations on large parts of the country. Officially the country has enjoyed 12 consecutive years of a 'normal' monsoon, but particular areas did not escape a deficiency in rainfall in 1999. Though that should have alerted the administration to the emergence of a regional drinking water and fodder crisis, as is often the case the Central and State Governments are only now waking up to its severity in drought-affected areas of western Rajasthan, the Saurashtra and Kutch regions of Gujarat, Malwa in Madhya Pradesh and Telengana in Andhra Pradesh.

Since the next two months are going to be a critical period, the response to the appeal for public contributions by the Prime Minister, Mr. Atal Behari Vajpayee, has to be immediate and overwhelmingly positive if the people in the affected towns and villages are to be helped tide over the summer. The Centre cannot escape its own responsibility to provide more funds than it has so far. The decisions that the Centre has recently taken — larger allocations of cereals at lower prices and the provision of more grain for 'food-for-work' programmes - are important but insufficient given the challenges before the 2000 monsoon hopefully brings the drought to an end. There will be corruption in the use of such funds, as the allegations of misappropriation during the relief operations after the Orissa cyclone of last November demonstrated, venality shows no respect for the human condition. But the likelihood of corruption is no reason to close the tap on financial assistance. The horrifying reports from the afflicted areas of women walking more than 10 km to fetch a pot of water, of towns receiving water once a week for less than a hour, of 'water riots' and of cattle dying in 'cattle camps' because of a lack of fodder should have galvanised the local administration into action. While some State Governments are indeed doing their best to cope with a difficult situation, it is astonishing that Mr. Keshubhai Patel, Chief Minister of Gujarat, still insists that there is "absolutely no crisis" in any part of the State. There can be no ambiguity about the emergency action that is required. First, new borewells have to be dug, existing ones deepened if possible, damaged hand-pumps repaired and in the extreme 'water trains' arranged — all for drinking water. Second, since employment disappears as the crops wither in the fields, public works programmes that combine cash with kind payment are essential to prop up incomes. Third, expensive it may be but if necessary fodder has to be transported to the affected areas to prevent large-scale death of livestock.

The immediate task is to alleviate the blight of this summer, but there is a long-term agenda that the country should not lose sight of. The severity of the drinking water shortage in Gujarat and Rajasthan tells us that the 'water crisis' that many have warned will strike India in the 21st century has already arrived. A crisis has been brewing over years in different parts of the country as groundwater resources have been over-exploited, water-intensive crops grown in dry areas and Government-planned projects implemented with little regard for local concerns and local conditions. When a monsoon fails, it does not cause a crisis, it only worsens one - whose severity increases in areas that traditionally receive only moderate amounts of rainfall. But this need not be the case. As the fairly large experiments in Alwar by the Tarun Bharat Sangh and in Ralegaon Siddhi by Mr. Anna Hazare have shown, dry areas can be made green and drinking water available for all with people's involvement in a methodical harvesting of rain water and a careful use of available surface and groundwater resources. If the ongoing crisis gives a new direction to the harvesting, use and conservation of the country's water resources then it may yet have given a painful but necessary lesson for a better future.

The great Gujarat water trick

PATAN (Gujarat), May 6. When Mr LK Advani went visiting drought-hit Gujarat last weekend, the state government took him to precisely those villages where the devastating natural calamity had had practically no impact.

And lest the beans be spilled on the government's carefully set up edifice of deception, the common, suffering people of the state were not allowed to go anywhere near the Union

home minister.

Mr Advani — along with Cabinet colleague Mr Sunderlal Patwa — went ga ga at a press conference over the "miracle" they had just seen: cows and buffaloes in panjrapoles (cattle shelters) in completely dried-up districts being given green fodder.

The greatly impressed rural

development and agriculture minister had told the reporters even he could not serve green fodder to his cows back home in Madhya Pradesh at this time of the year.

And Mr Advani himself had marvelled at how few people had come to him with complaints despite the state being in the grip of such a "severe

natural calamity"

The truth is that the green fodder — "miracle" — the home minister saw at the panjrapoles in Sami and Santhalpur talukas of Patan district, is the product not of the state government's efficiency in drought management, but the gift of a little-known subterranean pipeline that has been supplying sweet water to 132 villages of the Radhanpur and Santhalpur talukas for 14 years now.

The underground water supply system — officially the Santhalpur Regional Water

Supply Scheme — is locally known as the "Netherlands pipeline".

The name derives from the fact that the Dutch government helped Gujarat through finance and knowhow when the pipeline was laid in the 1980s.

The pipeline stretches from Sihori to the villages on the far end of the Rann of Kutch. For more than a decade now, it has been the source of drinking water for the villages it run through. And this year, as ponds have dried and wells turned murky — it rained on a mere six days last monsoon in Santhalpur — the "Netherlands pipeline" has turned into a wellspring of life for the villagers and cattle of the area.

The first phase of the "Netherlands pipeline" was completed in 1986. It cost Rs 97.7 million, and served 71

Hit by one of the worst water crisis ever, this largest city of Saurashtra is finding innovative ways to entice customers and ensure the cash boxes keep rattling.

"Buy a refrigerator or television set, and get water free for rest of the summer," says one innovative advertisement. "Buy any of our products, and you will get 500 litres of water free for four days a week, for next two months," says another ad, one of the many that are flooding local newspapers, vying for attention along with the usual advertisements for sale of water.

Bhavesh Patel, who belongs to Viravav village, opened a showroom for consumer goods in the city's posh Kalawad Road six months ago. He was the first to hit upon this 'bright' idea last month. It is now a rage

Considering the plummeting sales, Mr Bhavesh, who had first-hand experience of water crisis, said it was only natural to think of what his customers would need most through the torturous summer. "We decided to offer free water with TV sets of size 20" or more, and refrigerators of 310 litres or more. Being dealers of Samsung products, we launched the scheme for this brand, though there is no financial support from the company, except for sharing the advertisement costs,"

The products were selling at normal market rates with the added benefit to the buyer of 500 litres of water every day for 45 days. "The response was very

good. We reversed the trend of dropping sales, sales actually soared by over 20 per cent. This was when the rest of the people in the town were scratching their books to remain in business?" says Mr Rhough heads to remain in business," says Mr Bhavesh.

Today, he is supplying water to over 60 customers.

However, going into the economics, he admits that the scheme has cut down his profits considerably. "We have to spend about Rs 2,500 to Rs 3,000 per customer to supply water. Rickshaw-wallahs of my village have helped me supply water at lower costs."

Not to be left behind, Patel Electronics, another leading dealer of electronic equipment, jumped onto the water wagon. "Our scheme includes supply of 500 litres of water for four days in a week for two months to any customer who buys an oven, a fridge, a washing machine, a TV or other products. The scheme was open for one week in April," says proprietor Jitesh Pa-

Sales have risen, he says, and now he is planning to supply free air-coolers too, looking at the constantly rising mercury.

Companies agree the incentive has worked wonders. Our sales have picked up three-fold after we offered the scheme. We took Rajkot as a test case, since such commercial water supply networks are not available at other places," says Nitiraj Chudasama, senior execu-tive (sales) of Samsung in Ahmedabad.

However, its not the just business that is affected by the drought. Employees of leading companies posted in Rajkot too have been affected. A cellphone major has started giving a monthly water allowance of Rs 1,000 to all its employees.

Deadline ends, Gopal receives signal

CHENNAI, AUG. 19. After a two-day wait in the forests, the journalist-emissary, Mr. R.R. Gopal, received signals from the fugitive-bandit Veerappan this evening. He is likely to meet Veerappan late Saturday night or early Sunday and resume negotiations for the release of the abducted actor, Mr. Rajkumar, and three others.

Sources said Mr. Gopal contacted the *Nakkeeran* office and informed that he had established contact with the brigand and he was proceeding to his hideout.

Earlier in the day, there was a sense of unease in the Government when the deadline set by Veerappan for the Karnataka and Tamil Nadu Governments to convey their responses ended today.

Court nod for freeing Tada detainees

BANGALORE, Aug. 19. — The principal district and sessions judge, Mysore, today allowed the Karnataka government to withdraw the charges against 51 Tada detainees lodged in Mysore jail for the past eight years.

The government appeal ed to the court after Weera ppan demanded that the deta inces be released. This was one of the pre-conditions that the f orest brigand had set for freeing Kannada actor, Dr Rajku mar, held hostage since 30 July.

The petition was opposed by Mr Abdul Karim, father of Shakeel Ahmed — the police officer killed in an ambus h by the brigand in 1992. The judge, Mr Rajendra Prasad, alle owed the special public prosecutor,

Mr Ashwin Kumar, to withdraw cases under Sections 3 and 5 of the Terrorist and Disruptive Activities Prevention Act even as he overruled Mr Karim's appeal.

The court will take up the bail applications of the detainees from Monday. The government will not oppose the applications, Mr SM Krishna said.

The chief minister said Mr RR Gopal, emissary of Karnataka and Tamil Nadu, had reached the forests though heavy rain had prevented him from making contact with the brigand.

He said he was awaiting information from his counterpart in Tamil Nadu on the second mission of Mr Gopal.

No word from Gopal: There is no word yet from Mr Gopal on whether he has established contact with Veerappan even

as the 8-day deadline, set by so brigand for Tamil Nadu and Karnataka governments to meet his demands, elapsed today, PTI adds from Chennai.

Mr Gopal's office here said it was awaiting information from the emissary. The Tamil Nadu government is silent over the emissary's mission.

Mr Gopal is carrying documents from both governments on the action taken so far to meet the demands. But the demand on the release of five Tamil extremists is defying a solution as the ultras have refused to seek bail and are insisting on withdrawal of all cases against them. The government is still examining the issue.

Bail granted to 51 'Veerappan aides

MYSORE, AUG. 28. On expected lines, the Principal and Sessions Judge, Mr. Rajendra Prasad, today approved granting of bail to 51 detenues, supposed to be associates of the forest brigand, Vegrappan. Reading out the operative portion of his order, the judge stated that the bail applications of the accused be allowed and they be released on their executing a bond for Rs. 10,000 and one surety for the likesome, or providing cash surety for Rs. 20,000.

cash surety for Rs. 20,000.

The bail applications which were filed by the four defence counsels earlier was heard today.

One of the counsels, who had filed applications on behalf of 21 accused, impressed upon the court that in granting bail, the court would assist the State machinery in expediting the release of the abducted film actor, Mr. Rajkumar, and three others held captive by Veerappan.

He pointed out that the prosecutor in his submission earlier on the bail applications had maintained that the accused, housed in Mysore jail, were directly or indirectly involved in offenses under Sections 3, 4 and 5 of the TADA, which had been withdrawn. The defence counsel said

that considering the gravity of the situation, the accused should be granted bail. He brought to the notice of the court that those already on bail had not violated any bail conditions.

The advocate for Mr. Abdul Kareem, father of the slain police officer, Shakeel Ahmed, who was killed along with Harikrishna, SP, by Veerappan in an ambush on August 14, 1992, made a submission to the court that the special leave petition (SLP) filed in the Supreme Court was admitted today and the hearing was posted for Tuesday. He prayed the court to reserve its ruling in this case till

the Shawas heard in the Supreme Court. Mr. Rajendra Prasad, overruling this submission made on behalf of Mr. Abdul Kareem, maintained that these accused while on bail must appear before this court when required.

The accused must not tamper with evidence and also not repeat any of the offenses. As regards to the bail conditions for which submissions were made by the defence counsels earlier, the judge said that relaxation of conditions for bail would be taken up at the next hearing.

Veerappan adds 'riders' to demands

The much awaited reply from the forest brigand Veerappan to the "responses" of the Tamil Nadu and Karnataka Governments to his 14-point charter of demands for the release of the Kannada actor, Mr. Rajkumar, and three others, will be discussed by the Chief Ministers of the two States here tomorrow.

The Government emissary and journalist, Mr. R. R. Gopal, who returned from the Sathyamangalam forest this morning, after his second round of talks with Veerappan, handed over a video cassette to the Chief Minister, Mr. M. Karunanidhi, containing fresh clarifications sought by Veerappan.

According to sources, while Veerappan has not set any fresh conditions, he has added "riders" to his earlier demands and is understood to have expressed "disappointment" with the responses of the two Governments. The brigand is said to be "furious" with the Karnataka government for "not yet clearing the legal decks for releasing his 51 accomplices detained under the TADA

Act". After a two-and-a-half-hour meeting with Mr. Karunanidhi, the *Nakkeeran* editor told reporters that the Karnataka Chief Minister, Mr. S. M. Krishna, would arrive here tomorrow for consultations with his Tamil Nadu counterpart before the two make known their latest responses.

The emissary is likely to leave for the jungles on his third mission late on Friday or on Satur-

day.

After viewing the cassette, Mr. Karunanidhi contacted Mr. Krishna and conveyed to him its contents. He also had a brief discussion with senior officials.

A copy of the cassette has been sent to Bangalore.

Mr. Gopal's meeting with Mr. Karunanidhi was kept under wraps and there was some confusion about the venue initially with reporters given to understand that it would take place in the Secretariat. However, around 10.30 a.m the emissary arrived at the Chief Minister's residence taking everyone by surprise.

With the decks cleared for the withdrawal of all the cases against the five extremists jailed in Tamil Nadu, the legal issues related to

the release of the 51 TADA detenus in Karnataka are still causing anxious moments here.

Rajkumar sounds a note of caution

BANGALORE, AUG. 24. Kannada film icon, Mr. Rajkumar, has spoken against any action by police to rescue him.

In a message, sent through a video cassette brought to Chennai by journalist-emissary, Mr. R. R. Gopal, this morning, Mr. Rajkumar said it would be improper if the police launched a rescue mission by force.

The message addressed to the Karnataka Chief Minister, Mr. S. M. Krishna, and his Tamil Nadu counterpart, Mr. M. Karunanidhi, was telecast by the private Kannada channel, Udaya TV.

"They (the Veerappan gang) will escape since they know the terrain very well. We (himself and three other hostages) will get trapped," Mr. Rajkumar warned. "At any cost, police should not come here (to the jungle). It is not necessary."

He also appealed to the Kannada film industry to resume nor-

mal activities, which remained suspended following the actor's abduction. "I felt bad that the industry has come to a standstill rendering thousands of people jobless. It should not happen. (Film) shooting should resume."

Mr. Rajkumar requisted Tamil super-star, Mr. Rajnikaath, to visit his residence here and counsel courage to his sons. — PTI

S.C. stays release of some Veerappan associates

NEW DELHI, AUG. 29. The Supreme Court today directed that pending further orders none of the 115 "Veerappan aides" shall be released on "bail" or otherwise.

A bench, comprising Mr. Justice S. P. Bharucha, Mr. Justice Syed Shah Mohammad Quadri and Mr. Justice N. Santosh Hegde, issued the order while listing for hearing a special leave petition (SLP) for September 1.

The SLP from Mr. Abdul Kareem, a retired police officer and father of sub-inspector Shakeel Ahmed who, along with a Superintendent of Police, was killed allegedly by Veerappan in 1992, was directed against the August 19 order of the Designated Court, My-

sore, according "consent" to the Special Public Prosecutor for withdrawing charges for offences punishable under Sections 3, 4 and 5 of the Terrorist and Disruptive Activities (Prevention) Act — TADA — against certain accused (51 Veerappan aides).

The Bench allowed the Karnataka Government to file its counter-affidavit.

Earlier, when Mr. Ch. Badri Nath Babu, counsel for the petitioner, "mentioned" the SLP during the 'pre-lunch session' for an urgent hearing, the Bench ordered that none of the accused-respondents be released on "bail" or otherwise and said the SLP would be heard in the post-lunch session.

A total of 115 accused (including Veerappan) were cited as respondents.

The 51 accused, who were ordered released on "bail" by the Principal and Sessions Judge, Mysore, on August 28, are included in the list of 115 accused.

When the SLP was taken up for hearing, Mr. Harish N. Salve, Solicitor-General, submitted that the order made by the court during the pre-lunch session was immediately communicated to the authorities and that, in accordance therewith, none of the accused-respondents (in the SLP) had been released.

The SLP contended that the impugned August 19 order had "resulted in an unprecedented miscarriage of justice as the learned Designated Judge failed to appreciate that the permission (to withdraw 'TADA' charges) was sought on grounds extraneous to the interest of justice and therefore the judgment is liable to be set aside by this court (apex court)."

The SLP also pleaded that "the Designated Judge failed to appreciate that the application filed by the prosecution under Section 321 of the Cr.P.C. indicated that the police machinery in Karnataka became totally ineffective and it gives a signal to the general public that this kind of concessions given by the State Government enables the potential criminals to become hardened criminals so that whatever heinous offences they may commit they can escape from the clutches of criminal justice and even become elected representatives of the people and sit at the place of enactment and spoil the morality of the general public..."

A related SLP against the order dated August 28 made by the Principal and Sessions Judge, Mysore, granting bail to certain accused (Veerappan aides) was also before the court.

THE Karnataka government will file its counter-affidavit on September 1 in response to the petition filed before the Supreme Court challenging the government's decision to drop TADA charges against suspected associates of forest brigand Veerappan to secure the release of abducted Kannada filmstar Rajkumar and three others.

Karnataka Minister for Law D B Chandregowda told reporters here that the state would narrate before the apex court the "compelling situation" under which the government had to take a decision in the interest of maintaining law and order.

The Supreme Court had on Tuesday granted a stay on the release of suspected associates of Veerappan through bail, on a special leave petition filed by Abdul Karim, father of a police sub-inspector who was killed by the Veerappan gang in 1992.

Dropping TADA charges against 51 deternus who were in Mysore jail for the last eight years was one of the major demands set by the bandit for releasing Rajkumar and three others who have been in his custody since July 30.

Chandregowda said the government had only dropped five charges booked against suspected supporters of Veerappan under TADA. "The state still feels that dropping of charges under TADA, an Act which has been annulled already, is well within its powers," he said.

Militant's father asks HC to block deal with Veerappan

ANOTHER father files a plea, but this one's different from the one Abdul Karim filed in memory of his son who was killed by Veerappan. P S Annamalai, the father of Manikandan, one of the five Tamil extremists whose release has been sought by Veerappan in exchange for the freedom of Kannada star Rajkumar and three others, on Wednesday approached the Madras High Court seeking to prohibit the handing over of his son to Veerappan.

On a writ petition from Annamalai, Justice K Govindarajan has asked the District Judge, Tiruchirappalli to send a magistrate to the Tiruchi prison to ascertain whether Manikandan was unwilling, as was being claimed by his father, to be taken to the jungles after his release.

The court has said the district judge should send his report on September 8 and posted the case on that day.

The petitioner contended that after his son refused to seek bail as requested by a police official, he was informed on August 21 that charges against him were to be dropped and that he would be taken to the jungles, where he would be exchanged for Rajkumar.

As this was sought to be done against Manikandan's will, the pe-

titioner wanted the court to prohibit his handover to the "illegal custody" of Veerappan.

Manikandan is alleged to belong to the Tamil National Liberation Army, an LTTE-trained militia, which was allegedly involved in an attack led by Veerappan and his men on a police station at Vellithiruppur in Erode district in December 1998.

His detention under the National Security Act was revoked on August 14 in deference to Veerappan's demand for his release. Later, the government decided to go by Veerappan's demands to drop charges against him and four other extremists.

The petitioner, however, has contended that his son was only a sympathiser of the LTTE, who was first arrested in 1995 for putting up a poster of LTTE leader V Prabhakaran.

"This was the starting point of the foisting of a number of false cases," Annamalai said, adding that his son had not been convicted in any case so far.

Questioning how the respondents were authorised to handover his son to an outlaw, petitioner said there was no guarantee for his safety in the forest.

The other ultras whose release has been agreed to by the government are Sathymurthy and Muthukumar (both TNRT), 'Radio' Venkatesan and Ponnivalavan (both TNLA).

The Supreme Court has done well to pour the cold water of reason on

the emotional drama being enacted in the aftermath of Veerappan's kidnapping of Kannada film star Rajkumar. The court has, rightly, stayed the release of 30 jailed members of Veerappan's gang and the withdrawal of cases against 115 others as part of the bargain sought by the bandit in return for release of the actor who's already been held hostage for a month. The stay order should have a sobering effect on the governments of Karnataka and Tamil Nadu who seemed compelled to give in to Veerappan's demands. The high profile and popularity of the hostage, and the emotions aroused by his kidnapping, have been used by the political leadership in the two states to justify the surrender of state authority to an outlaw. The petition on which the court acted is also underscored by emotion — that of a father whose only son was among 28 police officials killed by Veerappan and his gang. The petitioner said that justice was being denied to the "victims of Veerappan's barbarity and banditry" and if his associates were released "many innocent civilians and brave forest officials will suffer irreparably". Far from undermining the rule of law, the plea buttresses the primacy of a principle which the authorities concerned have sought to disregard. Such abdication of responsibility only helps to magnify the media-created myth of Veerappan as a modern-day Robin Hood who is a moral law unto himself.

Following the court's judgment, those who have helped to mythify Veerappan must now demystify him; the so-called 'Bandit King' is no cult hero but a criminal, and a notoriously brutal one at that. He has killed over 130 people, including officials of the police, the BSF, the forest service and the Special Task Force set up to catch him. He has killed at least 2,000 elephants for ivory. His main business, with a turnover of Rs 120 crore, is sandalwood smuggling. The charges against him are legion. Despite the gravity of his offences, however, he has been projected as a colourful crusader pitted against the power of the state. This is a dangerous distortion; only too often elements within the state appear to have been in overt complicity with him. More than once operations planned against him have been scuttled at the last moment, with the official in charge of the exercises being transferred or moved to other duties. There have been reports of Veerappan being privy to decisions taken by state cabinets. Even a draconian measure like TADA, from which there was no escape for thousands of innocent citizens, was virtually nullified in his case; the TADA court readily consented to the special public prosecutor's plea to withdraw charges against Veerappan. The clandestine, and often not-so hidden, connections between politics and crime has today become a catchword. The bizarre case of Veerappan, necessitating the Supreme Court's intervention, exemplifies such unholy alliances. If Veerappan has his way this time, it is not only he who will be the victor; the real winner will be the pernicious system of which he is only a virulent symptom.

Ahmed Patel quits, crisis in Gujarat Congress deepens

New Delhi, July 5

THE FACTIONAL war in the Gujarat Congress has taken a seri-ous turn with Mr Ahmed Patel resigning from the post of AICC treasurer. The resignation letter, which was sent to Congress President Sonia Gandhi today, has come after AICC general secretary Prabha Rau's statement that the suspension notice issued to Mr Bharat Solanki by the PCC presi-dent C. D. Patel was illegal. Mr Patel also called on Mrs

Gandhi this evening to explain the circumstances that forced him to take the drastic step. "The matter now rests with the Congress presinow rests with the Congress president," sources close to 10, Janpath told The Hindustan Times after the AICC treasurer's hour-long meeting with the party chief.

Significantly, at a meeting which Mrs Gandhi held later with AICC office-bearers it was decided that

the party's disciplinary action committee will meet on July 8.

Ms Rau's statement reportedly gave a boost to the Madhavsinh Solanki lobby in the State and dealt a blow to the Patel group's demand that the suspension be ratified. Interested Congress circles made their own contribution to the crisis by gleefully interpreting her comments as a reflection of the

high command's disapproval of the rushed manner in which suspen-sion notices were issued without

adhering to party rules.

In his resignation letter, Mr Patel, who enjoys majority backing in the Pradesh unit, blamed a small group in the Gujarat Congress, led by a former Union Minister (read Madhavsinh Solanki), for launch-ing a personal attack on him as they were averse to his position in the AICC. "This group, which is smitten by jealousies and (is) having sinister desired. ing sinister designs, has achieved nothing for the party and does not enjoy public support. Its designs have foundations in its frustration of having lost office. This group is out to malign me personally through a media trial," Mr Patel

claimed in the letter.

The RS MP clarified that he was quitting because he was incapable quitting because he was incapable of matching his detractors' nefarious activities. "They have made me the target of media attack and are doing considerable damage. I feel that my presence is indirectly contributing to irreparable damage to the party," the resignation letter said. Claiming that he had fought such elements in the past, he such elements in the past, he recalled his earlier, unpublicised March 15 resignation while stating that he would like to work for the party without the 'shackles or bur-den' of any office.

Veerappan wants 5 TN convicts freed

FIVE Tamil Nadu prisoners whose release outlaw Veerappan has demanded are understood to be members of two extremist outfits in the state, reliable sources who heard the cassette containing the demands said.

The sources said the cassette specified five prisoners and sought their release as one of the conditions for release of Kannada thespian Rajkumar and three others held hostage by the outlaw since July 30.

Two of the convicts were stated to belong to Tamil Nadu Liberation Army (TNLA) and others to Tamil National Retrieval Troops (TNRT). Names of the ex-

tremists, according to these sources, are: Venkatesan and Ponnivalavan (both TNLA), Sathyamurthy, Manikandan and Muthukumaran (TNRT). Joint response of Karnataka and Tamil Nadu to this particular demand was that it will be considered favourably.

Significantly, the 10 demands were not in voice of Veerappan, but that of an unnamed associate. Veerappan, sources said, makes only a brief introductory remark and hands over task of reading out the demands to another person.

The 10 demands, in exactly the same order as released by the government yesterday, were made in pure Tamil and not in conversational language usually used by Veerappan, they said.

The sources said the demand for adequate com-

pensation to the families of nine murdered Dalits was a reference to the March 11 carnage in a Dalit locality at Kambalapalli village in Kolar district of Karnataka.

The TNLA, an extremist outfit started in 1980's, has been involved

in a number of blast cases, attacks on police stations and raids on armouries. It is now said to have split into a number of groups. Many of its members are in jail.

The TNRT was an outfit whose members had undergone training under LTTE in 1990. Its existence was discovered by the state 'Q' Branch-CID during probe into the Rajiv Gandhi assassination case.

CHENNAI: The response of the governments of Karnataka and Tamil Nadu to Veerappan's demands for the release of Kannada actor Rajumar have failed to satisfy the bandit.

This was clear from a video-cas-sette that Nakkeeran editor R.R. Gopal brought to Chennai after five days of negotiations with the bandit. The cassette was presented to Tamil Nadu chief minister M. Karunanidhi on Friday morning and its contents were telephonically conveyed to Karnataka chief minister S.M. Krishna.

According to Gopal, Veerappan has placed fresh demands for the release of the Kannada film star and three other hostages and has given the two governments eight days' time to respond. Mr Gopal told a crowded press conference that the outlaw had also sought some clarifications on the responses of the two governments to his earlier demands.

Mr Gopal said he had presented Veerappan's stand to Mr Karunanidhi and both chief minis-ters were discussing them. "It is for them to discuss the demands and brief the press."

Mr Krishna rushed to Chennai

to hold discussions with his Tamil Nadu counterpart. The meeting continued until late into Friday night. Throughout the day, officials of both states refused to disclose the contents of the videotape.

The meeting of the chief ministers began at 5.30 p.m. at Fort St George, the secretariat of the Tamil Nadu government, and showed no signs of ending even after three-and-a-half hours. The indications to a large number of mediapersons waiting outside the venue was that Mr Krishna and wenue was that Mr Krisnna and Mr Karunanidhi, along with their respective police chiefs and other top officials, watched the cassette more than once. Going by the sheer length of the meeting, the talks with Veerappan undertaken by Goral appear to have made no by Gopal appear to have made no headway.

It was not immediately clear what actually the hitch was in the response of the two governments demands. Veerappan's Although sources in both states maintained that payment of ran-som was the main demand of the bandit, Mr Gopal denied at the press conference that Veerappan

unhappy with the lack of progress in the release of the five prisoners (belonging to two Tamil extremist outfits), although Mr Karunanidhi has promised to "consider the demand favourably".

Mr Gopal, however, for the record, claimed that Veerappan was not under the influence of extremists. "Veerappan is very much in command in the jungle, he declared. Whatever the fresh demands of the bandit, it was clear by Friday night, 12 days after the kidnap of Rajkumar and three others, that there was no hope of their immediate release.

According to an unconfirmed report released in Bangalore, Veerappan was prepared to release at least one hostage (not Rajkumar) and allow him to leave the jungle with Mr Gopal. But the report goes on to say that no hostage was prepared to leave without Rajkumar.

Asked about the involvement of a Tamil extremist group in the hostage crisis, Mr Gopal confirmed that Veerappan had the backing of an extremist group, but saw no reason to suspect that the brigand was in their clutches. "It is 100 per cent true that extremists are with him. In fact, Veerappan considers himself a Tamil extremist, but he is certainly the captain.'

Karnataka reply today

BANGALORE, AUG. 13. Karnataka will send its reply on Monday to the clarifications sought by the forest brigand, Veerappan, on his demands for the release of the Kannada matinee idol, Mr. Rajkumar, and three others.

The Chief Minister, Mr. S.M. Krishna, today presided over a meeting of the high-level committee set up following the abduction on July 31. It was attended, among others, by the Home Minister, Mr. Mallikarjun Kharge.

Mr. Krishna instructed the Commissioner of Police, Bangalore, Mr. Madiyal, and the police authorities in other centres to beef up security as schools and colleges are opening on Monday.

The State Government is not attaching much importance to the announcement made by a group of organisations that their members would enter the forest to secure Dr. Rajkumar's release. Speaking to *The Hindu*, Mr. Kharge said he had no information about the announcement. Everyone should exercise restraint as the Government was dealing with a delicate issue.

Fans plan rescue

BANGALORE, AUG. 13. Five thousand fans of Mr. Rajkumar will set out on Monday to rescue their hero.

The fans are from over 50 organisations, including Karnataka Dalit Sangharsha Samiti (KDSS) and Dr. Rajkumar Abhimanigala Sangha. According to the KDSS State committee president, Mr. N. Murthy, 1,000 people would leave for Mysore from the railway station here at 8 a.m. torform.

From Mysore, they would travel to Chamrajnagar and later move on foot to Gajanur, he told presspersons here on Sunday.He said the organisations had decided at a meet here on Saturday to "tackle" Veerappan. "Our group will comprise 10 battalions of 500 people each."

On the possible consequences of their action on Mr. Rajkumar and the other hostages, Mr. Murthy maintained that they had "no violent intentions of any kind". They had been forced to resort to the mission because Veerappan was holding the two State Governments hostage. "We have waited for two weeks. Now we are tired of inaction."

HAVING FORCED THE Tamil Nadu and the Karnataka Governments to react favourably to most of his ten demands. Veerappan has submitted an additional chapter of four demands in exchange for the freedom of his captive the iconic Karnataka filmstar, Mr. Rajkumar. If some of the ten demands were not easy to satisfy, the present list is more difficult to fulfill. In fact, at least two of the demands — the reference of the Cauvery dispute to the International Court of Justice and making Tamil the medium of instruction up to the 10th standard in Tamil Nadu - are naive and unrealistic. The International Court of Justice is the principal judicial organ of the United Nations and constituted to settle disputes between U.N. members and not States within the Indian Union. The question of extending Tamil as the compulsory medium of instruction has to be seen against the background of the recent Madras High Court ruling. The court held that parents have a right to determine their children's education, squashing a Tamil Nadu Government order which sought to enforce Tamil as a medium of instruction in nursery and primary schools. Quite obviously, neither demand can be met.

Of course, whether these demands really constitute the nucleus around which the actual negotiation is being conducted for the release of Mr. Rajkumar and three of his relatives is a matter of doubt. Although the Chief Ministers of Tamil Nadu and Karnataka have denied that Veerappan has demanded a ransom, it is hard to understand why, after having someone as influential as Mr. Rajkumar in his captivity, he would want to pitch purely for demands that are of a political and ostensibly selfless nature. What Veerappan wants for himself — be it a ransom or an offer of general amnesty — is something that will become clear only as the hostage drama plays itself out. The new

picture being painted of the brigand, one he has clearly assisted in drawing, is that of a romantic and revolutionary hero who is motivated by broad societal interests. But it is clearly asinine for this sandalwood smuggler-turned-elephant poacher-turned-serial abductor — who has killed over 130 police and forest department officials — to try and portray himself now as a latter day Che Guevera.

Veerappan's attempt to metamorphose into a altruistic do-gooder of sorts has coincided with his now obvious dependence on elements belonging to the Tamil extremist fringe. It was only a couple of years ago that the Special Task Force (STF), which was constituted with the specific purpose of nabbing him, had boasted that its operations had resulted in reducing his gang to a mere half-a-dozen. If this figure was correct, then it appears that Veerappan's gang has grown considerably since then. The question is whether this growth was fuelled wholly by the partnership he seems to have struck with groups such as the Tamil National Liberation Army (TNLA). Such alliances are dangerous, rendered even more so by the suggestion that the forest brigand has established a link with Sri Lankan Tamil militant groups. If these facts are true, did the Tamil Nadu's intelligence wing detect them and if not, why not? Moreover, did the STF, which repeatedly drew attention to the arrests of his accomplices and other such minor victories, have a clue about Veerappan's growing circle of extremist friends? In the face of such a growth, why were the STF operations scaled down, particularly on the Tamil Nadu side? Chief Ministers Mr. Karunanidhi and Mr. S. M. Krishna may now strain themselves to find a solution but the fact is the whole situation is a result of the total lack of administrative will. Once this crisis is over, the public will want some answers from them.

Uncertainty in Goa: Cong muddle keeps politicos guessing

Bomb hoax at Delhi, Mumbai delays A-I flights

HOAX calls against the backdrop of an Independence Day red alert resulted in two bomb scares on Air-India flights heading for international destinations since Tuesday night.

The first flight (AI 112) headed for Mumbai from New York was forced to land in New Delhi due to a hoax call to a television channel, leading to a ten-hour delay. The flight was carrying 291 passengers.

The next one, a Mumbai-Delhi-London Air-India flight (AI 111) was delayed by two hours on Wednesday morning at the Chhatrapati Shivaji International Airport in Mumbai.

AI-111 was scheduled to depart from Mumbai at 3.50 am on Wednesday, but the the flight carrying 284 passengers finally took off at 5.50 am. An Air India spokesperson said an unidentified person had called the Airports Authority of India in Mumbai to say there was a bomb on board the aircraft, but a search turned up nothing. A thorough check was undertaken by the bomb disposal squad and the Bureau of Civil Aviation Security in Mumbai, said the airport police here.

Explaining the delays caused, an AI spokesperson told The Indian Express today that safety is always of prime concern, and it therefore takes preference over passengers' convenience.

In Delhi too, the bomb disposal squad of the Delhi police, assisted by other security agencies and sniffer dogs, searched the plane for several hours soon after it landed at Indira Gandhi International Airport at 10.49 pm.

As the plane, which reached Delhi after a halt in London, remained parked in the bay of the Airport, security personnel and fire tenders took up positions for any eventuality. A thorough search was also conducted of the baggage on board the aircraft, including the cabin and cargohold, airport sources said.

Karnataka pins hopes on Gopal's mission to rescue actor Rajkumar

BANGALORE: Two days after the kidnapping of Kannada superstar Rajkumar and three others by forest bandit Veerappan, the Karnataka government is pinning its hopes on the success of the mediation mission by Chennaibased Tamil magazine editor R.R. Gopal.

Gopal left for the forest where Veerappan is believed to be holed up with the 73-year-old actor on Tuesday evening, an employee of the magazine, Nakkeeran, told The Times of India.

Veerappan had kidnapped Rajkumar, his brother-in-law and two of his associates at gunpoint on Sunday night from the actor's farmhouse in Tamil Nadu, 5 km from the Karnataka border, plunging the ten-month-old Congress government of chief minister S.M. Krishna into a major

crisis.

After hectic parleys between Mr Krishna and Tamil Nadu chief minister M. Karunanidhi on Tuesday, the states decided to despatch Gopal, who has met Veerappan in the past on similar missions, to negotiate with the brigand and secure Rajkumar's release.

Normal life was disrupted in Bangalore and parts of the state for the second day, but the situation appeared to have improved with the police taking tough preventive measures against potential trouble-makers. Patrolling on the streets intensified and the elite Rapid Action Force was deployed.

Gopal would have left Chennai for the jungles immediately, but his departure was delayed due to

the murder of one of his correspondents at Perambalur, 200 km from Chennai. The murder, an official clarified, had nothing to do with the Veerappan drama.

As demanded by Gopal, the Karnataka government decided to close a police case filed against him in 1996, Karnataka's directorgeneral of police C. Dinakar told reporters after the meeting of a high-powered committee to review the situation. He said the case had been registered by the Kollegal police in 1996 for "certain actions which were thought to be illegal and anti-state". Mr Dinakar added, "Since Gopal is doing us a favour, the latter's desire is it should be closed."

Mr Dinakar said as the case was still in the stage of investigation, he would study the file and close it."I will bring a happy end to the case," he maintained.

Mr Krishna said the state government had suspended all operations in connection with Veerappan since Monday to ensure the safe release of Rajkumar. He dismissed as a "canard" and "untruth" reports that the operations were continuing.

Earlier, a high-level meeting comprising the CM, home minister Mallikarjun M. Kharge, home secretary M.B. Prakash, principal secretary S.V. Ranganath and top police officials decided to station K.R. Srinivasan, inspector-general (training), in Chennai as a nodal officer to co-ordinate the efforts of the two states.

The committee will constantly monitor the developments in Tamil Nadu and Karnataka.

Mr. Karunanidhi, speaking to the media later, however said that he had told Mr. Shivraj Kumar that Mr. Gopal, Editor of the Tamil magazine, Nakkeeran, was expected to make first contact with Veerappan either tonight or tomorrow. The brigand's demands will be known after that and "I hope that the outcome will be good," said Mr. Karunanidhi.

The Chief Minister said he had also spoken to Mr. Rajkumar's wife, Mrs. Parvathamma, over the

phone and requested her not to worry, adding that everything would end well.

Expressing concern over Mr. Rajkumar's health, Mr. Karunanidhi said though Veerappan had been charged with several crimes, in "matters such as this" the brigand had shown some sympathy in the past. "Given the deteriorating health of Dr. Rajkumar, I hope Veerappan will ponder over this aspect to ensure that the film actor was out of harm's way and release all the hostages," Mr. Karunanidhi said.

Asked if Mr. Gopal had made any request to the State Government as in the case of Karnataka before leaving for the forest, Mr. Karunanidhi, referring to Karnataka closing a case against the journalist, said there was no case against him in Tamil Nadu and hence the question did not arise.

An Erode report said that Mr. Gopal, two of his staffers, Mr. Sivasubramaniam and Mr. Balamurugan, besides Mr. Subbu, a video cameraman, had reached Thalavadi by car and proceeded to the forest on foot.

Sources say they would have either trekked towards Bandhipur, 20 km from Dhoddagajanure, from where Mr. Rajkumar was abducted three days ago, or to Thengumarata, 15 km from Thalavadi and await instructions from Veerappan. Mr. Gopal and his colleagues are well-stocked with food and other requirements.

Gopal contacts Veerappan aides

CHENNAI, AUG. 3. Four days after the abduction of the Kannada film star Mr. Rajkumar and three others, the official emissary, Mr. R. R. Gopal, today established "contact" with the sandalwood smuggler Veerappan's men.

According to informed sources, the brigand's aides met Mr. Gopal, editor of the Tamil magazine Nakkeeran, last night and twice today near Thalavadi in Erode district of Tamil Nadu.

Though he received the "goahead" signal from the forest brigand last night, the emissary decided to enter the forest only in the evening. For, the movement of villagers would be minimal, "there would be no police snooping" and the brigand preferred a "late evening appointment."

Mr. Gopal and his aides would have to walk a minimum of four hours to reach the interiors of the forest, where Veerappan is said be hiding with the four hostages. This morning, Mr. Gopal contacted his Chennai office and said, "negotiations and preparations

were on" for the trek to Veerappan's "den". Earlier in the day, the Tamil Nadu Director-General of Police, Mr. F. C. Sharma, told reporters here that Mr. Gopal's mission had been hampered by heavy rain. The DGP said the police were not monitoring the emissary's movements and "he is operating on his own".

The "top priority" was the safe release of the hostages, the DGP said. No time-frame could be fixed for getting the hostages released, he said adding, "we should allow time for negotiations to take place and progress." The question of drawing up a contingency plan in case Mr. Gopal's mission failed did not arise, he said.

Addressing a press conference, the Karnataka Home Minister, Mr. Mallikarjun Kharge, confirmed that the emissary had established contact with Veerappan's associates and the medicines sent through him had reached Mr. Rajkumar.

Gujarat bandh turns *Sena will not back* violent, one killed

GANDHINAGAR: One person was killed, a place of worship torched and several business establishments damaged in different parts of Gujarat as violence broke out on Thursday during the Viswa Hindu Parishadsponsored state bandh to protest against the killing of 100 people, including Amarnath yatris, in Kashmir.

Incidents of violence and arson were reported from Ahmedabad, Sabarkantha and Surat, where one person was stabbed to death. Curfew was clamped on Khedbrahma town in Sabarkantha district after a mob went on the rampage, setting "specific" shops on fire.

In Ahmedabad, stray incidents of violence, including

the torching of a place of worship, were reported as VHP activists roamed the streets, enforcing the bandh by stoning shops and other business establishments which had stayed open and deflating the tyres of public transport vehicles. Traffic in Gujarat's largest city remained off the roads and educational and business establishments remained closed.

The police had to fire over 35 teargas shells to disperse violent mobs indulging in stone-throwing in "sensitive areas". One person was arrested in connection with the attack on a place of worship near Chamunda bridge on Naroda Road, right in front of the Saher Kotda police station. Incidents of stone-pelting were also reported from some areas of the walled city, including Saraspur, where a footwear shop was looted.

Buses of the Ahmedabad municipal transport service

were withdrawn following stone-throwing. Some buses of the state transport service were also stoned in the rural areas. The damage has been estimated at Rs 50 lakhs, along with a revenue loss of Rs 3 crore due to the with-drawal of the buses.

MUMBAI: The Shiv Sena will not take part in the nationwide bandh called on Friday by the Vishwa Hindu Parishad to protest the killings of about 100 people, including Amarnath yatris, in Kashmir. However, the Mumbai BJP has decided to support the bandh.

City BJP president Vinod Tawde said his party would not only participate in the bandh actively, but also perform 'mahaartis' in the evening.

VHP activists intend to block vehicular and rail traffic at various places in the city as a part of their agita-tion. In a statement, chief of the Mumbai VHP Mohan Salekar appealed to shopkeepers, businesspersons and various associations to down their shutters voluntarily and support the bandh. "All BJP MLAs, corporators, office-bearers and workers shall come out in the open to canvass for the bandh," he added.

He demanded compensation of Rs 5 lakh each for the kin of those killed and Rs 50,000 to those injured in the massacre. Calling for an immediate stop to the "Pakistan-sponsored killings in Kashmir", he said the Farooq Abdullah government should be dismissed and steps should be taken to improve security for Vaishnodevi and Amarnath yatris.

Meanwhile, several leaders, including MPCC president Govindrao Adik, MRCC president Murli Deora and general secretary of the Raza Academy Syed Noori, have denounced the killings in Kashmir. The Raza Academy and other Islamic organisations will stage a dharm near Shelimar Hotal Bhandi Bassar at 4 stage a dharna near Shalimar Hotel, Bhendi Bazar, at 4 p.m. on Friday. Mr Noori said the militants in Kashmir were grossly misusing Islam to justify their actions. "It is wrong to portray the violence in Kashmir as a jehad," he observed.

Rajkumar warns against rescue mission 'Veerappan's demands should Bandit in impregnable position

BANGALORE: Bandit Veerappan has delivered an audio cassette to the Tamil Nadu authorities which contains a short speech by kidnapped Kannada superstar Rajkumar. The actor has assured his fans that he is safe

and sound and has warned of serious consequences to those held hostage in case of a rescue mission.

Rajkumar's voice has been authenticated by his family here. The actor has appealed to the authorities to accept Veerappan's demands as early as possible. He did not, however, spell out those demands.

In characteristic cloak-and-dagger fashion, Veerappan's associates delivered the cassette to a journalist in Pondicherry who then relayed it to officials in Chennai late on Thursday night. The tape was made

public in Bangalore on Friday by chief minister S.M. Krishna. The cassette reached Mr Krishna through Tamil Nadu chief minister M. Karunanidhi.

Assuring listeners that he was safe, Rajkumar said there should be neither fear nor anxiety about him. "I will come back soon," he said.

The 73-year-old actor-singer said, "He (Veerappan) has something in his mind. He has a demand. This should be fulfilled at the earliest.

The actor has also appealed to the Centre as well as the Karnataka and Tamil Nadu governments not to send any forces on a rescue oper ation. Rajkumar said he had heard over the radio that police forces would surround them and launch such an endeavour. He cautioned that such action would have "serious consequences

Describing the kidnapping incident as "accidental", Rajkumar, who spoke in a composed, calm and confident tone, said it was a new experience for him. He added that he and Veerappan had learnt something from each other.

The delivery of the cassette, officials explain, is a development completely independent of the media-tion mission undertaken by editor R.R. Gopal of the Tamil magazine, Nakkeeran.

Meanwhile, it is still not clear whether Mr Gopal has met Veerap-pan in the jungle. But whether he has already met Veerappan or is still on his way to meet him, Veerappan is expected to continue the drama for some more time.

By prolonging the drama, Veerappan also wants to make doubly sure that nobody is following Mr Gopal to his hideout. The ever suspicious Veerappan, according to Nakkeeran sources, is taking the ut-most precautions to prevent overzealous officers from tailing Mr Gopal.

The tape has served one important purpose for Veerappan: the two governments are now less likely even to think of a dare-devil rescue mission. By assuring all con-cerned that Rajkumar is safe, Veerappan has removed any sense of urgency that might have weighed with chief ministers S.M. Krishna and M. Karunanidhi.

The two CMs can now be expect ed to think twice before discussing any offensive for another reasonthrough Rajkumar's voice, Veerap-pan has delivered a threat of "serious consequences" in case of a rescue mission.

He said, in a seven-minute long taped message sent to TN CM M. Karunanidhi through Veerappan's nether network of couriers, that his abductor "should be given a chance to reform and lead a new life".

"During the last two days I've had long discussions with him and the two of us have learnt a lot about each other. And I feel that he wants to lead normal life. Why not give him a chance? I hope the two governments would consider his demands and accept them."

The message, in Kannada, was layed to Rajkumar's son played to Rajkumar's son Sivarajkumar (who is now camping in Chennai). He confirmed that it was his father's voice. Sounding relaxed, Rajkumar says that he has been treated and looked after "like a brother". "I am actually enjoying my experience in the forest and even my health is quite fine."

"When I introduced myself as Rajkumar and asked him what he wanted Veerappan replied, 'Only you sir.' I said, okay let's go. I

But the Kannada star does not hide the pain and disapproval of his fans' behaviour in attacking Tamil targets in retaliation for the kidnap.

"Karnataka is a state where Kannadigas, Tamil and Telugus and others have lived in peace for decades. Do not attack Tamils or indulge in any violence because that would only give me a bad name," he tells his fans in the tape.
"Veerappaga is correct when he

"Veerappan is correct when he says that he and his men will escape the moment forces enter. But only the four of us (captives) will get lost in the jungle. So withdraw all forces," Rajkumar says in his message.

One thing is quite certain. When Rajkumar returns from the forests, he could be expected to make a film of this real life drama. While there are no prizes for guessing who the film's hero will be, it remains to be seen if Veerappan will be in a position to replay his character before the cameras.

After all, one of the original demands linked to his offer to surrender was that a film should be made on his life.

Krishna coming for talks

CHENNAI, AUG. 5. The kidnap crisis is all set to enter the crucial negotiation phase with Vee-rappan having sent a fresh audio cassette addressed to the Chief Ministers of Tamil Nadu and Karnataka.

To discuss the fresh demands, the Karnataka Chief Minister, Mr. S.M. Krishna, is arriving here tomorrow for a second round of discus-

sions with his Tamil Nadu counterpart, Mr. M. Karunanidhi, since last Sunday's abduction.

Even as the cassette had been sent to the journalist-emissary, Mr. R.R. Gopal, through the brigand's aide, Mr. Karunanidhi heard the tape this morning. The cassette from Veerap-pan's hideout, on reaching Mr. Gopal — still camping in the forest — was brought to Chennai late last night by Mr. Balamurugan, a staffer of the Tamil bi-weekly, Nakkeeran, who accompanied his editor, sources in the magazine said. It was then handed over to the Chief Minister's office.

Gopal yet to make contact?

The fact that the cassette was sent by Veerappan to Mr. Gopal implied that the magazine editor was yet to "meet" the outlaw. Confirming this, Mr. Karunanidhi told the media at the Secretariat today Mr. Gopal might meet Veerappan later today.

Mr. Karunanidhi also spoke to Mr. Krishna over phone after receiving the cassette, when the Karnataka Chief Minister informed him that he would come down to Chennai on Sunday to discuss the further course of action.

chennal, aug. 6. The Tamil Nadu and Karnataka Governments today acceded to the "major demands" placed by the forest brigand, Veerappan, and urged him to release the veteran Kannada actor, Mr. Rajkumar, and three others, held hostage for the last one week.

After a two-hour closed-door confabulation, Mr. M. Karunanid-

After a two-hour closed door confabulation, Mr. M. Karunanidhi and Mr. S.M. Krishna, Chief Ministers of the two States, told a press conference, "We have responded favourably to all the 10 demands. We hope wisdom will prevail."

Earlier, Mr. Krishna, accompanied by the Union Minister for Tourism and Culture, Mr. Ananth Kumar, the Karnataka Home Minister, Mr. Mallikarjuna Kharge, and senior officials of his Government, arrived in Chennai to discuss with the Tamil Nadu Government the official response to Veerappan's demands. The Tamil Nadu Electricity Minister, Mr. Arcot N. Veerasamy, was present.

Ransom not sought

To a question whether Veerappan had demanded amnesty and Rs. 50 crores as ransom, Mr. Karunanidhi said he had not received such demands. According to a statement disting the brigand's

demands and the responses of the two Governments, the "demands" include implementation of the interim order of the Cauvery Water Disputes Tribunal, adequate compensation and protection to the Tamil victims of the 1991 riots in Karnataka on the Cauvery issue, the release of "innocent persons" kept in Karnataka jails and five detained in Tamil Nadu prisons, and steps for unveiling a statue of the saint poet

Thiruvalluvar in Bangalore.

In their response, the Tamil Nadu and Karnataka Governments agreed to install and unveil statues of Thiruvalluvar, and the Kannada poet, Sarvajna, in Bangalore and Chennai. The Chief Ministers would participate in the functions. While Karnataka agreed to drop the TADA charges against some prisoners, Tamil Nadu would consider "favourably" the question of releasing five persons.

The Tamil Nadu Chief Minister said the responses of the two Governments would be conveyed to Veerappan through a messenger sent by Mr. R.R. Gopal, official emissary and *Nakkeeran* editor.

Extremists' backing?

On whether any Tamil chauvinist group had joined hands with Veerappan, Mr. Karunanidhi said, "There are reports to suggest this perception, but there is no confirmation yet... Veerappan himself may have turned a Tamil extremist." He, however, said there was nothing wrong in displaying deep love towards one's mother tongue; but one should not indulge in terrorism.

On the voice of the person in the cassette received on Saturday, Mr. Krishna said, "We are no voice specialists or analysts. We believe that it is Veerappan's as we got the cassette from him

'Gopal met brigand'

In Bangalore, Mr. S.M. Krishna, told reporters soon after his arrival from Chennai, "Mr. Rajkumar, Mr. Gopal and Veerappan and others are in a house and not in a guhe (Kannada for cave) or jungles."Mr. Krishna added: "We have also got a response for this response... Opposition backs Krishna Govt. strategy

BANGALORE, SEPT. 9. The Karnataka Government today received a shot in the arm in its efforts to obtain the release of the Kannada actor, Mr. Rajkumar, and three others with the leaders of the Opposition parties, by and large, standing by it.

The Chief Minister, Mr. S. M. Krishna, summoned a meeting of political leaders here to share with them the outcome of his talks with his Tamil Nadu counterpart, Mr. M. Karunanidhi, yesterday. Unlike the meeting earlier this week, where the Government's handling of the situation came under fire, today's meeting saw some leaders even suggesting a way out of the imbroglio.

Bolstered by the Opposition' support, the Government decided to continue the negotiations with the forest brigand Veerappan, apart from pursuing the case in the Supreme Court. The Government was, however, non-committal on when the emissary, Mr. R. R. Gopal, would undertake another mission to the forests.

The Leader of the Opposition in the Legislative Council, Mr. K. H. Srinivasa, said the Government should immediately ask the Centre to promulgate an Ordinance to abate the pending TADA cases. The ordinance would automatically result in the release of detenus and by seeking such an ordinance, the State would not be offending the Supreme Court, he said.

At the last meeting, Mr. Srinivasa had urged the Chief Minister to invite Mr. Karunanidhi to visit Bangalore to assuage the feelings of the local people and infuse confidence among the Tamils. Sources in the Government pointed out that Mr. Karunanidhi's statement that he was here to share the agony of Kannadigas following the abduction had made a big impact.

The floor leader of the Janata Dal(U) in the State Assembly, Mr. P. G. R. Sindhia, and the party's State unit president, Mr. C. Byre Gowda, said they had suggested that the Government prepare an alternative strategy and that it

should not hesitate to seek Central assistance.

The Home Minister, Mr. Mallikarjun Kharge said the Government would be ready with its arguments to be submitted to the apex court in two days and that the Opposition leaders' suggestions would be incorporated.

According to sources in Nakkeeran, Mr. Gopal is unlikely to leave on his fourth mission to the forests before the Supreme Court ruling on the release of the 121 TADA detenus in Karnataka and the five ultras in Tamil Nadu.

T.N. deposition irks Karnataka γ

BANGALORE, SEPT. 21. The S.M. Krishna Government is clearly unhappy over the Tamil Nadu Government's latest affidavit before the Supreme Court, complaining that it did not inform the latter of the visit of Mr. Rajkumar to his farmhouse at Gajanur, in Erode district, on July 30.

Replying to a public interest litigation petition, the Tamil Nadu Government on Wednesday blamed the Karnataka Government for not informing it of the visit of Rajkumar to the State. The response, which was received with surprise here, has added a new dimension to the entire abduction episode. The Tamil Nadu Government pointed out that it would have provided adequate security to the actor and his family if the Karnataka Government had informed it about Mr. Rajkumar's visit.

The top echelons in the Karnataka Government view the latest development as an "ingenuous and clever" move by the Tamil Nadu Government to convince the apex court that it was not responsible for the abduction of the Kannada actor by Veerappan. Ac-cording to them, the Tamil Nadu Government said it had shared the information with the Karnataka police that there was a possibility of Veerappan kidnapping the actor. It had put the blame at the doors of the Karnataka Government. The Tamil Nadu Government was absolving itself of blame. It had sent a rejoinder to the Karnataka Government's response that the onus of getting the actor released greatly rested with it (the Tamil Nadu Government) as the actor was abducted from and was being held hostage in the forest of that State.

A spokesman of the Karnataka Government said it was not the time for "mutual recriminations and trading of charges". Both the Governments should work to-gether to secure the freedom of the hostages without further delay, he noted. Bickering and conflicts should not come in the way of their joint endeavour to end the abduction drama on a happy note, he felt. It was at the behest of the Karnataka Government that the Tamil Nadu Chief Minister, Mr. M. Karunanidhi, persuaded Nakkeeran Editor Mr. Gopal, who was acting as an emissary of both the Governments, to meet the outlaw for the fourth time and plead with him to release the hostages.

The Karnataka Home Minister, Mr. Mallikarjun Kharge, who met Mr. Karunanidhi two days ago in Chennai, reportedly stated that the patience of Mr. Rajkumar's fans and supporters was fast wearing and it might ultimately result in violent reprisals targeting over 18 lakh Tamils residing in Karnataka. He apparently wanted this message to be conveyed by Mr. Gopal to the outlaw in clear terms.

The leaders of Rajkumar's fans associations and several Kannada organisations have become restless over the inordinate delay in securing the freedom of the actor. Several towns and cities apart from Bangalore have been witnessing bandhs and agitations followed by sporadic violence during the last couple of days. A State-wide bandh was being planned to bring to the notice of the Union and State governments that they would not put up with the impasse any longer.

The sons of Mr. Rajkumar have expressed their anguish and concern over the state of health of their 73-year old father, who has been forced to live in the harsh conditions of the forests. They have said that they would volunteer to become the captives of Veerappan if he freed their ailing father. Cable TV operators all over the State stopped transmission for a day on Wednesday to express their displeasure over the impasse. The Kannada film industry on Thursday took out a mammoth procession and presented a memorandum to the Governor at the Raj Bhavan. All the leading lights of Kannada cinema took part in the rally. A slight setback in the health of Ms. Parvathamma, wife of Mr. Rajkumar, who was admitted to a private hospital, has caused widespread anxiety.

Apprehending violent retaliation against the Tamils in the State, a prominent Tamil organisation presented a memorandum to the Governor to impress upon the Government the need to provide them adequate security. In another development, 17 Tamil organisations, including the Bangalore-based Tamil Sangham, have despatched fervent appeals to the forest brigand through Mr. Gopal to release the hostages without further delay. They have conveyed their fears of violent reprisals, if the impasse is not broken early.

'T.N. has not blamed us'

BANGALORE, SEPT. 21. Tamil Nadu's affidavit before the Supreme

Court on Karnataka's failure to inform it about Mr. Rajkumar's visit to the Gajanur farmhouse from where he was abducted by the brigand, Veerappan, has not complicated the process of obtaining the actor's release.

This was the stand of the Karnataka Law Minister, Mr. D.B. Chandre Gowda, who at first said this was not the issue before the Supreme Court and the State and he did not want to get into a controversy.

The issue before the court was the powers of the State under Section 321 Cr.P.C. to drop cases against the TADA detenus whose release Veerappan had sought.

On persistent questioning, however, Mr. Gowda, who was briefing the press about today's Cabinet meeting, said he did not think that Tamil Nadu's affidavit would complicate the Rajkumar release issue.

Tamil Nadu, he said, had not blamed the Karnataka Government. He could not make any further comment as he was yet to get a copy of Tamil Nadu's affidavit.

Asked what the State, which was depending on the cooperation of Tamil Nadu, thought about the latter's stand, Mr. Gowda said this was not the time to say anything. The two governments were working together (in the court) and many senior advocates were appearing for them.

Mr. Gowda did not agree that Tamil Nadu had betrayed the State by the stand it had taken. It had not gone back on its original stand either. Karnataka would reply to what Tamil Nadu had said, if at all it was needed.

Centre approves of prisoners' release for freeing Rajkumar

DANCAL ODE CA SEDTEMBED

THE CENTRAL government has supported moves by Karnataka to free the detained associates of forest brigand Veerappan in exchange for Kannada matinee idol Rajkumar, now in his ninth week of captivity with the bandit.

"Withdrawal of prosecution could be permitted in the larger interest of the public," the central government has said in an affidavit filed in the Supreme Court. "Ultimately, the test which may be applied by the court in order to determine the validity of grounds of withdrawal in a particular case is the requirement of public justice outweighing the legal justice of the case," the affidavit says.

The court is hearing an appeal against Karnataka's decision to release 121 associates of Verappan who have been

detained in jails in Mysore, key city in Karnataka, under a defunct anti-terrorist law. The release of the detainees is a key demand of Veerappan for freeing Rajkumar.

"Withdrawal from prosecution can be permitted not merely on paucity of evidence but also on

other relevant grounds as to further the broad ends of public policy, order and peace," says the affidavit, filed in the name of Durgadas Gupta, the joint secretary in the ministry of home affairs.

The state government "had not acted against rule or law and/or against public interest on the basis of narrow sectarian or political reasons," the affidavit says.

Retired police official Abdul Kareem, whose son, sub inspector Shakeel Ahmed, was gunked down by Veerappan eight years ago, has challenged the release of the detainees. In staying the release, the Supreme Court had asked both Kareem and the Karnataka government to submit their documents by October 11, when the case will be heard.

In essence, the court was questioning the bona fides of Karnataka in withdrawing the cases filed under the defunct antiterrorist law.

The court had blasted the Karnataka government for bowing to the "illegal demands" of Veerappan in agreeing to release his detained associates. It had asked the Karnataka government to quit if it could not maintain law and order, an apprehension that the state had expressed if Rajkumar's release was delayed.— IANS

When they asked for "saar" (Rajkumar), declaring they wanted to take him away, the film star got up and asked them to take him but leave the others.

Veerappan told Parvathamma that they would treat Rajkumar, 72, with care and respect and ensure that no harm was caused to him. Thereafter, he gave her an audio cassette, asking her to give it to the Chief Minister and warned

against alerting the police.
Along with Dr Rajkumar, his brother-in-law, S A Govindaraju, a relative, Nagappa, and an associate director, Dr Nagesh, were taken

away "to look after the film star."

According to Chief Minister S M Krishna, the cassette contains Veerappan's message, asking a State representative to meet him to discuss his demands

Dr Rajkumar's youngest son, Raghavendra, told reporters that the State intelligence had warned the family of the threat to the actor and had requested them to inform the local police if he intended to travel beyond Mysore, which is

Veerappan's territory. Though this upset Dr Rajkumar, he did not go for security. However, he stopped going to Gajanur. "Why will he want me? What will he get from me? I am prepared to hand him my shirt and dhoti if he wants," he was

quoted as having said.

But with the police warning having come a year ago and Veerappan completely inactive, the family had begun overlooking precautions.

Therefore, on Sunday night, Veerappan took Dr Rajkumar and those present completely by sur-prise. No resistance was offered. Immediately after the abduction, a shocked but Parvathamma composed rushed Bangalore.It was 2 am before she could inform Karnataka Home Minister Mallikarjun Kharge about the abduction.



An unexpected crisis for Krishna Govt.

By S. K. Ramoo

BANGALORE, JULY 31. The people of Karnataka woke up on Monday morning to the shocking news that the popular matinee idol, Dr. Rajkumar, had been kidnapped by an armed gang led by the notorious forest brigand, Veerappan. They received the news with a sense of disbelief.

The abduction comes as an unexpected crisis for the Chief Minister, Mr. S.M. Krishna, and his nine-month-old Government. The adulation that millions of fans have for the film star has to be seen to be believed and they expect the State Government to act swiftly to obtain his release.

The Krishna Government is already under tremendous pressure and it has gone on record that the health and safety of the film star is paramount and that it will strive to ensure that the charismatic star does not come to any harm. The Chief Minister, who has so far taken correct and appropriate measures, flew to Chennai and met the Chief Minister of Tamil Nadu, Mr. M. Karunanidhi, to seek the latter's co-operation for the release of Dr. Rajkumar.

An informal emergency meeting of the Cabinet in the morning conveyed the Government's concern over the episode. Mr. Krishna is definitely a worried person as he is well aware that any delay in securing the freedom of the actor, can lead to a grave law and order problem. There is fear and uneasiness, and bouts of violence have already been unleashed in Bangalore. In Bangalore and several other

cities in the State, bandhs were observed without anyone giving a specific call. In areas such as Chamarajpet, J.P. Nagar, Banashankari and Jayanagar in Bangalore, gangs blocked roads and stoned passing vehicles. Shops and other commercial establishments, including petrol bunks, were closed. Schools and colleges have been closed for two days.

The elusive bandit masterminded the abduction in a daring manner. The State police force and its intelligence agencies have been taken by surprise. This is all the more dismaying because one of Dr. Rajkumar's sons, Mr. Raghavendra Rajkumar, said his family had been warned by some individuals two months ago that the actor should not travel to his Gajanur farmhouse in Satyamangala taluk in Periyar District of Tamil Nadu, without taking adequate precautions. The police intelligence agencies have either failed to get the information or had glossed over the information they

The outlaw has struck where it hurts most. For millions of adoring fans, Dr. Rajkumar's kidnap is akin to sacrilege. The Krishna Government is not in a position to adopt a tough and uncompromising stand against the bandit. It will have to negotiate and even compromise in order to get the actor released. It is expected that one of his demands will be a hefty ransom and amnesty for all his killings. In recent months, he has demanded blanket pardon for all his criminal actions. He has been held responsible for the killings of over

100 persons, including forest and police department personnel.

Governments in Karnataka, without exception, have been guilty of empty bravado in claiming that the poacher and smuggler would be apprehended soon.

On the other hand, Vecrappan and his gang have been ruling the roost from their forest hide-out by openly defying the Special Task Forces of both Karnataka and Tamil Nadu.

Mr. Gopal said he explained to Veerappan that in both cases the release had run into legal hurdles with cases filed before the Supreme Court. "Hoping that there may be some development in the apex court, I delayed my departure from the forest with a view to returning with Mr. Rajkumar and the others." But Veerappan firmly drew a line winding up the talks, said Mr. Gopal adding, "I realised that there can be no further negotiations until the Supreme Court gave its verdict and decided to re-

Asked when Mr. Rajkumar's release would be in sight, he said, "it now depends upon the Supreme Court."

Making it clear that it was now upto the two Governments to decide on whether or not he should undertake a fourth mission, Mr. Gopal saw his role as trying to bring a "meeting point" between Veerappan and the two Governments.

Stating that the brigand had made no fresh demands, Mr. Gopal said the actor's health was fine. He had adjusted to the forest environment and sent an audio tape to his family.

On whether Veerappan was convinced about the Governments' responses to his other demands, Mr. Gopal said, "we achieved progress on those issues during the negotiations." Regarding the Karnataka High Court's stay against resumption of the Sadhasivam Commission of inquiry into the STF's "excesses", he said, "I left the forest before this news reached us."

After showing Veerappan the copies of the orders of the two Governments and their explana-tions, he had brought back the documents. They would be given to Veerappan only after the hostages' release.

Act swiftly, T.N., Karnataka told

CHENNAI, SEPT. 7. The Union Minister of State for Finance, Mr. Dhananjaya Kumar, today called upon the Karnataka and Tamil Nadu Governments to "act swiftly" to bring an early end to the hostage crisis involving the Kannada film actor, Mr. Rajkumar.

Addressing a press conference here, Mr. Kumar, who represents the BJP from the Mangalore Lok Sabha constituency, said he was only "expressing the concern of the people" that the crisis was dragging on and that the efforts and strategy adopted by Karnataka had not yielded results.

Asked if he was advocating Central intervention, the Minister said the Centre could consider providing assistance only if it was asked for. He would not even proffer an "advice" of how to handle the matter at this stage since unsolicited advice would only "add to complications". The Karnataka and Tamil Nadu Governments had been emphasising that they were competent to handle the issue, he said, refusing to say whether he would suggest a commando operation to rescue the hostages.

Mr. Kumar said there was practically no Government functioning in Karnataka for the past 40 days and files were not moving. "As a prudent Government, should you not have al-

ternative plans to deal with the situation? Why earn the wrath of the judiciary, if the State Government felt that it was doing the right thing in releasing detenus in response to Veerappan's demands," he asked.

Claiming that there were differences of opinion between the Karnataka Government and its police chief and also within the State Cabinet. "The (two) State Governments cannot go on for long in this fashion, dealing with such a known criminal."

S.C. accepted our plea: Krishna

BANGALORÉ, SEPT. 7. The Chief Minister, Mr. S.M. Krishna, will meet his Tamil Nadu counterpart, Mr. M. Karunanidhi, in Bangalore on Friday to discuss the next move on the Rajkumar kidnap crisis.

"Dr. Rajkumar was kidnapped in Tamil Nadu and is being confined in that State. It is, therefore, fitting that Mr. Karunanidhi comes here for talks," Mr. Krishna told mediapersons here.

Asked if the Chief Ministers would discuss alternative arrangements in view of the journalist-emissary, Mr. R.R. Gopal's failure to se-

cure the actor's release, Mr. Krishna refused to be drawn "into a public dialogue on the issue". Asked if any Union Government representative would be involved in the talks, he stated he was "not aware of any such development".

The Chief Minister clarified that the Supreme Court had not turned down Karnataka's plea for an early hearing on the Special Leave Petition (SLP) filed by Mr. Abdul Kareem, father of Shakeel Ahmed, the police subinspector killed by Veerappan. "We have made our next move and the S.C. has accepted our contention that an early hearing on the SLP is warranted," he said.

No change in strategy

The Minister of State for Information and Publicity, Prof. B.K. Chandrashekar, told presspersons that although the State Government was considering various options to secure the release of Mr. Rajkumar, it would, for the present, pursue the same strategy.

Prof. Chandrashekar said the Government would get the "broad directions" it might have to follow in the next two or three days. Only after the two Chief Ministers meet tomorrow would the next course of action be decided, he said.

Mumbai HC admits State's petition in Thackeray case

THE Mumbai High Court today admitted an appeal filed by the Maharashtra Government challenging the July 25 order by a magistrate who dismissed the case against Bal Thackeray relating to alleged inflammatory writings in Saarma during the riots in 1993.

Admitting the petition moved by public prosecutor P R Vakil, Justice Vishnu Sahai said the state government's case was "arguable" as the impunged order of the magistrate was "improper." The judge however, refrained from listing the reasons for admitting the appeal in writing in order to "prevent any prejudice during the final hearing of the case."

However, Justice Vishnu Sahai refused to grant a stay on the operation of the order passed by additional Chief Metropolitan Magistrate B P Kamble. The judge also refused to expedite the hearings and asked State counsel P R Vakil to make an application to the Chief Justice in this regard. He added if both sides agreed, he would give a date the very next day.

The petition filed under Article 227 of the Constitution of India and Section 468 of the Code of Criminal Procedure, seeks to set aside and quash Magistrate Kamble's judgement on July 25, 2000 on a remand application. Kamble had discharged Thackeray, Saamna editor Sanjay Raut and publisher Subhash Desai in a common judgement and also termi-

Karunanidhi, Krishna to meet PM on Rajkumar kidnap issue

THE CHIEF Ministers of Karnataka and Tamil Nadu will meet Prime Minister A B Vajpayee after his return from the United States to seek his advice on ways to end the crisis over the kidnap of Kannada superstar Rajkumar by bandit Veerappan.

At a joint Press conference here of Karnataka Chief Minister S M Krishna and his Tamil Nadu counterpart M Karunanidhi, the two, however, made it clear that they did not see Central intervention necessary at this point. "If we feel the need we will ask for the Centre's help," Mr Karunanidhi

said. The two Chief Ministers decided to pursue negotiations with bandit Veerappan while simultaneously plead with the Supreme Court to dispose speedily the petitions against the release of TADA detenues in Karnataka and the five extremists in Tamil Nadu. The SC hearing is on September 13.

Mr Karunanidhi said he will go to Delhi along with Mr Krishna soon after the Prime Minister returns and apprise him of the situation. "We will also speak to Home Minister L K Advani on the issue," he said.

The visit of the Tamil Nadu Chief Minister to Karnataka comes amidst rising tension in the State over the continuing hiatus in the release of Rajkumar.

Kannada organisations of all hues have chalked out programmes to pressure the two governments to do "something" fast. Karunanidhi's visit Bangalore, the first since the kidnapping on July 30, is to reassure people in Karnataka about the seriousness of his government in ensuring a quick end to the crisis. The Tamil Nadu Chief Minister

said he could have met Mr Krishna anywhere, but he chose to come to Bangalore to "reassure Kannadigas and Tamilians in the State about his intentions to speedily resolve the crisis". The two Chief Ministers set aside speculation over continuing Nakkeeran Gopal as the emissary on the grounds that he had gained the trust of Veerappan. "Oopal was successful in his mission. But for the SC stay the situation would have been different. He will continue to be our emissary," Mr Karunanidhi said.

Mr. Parrikar, 45, a metallurgical engineer from IIT and leader of the BJP legislature party, was sworn in along with a 14-member Council of Ministers by the Governor, Mohd. Fazal, at a simple ceremony at the Raj Bhavan marking the change of guard for the 13th time in a decade.

Mr. Parrikar said the Governor had not asked him to prove his majority claiming that the latter was satisfied with the list of MLAs "I submitted in support of my strength in the 40-member House."

The BJP legislature party leader has claimed the support of 22 members in the Assembly, including 18 from his party, two from the Maharashtrawadi Gomantak Party (MGP) and two others. The Parrikar Ministry comprises 13 from the BJP and one from the MGP and accommodates all those who recently quit Congress and its splinter group to join the party.

Mr. Parrikar was invited to form the Government following Mr. Sardinha's resignation without facing a vote of confidence as directed by the Governor after his 11-month-old government was reduced to a minority last Saturday.

Mr. Sardinha's fate was sealed when in a development late last night, four Ministers from his Goan People's Congress Party (GPCP) — Mr. Alexio Sequeira, Mr. Francisco Desouza, Mr. Venkatesh Desai, Mr. Arecio Desouza — resigned and formed a new party. He quit this afternoon shortly before a special session of the Assembly was take up the trust vote.

Messrs Ravi Naik, Ramakant Khalap, Digambar Kamat, Sheikh Hassan Haroon, Prakash Velip, Pandurang Raut, Suresh Amon-

kar, Sanjay Bandekar, Prakash Phadte, Manohar Ajgaokar, Philip Neri Rodrigues, Jose Philip Desouza and Ramarao Desai were all sworn in Cabinet Ministers.

The Ministers took the oath of office either in Konkani, Hindi, Marathi or English. Barring Mr.

Parrikar, Mr. Ajgaokar, Mr. Rodrigues, Mr. Desouza and Mr. Dessai, the others have served as Ministers at one time or other.

The partywise strength at present is BJP (18), GPCP (7), Congress (6), Goa People's Congress Party (Venkatesh group) (4), Congress (Sheikh Hassan group) (1), MGP (2), Nationalist Congress Party and independent one each.

During the fast-paced developments, the Congress suffered a third split since the Assembly was formed. The first was when Mr. Sardinha toppled the Congress ministry and formed the government with the help of the BJP, eleven months back.

Another group of five Congress MLAs quit last August to form the Congress (Sheikh Hassan group), which itself split when four of them joined the BJP on Monday.

The process set in motion by Mr. Sardinha, however, boomeranged on him when the BJP withdrew support and felled his government with the help of eight former Congressmen. — PTI

Goa CM to seek trust vote tomorrow 23/10

PANAJI, OCT. 22. The Goa Chief Minister, Mr. Francisco Sardinha, will seek a vote of confidence in the State Assembly on October 24. Official sources said here that the Governor, Mr. Mohammad Fazal, had directed the Chief Minister to seek a vote of confidence at the special session of the State Assembly, scheduled to be convened at 2.30 p.m. on October

Earlier, the BJP legislature party leader, Mr. Manohar Parrikar, had called on the Governor and withdrawn his party's support to the eleven-month-old coalition Government headed by Mr. Francisco Sardinha and also staked his claim to form the Government.

However, Mr. Sardinha refused to resign saying that his Government was in a majority and he would prove it on the floor of the House.

Mr. Sardinha, expressing confidence that his Government would tide over the present crisis, said the 11 MLAs of his Goa People's Congress were united and an appropriate strategy would be drawn up to deal with the situation.

On whether he would accept support from the Congress, Mr. Sardinha said he would not hesitate to do so. Asked who would be the Chief Minister in the event of a re-alignment with the Congress and this group securing the required strength to form a Government, he said, "who becomes Chief Minister is not important'

The Chief Minister accused the BJP of stabbing his

Government in the back when he was on a foreign tour. "We did not realise that their intention was not good when they extended support to us to form a Government in November last year."

Stating that he had handed over to the Governor a letter withdrawing his party's support to the Sardin-ha Government and the resignations of three of its Ministers, Mr. Parrikar said the BJP had requested him to take a decision before Deepavali.

The Governor was aware of the political situation and would take an appropriate decision at a proper time, he said.

Asked about the possible composition of his Cabinet, Mr. Parrikar said the Union Information Tech-Minister, Mr. Pramod Mahajan, was expected to reach here tomorrow afternoon to oversee the formation of the new government and finalise its modalities. To another question, he said the BJP was always in favour of a "small Cabinet".

On Mr. Sardinha's performance in the last 11 months, the BJP leader said, "Mr. Sardinha is a gentleman, but he had to suffer because of other elements. He should have remained alert against such elements.

The State Congress spokesman, Mr. Jitendra Deprabhu, said the party was watching the situation closely. On whether the party would support Mr. Sardinha, he said, "first there has to be a request for support. Then we will discuss and take a stand.'

surprised **over documents**

NEW DELHI, OCT. 22. The former Law Minister, Mr. Ram Jethmalani, today expressed surprise over the official documents authenticating the real age of the Chief Justice of India, Mr. Justice A.S. Anand being published in the media and wondered "why these documents did not surface when they were required most - at the time of enrolment of Justice Anand as an advocate in 1964 and the hearing of the PIL on this issue in the Madras High Court in 1991.

"It is the duty of a judge to see that truth prevails. Why, did Justice Anand not assist the petitioner in the High Court in procuring the document about his age," he asked.

Asked to comment on the official documents showing the date of birth of Justice Anand as November 1, 1936, the former Law Minister said "the Chief Justice did not produce the documents at the proper time. Even if these documents are genuine, his conduct at that time was wrong.

Asked whether the President should take note of his book, Big egos, small men,' to be published tomorrow, and order an investigation into the real age of the Chief Justice, Mr. Ram Jethmalani said "the President has power only with regard to a High Court Judge as far as ascertaining the age was concerned. In the present

case, only Parliament is empowered to provide for an authority under law to determine the age.

Mr. Jethmalani, replying to another question, said "I wish the Prime Minister to get back to his full vigour and then read the book and apply his mind." After reading the book, the perception of the public would change about every single person involved in his exit from the Union Cabinet, he claimed.

'Fiction at its worst': Sorabjee

NEW DELHI, OCT. 22. The Attorney-General, Mr. Soli Sorabjee, today dismissed as "fiction at its worst" the new book written by former Law Minister, Mr. Ram Jethmalani, attacking him and the Chief Justice of India, Mr. A.S. Anand.

Back from Mumbai after a knee surgery Mr. Sorabjee, when asked to comment on Mr. Jethmalani's book "Big egos, small men" to be released tomorrow, said "at present, I am concentrating on my recovery from my operation. From what I have been told the book appears to be fiction at its worst." The book describes him as one of the key conspirators in the sacking of Mr. Jethmalani in July last. — PTI

Although book bracketed the Attorney General Mr Soli Sorabiee, and Justice Anand with the current Law Minister, Mr. Arun Jaitley, as the trio which had "conspired" to get him sacked, it does not contain any severe criticism against Mr. Jaitley.

Mr. Jethmalani criticised Mr. Jaitley for supporting the inclusion of Mr. Sorabjee's name in the Constitution Review Commission. "I candidly wrote to the Prime Minister that though Mr. Sorabjee is supported by Advani and even more by Jaitley, my own view is that a law officer of the Government should not be on this Commission." On the controversy over his exit from the Cabi net, the book says the Prime Minister was told by Mr. Sorabjee that Mr. Jethmalani's remarks had put the Executive on a collision course with the Judiciary.

"Maybe the Prime Minister consulted somebody else too. I believe on the evidence of India Today (magazine) that Arun Jaitley too was present and he too gave the same advice. I am not surprised. Ambition has made traitors of much better men," Mr. Jethmalani writes.

He then refers to his speech in the Rajya Sabha after his resignation where he concluded with a 'mild admonition of Arun Jaitlev.' - PTI

HE six-year-old legal wrangle over the Rs 18,000 crore Sardar Sarovar Project ended today with the Supreme Court okaying further construction

of the dam on the river Narmada as per the Narmada Tribunal Award. The court, in a majority judgement,

said the review committee could refer to the Prime Minister any differences over the implementation of the award, whose decision will be final.

By a 2-1 judgement, the three-member bench permitted construction of the dam up to 90 meters on the basis of the clearance by the project's relief and rehabilitation sub-group. But construction beyond this height may be undertaken only after clearance by the environment sub-group of the ministry of environment and forests.

The judgement is a major setback for the Narmada Bachao Andolan which has been spear-

headed a mass movement against the project.

The majority judgement was in the name of Chief Justice A S Anand, who concurred with Justice B N Kirpal. Dissenting judge S.P. Bharucha wanted the dam's construction halted till the environment ministry

clears the project on the basis of expert advice.

Senior counsel Shanti Bhushan, who represented the NBA, wanted an independent judicial authority review of the project, contending that its harsh impact on the

environment were not fully assessed.

The Court observed: "Perhaps the setting up of a ther-

mal plant may not displace as many families as a hydel project may, but the pollution caused by the thermal plant and the adverse affect on the neighbourhood could be far greater than the inconvenience caused in shifting and rehabilitating the ous-

Judges Anand and Kirpal directed the Narmada Control Authority to moot within four weeks a plan for the completion of the dam and the rehabilitation of the people displaced. Madhya Pradesh, Gujarat and Maharashtra, the states covered by the project, should abide by the plan and disputes could be represented to and disputes could be represented to

the review committee, the court said.

The grievances redressal authorities, the court said, was at the liberty to direct the three states to implement the rehabilitation programmes, and even approach the review committee if it was not forthcoming.

BOOKER PRIZE winning author Arundhati Roy, a passionate campaigner against the Sardar Sarovar Dam, said the Supreme Court judgement today giving the green signal for the project was "shocking and disgraceful".

"For the Court to give the go ahead for the project, when hundreds of families affected by it have not been rehabilitated or given alternative agricultural land

shows that the issue of basic human rights has been completely ignored," Ms Roy told UNI.

Praising the dissenting judgement of Justice S.P. Bharucha for striking the right note of caution, Ms Roy said the judge had observed that the environmental consequences of the project had not been examined at the time of clearance and work on the site should be stopped forthwith, pend-

ing an environmental assessment.

Minister demands probe into funds received by NBA

EXCITED OVER the Supreme Court verdict clearing further construction on the disputed dam on river Narmada, Gujarat's Narmada Development Minister Jay Narain Vyas has demanded an enquiry into the alleged foreign exchange violations by the Narmada Bachao Andolan (NBA) led by Ms Medha Patkar.

In a letter to Union Home Minister L.K.Advani, the Minister has pointed out certain violations of the Foreign Contribution Regulation Act (FCRA) in the funds received by the anti-dam movement spearheaded by the NBA. He has asked the Union Home Minister to institute a CBI probe into the foreign funding of the NBA and the Income Tax exemptions claimed.

Refusing to disclose the names of the countries, which had been funding the anti-dam agitation, the Minister said that he has enclosed some incriminating documents along with the letter he has written

to Mr Advani.

Though the foreign connections and funding of NBA were fairly well-known, this is probably the first time an inquiry is being demanded into the matter.

Meanwhile, the Gujarat Government has planned a gala celebration at the dam site on Oct 31, the birth anniversary of Sardar Patel, to mark the re-launch of the construction activity of the project. L. K. Advani would start the concrete work and unveil a statue of Sardar Patel. A rally also has been planned on that day. 'Narmada poojan' will be conducted in the villages at 12.39 in the afternoon, the auspicious time when the construction of the dam would resume.

'Human dimensions of dam overlooked'

Karnataka yielding to illegal demands: S.C.

NEW DELHI, SEPT. 2. The Supreme Court, in its oral observations during a hearing of the "Veerappan associates-release case" expressed concern at the inability of the Karnataka Government in apprehending the forest brigand for the past eight years.

"What have you (the State Government) done for the past 8 years to apprehend that man? We make it clear it is the responsibility of the State Government to maintain law and order. If you cannot do it, then quit and make way for somebody else who can," a Bench said.

(According to a PTI report, the court rapped the Karnataka Government for succumbing to such "illegal and unreasonable" demands of the brigand to secure the release of the Kannada actor, Mr. Rajkumar.)

The Bench, comprising Mr. Justice S. P. Bharucha, Mr. Justice D. P. Mohapatra and Mr. Justice Y. K. Sabharwal, made the observations while directing that its August 29 interim order — that none of the respondents-accused (Veerappan associates') be released on bail or otherwise pending further orders — operate pending disposal of the appeal from Mr. Abdul Karim, a retired police officer.

Earlier, the Bench granted special leave to the appellant, father of sub-inspector Shakeel Ahmad who along with Superintendent of

Police Harikrishna, was killed allegedly by Veerappan in 1992, to appeal against an August 19 order of the 'designated court', Mysore, according "consent" to the special public prosecutor to withdraw charges for offences punishable under Sections 3, 4 and 5 of the Terrorist and Disruptive Activities (prevention) Act against certain accused (Veerappan associates). In all, 115 accused (including Veerappan)

were cited as respondents.

It is learnt that 51 accused who were ordered released on 'bail' by the Sessions Judge, Mysore, on August 28 are on the list of the 115 accused (in the SLP). The Mysore sessions judge's order of August 28 is also under challenge in a related petition.

Earlier, Mr. Harish N. Salve, Solicitor-General, appearing for Karnataka, submitted that the impugned decision of the Govern-

ment (to withdraw the 'TADA' cases) was taken not to secure the release of a cine star (Mr. Rajkumar — kidnapped along with three others by Veerappan over a month ago) — but in the larger interest of the linguistic communities, harmony and tranquillity in the State. At this, the Bench said, "it is the State's responsibility to maintain law and order. Do not bring the judiciary or judicial process into it."

The Bench observed that "as the facts exist today, we will not give any relief" (on the question of release of the Veerappan associates), "as it amounts to compounding negligence upon negligence".

The Bench wondered whether it was open to the State Government to say if it could not withdraw cases involving a series of rare offences against certain accused, it might cause public unrest. The State should protect every citizen, the Bench added.

When the Bench observed that the affidavit (filed by the Karnataka Government in response to the SLP) was — "very coy and certain things are not said," the Solicitor-General requested the court that the State be permitted to file a better affidavit giving the reasons and background which prompted the Government to take the decision (to withdraw 'TADA' cases).

'Govt. sensitive to orders'

BANGALORE, SEPT. 2. The Karnataka Chief Minister, Mr. S.M. Krishna, has said the Government is sensitive to the Supreme Court's orders in the matter of the release of 51 ex-TADA detenus from the Mysore jail. He was reacting to the directions of the Court, which yesterday stayed indefinitely the release of the detenus following a petition filed by the father of Shakeel Ahmed, sub-inspector, who was shot dead by the forest brigand, Veerappan.

The Chief Minister said the orders of the court and the release of Mr. Rajkumar from captivity of the brigand were two different subjects. Irrespective of whatever happened on the kidnap front, it should be remembered that the rule of law prevailed in the country. The State Government could not keep away from the law of the land, he added.

Mr. Krishna pointed out that even the Attorney-General, Mr. Soli Sorabjee, had in his submission said the Karnataka Government had done a fine act of balancing the decision to ensure the release of the prisoners on bail. "He has succinctly placed the State's line of approach before the Supreme Court." On the Government's plea to the court that it had to take certain steps to prevent disturbances, Mr. Krishna said no Government would be complete if it could not anticipate things. Given the present situation, there was every possibility of law and order in the State facing a threat.

Krishna calls emergency Cabinet meeting

BANGALORE, SEPT. 3. The Karnataka Cabinet is holding an emergency meeting here on Monday morning to discuss the situation arising out of the Supreme Court order against the release of the associates of the forest brigand, Veerappan, detained under the Terrorist and Disruptive Activities (Prevention) Act.

The Chief Minister, Mr. S.M. Krishna, has also convened a meeting of the floor leaders of various political parties for tomorrow afternoon. The Cabinet, which generally meets on Thursdays, is meeting on Monday in view of the developments regarding the Rajkumar abduction crisis

The only ray of hope for the Government on the legal front now is to move the Chief Justice of India for an early hearing of the special leave petition filed by Mr. Abdul Karim, a retired police officer of Mysore, against the release of the TADA detenus. Mr. Karim's son, sub-inspector Shakeel Ahmed, was killed by Veerappan's gang in 1992.

The three-judge Supreme Court Bench, which continued the interim order of August 29 against the release of the detenus, has said that it was open to the State (Karnataka) to move the court with regard to the release (other than withdrawal of prosecution) of the women detenus.

Opposition flak

Meanwhile, the attitude of the Opposition parties is hardening. The Leader of the Opposition in the Assembly, Mr. Jagadish Shettar, has criticised the Government over the stand it took before the

Supreme Court in justification of the release of the detenus, namely the law and order problem in the State.

Though the Cabinet has remained united on the issue, some of the Congress(I) leaders are known to be sore with the way the crisis is being handled. One of them, the former Chief Minister, Mr. S. Bangarappa, MP, is said to have been pleading from the very beginning of the abduction for granting pardon to Veerappan in return for the release of Mr. Raj-

kumar and three others. Mr. Bangarappa is a close relative of Mr. Rajkumar.

PTI reports:

The high-powered committee, constituted by the Government to manage the Rajkumar hostage crisis, met here this evening and took stock of the situation. The meeting, chaired by the Chief Minister, was attended among others by the Home Minister. Mr. Mallikarjun Kharge, and the Director-General of Police, Mr. C. Dinakar.

The DGP today neither confirmed nor denied reports that he had advised the Government against dropping charges against suspected associates of Veerappan. "I don't want to comment on it," he said on reports that he had written a letter to Home Secretary, Mr. M.B. Prakash, expressing opposition in this regard. Mr. Dinakar reportedly conveyed that his conscience does not allow him to be party to the dropping of charges against the suspected associates of Veerappan.

We are with you: Sonia

The members felt that it was all the more necessary that the Chief Minister should have a free hand to deal with the problem; moreover, the Chief Minister should know that he had the full backing of the party's central leadership.

Mr. Azad's mission was to tell the Chief Minister that he had the full confidence of the Working Committee. The message was reinforced this morning when senior party member, Mr. Pranab Mukherjee, is reported to have telephonically spoken to Mr. Krishna; the bottomline being "we are with you". Other members have also spoken to the Chief Minister, offering him the benefit of their long ministerial experience at the Centre.

The informal session of the CWC was attended, among others, by Mr. Mukherjee, Dr. Manmohan Singh, Mr. R.K. Dhawan, Mr. Madhavrao Scindia, Mr. Oscar Fernandes and Ms. Ambika Soni. Except Mr. Dhawan, who thought Mr. Krishna had not proved equal to the Veerappan-induced crisis, most members were supportive of the Chief Minister and were appreciative of the difficult choices before him.

The "vote of confidence" by the CWC for the Chief Minister becomes important given that in the post-kidnapping days there has been virtually no communication between Mr. Krishna and the Ms. Sonia Gandhi. And, in the Congress (I) way of doing things, this absence of communication was being seized upon by the Chief Minister's detractors to start a whispering campaign.

VEERAPPAN ISSUE: KARNATAKA GIVEN 10 DAYS TIME

Complete pleadings before pressing for early hearing: S.C.

NEW DELHI, SEPT. 4. The Supreme Court today directed Karnataka and the parties concerned to complete their pleadings and file additional documents, if any, in connection with the Veerappan associates' release case within 10

A Bench also gave liberty to the parties to request the court for an early hearing after 10 days.

The Bench, comprising the Chief Justice, Dr. Justice A. S. Anand, Mr. Justice Santhosh N. Hegde and Mr. Justice K. G. Ba-

lakrishnan, made this order after Mr. Harish N. Salve, Solicitor-General requested an early hearing (of appeal and related writ petition) in view of the urgency of the matter (in the context of the safe release of the cine star, Mr. Rajkumar, and three others from the captivity of the forest brigand).

A three-member Bench on September 1, directed that its August 29 interim order — that none of the respondents-accused (Veerappan associates) be released on bail or otherwise pending further orders - operate pending the disposal of the appeal from Mr. Abdul Karim, a retired police offi-

The Bench also allowed Mr. Karim, father of sub-inspector Shakeel Ahmad, who along with Superintendent of Police Harikrishna, was killed allegedly by Veerappan in 1992, to appeal against an August 19 order of the designated court, Mysore, according "consent" to the special public prosecutor to withdraw charges for offences punishable under Sections 3, 4 and 5 of the Terrorist and Disruptive Activities (Prevention) Act - TADA

against Veerappan's associates. In all, 115 accused (including Veerappan) were cited as respondents in Mr. Abdul Karim's special leave petition.

It is learnt that the 51 accused, who were ordered released on "bail" by the Sessions Judge, Mysore, on August 28 are among the 115 accused. His August 28 order is also under challenge in a related petition.

In its oral observations on September 1, the apex court expressed concern at the inability of the Karnataka Government to apprehend Veerappan for the past 8

"What have you (State Government) done for the past 8 years to apprehend the forest brigand? We make it clear it is the responsibility of the State to maintain law and order. If you cannot do it, then quit and make way for some-body else who can," it said.

The Bench also issued notices to the Union of India, Karnataka and Tamil Nadu on two connected writ petitions filed by Mr. B. L. Wadhera, an advocate and another person. These were directed to be tagged on to the main appeals (from Mr. Karim).

Appearing for the Karnataka Government on September 1, Mr. Salve submitted that the impugned decision of the State Government (to withdraw 'TADA' cases against Veerappan's associates) was taken not to secure the release of a popular cine star (Mr. Rajkumar — who was kidnapped along with three others by rappan over a month ago) — but in the larger interest of the linguistic communities, harmony, peace and tranquility in the State.

At this, the Bench said, "it is the State's responsibility to maintain law and order. Do not bring the judiciary or the judicial process

Karnataka to persist with talks

BANGALORE, SEPT. 4. The Karnataka Government today decided to persist with the strategy of securing the release of the film star, Mr. Rajkumar, and three others through negotiations with the forest brigand Veerappan, and said the hostages' release was a matter of time. As the crisis entered the 35th day, the Cabinet, putting up a brave face, decided to give another chance to the strategy of conciliatory moves followed so far. At the same time, the Cabinet after an emergency meeting here decided to petition the Supreme Court (the Chief Justice of India) for the early disposal of the special leave petition filed by the retired police officer, Mr. Abdul Karim, praying against the release of the associates of Veerappan held under the Terrorist and Disruptive Activities (Prevention) Act.

After the meeting, the Minister for Information and Publicity, Prof. B. K. Chandrashekar, told reporters that the Centre was in full agreement with the strategy being followed by Tamil Nadu and Karnataka. The Prime Minister, Mr. A. B. Vajpayee, and the Union Home Minister, Mr. L. K. Advani, were being informed regularly about the moves. being informed regularly about the moves being made by the State from the very first or second day of the abduction. The Minister said

he Cabinet was informed that the strategy negotiations was adopted after consulting the senior officials. It was perhaps to correct the impression that decisions were being taken by a few without consulting the police top brass or other officials concerned.

The Cabinet did not go into the Supreme Court's order continuing the stay against the release of the detenus or the critical observations made by the apex court against the State Government. "It was felt that it was not necessary to go into it." Prof. Chandrashekar reiterated that the negotiations with Veerappan through the emissary-journalist, Mr. R. R. Gopal, had reached a crucial stage and that the Government expected news from Mr. Gopal in the next three or four days. "This time Mr. Gopal has said he would bring Mr. Rajkumar and the others with him. And there are indications to

Moreover, Veerappan had not made any fresh demands. He had only sought certain clarifications. Veerappan had been informed about the views of the Government and the turn of events. The Cabinet felt that there wa no need to change the strategy at this crucial hour. To a question the minister said "there is no feeling of helplessness or hopelessness in the Cabinet" about the crisis.

Karnataka HC blocks another Veerappan demand

BANGALORE, Sept. 5. — The Rajkumar hostage crisis deepened today, with Karnataka High Court staying the proceedings of the Sadhashiv Committee, constituted by the National Human Rights Commission to inquire into the atrocities allegedly committed by the special task force during operations to nab Veerappan.

Acting Chief Justice Mr Ashok Bhan and Mr Justice R Gururajan, directing issuance of notices to the state government and other respondents on a writ appeal by a senior police officer, passed an interim stay on further proceedings.

Meanwhile, Karnataka today said press reports suggesting that the Supreme Court had rejected the state government's plea for expeditious hearing of a petition challenging the release of Veerappan's 30 associates "do not represent the correct position and gives a wrong impression"

"The order does not state that the plea of the state government was declined. On the contrary, taking into account the urgency of the matter, a short period (10 days) was given for the parties to complete the pleadings," said state Advocate General Mr AN Jayaram. The plea for two weeks for the purpose, pleaded by the

petitioners' counsel, was declined, he said.

Ordinarily, when leave is granted by Supreme Court, the hearing is based on the position in the list of pending cases and such a hearing was bound to take a few months or even one or two years, he said. "In these circumstances, the impression given that Karnataka's plea for an early hearing was rejected is not a correct

understanding of the Supreme Court order.

We cannot change course now: Krishna

The Karnataka Government has decided that there will be no change in its strategy to obtain the release of the veteran Kannada film actor, Mr. Rajkumar, who has spent 36 days in the captivity of the forest brigand, Veerappan, in the forests of Sathyamangalam.

The Government's crisis management team, headed by the Chief Minister, Mr. S.M. Krishna, discussed for over three hours the pros and cons of its strategy and decided that the present line of action was the best under the circumstances, and that it was imperative for the Government to patiently wait rather than resort to a hasty decision. The belief was that the strategy endorsed by the Karnataka and the Tamil Nadu Governments had worked, in the sense that negotiations were in progress and it was only a matter of time before the hostages were set free.

The two Governments were awaiting word from the joint emissary, Mr. R.R. Gopal, Nakkeeran Editor, who has been negotiating with Veerappan for the fifth day in the forests.

fifth day in the forests.

Mr. Krishna said there was no significant development during the day, and the Tamil Nadu Government had also not received any information from the emissary. "We are continuously in touch. We are also in constant touch with the Union Government right from day one of the kidnap. The services of other agencies would be utilised as and when the need arose. Right now, we have fully backed Mr. Gopal and will wait for him. We are awaiting a positive reply. We cannot change course midway."

He said the Government had taken a serious note of the suggestions offered by leaders of Opposition parties with whom the Government held a meeting on Monday. "The Government is open to suggestions and we welcome them."

T.N. plea today

CHENNAI, SEPT. 5. Hoping for a quick end to the hostage crisis, the Tamil Nadu Government is set to file its counter-petition in the Supreme Court tomorrow, to the public interest litigation (PIL) preferred by two New Delhibased lawyers opposing the release of five Tamil militants jailed in the State.

The release of the ultras is one of the demands made by the forest brigand Veerappan.

A high-level meeting, chaired by the Chief Minister, Mr. M. Karunanidhi, at the Secretariat here today, discussed the Government's "draft response" to the PIL, taking all aspects of the 38day-old kidnap crisis into view.

Later, official sources said the counter-petition "will most prob-

ably be filed tomorrow". Indications are that the decision to withdraw the cases against the ultras was within the ambit of Section 321 of the Criminal

Procedure Code. Claiming that the Government was empowered to withdraw cases, subject to the satisfaction of the public prosecutor and the court concerned, the sources said Tamil Nadu "can adequately meet the points raised in the PIL". There were innumerable case laws in the past, attesting to the Governments' power of withdrawal of cases under this provision and some of which even pertained to former Central Ministers. While the legal process would take its own time adding to the uncertainty over the release of the Kannada actor, Mr. Raikumar, and three others, the Government is banking on a "positive word" from the journalist-emissary, Mr. R. R. Gopal, by tonight.
