## PWG setting up new HD-1

HYDERABAD, OCT. 23. The CPI(ML) People's War Group (PWG) has redefined its priorities and set in motion plans to form base areas in Dandakaranya and in the newly-formed Andhra Orissa Border Special Zone, comprising five districts of Orissa and the adjoining four North Coastal districts of Andhra Pradesh.

This paradigm shift could only mean that the PWG plans to establish its own form of governance and not allow any elected government to function.

A special PWG congress attended by the all-powerful central committee and secretaries of different states in March, is said to have given its stamp of approval for strategy changes are bound to cause concern to the Orissa and Andhra Pradesh Governments.

The existence of large and nearly impenetrable

tracts of the forest areas in East Godavari, Visakhapatnam, Vizianagaram, Srikakulam (in Andhra Pradesh), Malkangiri, Koraput, Ganjam, Gajapathi and Raigarh (in Orissa) is believed to have prompted the decision to form base areas in these districts.

Each base area, the PWG feels, should be around 400 sq.km. Similarly, base areas are to be formed in the Dandakaranya region consisting of Gadchiroli (Maharashtra), south Bastar and north Bastar (Madhya Pradesh), and Abuz Mad (in Chattisgarh).

This concept arose out of the PWG's decision to work with a 'liberated zone perspective'. Theoretically, a liberated zone is an advanced stage of revolution which comes after successful completion of the guerilla zone stage. The PWG had categorised its

movement in north and south Telangana districts as that of guerilla Zone stage.

In simple terms, it means that the PWG and the State are on an equal footing fighting for area domination in a guerilla zone phase; in the liberated zone phase, the PWG cadre would be on an all-out offensive while the State goes on the defensive. From this, it is clear the PWG leadership believes that the situation in the nine border districts and in Dandakaranya is conducive to launch the struggle with the liberated zone perspective.

Elsewhere in the five districts of north Telanagana (Adilabad, Nizamabad, Karimnagar, Warangal and Khammam) and south Telangana (Mahabubnagar, Medak, and Nalgonda), the activity continues to be in the guerrilla zone phase, the PWG leadership appears to believe.

The lack of preparedness of the Orissa police in face of the onslaught, and in that of the government in failing to understand the subtilities of revolutionary warfare has come in handy for the PWG. But the situation in the bordering Andhra Pradesh districts is different.

In Andhra Pradesh, the police is aware of the fallout of such drastic changes in PWG strategy, but the task of sensitising the ground level forces to the emerging situations is certainly a problem. However, police top brass assert that efforts are under way to tackle the problem. Senior police officers of the two States had met to discuss the situation, and the Centre had rushed two battallions of the central forces to Orissa to buttress the anti-extremist operations.

The People's War Group gave another turn to the controversy, saying those killed on 4 January were its activists. The PWG says eight of their activists were killed and five still missing. This gives rise to three questions: Which party did the 'victims' belong to?; if those "killed" were identifiable Trinamul members why

yes are on Midnapore should the PWC claim them to now, especially after be its activists; and what a Trinamul's Rajani Dolui Maoist outfit like the PWG has got to do with Trinamul, which it considers to be a rightist reactionary party. That there was a PWG-Trinamul tie-up was evident from the name of one of the "victims", Bhoda Majhi, a resident of Manikbandh. in Goghat. For, Majhi has been a known PWG member.

But why did PWG tie up with Trinamul? To know that, we have to travel back in time. From the mid-70s Naxalites in Andhra began rebuilding their outfit. The first Telengana Regional Conference was held from 29 December 1976 to 1 January 1977 under the leadership of Kondapalli Seetharamaiah that's when the Andhra Pradesh State Committee CPI-ML (People's War) was formed. The top secret document came to be known as the "Nagpur Report". The PWG programme was: "Let us lay the foundations to extend into the forests by sending one or two squads into the foresti and organising the tribals.

That's how and when PWG activists entered the forests and villages of Midnapore-Bankura. The PWG believed in the Charu Mazumdar doctrine of keeping the party underground and forming revolutionary frontal units. The Nagpur Report had

armed struggle relying on mass line, mass organisation." That gave rise to Jana Natya Mandali, Rayat Kuli Sangham, and Radical Students' Union. The RSA and PWG's Biplabi Krishak Samiti have been active in West Bengal since the Nineties, the decade when the PWG underwent à radical change.

The PWG was helped by many Naxalites from different factions, who wanted the "people to know the difference between a real Communist party and the CPI-M". PWG's West Bengal unit was formed in early 1995 and it began "work" in Midnapore, Bankura and Hooghly. But before PWG, another Naxalite outfit, Central Organising Bureau of CPI-ML had been active in the Midnapore-Bankura-Hooghly border areas since the mid-80s. It had made the forests its "strategic zone' and a Calcutta vouth was its leader.

Since people in the Midnapore-Bankura-Hooghly border areas, the adjoining forest belt and the bordering areas of other states are generally poor, the Naxalites got their support to build their organisation. The first direct confrontation with the CPI-M took place on 26 June 1989. The Naxalites had called a meeting against CPI-M atrocities at Masinapur village near the Bankura-Hooghly border. A group of 30 youths and students and farm labourers, after organising a procession at Masinapur, was going towards Jairambati bus (route 21) stand. Suddenly, some CPI-M cadres attacked the BKS procession. About 60 BKS activists were held hostage by CPI-M cadres in a local school and beaten up mercilessly. Some of the BKS activists' limbs were broken. About 53 of them were locked up in Bishnupur jail on what the Naxalites alleged were trumped up charges.

The next clash took place in the Nalpa-Kashtaguda, in that CPI-M cadres had murdered one of their comrades, Tapan Chakraborty. Till 1995, some students and youths were they all joined it.

He accused the Trinamool of tying up with "divisive forces" such as the KPP and JMM. On Mamata, he said: "Anarchy is all she wants. For this, she shook hands with Gandhiji's assassins and is now aligning with forces that are out to divide Bengal."
