One party rule Forward Bloc's charge against the Marxists

Since the last Assembly elections in May when the CPI-M lost its absolute majority it has had to watch while coalition partners raise the decibel levels against "its big brotherly attitude." But what Ashok Ghosh, a veteran Forward Bloc leader who is also the secretary of the West Bengal unit of the party and one of the founders of the Left Front, said at an open rally at Sahid Minar on Thursday is unprecedented by any standards. Not only did he defy the Left Front whip that no Front partner should criticise another publicly, he went a step further and threatened to pull his party out from the 25-year-old coalition if the CPI-M did not mend its ways of "reducing the Left Front to one-party rule". That is more than what he or any other Front partner has said in the recent past, which should be quite disturbing.

Whether the threat is carried out is immaterial; the tenor of his utterances at the party's state conference has shocked Alimuddin Street. So also that of Kamal Guha, the Forward Bloc's minister of agriculture, who in recent speeches has virtually declared a jihad against the CPI-M. What is more is that the Forward Bloc, at its state conference, has drawn up a litany of charges against the Marxists in a political document which again is unprecedented. Surprisingly the Marxists, unlike in the past, have chosen not to hit back and have sought to play down "these differences among Front constituents as nothing

unusual"

They know any riposte will snowball into a major controversy and undermine the stability of the Left Front Government. That the approaching panchayat poll, which may take place some time in 2002, had something to do with the Forward Bloc's outbursts can be assumed. Being the second biggest Front constituent with 25 seats in the state assembly, the Forward Bloc recently sought the revival of the deputy chief minister's post and also claimed it. It wants to be treated with respect commensurate with its numerical strength. Already it is locked in an intense power struggle with the Marxists in some districts of north Bengal where both the parties have indulged in violence resulting in police firing and even bandhs. Expanding their areas of influence, even at the expense of Left Front partners, is what both are after.

This is at the root of the Left Front's problem which has led to clashes between the Marxists and the RSP as well. Being much bigger organisationally with better resources, including control of the police, the Marxists have sought to dominate the smaller partners by force when necessary. Their policy of dominating the grassroots has subverted attempts to form Left Front committees at the district level. The domineering attitude has ensured that the party runs panchayats and Zilla Parishads

unilaterally.

Even at the state level crucial decisions are imposed on partners without discussion at Left Front meetings. The Marxists derive much of their strength from 32 government departments that they control many of which, including some key ones, have been taken away from smaller partners. The FB keeps venting its anger and frustration but it lacks the courage to do anything drastic because of the spoils of office. No wonder Marxists take the FB for granted.

Scheduled business bypassed in House

KOLKATA, Dec. 13. — The chief minister today set the stage for the introduction of a Bill on organised crime, sometime next year, by stating that tough administrative action is necessary to prevent ISI-backed hijacking and kidnapping in the state.

CPM sights plot within

Calcutta, Dec. 22: The CPM has smelt "a conspiracy to discredit the sixth Left Front government" headed by Buddhadeb Bhattacharjee behind the public criticism of the state administration by the Forward Bloc and the RSP, its partners in power.

The CPM, which recently issued a whip to all Front partners not to publicly air grievances against their government, however, has decided not to confront the parties but initiate bilateral discussions to sort out the differences. Talks between the RSP and the CPM will be held on January 2 and a similar discussion between the Marxists and the Forward Bloc will take place later.

Both the RSP and the Forward Bloc have accused the CPM of ignoring their views while framing government policies and of taking "unilateral decisions". While Left Front chair-

man and politburo member Biman Bose has refused to comment on the contentions, state CPM secretary Anil Biswas told party workers at Krishnagar that forces opposed to the Front were trying "to hatch a conspiracy to discredit us".

The Trinamul Congress has been quick to capitalise on the Front partners' differences. Pankaj Banerjee, leader of the Opposition in the Assembly, said the spate of criticism against the CPM "has only vindicated our charge that the party does not believe in democratic norms".

A day after the Forward Bloc blasted "big brother CPM" at a city rally for taking "unilateral decisions" to run the government, the RSP's Burdwan district committee severely criticised the state administration for a "lack of work culture" at a two-day conference yesterday.

"Despite the fifth Left Front government's do-it-now slogan.

there has been a growing tendency among state government employees to neglect work," a political-organisational report of the district RSP observed.

The RSP also felt that "there has been considerable erosion in the spheres of healthcare, power and education. The scope of self-employment has declined and there has not been expected decentralisation of power through panchayat and civic bodies".

The party almost echoed the Forward Bloc's demand for a core committee by asking for a Front committee to ensure better coordination between ministers and the Front leadership. The RSP report sought "greater control over the ministers".

Party state secretary Debabrata Bandopadhyay today said the Front has ceased to be "a weapon of people's struggle". "Left Front unity cannot be sustained if it does not percolate to the grassroots," he observed.

Bloc turns gun on rural rule

Calcutta, Dec. 22: The Forward Bloc tirade against the Left Front government continued today with party leaders targeting the CPM-controlled panchayat and land reforms departments during its 14th state conference here.

Jayanta Roy, MP of the second-largest party within the Front, said the government had distributed 13 lakh acres to landless agricultural labourers over the past 20 years. But many of them had failed to cultivate the land and handed over the plots to richer people. "About 18 lakh families in rural Bengal were supposed to have benefited from the government's decision to distribute land. Unfortunately, poverty has compelled many of these families to hand over the plots to other persons whose financial position is sound," Roy complained.

He admitted that the government, which 'had initiated major land reforms, failed to foresee the problem while distributing the plots. "Most of these poor people don't have the financial support to cultivate the lands and they have transferred those to others in the face of extreme poverty. It is true that we, the government and the Front itself, had failed to foresee the problems of these poor labourers when we decided to give them land under the panchayat system."

Almost all the 41 delegates who participated in the day's proceedings felt that the sole intention of helping the landless labourers through the panchayat system had been frustrated as most of them had handed over the distributed land.

Interestingly, CPM rebel Saifuddin Chowdhury had criticised the party on the same issue before leaving it to form the Party for Democratic Socialism. Asked whether his party supported Chowdhury on this account, Roy said: "We are not concerned about what Chowdhury had said about the panchayat system in the state. What I am telling you is the observation of my party on the panchayat system".

The Forward Bloc urged the land reforms and panchayat departments to take legal steps against those who had handed over the plots. Under panchayati raj, a landless labourer cannot hand over land given to him.

The CPM leadership refused to attach any importance to the criticism. One leader said: "They (the Forward Bloc) are making all these comments to keep their party supporters in rural belts active before the ensuing panchayat polls." Panchayat polls, due in 2003, is likely to be held next year.

The Forward Bloc had fared poorly in the last panchayat elections and the party leadership admitted it in the conference.

he politburo of the Communist Party of India (Marxist) is the enemy of promise in West Bengal. It has gone out of its way to hinder one crucial plan the chief minister of the state, Mr Buddhadeb Bhattacharjee, had for giving a new image to the state. The politburo has scuttled Mr Bhattacharjee's plans to introduce a new law, the prevention of organized crime ordinance. Such a law would give a tremendous boost to the flagging morale of the state's police force and transform the state's record on law and order. Mr Bhattacharjee was convinced about the need for such a stringent law after a series of crimes ranging from kidnapping to rob-

bery which provided clues that organized criminal gangs were trying to gain access into West Bengal. Pushed out of Maharashtra because of the existence of a separate law against organized crime there, the criminal gangs were looking at West Bengal as a possible soft target. Since then, the threat

of terrorism and the resurgence of Maoist violence in Midnapur have given to POCO a new and immediate urgency. Between Mr Bhattacharjee's recognition of the need for POCO and the passing of the ordinance has fallen the shadow of the politburo and its putative national agenda.

The leadership of the CPI(M) decided in its wisdom to oppose the prevention of terrorism ordinance which the Central government has put on the anvil. Suspicious of the motives of the Bharatiya Janata Party and of the misuse of POTO by the BJP against the minorities, the CPI(M) has set itself up to oppose POTO at the national level. Mr Bhattacharjee is not an unqualified supporter of POTO: his position is a little more nuanced. Mr

Bhattacharjee does not deny the need for special laws to combat organized crime and terrorism. But he argues that the enactment of such laws should be left to the state governments. A Central legislation will only work against the federal structure of the Indian Constitution. There is an obvious difference between the position taken by the politburo of the $\mbox{CPI}(\mbox{M})$ and the argument advanced by the chief minister of West Bengal. His argument, however, has been set aside by the decision of the politburo. The latter believes that the enactment of POCO in West Bengal/while the party opposes POTO nationally will only create confusion about the intentions of the party. It has thus

prevailed upon Mr Bhattacharjee to delay the presentation of POCO to the state assembly. Mr Bhattacharjee, ever the loyal party man, has consented to do just that.

The episode is imbued with a wider significance. It suggests that Mr Bhattacharjee's efforts to separate the functioning of his

government from the direct influence of the party are not making very much headway. The process of reform and rejuvenation that Mr Bhattacharjee is so keen to initiate and implement hinges on the degree of autonomy he enjoys from the backroom boys of his party. The CPI(M) is a centralized party with a long history of interference in the affairs of successive Left Front governments. The CPI(M) refuses to acknowledge that a government has a commitment to the people who elected it, whereas the apparatchiki have no such commitment since they are not elected representatives of the people. Mr Bhattacharjee had promised a government of the future. His setback on POCO marks a retreat to the past.



"While Poto can be used against lawful agitations, strikes and public gatherings, Poca would deal with specified crimes. These include kidnap ping for ransom, hijacking and armed insurgency," he said. Poto empowers a DSP to take action, but under Poca, no officer below D-G can start proceedings against an accused. An accused cannot be charge-sheeted without the Home Department's approval."

However, agreeing that these safeguards might not be enough to set all doubts at rest, the Chief Minister said there is still scope

KOLKATA, Dec. 6. - Mr Buddhadev Bhattacharya today finally yielded ground. He decided against moving the Prevention of Organ-ised Crime Bill during the winter session of the

Assembly, commencing tomorrow.

Pushed to the wall over Poca by his party and Left Front constituents, the chief minister sought to perform a face-saving act after an emergency Cabinet meeting discussed the Bill this morning for the second time in two weeks.

"The Bill was cleared again by the Cabinet. But we are not moving it during this short session of the House," he said.

The Cabinet, incidentally, diluted several

provisions of the draft it had cleared on 22 November. But Mr Bhattacharya took the plea that the delay was ostensibly due to his government's intention to avoid confusion in people's minds over the difference between the Centre's proposed law and the state's proposed legislation to combat terror.

Reiterating that the

Reiterating that the two laws were different, the chief minister said the state would prefer to wait till Parliament debates the Centre's anti-terror Bill. He said: "That's a black law. It's draconian and Left parties will oppose it."

In a further attempt to display firmness, Mr Bhattacharya said the state would go ahead and table the Bill later "whether or not Parliament passes Poto". In such an eventuality, any action against terrorists and organised criminals in the state would be taken under Poca and not Poto, he added.

Outlining the watered down provisions of the draft Bill cleared by the Cabinet today, he said the crimes specified were kidnapping for ransom, hijacking and armed insurgency affecting the country's security and integrity.

The amended draft specifies that one could be booked under the law if one has been chargesheeted for such crimes at least twice in the past. Also, for a criminal to be booked under it, clearance must be sought from the state's director-general of police or the city police com-missioner either before or soon after his arrest.

The bail provisions had also been diluted. The amended draft removes the provision for detention without bail for 180 days. An accused can obtain bail earlier but the public prosecutor must appear during the hearing in court. Also, an accused must be chargesheeted within 180 days of arrest. But the state government's clearance must be sought by the police before a chargesheet is filed.

Shelving of Poca is being seen as a setback for the chief minister, who had maintained a brave face when his predecessor snubbed him over the Bill. Mr Jyoti Basu had said in New Delhi last week that the state Assembly would not pass the Bill though the Cabinet had cleared it. Mr Bhattacharya had seemed firm about moving the Bill then and said he would make a statement in the Assembly.

Haldia offer to Purnendu

Calcutta, Nov. 26: The Bengal government has offered Purnendu Chatterjee, its partner in Haldia Petrochemicals, majority stake and management control.

Both sides now hold 43 per cent each with the balance resting with the Tatas.

Nirypam Sen, the commerce and industry minister, said: "If Purnendu Chatterjee brings in the money required for the survival of HPL, the government will gladly hand over majority control to him."

Sen revealed that Chatterjee was told of the government's decision at the last promoters' meeting in Delhi. "Purnendu has already been reminded about the matter."

Chatterjee group officials refused comment, but said he had sounded optimistic after the Delhi talks. Sources said Chatterjee has been set a deadline of December 31 to make up his mind on bringing in additional funds.

Sen confirmed this when he said: "Hopefully, things will be sorted out by December-end."

The development follows the logiam in negotiations with Indian Oil, which was proposed to be brought in as the fourth promoter. But Indian Oil insisting on management control with a shareholding of 26 per cent, which is not acceptable to the other partners.

Under the original agreement among the partners, if the Bengal

government or the Tatas sell their stake, in part or whole, it has to be offered to the other partner first. "If he (Chatterjee) refuses that offer, we will have to bring in some other party who is keen to run the company. We will abide by the joint venture agreement," Sen said.

Ratan Tata has expressed his wish to sell out of HPL. The Bengal government also does not feel it should be engaged in running a business. "One thing is clear — the state government will not be in the business of running HPL," Sen said.

He said it had yet to be decided at what price shares would be offered to Chatterjee. "We will appoint a consultant for valuation of HPL's shares. All these are part of the financial restructuring package which is being worked out."

Terrorism a weapon of those 'against us': Chomsky

MOLKATA, NOV. 20. Prof. Noam Chomsky, social theorist and political analyst, says that it is a very serious analytic error to say terrorism is the weapon of the weak. Like other means of violence, it is primarily a weapon of the strong — overwhelmingly, in fact.

Addressing a gathering in Kolkata, Prof. Chomsky said that terrorism was not the weapon of the weak. "It is the weapon of those who are against 'us', whoever 'us' happens to be."

Speaking on "Sept. 11 and its aftermath: Where is the world heading?", Prof. Chomsky said that the new millennium had given the world two things: terrorist attack and the reaction to it. "The reaction to the attack told us in which direction the world is heading to."

Today's lecture was organised by the West Bengal Government at the Science City auditorium. The Chief Minister, Mr. Buddhadeb Bhattacharjee, presided over the lecture.

CHIEF MINISTER Buddhadeb Bhattacharjee admitted at a Left Front meeting today that he had moved hastily on Poco and that he should have taken the coalition into confidence before placing the proposed legislation before the Cabinet.

He insisted, however, that the legislation he had in mind was quite different from the Centre's Prevention of Terrorism Ordinance (POTO).

Bhattacharjee's move has a parallel only in the way his predecessor Jyoti Basu pushed through the State's New Industrial Outlook in the Assembly without even consulting the CPI(M) state committee. The Left Front made it clear today that it wouldn't give Bhattacharjee the long rope that Basu enjoyed.

Earlier, the CPI(M) politburo had also cautioned the Chief Minister against the haste he showed. Other Front partners were not willing to back the legislation and urged Bhattacharjee to make a comparative study of

the POTO, the TADA, the Maharashtra law against organised crime and POCO. They wanted a discussion among Front partners before the Bill was tabled.

After today's meeting, Left Front chairman Biman Bose tried to dispel any impression that the party politburo had restrained the Chief Minister.

"The Chief Minister was keen to have the ordinance in place before the accused in the Khadim abduction case got bail," Bose said. But he did not deny that such "policy matters" should have come to the Left Front first for a discussion.

The Left Front chairman was, however, convinced that the Chief Minister wasn't going the Advani way. "The proposed POCO has nothing to do with the POTO. The Central ordinance is ranged against journalists and lawyers while there is no such provision in the POCO." But Bose would not comment on the Poca provisions. All he would say was: "The Chief Minister will place his argument in detail while laying the Bill in the Assembly."

Bhattacharjee today informed the Left Front of administrative arrangements for the bifurcation of Midnapore into two districts, East and West. "He has also held an all-party meeting on this issue at Midnapore," the Left Front chairman said.

He also promised Front partners to tackle the problem of Bangladeshis seeking shelter in the border district with Home Minister LK Advani. The Chief Minister is scheduled to go to Delhi on November 17.



The district administration is hesitant to take any legal action for the deportation of these families for humanitarian reasons. They have not yet received instructions from the state government on what should be done with them.

Some families in this district town have already told district officials that they would never return to Bangladesh. They said: "We are not in a position to live there fighting the fundamentalists backed by the BNP". They have decided to seek permission of the panchayat to live here.

A Ajimpur resident said: We supported the Awami League but could not cast our vote during the elections. Fundamentalists came to our house and forcibly put voting ink on our fingers so that we could not cast our votes according to our choice". "We have left three bighas of land, our homes, and our cattle. Our

Driven by fear and despair

PETRAPOLE (North 24-Parganas), Nov. 8.— They looked as if they were caught in a trap — the mother and her three children. The mother shuddered at the thought of returning home and the children, without food for about 10 hours, cast flitting glances at the mother seeking a sense of security, but in vain.

Nirmala Das and her children were among the 13 Bangladeshi nationals detained today at the BSF outpost here. They fled their home in Barisal last night in search of safe passage across the border, fearing torture and persecution by "fanatics".

They were intercepted by BSF personnel when they tried to cross the border.

Nirmala was in tears pleading to be allowed to stay on at least till "things settle down" in her country. Her belongings, wrapped in soiled bed sheets, lay stacked near the steps of the outpost, while her children clutched at her sari. Nirmala hasn't been a witness to any torture, but she has heard tales of persecution, arson and molestation and she decided to flee.

Nirode Das from Aralia village of Bhola district said he fled his home as he was unable to "pay any more fine" to his tormentors. "It started since the election verdict was known and the BNP and its allies captured power. They came in droves and threatened us with dire consequences if we didn't pay up. The amount of fines kept mounting and we were forced to cough up money too frequently. The last time I paid

them Taka 700 and then realised I can't appease their lust for money," he said.

The police and the district administration denied there was any large-scale exodus from Bangladesh.

"During the last month 80 to 82 Bangladeshis were detained and pushed back along this border region and the number, compared to any other month is not unusually high," Mr Milan Pramanik, SDO, said.

But scores of people are daily coming from across the border without the knewledge of the district administration and the BSF, said Mr Biswanath Roy Choudhury, vice president, Bongaen Panchayai Samiti.

The SDO did not contest Mr Choudhury's claim and said such an exodus is "a distinct possibility".

MAMATA BANERJEE has no good word for her arch-rival Buddhadeb Bhattacharjee on his first anniversary as Chief Minister and gives him 0 out of 100 for his "appaing performance" on all fronts. Mamata, in fact, has come to believe that things were better when Jyoti Basu was the Chief Minister.

Former State Congress preeldent Somen Mitra, however, won't go that far. "It's too early to make a comparison with the Basu regime." Asked what he got out of his discussion with the Chief Minister on law and order today, Mitra said: "Only a cup of coffee."

But the Trinamool chief is unsparing on the Chief Minister. "He can't react to a problem in time as is evident from his apathy towards the refugees from Bangladesh. He is a total failure," thunders Mamata. "Why waste time in rating a person full of promises and no work at all? He has no idea of the grassroots as he has never worked among them."

Looking back on the Basu regime, she said: "Basu had a stature. The administration during his tenure was responsive to the Opposition though I was beaten up in front of his chamber. At least, the Home Department used to take our telephone calls then."

According to her, the current Chief Minister is bent on margin-

alising the downtrodden and stifling voice of dissent. "He doesn't bother to consult the Opposition. He doesn't take cognisance of the letters Opposition MLAs send him. The Basu Government was n't like this. Bhattacharjee just goes by his whims."

Mamata then cited a series of Government orders ranging from the "steep fee hike in colleges and universities" to "the eviction drive along the Tolly's Nullah without the least improvement of the nullah." She also accused the Chief Minister of bias. "CPI(M) cadres can of bias. "CPI(M) cadres can escape the arms of the law even if they beat up a hospital superintendent at his chamber while the police round up innocents

CM warns separatists, watches infiltrators

Siliguri Nov. 4: Chief minister Buddhadeb Bhattacharjee today gave an ultimatum to Kamtapuri separatists while expressing grave concern over the recent influx of Bangladeshis.

Talking to reporters at the North Bengal University after kicking off its 40th anniversary celebrations, Bhattacharjee said Kamtapur Liberation Organisation activists should surrender or face the wrath of the state.

"The KLO has ignored the government's overtures to join the mainstream. It is our last message to them: either surrender before it's too late or face the music. The government is in no mood to compromise with extremists and those who perpetrate terror. It is time these misguided youths saw sense and gave up arms," the chief minister warned.

Dismissing the Kamtapur People's Party's charge of violating human rights, he said Kamtapuri activists languishing in jail would be released if found innocent.

The chief minister, who also inaugurated the Rabindra-Bhanu Mancha near here, voiced his government's anxiety over the steady flow of harassed Hindus from Bangladesh into the border districts. "We are certainly concerned about the recent infiltration. We are keeping a

close watch and taking appropriate steps to stem the influx."

Refusing to put a figure on the exodus, the chief minister said: "There has been infiltration in nine border districts, with the highest (concentration) being in South Dinajpur and Malda." He denied that refugee camps had been set up or that the authorities were providing food and shelter to the infiltrators.

"If the situation worsens, we will have to take up the matter with the Centre. The matter has to be sorted out between the Centre and the Bangladeshi authorities," he said.

Bhattacharjee added that his government had beefed up security in north Bengal, especially in the vulnerable Bengal-Assam-Bhutan corridor along Kumargramduar in Jalpaiguri. "We are now aware that the Bhutan-based Ulfa and Bodo extremists have been pushed out. These

extremists and their KLO comrades are trying to take shelter in Assam and Jalpaiguri and Darjeeling districts. Besides, some ISI-backed organisations and Nepal Maoists are very active in the region. We are keeping a close watch on them," he said.

"Police administration and intelligence are being strengthened and several police stations will be established. One will come up at Samuktala in Kumargramduar under Alipurduar sub-division I. The special Indo-Nepal border taskforce is awaiting the Centre's nod," the chief minister added.

KOLKATA, Nov. 1. — Mr Buddhadev Bhattacharya today formally yielded to demands within and outside the Left Front and put on hold the promulgation of the Ordinance on prevention of organised crime.

"It will not be wise to rush the Ordinance. But the law must be framed and a Bill on the lines of the Ordinance tabled soon," the chief minister said.

He ducked a question on whether he was under pressure from the CPI-M leadership, but insisted there were no differences in the party on the contents of the proposed law.

The issue was discussed by the CPI-M central committee earlier this week. Mr Bhattacharya said he had thought of promulgating the Ordinance under "special circumstances." The Cabinet had cleared the draft Ordinance last week.

But differences in the LF and with the Opposition prompted him to have a debate in the Assembly.

Mr Bhattacharya stuck to his guns on the need for the pro-

posed law, whether promulgated through an Ordinance or otherwise. Some misgivings on the proposed law have arisen because it has been misinterpreted, he said. It is being projected as if the law provides for detention without trial.

"The law is necessary because of incidents like the Partha Roy Burman case," he said.

Mr Bhattacharya wants public prosecutors to be given an opportunity to oppose bail in organised crime cases. But how could Chunnu Mia, one of the main accused in the Roy Burman kidnapping case, get bail? The chief minister said: "It is exactly why I want the law."

Chunnu was granted bail because he was not chargesheeted within 90 days of his arrest. The proposed law will give the prosecution 180 days to file a charge-sheet against an accused in an organised crime case.



Buddha to change terror Bill

NEW DELHI, Oct. 30. — The CPI-M central leadership has reportedly asked Mr Buddhadev Bhattacharya not to pass the proposed anti-terrorism Ordinance, but introduce a Bill that won't contain any "draconian measures".

This was announced today by Mr Harkishan Singh Surject and Mr Prakash Karat.

The Centre's Prevention of Terrorism Ordinance has been widely criticised, for it contains several "draconian elements".

The CPI-M, leading a protest against the Centre's Ordinance, found the criticisms politically inconvenient.

Mr Surjeet and Mr Karat, however, denied that the state government had any plans to issue such an Ordinance. "The chief minister has told us that the government is not planning to bring in any Ordinance. Instead, it would introduce a Bill in the next session of the Assembly that will take care of the requirements of West Bengal to deal with elements such as the Kamtapuri activists. The chief minister has told us that the Bill won't contain draconian measures like the Poto," Mr Karat said. Will the Bill be able to stop ISI

Will the Bill be able to stop ISI activities in the state? Mr Karat said: "ISI activities are all over the country... We haven't seen the details of the Bill. The state is working on it. But the chief minister has told us that the Bill will be effective to deal with extremists in the state."

Mr Surjeet said the Vajpayee government is wrong in thinking that it can get through with Poto. The CPI-M will defeat it in Parliament. "Poto will be a violation of democratic rights and misused against trade union activities and popular struggles."

A Left rally burdened with contradictions

If the Left Front needed an issue to bring all its constituents together on a single platform, it was provided by the American air strikes in Afghanistan. Alimuddin Street could not resist the opportunity to launch its own strikes against American and British imperialism, even if in the process it made nonsense of its own resolution less than a fortnight ago to protect the city from the scourge of rallies and readblocks. to protect the city from the scourge of rallies and roadblocks. It was not just that the mahamichchil, as it was called, threw the city out of gear, disrupted examinations and obstructed freedom of movement. More galling was the orchestrated revival of anti-imperialist rhetoric that had at one time resulted in the mad drive to dismantle statues of British leaders works of art fit for a prestigious museum. Where a political agenda must be adopted for the limited purpose of sustaining the morale of cadres, everything else becomes secondary. Even a normally sensible Buddhadev Bhattacharya must climb down from his position and share the platform with Jyoti Basu who grabs the slightest opportunity to emerge from retirement and speak at cross purposes with his successor. It will be a tragedy if Buddhadev is reduced to rolling back his honest efforts to undo the damage of the past and, worse, begin to speak in more than one voice. Disturbing signs were evident in the case of Laxmi De who led an assault on the superintendent of Calcutta Medical College and went scot-free after a clean chit from Buddhadev even before an inquiry could begin and which may be quietly buried. Now he maintains a deafening silence when Left Front chairman Biman Bose says that rallies and roadblocks are out because they are a curse for the common man but processions are a different matter especially when Marxists have a ready excuse to target an old enemy.

Marxists have learnt to distinguish ideological obligations from practical necessities — in other words, speak according to convenience, invite multinationals but damn imperialists on the slightest pretext, talk of improving urban living standards but clog the roads with slogan shouting cadres whose understanding of Marxist doctrine is minimal if it exists at all. If it looks like a pathetic attempt to sustain Left unity in the context of the disappearance of old values, the duplicity surprises no one in Bengal and the rest of India — who's listening in America and Britain anyway? There was no word of sympathy for the thousands of unsuspecting civilians of several nationalities killed in the 11 September assault, nor for the thousands who have lost their near and dear ones, many of whom are still in distress. The anti-American response falls within the political agenda of the few Marxists left in one corner of the world and an opportunity to expand a vote-bank that now doesn't extend beyond Bengal, Kerala and Tripura. As always they are working to a plan but with two difficulties: one, the agenda has room for politicised peace, not for the gamut of basic human values; and, two, it throws the grand design of a "new Left" out of the window. Buddhadev cannot be a very happy man.

CPM men beat up hospital super in MLA's presence

KOLKATA, Oct. 7. - The superintendent of Calcutta Medical College and Hospital and his son were today beaten up by CPI-M men in the presence of Mr Laxmi De, MLA and party chief whip.

Though gheraoing superintendents had been a regular affair till the health minister banned it last week, today's incident is unprecedented. It seems that the govern-ment's move to free health service from agitation had failed to impress Mr De.

Dr Sinha's family members have filed an FIR against Mr De and four others at the Bowbazar police station. On the basis of the complaint, police have started criminal cases against them for unlawful assemblage, assault of a government official on duty and causing injury to him.

Three of those who were named in the FIR were later arrested, said Mr Zulfikar Hasan, DC (central). But Mr De was not held. He met Mr Anil Biswas and denied the charges against him.

A police picket, in addition to the existing outpost inside the hospital premises, has been posted outside the superintendent's quarters.

On receiving the health department's instructions, the hospital authority had evicted about 60 families, illegally occurred. pying the service quarters of the Group C and D employees. Six unauthorised constructions within and outside the hospital premises, including a Citu-affiliated union office, were demolished.

Dr Sinha's wife, Mrs Soma Sinha said Mr De arrived in his VIP car around 11.50 a.m. and called her husband downstairs. He demanded an explanation from the superintendent as to why he had evicted people from 27 rooms. "He asked my

husband why he had conducted the eviction when he had told him not to do so," Mrs Sinha said.

She was at the balcony of her house when about 50 people, mostly outsiders, came out of nowhere. They dragged Dr Sinha to the ground and started beating him up. They kicked him on his chest and face. They also threw stones at him and abused him. Mr De watched it all from a safe distance and made no attempt to rescue Dr Sinha, she added.

Her son, Mr Rupam Sinha, medical student in Bangalore, ran down to save his father. He was also assaulted. He has a fracture in his right arm and injuries in his legs.

Mr De had quietly sneaked off by then, Mrs Sinha said.

The attack was led by Sambhu, Shankar, Rajendra and other CPI-M party members. who are known for flexing their muscles on hospital issues, said Mr Runan Sinha Washanas and Mr Runan Sinha Washanas Rajendra Runan Sinha Rajendra Ra pam Sinha. They have been named in the FIR along with Mr De, he added.

The Sinhas called up the police outpost inside the hospital when Mr De arrived apprehending attack. "But by the time they reached the spot, the damage was done," Mr Rupam Sinha said.

Mr De later called up to "apologise," but Mrs Sinha didn't attend the call. "He's known to us because he used to call us for booking beds in the hospital for people close to him," she said. "We don't want to

stay here in such insecurity.'

However, the MLA had received a clean chit from the party top brass. Mr Anil Biswas said Mr De wasn't present

at the spot during the incident and had left

much before it happened.
"I met him during the day and he had informed me of the incident," Mr Biswas told reporters at the Alimuddin Street headquarters. Police are probing into the incident and the CPI-M's Kolkata district committee will also conduct a parallel investigation, Mr Biswas said. "The report will be given to me either today or tomorrow," he added.

Though senior party leaders have demanded the arrest of Opposition MLAs if they are involved in similar cases, Mr Biswas said: "Let those allegedly involved

be proved guilty first".

He said eviction from hospital premises will not be slowed down. There will be no pressure on the administration to call off the drive nor will our partymen be allowed to oppose eviction, he added.

Mr Tapas Ray, Trinamul leader, said now that a CPI-M leader has flouted Left Front instruction, it remains to be seen what steps the government takes against him.

T is not yet five months since the Congress-Trina-mul alliance lost the Assembly elections. Its breakup, which followed the defeat, is an even more recent event. Yet, there are signs already that a fresh alignment of Opposition forces may be in

the offing.

The immediate impetus comes from the panchayat elections, which are due in a mere year and a half. It is clear, however, that the real goal of at least a section of the Opposition is to present a new challenge to the Left Front rule at the state level.

For several years now, it has been clear that the Left has continued to rule through its rural power base, which compensates for its relative weakness in urban West Bengal.

In real terms, say senior Pradesh Congress Committee leaders, "panchayat power" includes control over the police and district administra-tions. This is why, they say, forthcoming polls are

"Our party cannot do well in Assembly or Lok Sabha polls Assembly or Lok Sabha polls if it has no role in the panchayats," PCC president Pranab Mukherjee told the Press at the end of a two-day PCC general body meeting last week.

New anti-Left force maturin

The Congress in West Bengal now seems interested in winning back full credibility as an Opposition party and is eager to fight the Marxists. The Trinamul camp, too, seems to have entered a phase of soulsearching that corresponds to the situation in the Congress, K writes TAPAS RAY

The only way to do so is to go on the offensive against the Left Front government. If Congress does so, its path will run parallel to the Trinamul's. Even if a formal alliance is not formed, the objective basis for one will be laid, and workers of the two parties will come closer psychologically.

It may or may not be a coincidence that the Congress appears to be taking this path not at the behest of the PCC president, but upon being pushed there from above and below – by Priya Ranjan Das Munshi, chief whip of the Congress Parliamentary Party, whom some PCC leaders describe as "close to Mamata," and a section of grassroots leaders and workers

Early in September, Mr Das Munshi had urged Mr Mukherjee to take up a prog-ramme of agitation against the Left Front government on such issues as the politicisation of education and the state's poor plan performance. He had indicated that the Congress workers in the state were a disheartened lot. Instead of making these observations in confidence, he had chosen to write to Mr Mukherjee, and distributed copies of the letter at a Press con-

Naturally, this embarrassed the PCC chief. When Mr Mukherjee visited Malda and Birbhum subsequently, some party workers told him they wanted the party to agitate

against the Left Front government and to ensure a degree. of visibility as an Opposition force, through the media.

Pradesh Congress insiders say the party has now accepted some of Mr Das Munshi's proposals.

Among these is an agitation programme against the Left Front government, and the forming of a 25-member "introspection" committee to find answers to such ques-tions as, why the state Congress has remained so far from power for so many years, and why it is no longer producing national-level leaders.

This is clearly a compromise, since differences between Mr Mukherjee and Mr Das Munshi over tactics had brought the question of leadership into discussion.

insiders "certain pro-Mamata leaders" were keen that Mr Mukherjee should go, and Mr Das Munshi should take his place as the PCC president.

The Trinamul camp, seems to have entered a phase of soul-searching that corresponds to the situation in the Congress.

PCC insiders say that some senior Trinamul leaders, including MLAs, were thinking of returning to the Congress. One of them admitted that many Trinamul workers in Kespur were switching loyalty to the CPI-M to save themselves. He is dissatisfied with the pace at which the work of building an organisational

structure - a weak point identified after the electoral defeat - has progressed in the Trinamul.

There was a call for work in this direction at our recent

panchayat conference,' told this correspondent, "but no concrete effort has been visible since then.


Though he said he was "not yet" thinking of rejoining Congress, the question of the party's leadership was on his mind - he said he felt the Congress would be better off under Mr Das Munshi than it is under the present leadership.

In other words, though Ma-mata Banerjee has returned to the National Democratic Alliance at the Centre and reiterated a go-it-alone policy in West Bengal, sections of her party are leaning towards the Congress.

Even if they do not rejoin the Congress, they seem to view the party as a viable Opposition force once again.

There are many Congress who share Trinamul's anti-Left combativeness and even want a fresh alliance with it. The conditions for a new Opposition alliance, thus, seem to be maturing in the state.

Consensus eludes CM's anti-blockade proposal 210

CHIEF MINISTER Buddhadeb Bhattacharjee found support for his efforts for an agreement against "rail and road blockade", but not a consensus with the Trinamool boycotting the meeting.

The SUCI too opposed the move in principle, but its representatives were present at the meeting.

Buddhadeb dubbed the Trinamool's absence from the allparty meeting as a failure to fulfil their responsibilities towards the people and the State Government as the main Opposition. In a bid to drive a wedge within the Trinamool camp, the Government let Panja-loyalist Bani Singha Roy to represent the State Trinamool Congress. Singha Roy spoke in support of the proposal.

Buddhadeb stressed on banning road and rail blockades as means of political agitation. "We have nothing against processions, meetings or political gatherings. In fact, we are not talking of intruding into the trade union rights, democratic rights or human rights," Buddhadeb said.

The same does not hold true for rail and road blockade. They affect and harass innocent people at large, who may not be related to the issue of blockade at all. How would such an agitation affect the Government, if the Opposition took to the streets, instead of trying to solve it mutually," Buddhadeb said.

But he didn't insist on enforcing a ban. Rather, the Chief Minister invited people to debate on the issue before taking a legal stance. "The Government is not

planning to impose a law to enforce the ban. We have laws, provision of fines and even jail, against blockades. But I would prefer a consensus," he said.
"You cannot expect the resolu-

tion to be a decision from today, the Chief Minister said. He added that a draft of the resolution will be sent to all parties in the district and block levels and a general opinion building exercise and awareness would be created to help parties arrive at an agreement. Pradesh Congress leader Manas Bhuniya and State BJP president Asim Ghosh too welcomed the move.

Even as there was a consensus among the Left Front, partners differed over interpretations. For instance, CPI(M) State Secretariat member Shyamal Chakrabarty said the Front representatives agreed to do away with blockades. State CPI(M) Secretary Anil Biswas clarified that the blockades should no longer be used as a means of protest against the State or the Centre.

Rehab package gathers dust

KOLKATA, Sept. 24. - A rehabilitation package for 600 families living along Tolly's Nullah between Kudghat and Garia has been gathering dust for over a decade.

The Centre had allotted Rs 34 lakh in 1988 under Calcutta Slum Improvement Project for the families' rehabilitation. Each family was to get Rs 24,000. The CMDA too had allotted six acres of land (dag No 10 and 13) at Chowkganiagachia, Kalikapur mouza. Mr PB Nag, CMDA staff un-

ion general secretary, has written to the local MP, Miss Mamata Baneriee, to take up the matter with the Centre and state government. Mr Subrata Mukherjee, mayor and CMDA board member, too has been informed.

It was decided at a meeting in 1988 that the encroachers would be persuaded to leave to facilitate cleaning of the canal. The meeting was presided over by Benov Chowdhury, then land and land reforms minister. Mr Kamal Basu, then mayor, senior CMDA officials and the irrigation department's chief engineer had attended the meeting. The matter was, however, not taken up as the irrigation department had shelved the cleaning of the canal for the time being.

Senior urban development officials said most of the people who prepared the scheme had either retired or had been transferred. They said there was no proposal to revive the scheme.

But why the government is not using the 600-acre land to rehabilitate the encroachers who have been evicted from the banks of Tolly's Nullah recently to facilitate Metro Railway expansion remains unanswered. Also, if the Centre could allot money then, why is Mr Buddhadev Bhattacharya not trying to persuade it to do so now?

Haldia Petrochem gets a financial lifeline

KOLKATA, Sept. 5. – Leading financial institutions today offered help for the deat-restructuring of Haldia Petrochemicals Limited. There were indications that Indian Oil Corporation

would join the project as an equity partner.
The meeting was convened by HPL promoters to discuss the restructuring of company's debts with IDBI, ICICI and State Bank of India, in a bid to pull it out of the financial crisis.

Two of the three HPL promoters, the state gov

ernment and the Chatterjee Group, attended the meeting in Mr Nirupam Sen's chamber.

"Banks and financial institutions offered all possible help for a speedy restructuring of HPL,"
Mr Sen told journalists after the meeting. He did not give details of the restructuring plan or any fixed timeframe. Positive discussions were held on marketing and the issue of preference shares. The minister evaded questions on the extent to which HPL's debt burden would de-

cline after restructuring.

The HPL had received a proposal from IOC to enter as fourth partner in the project. "We have received a proposal from IOC and the proposed restructuring package will also consider it.

tion in the HPL," Mr Sen said. But the three existing promoters would first discuss the nature of its participation. "Participation does not imply that we must agree to whatever they want."

Calcutta, Aug. 30: After sitting for eight years, India's only surviving Tada court came close to winding itself up today when it pronounced Rashid Khan and five associates guilty of engineering the 1993 Bowbazar blast in which 69 died and 40 were maimed.

The judge found Rashid and his henchmen — Abdul Aziz, Pannalal Jaiswal, Md Mustafa, Md Halim and Md Gulzar — guilty of causing the blast and conspiring against the nation and the interests of communal harmony. But he acquitted them of the charges of murder and damage to property for lack of "direct evidence".

Investigations have revealed that the explosion, on the night of March 16, 1993 — four days after the Bombay serial blasts — at 267 Bepin Behari Ganguly Street, was triggered by a massive store of explosives. The impact was such that the three-storey building where the explosives were stored was blown up, three neighbouring buildings developed yawning cracks and the verandah of another building was shattered. Be-

KOLKATA, Aug. 24. - The former Dum Dum municipality chairman, Mr Sudhir Bhattacharya, was today arrested for his involvement in Sailen Das's

murder, police said.

Mr Bhattacharya, who was detained this morning under charges that he allegedly paid Rs 1.10 lakh for the murder, was formally put under arrest late tonight after sustained interrogation. Police said he would be

produced in the SDJM's court, Barrackpore, tomorrow. Meanwhile, the DIG (Presidency Range), Mr Gautam Chakraborty, who is handling the case, said the plot was uncovered during the interrogation of Mr Bhattacharya.

The chief minister, Mr Bud-

dhadev Bhattacharya, said: "With this arrest, we've been able to find the culprits. Some more arrests are in the offing."

The SP, North 24-Parganas, Mr Kuldip Singh, said: "The former chairman was probably into a coup to remove Sailen Das and hoped to replace him

after killing him.

Mr Sudhir Bhattacharya was the municipality chairman for 32 years till he was defeated by Sailen Das in 1999. He was expelled from the CPI-M in 1974 for anti-party activities. However, he continued as the chairman after forming an organisation called Dum Dum Puro Unnayan Sanstha. From time to time, he enjoyed the support of the Congress and the CPI-M.

Five more people had been arrested since last night in connection with Sailen Das's murder from Dum Dum and Baguihati. They are Sambhu

Kamath, \ Debashis Prasad Ghatak, Babulal Sharma, Mrityunjay Ghosh and Tapas Sharma, Bhattacharya. They were produced before the SDJM Barrackpore and remanded in police custody for 10 days. The first three have named the former chairman.

Police said on being tipped off by Kamath, an employee of the Dum Dum Municipal Hospital, they raided Mr Sudhir Bhattacharya's house this morning.

Kamath had admitted receiving the money during interrogation. Kamath said it was for chalking out a plan for the murder.

Police recovered Rs 40,000, paid for the killing, from three of them. About Rs 25,000 was recovered from Kamath and Rs. 5,000 from Babulal Sharma, a promoter and CPI-M activist in Dum Dum. Kamath reportedly lured Babulal into the plot. Babulal was promised more money if he could kill Sailen Das. Kamath also assured him that he would be permitted to build a house in the area once the job was done. He was given 16 copies of Das's photograph and his house was shown to him.

Babulal later contacted Debashis Ghatak and informed him about the time when Das usually left for office. The two came to the area thrice to identify Sailen Das. They planned to murder him either when he was leaving for office or was on his way back home.

All three have individually told police that Mr Sudhir Bhattacharya had paid them for the murder. Police said the murder could have been due to the contention for the post of Dum Dum municipali chairman. Planning begafter the Assembly elections. municipality nning began

MEA no to Bangla for Bengal

THE MINISTRY of External Affairs (MEA) has turned down the West Bengal Government's demand to rename the State as Bangla. The MEA sent a note to the Home Ministry saying that such a name change would invite unnecessary diplomatic problems and strain ties with Bangladesh, which is already perturbed by the State Government's decision.

In July last year, the West Bengal Assembly had adopted a resolution to change the names of Calcutta and West Bengal to rid the State of its "colonial legacy". State Chief Secretary Manish Gupta then sought the Home Ministry's approval. On December 9, the Ministry

told the State that Calcutta

shouldn't be renamed unless there were very special reasons and that a 'change should not be made merely on grounds of local patriotism or linguistic reasons". It sought detailed reasons for the proposed change.

Subsequently, North Block approved the renaming of Cal-

cutta in December, and the city was officially re-christened Kolkata on January 1.

But it wasn't that easy with 'West Bengal'. There was dissent in the State itself and the matter was shelved. In June, Chief Minister Buddhadeb Bhattacharjee revived the issue. Sources said a final decision was yet to be taken.

They said a constitutional amendment would be required to effect the change. Before Calcutta became Kolkata, the names of two other cities — Bombay and Madras — were changed to Mumbai and Chennai. But so far, no State has sought to rename itself.

It is unlikely that the Centre will agree to the State's proposal. It may insist that the Left Front think of another name for West Bengal.

"One must realise that we are up against a formidable team high on resources, skills and resolu-tion," head of the special investigation team and inspector-general of police (South Bengal) Prasun Mukherjee said today. "It wasn't a neighbourhood operation carried out by a cheap gang."
The CID has collected sizeable

evidence, which points to the role of some inter-state gangs.

A CID officer said the American Federal Bureau of Investigation (FBI) was called in to assist in tracking the phone calls routed through that country. The FBI traced two calls the Roy Burmans received three days after the abduction to the Amsterdam-New York-London-Chennai-Calcutta route.

Officially, the administration still refused to shed light on the kidnapping. Chief minister Budinspector-general Partha Bhattacharvya, was mum today as well. 'I shall make a statement on the issue when I am in a position to do so. You need not ask, I shall myself call you and explain everything. Wait till then," the chief minister told reporters.

The police carried out overnight raids after Roy Burman returned home yesterday and detained several people for interrogation. Some key arrests are likely to follow shortly.

"We have enough evidence that proves that local contacts actually collaborated with the abductors and helped them get a safe passage from the scene of the crime," an official said, adding that the CID was now trying to trace a police informer who was tipping off Tiljala businessman Chunnu about the raids.

Officials are also combing areas in North 24-Parganas, where, they believe, Roy Burman was taken and given crude medical treatment for eight days

A West Bengal Armed Police official has been sent to Hyderabad where, the police believe, payment of the ransom was arranged. CID officials also visited Woodlands Hospital where Roy Burman was operated on today. The wounded shoe magnate asked for time to reconstruct the entire incident, officials said.

The police have sought the help of their Mumbai and Uttar Pradesh counterparts to trace Hafiz Alam and Saudagar Singh, henchmen of Chhota Rajan's rival Fazl-ur-Rahman. Investigators feel they are among the main suspects in the case. They were told by their sources that the duo came to the city a week before the abduction.

But Mumbai police do not seem to have much idea about the activities of Alam and Singh. According to the information they have provided, both come from Uttar Pradesh and initially worked for Chhota Rajan before switching loyalties to Rahman.

However, investigators have learnt that both probably masterminded the abduction of a Biharbased industrialist and a Gujarat businessman.

Roy Burman's abduction is a signal to the city's businessmen that they are no longer immune from being the target of interstate gangs. One theory doing the rounds is that the shoe baron was one of six city-based industrialists that the gangs may have tar-

"The local councillor is a non-entity and we do not even know his/her name." Tuberculosis patients here are treated without any X-ray being done because the machine has been ly-

ing defunct for years now. That these health centres are in a shambles is beyond debate. Councillor Shamima Khatoon, a teacher by profession, is totally ignorant of local needs and has no time to visit these centres which have become a haven for drug addicts and anti-socials. Indeed, the sorry state of these Centres are in stark contrast to the well-managed nursing homes in the area owned

Netaji Nursing Home owned by state minister for food and supplies Kalimuddin Shams was established in 1999. Eminent personalities such as J&K chief minister Faroog Abdullah, Justice AH Ahmadi and Forward Bloc general secre-

tary Ashok Ghose were present at its inauguration. Interestingly, Shams claimed in his inaugural speech that the nursing home was dedicated to the poorest of the poor of the area. Reality is something else.

Local legislator Ram Pyare Ram also runs his own nursing home, Shri Matri Bhavan. Apart from this, Ekbalpore Nursing Home and Bellona Nursing Home are run by M. Purkaistho, a retired doctor of the Kidderpore Maternity Home, and Dr Qasim, a Trinamul leader, respectively.

These nursing homes are really expensive. A local health worker says that "they are plundering poor people" in the name of treatment. She adds that these nursing homes have their paid agents in Kolkata's government hospitals who "bring in patients" arriving in the city from different parts of the country for treatment.

'I'm not here to make compromises'

You must be aware that you represent sky-high hopes - for an hon-

these demands and aspirations?

Arunava Das

I'm quite aware of what we are capable of doing and what we are not. We'll definitely do what we think we can do. And the things that are impossible for us must be openly explained to the people. At the public meetings I addressed before the elections, I said: Pa thakbe matite, kintu aamaader matha unchu korte hobe ekabingsho shatabdir akashe. (With our feet placed firmly on the ground, we must look up to the 21st century sky). There is no doubting that people wanted a change. But some people were bent on giving this desire a negative shape. Had they been successful, things would have gone from bad to worse. But the Left Front victory made sure that didn't happen. And the people by and large have accepted this change.

So you admit things were bad and some sort of changes were necessary. Many believe that had Jyoti Basu continued things would have been tough for the Left.

Bad is a relative term. But it is true that in the course of so many years of rule, a sort of stagnation has set in. It was evident in our performance, both in the government and in the party. So I was very clear from the outset. I convinced our party men that we must go to the people and tell them what we had done and we had not done. There was the anti-incumbency factor and we convinced ourselves that we had to admit to our mistakes. There was no option. If I spent 30 minutes detailing our achievements, I also spent 30 minutes speaking of our mistakes. We identified our failures and admitted our inability to correct these. And that paid off.

What are you going to do about the failures?

Now that we have been able to identify our failures and problems, there's no point sweeping them under the carpet anymore. It snould be an open exercise. Lither you set things right or get lost.

What if you fail to set things right?

Look, I'm a realist. I don't dream of anything that is not achievable. But we must also see things in the larger perspective. We have poverty, unemployment and illiteracy and these issues aren't unique to West Bengal. We are one of the 28 states in the country. The GDP growth is only five per cent; in agriculture it is two per cent. The growth rate in industry has come down from seven to five per cent. So we have to do everything in the present context and in the present reality.

Unemployment has got to be the most testing of problems.

Yes, it is. But can one state solve unemployment altogether? The main problem lies in the planning that is done at the Central level. One hundred and fifty million people are unemployed. How can you hold one state responsible for this scenario?

But something has to be done...

Yes, of course.

job opportunities?

We have decided to put the accent on the traditional sectors - small and medium-scale industries. We have handloom that needs modernisation. Computers will be used to create new designs. We have sericulture, hosiery, leather, and plastics industries... Sixty-two items have been identified in both the manufacturing and service sector. Cooperative banks will play the main role in financing.

What about marketing?

The government will take care of more than 50 per cent of marketing through its PDS schemes. The smallscale manufacturers do not have much to worry about marketing any longer. We hope to generate 600,000 jobs through such schemes.

Knowledge-based industry is another important sector. I agree that it is not going to create many jobs in terms of numbers, but the future lies in this sector. Though a late starter, West Bengal already has a 20 per cent share of total national export in software. Last year, our export was worth Rs 965 crore. We started in 1996-97, announced our IT policy in 1999. But now we are making rapid strides. Two sectors in Salt Lake are already brimming with IT units. So is Nonadanga. Now we're ready to go to Durgapur.

Are you entering into any collaboration?

Companies like IBM and Wipro are showing a considerable interest in our state. With IBM helping us, we have set up a learning centre, the first in the country. Now IBM has come up with a proposal that it will take charge of computer teaching in secondary and higher secondary schools. It has offered assistance for 2.000 schools. But we are not in a position to respond because of a funds constraint. We will begin with 200. Not all schools are sufficiently equipped and have the minimum infrastructure for setting up computer centres. We are going to sign an MoU with Microsoft. It will help us introduce E-governance in government departments. Home, police, budget, land revenue, pension, salaries will be computerised soon. This apart, we have approached IBM to help us set up a training institute for IT teachers needed for schools, engineering and polytechnic colleges.

There has been a huge migration of students over the past few years. Have you contemplated measures to arrest this trend?

It's not easy. Give us some more time. From nine engineering colleges two years ago, West Bengal now has 31 colleges. IT is now being introduced in polytechnic colleges also.

The owner of Suraj Factory at 8 East Topsia Road also admits to not having a trade license. "People do come to inspect. The nice ones don't bother. The bad ones demand money," he says. His shed and compound are heaped with plastic items ranging from saline water bottles, which fetch the highest price, to talcum powder containers. plastic syringes and combs.

Rafiq Mollah, who works with Jai Bajrangwali Rubber, says he earns Rs 50 a day. Jagdish and Santosh of DS Plastic earn 50 paise per kilogram of plastic recycled.

According to Satyesh C Chakraborty of Ekta Ecological Foundation, which published a study on the subject in December 2000, raw material worth Rs 53 crore is recycled every year in Kolkata alone. "And this is a modest estimate," he adds. "Entrepreneurs have to be assisted with finance. The recycling capacity can be improved. Different strategies need to be chalked up for different substances."

Chakraborty also places recycling units operating without a trade license at "over 50 per cent". But few studies and insufficient data make this an understudied sector.

PARTISAN, POLITICS Speaker's bid to select PAC chairman

NEVER before has the appointment of chairman of West Bengal assembly's Public Accounts Committee generated so much controversy as it has this time. The reason is understandable. With Trinamul becoming the principal Opposition, there is considerable consternation among the ruling Marxists that they may no longer be able to hide the skeletons in their cupboards when the malleable Congress was the main Opposition. They are worried that if the chairmanship of the quasi-judicial PAC goes to any of the "hostile" Trinamul MLAs their image would suffer. It is to forestall this that the Marxists have not hesitated in making the Speaker Hashim Abdul Halim a party to the controversy. It is an open secret why Halim in cahoots with his party prefers Subrata Mukherjee. The Mayor is under the control of the state government's municipal affairs department. As PAC chairman how can he sit in judgment since the Calcutta Corporation receives hundreds of crores of public funds from the state government? After all, the financial irregularities of both the municipal affairs department and the Calcutta Corporation come under the scrutiny of the CAG whose audit report forms the basis of PAC investigation. Subrata has compromised himself by promising he would not have any confrontation with the state government. His appointment will compromise the PAC's credibility. The Marxists are stoutly opposing Dipak Ghosh's candidature as he has stirred a hornet's nest by seeking judicial intervention in the Salt Lake land allotment scandal. Saugata Roy is also a fit candidate for the job which must go to someone who is equal to the task. Certainly not someone who capnot stand up to the Government.

TF one goes by representations made by the Bharat Chamber of Commerce before the West Bengal Electricity Regulatory Commission, the CESC's proposal to increase power tariffs is entirely without basis. One will have to hear the CESC out on the subject before coming to conclusions, but the many questions raised by the BCC should make the CESC squirm and the public extremely inquisitive. Most accusations levelled by the BCC against the CESC relate to ineffective or less than honest cost management, to enumerate a few: more expensive LDO is used instead of furnace oil for all fuel requirements; the two older plants at New Cossipore and Mulajore, that employ more people per KW produced accounting for less than 10 per cent of the utility's overall production which can be easily made up by its other plants which are under-utilised, effecting a saving on the wage bill of roughly Rs 80 crores; the CESC has brought its transmission and distribution losses up 58 per cent in nine years; the 6.6 KVA feeders are unmetered, the suspicion being that CESC officials are involved in illegal supply of unmetered power to bulk consumers; the savings on decreasing interest charges and normal growth in power sales should bring in the extra revenues they are looking for, while the fuel surcharge should take care of any increase in fuel rates over and above the applied tariff. These are serious accusations and since the BCC note is out in the rublic domain, the CESC needs to do some detailed answering and quickly. One should point out to the BCC that it is not easy to get rid of 2000 workers in the state of West Bengal, but it is a requirement the government should recognise.

On the tariff proposals as such, the BCC paints an even grimmer picture. It has conducted studies on four industrial units to show that the new method of computation, based on KVA instead of KWH, will lead to an increase in power bills ranging from 43 to 76 per cent. The effect this can have on an already depressed industrial climate and on inflation in general can be devastating. Also, the BCC says that the CESC's proposal to ask industries that draw less than 75 per cent of their contract demand to pay the shortfall is inequitous since the CESC pays no penalties when it fails to deliver power when needed. Is this the norm for private power suppliers operating in other parts of the country? One knows that the MSEB is under obligation to draw a certain amount of power from the DPC, under pain of penalty, but then MSEB is not the direct consumer, only the distributing agency. Is it fair to penalise industries for not taking the power they do not need? The BCC says this is in response to the decline in the consumption of high tension electricity which, according to the CESC itself, is its principal business segment. The point best taken in the BCC note is about the need for competition in the private power sector. The 16 per cent return on investment guaranteed by the Centre, says the BCC, allows private monopolies, such as the CESC to un their units "the way they like, at the cost they like".

Q: What are your plans on IT? A: One thrust area is the setting up of software-based IT industries. We are encouraging small and big IT firms to invest here. Already in two sectors at Salt Lake, 20 companies are functioning, employing over 14,000 people. The second thrust area is training. Now we are thinking of setting up IT training centres at Siliguri, Durgapur and Haldia. We have approached Microsoft for setting up training institutes for IT teachers. Q: Health system is another area that is in a very poor condition. What is your Government doing about it?

Unless they are made accountable for their duties, things cannot

The education system also needs to be improved. We have primary schools, but the quality of teachers and teaching techthat is not true. Jadavpur University received an award as institute of excellence and Calcutta University recently got the five-star status. However, we have to change the orientation of higher education. We need to give more emphasis on science and technology and set up more technical institutes and engineering colleges

Q: Your Government seems to be more corpo in nature and you appear to be the new CEO...

A: (Laughs) No, no. I am not trying to follow the Chandrababu model. I am doing it my own way. I believe just hi-tech and computers cannot improve living condi tion of the teeming millions. Science and technology should be blended with the ground realities. Man and machine should work together for optimum result. The main thing is to create job opportunities for the younger generation in Bengal.

In agriculture, we have to consolidate our achievement and sustain it. Now we should create more job opportunities in traditional small-scale sectors like leather, handlooms, hosieries, agro-based industries, chemicals and plastics. My aim is to improve the living condition of the 25 per cent below the poverty line and to strengthen the PDS. One should not forget that in this election, the mandate was for the Left Front to fulfil its promises and rectify its mistakes

F only Prime Minister Atal Behari Vajpayee respected the unanimously passed resolu-Lion of the state unit of the Bharatiya Janata Party to recall Tamil Nadu governor Fathima Beevi, and a similar resolution by the Dravida Munnetra Kazhagam, leader of the National Democratic Alliance in the state, for showing scant regard to the spirit of the Constitution and democratic norms in inviting J Jayalalitha of the AIADMK — a criminal convicted thrice over and sentenced to varying jail terms but out on bail granted by Madras High Court to form the government, the nation could have been spared the ignominy of having in the Indian Union a banana republic where jungle raj

prevails. Even if Miss Beevi pleads ig-norance of the nuances of the Constitution, she should have known that when a criminal is elevated to the post of chief minister, the rule of law will be the first casualty. And that is exactly what has been happening in Tanil Nadu from the day Miss Jayalalitha was sworn in as chief minister by Miss Beevi. During her campaign for the Assembly election in April-May, Miss Jayalalitha told the electorate that if voted to power her first priority would be to put DMK president and former chief minister Muthuvel Karunanidhi and members of his family behind bars. She also boasted that Mr Karunanidhi would be locked up in the same cell in Chennai Central Jail in which she was detained, quite legally, for a few days in 1996 during the DMK regime.

Opp cries foul but makes no dent

THERE WAS a lot of noise and little of substance in the Assembly today. The Opposition demanded a CBI probe into Tuesday's raids, ripped up copies of the Chief Minister's statement and walked out. However, they did not use parliamentary procedures to put their views on record effectively.

The Leader of the Opposition subsequently referred to Bud-dhadeb Bhattacharjee's statement in the House as a piece of toilet paper—a strong statement by all means—but of little use. Especially since the Opposition did little to punch holes into the Chief Minister's report.

And how could they? Neither the Trinamool nor the Congress moved a calling attention motion demanding a statement from the Chief Minister. Even if senior Congress MLA Abdul Mannan had done so some days ago, he wasn't even present in the House to pursue the matter. An opportunity to put the Government on the mat was clearly missed.

Instead, unruly Trinamool Congress reveled in thumping desks and raising a din—so much so, that the SUCI's Debaprasad Sarkar who had moved the calling attention motion could not even ask his question. The din proved clearly counterproductive. As the Opposition members raised hell, the Chief Minister-who was originally supposed to read out his statement-quietly laid it on the table of the House and walked away unchallenged.

Senior Opposition legislators such as Shobhandeb Chattopadhyay and Saugata Roy were no exceptions. They called Transport Minister Subhas Chakrabarty's attention on the misappropriation of CSTC funds. Instead of asking questions on

the subject, they too digressed to the stadium muddle.

As if to lampoon the sports minister, Trinamool MLA Sonali Guha came in a hat and raised slogans such as "Subhasher khelaghore criminalra khela kore". Guha and her followers stomped the secretary's desk. Soon enough, Chattopadhyay and Pankaj Banerjee tried to force their way to the Speaker's seat and a Trinamool MLA vented his spleen on a hapless

Assembly staff keeping minutes of House proceedings.

Chattopadhyay returned to his seat only after the Speaker sternly asked him to ask his question.

"I am asking you for the last time to ask your question to the Sports Minister." The Trinamool MLAs, bent on losing an advantage that was theirs, continued hollering even when the Chief Minister rose to and he didn't make an effort to be heard. He tabled his statement and cleared out. Later, the Trinamool and the Congress walked out of the House demanding the Sports Minister's resignation.

Later, Banerjee literally ate his own words when he described the Chief Minister's statement as a piece of toilet paper and yet demanded a discussion on it.

'We urged the Speaker to let

us ask our questions before the Chief Minister made his speech. But he behaved like a loyal CPI(M) cadre and denied us the opportunity," Banerjee said. Both the Trinamool and the Congress sought a CBI probe. "The CID is part of the State police. We don't have faith in it. We have therefore sought a CBI probe. And when the inquiry is on, Chakrabarty must remain out of the ministry," Banerjee said.

Subhas loyalists see party More arrests in the offing hand in stadium slur

LOYALISTS OF Subhas Chakrabarty believe that elements within the CPI(M) – worried by the recent narrowing down of differences between the Minister and Buddhadeb Bhattacharjee stage-managed Tuesday night's arrests from Salt Lake and Howrah.

Chakrabarty, putting up a brave front insisting his party is behind him, himself believes that some people within the organisation had set it all up to humiliate him. his camp followers say.

It's virtually impossible for such a massive raid to be carried out without either the Chief Minister or the party top brass knowing of it. Chakrabarty is learnt to

have told his confidants. 'I would like to believe that I enjoy the party's support. All I can say is that those who don't like me are behind this. Such mischief won't pay off. They can never tarnish my image. They can't turn the people against me,' Chakrabarty told Hindustan Times.

There could be two motives behind the frame-up bid. The party leadership, his

camp believes, did not take his pre-poll tantrums kindly and was itching to get back at him. Hence, the police action. Chakrabarty's plain-speaking had pushed the party to the brink of a crisis. Only after he gave the likes of Anil Biswas and Buddhadeb Bhattacharjee some sleepless nights, did he agree to contest the polls from Belgachia East.

But it's the other thesis that Chakrabarty loyalists find more plausible. Topparty leaders, uneasy at the new bonhomie between Bhattachariee and the minister. took this step to paint the minister in poor light.

Subhas-baiters such as Anil Biswas, Biman Bose, Nirupam Sen, Surva Kanta Mishra, Asim Dasgupta, Amitava Basu and Amitava Nandi were all in it, they believe.

These men saw the rise of the Buddha-Subhas combine as a direct challenge to the party's stranglehold over the administration. The "expose" would not just malign Chakrabarty, it would also embarrass the Chief Minister. The destabilisation it would cause would land Bhattacharjee in a crisis.

Biswas, however, dis-

missed these theories as sheer bunkum: "I don't see conspiracies everywhere. The party is backing Buddhadeb to the hilt. And, it will continue to do so.'

Equally strong was Nirupam Sen's rebuttal. "This is ridiculous. How can one even think of playing such a dangerous game? Subhas is a senior Cabinet member and a party colleague. If the police claims that Tapash Ghosh – arrested for harbouring goons inside the stadium is known to Subhas, it's just as true that the Chief Minister, CPI(M) State secretary, Home Secretary, DGP and I didn't have any knowledge of the first police raid.'

Sen insisted that the Opposition, instead of boycotting the House, should agree to a discussion. "Only then will the truth be known." Perhaps, he was hinting at some evidence of Trinamool involvement in the episode gathered by the police.

"It's known that most of the hoodlums nabbed worked for Howrah Trinamool leaders. The investigation will unearth who they really worked for. I'm sure Subhas had nothing to do with these men," said CPI(M) MLA Kanika Ganguly.

THE CHIEF Minister may still not be "satisfied" with the progress of investigations into the Salt Lake Stadium scandal, but if feelers within the police are any indication, there should be more arrests in the offing.

At least four people had already been identified along with Tapash Ghosh for harbouring criminals at the stadium, and a massive manhunt was underway for them, insiders said.

The police are curious to know what exactly had prompted them to harbour the criminals rounded up from the stadium.

'We are not interested in political affiliations of the offender. Because, law does not discriminate on such grounds. We'd like to know why these youths had been provided shelter, and we will try to ascertain the motive," a senior officer heading the investigating team told the Hindustan Times today

Besides Tapash Ghosh, the other man prominent on the "wanted" list is Beliaghata heavyweight Gobindo Dey. Denying claims of his arrest, the sleuths said today that they were still on the lookout for the absconding man. They refused to name the others on the 'wanted' list.

That the cops were in no mood to let the investigation lose any of its bite was apparent today when they urged the court not let Tapash Ghosh get out on bail. The plea was granted and Ghosh was sent to judicial custody for 14 days for an ordinarily bailable offence.

But while such moves might leave no room for doubt that the cops this time mean business, but why Ghosh was arrested five days after the criminals had been rounded up from Salt Lake and their confessions were heard, is still far from clear

Police, on their part, are claiming that their primary motive was to know where the gang was heading for and not who provided them shelter. But not many citizens are convinced.

While the district police are gearing up to flush out a few more crooks, the CID sitting up and taking a serious note of the Presidency Range DIG's report on the stadium scandal. Additional directorgeneral of police (CID) KK Mondal has been entrusted with the task of setting up teams to carry the investigation forward.

According to a section of senior CID officers, the primary of the police would be to look into the details of the criminal motive of the arrested gang and then proceed to find out the objective of those who had provided them shelter. So far, only Rabindra Nath Mondal has been retained in police custody but questions are being asked as to why Dick and Toton were allowed judicial custody even though the police were aware of the depth of their involvement in criminal activities in Howrah and parts of Dum Dum and Lake Town.

We will demand a discussion on the Chief Minister's statement in the Assembly," Opposition leader Pankaj Banerjee said. The Congress is likely to follow suit as senior party MLA Abdul Mannan had earlier moved an adjournment motion on the deteriorating law and order in the State.

Trinamool MLAs also plan to use the Question Hour tomorrow, in which Subhas Chakrabarty is slated to answer questions.

The leader of the Opposition took the decision of lifting the boycott after some of his party As, including Saugata Roy and freshers like Arunava Ghosh and Partha Chatterjee, urged him to reconsider continuing the boycott till Tuesday and instead use the House session to embarrass the Government.

Banerjee has also requested Congress MLAs to participate in the Assembly proceedings tomorrow. "I have urged Mannan to convey the decision to his MLAs.

STADIUM SCANDAL

Subhas loyalist in police net

IN A surprise swoop, the North 24-Parganas police today arrested Transport Minister Subhas Chakrabarty's Man Friday Tapash Ghosh on charges of harbouring criminals at the Salt Lake stadium.

Forty-five-year-old Ghosh was arrested after two criminals, Digbijoy Moitra alias Dick and his associate Tarun Chakrabarty alias Toton, identified him as the man who had sanctioned their stay inside the stadium compound for more than a month.

Apart from Ghosh, party member Gobindo Dev's name too figured on the list of those identified by the criminals.

The arrest, which comes barely four days after the Howrah Police rounded up a gang of 16 criminals from the stadium, is likely to give a new twist to the raging controversy over the politician-criminal nexus in the State.

The arrest will be a shot in the arm for the Opposition, which will certainly try to nail Chief Minister Buddhadeb Bhattacharjee when the latter makes his statement in the Assembly tomorrow.

Within hours after news broke

of the arrest. Subhas Chakrabarrushed to meet former Chief Minister and his mentor Jyoti Basu at the latter's Salt Lake residence. He was not available for

comments till late in the evening. Chakrabarty's visit followed Chief Minister Bhattacharjee's visit to Basu. In fact, Bhattacharjee met him twice during the day.

The arrest was the culmina tion of a perfect operation. Earlier in the day, the police called Ghosh from his Baguihati residence for his reaction to the claims made by two notorious criminals from Howrah. When Ghosh denied any involvement,

he was picked up and taken to Howarh for cross verification. Once Ghosh was brought face to face with Dick and Toton, the two immediately identified him. Ghosh was arrested thereafter on charges of harboring criminals," the superintendent of North 24-Parganas police Kuldeep Singh said.

A joint secretary of the Friends of the Stadium and a member of the Sports Council, Ghosh was a key lieutenant of the Transport Minister, always playing a crucial role whenever function were organised at the stadium.

Police investigations revealed that both Toton and Dick were hardened criminals from the Lake Town and Dum Dum areas, who had joined hands with two notorious gangsters, Buro Khoka of Shibpur and Palash Das of Bally, to spread their spheres of influence beyond North 24-Parganas and into Howrah.

Ghosh's links with these two rattled a section of the police and

Bosses blow hot and cold on former rebel

Party gag on Subhas Chapter Chapter detractors at meet Chapter Opened


Calcutta, June 30: Known detractors of Subhas Chakraborty in the CPM, Amitava Bose and Shanti Ghatak, were not allowed to raise the Salt Lake stadium issue during the first day of the two-day CPM state committee meeting today.

State CPM secretary Anil Biswas and politburo member Biman Bose told the meeting that no discussion will be allowed even within the party forum till Monday when chief minister Buddhadeb Bhattacharjee will make a statement in the Assembly.

The CPM state secretariat, which met yesterday, had decided not to discuss the issue during the state committee meeting. Party leaders also instructed Chakraborty not to get "provoked" if any member tried to raise the issue during today's meeting.

"We have called the state committee meeting to review our poll performance and not discuss the Salt Lake stadium issue and we have made this clear to all our members," Biswas said.

It is learnt that despite this, Amitava Bose tried to raise the issue at the meeting but was firmly put down by Biswas and others.

However, those close to the transport minister tried to impress upon the other members to treat the entire issue as a "closed chapter" much like how the party tried to handle Jyoti Basu's reference to the "historic blunder" of not joining the Union government.

It is learnt that Bhattacharjee has already instructed the police to look into the allegation by Chakraborty that Trinamul Congress had masterminded the stadium episode with help from Sujit Bose, a Trinamul councillor from South Dum Dum, who was once

close to Chakraborty.

Sources said the CPM leadership is not going to take any stern action against Chakraborty as the budget session is on. Sources in the CPM also hinted that though no immediate step will be initiated against Chakraborty, the sports portfolio might be taken away from him at a later date.

Though the stadium issue was not raised, party leaders from Burdwan, Malda, Jalpaiguri and Cooch Behar mentioned that a number of CPM candidates in these districts had to face defeat during the May 10 Assembly polls because of "intra-party feuds".

Party leaders from Burdwan complained that the CPM nominee in Durgapur II Assembly seat, Debabrata Banerjee, was defeated due to "conspiracy by a section of party leaders in the district". The CPM candidate in Hirapur Assembly segment had to face defeat for the same "intra-party rivalry", district leaders mentioned during the meeting.

Representatives from Malda, Jalpaiguri and Cooch Behar, however, told the party leaders that alliance between the Trinamul and Congress had given the CPM an edge, helping many of its candidates to win.

Calcutta, June 30: Though the Alimuddin Street bosses declared the Salt Lake stadium controversy a "closed chapter", they today ratified recommendations from the party's North 24-Parganas district unit to set up a commission to probe the alleged "sabotage" by Chakraborty and his associates leading to the electoral debacle in the four Assembly segments in the district.

The issue came up at a marathon meeting of the state committee where former chief minister Jyoti Basu was among those present.

Chakraborty's detractors from the district alleged that the transport minister had played a role in ensuring the defeat of party nominees in Panihati, Habra, Rajarhat and Dum Dum Assembly seats.

The district committee had set up the commission headed by Gourisankar Bose, a district committee member, to probe the allegations of "sabotage" by senior district CPM leaders like Amitava Nandy, who had contested from Habra and lost.

Another important party leader was former chief whip in the Assembly, Rabin Mondal, who lost from Rajarhat.
