All-win situation for Samata in Manipur

NEW DELHI, June 1. – The political instability and possibility of imposition of President's rule in Manipur has put the Samata Party in an all-win situation. The Centre will take a decision on Manipur Governor, Mr Ved Marwah's recommendation of President's rule in the state by this weekend.

Given the state's current political situation, the Centre is left with two options – accepting or rejecting the recommendation. If the Centre accepts it, it would vindicate Samata Party's stand. Samata Party had been demanding imposition of President's rule since the Radhabinod Koijam government fell on the Assembly Floor.

If the Centre rejects the Governor's recommendations, Mr Radhabinod Koijam would be asked to continue as caretaker chief minister till a popular government is formed. In effect, this would mean reinstallation of the Koijam government, Samata's initial demand. Sources said the President would send the report to the Prime Minister through the Cabinet secretary and seek the Centre's opinion. A copy will also sent to the home minister. Since Mr Advani is in Leh today to inaugurate the Sindhu festival, a decision is unlikely to be taken tonight.

The Prime Minister will tour quake-affected areas in Gujarat on Sunday. The Centre could take a decision tomorrow when all the

top leaders would be in Delhi.

In its bid to buy peace with Samata Party, the BJP president, Mr Jana Krishnamurthy, had said his party and the Samata would not take part in formation of the government in Manipur and would stay away from from attempts made by other parties or groups.

Senior BJP leaders had, however, differed with their ally and said they did not want popular mandate and democratic process to be subverted in the state. They even foresaw a split in the party. The Manipur political situation continues to be fluid. The Speak-

The Manipur political situation continues to be fluid. The Speaker, Mr S Dhananjoy Singh, withdrew his claim to form the government. But in his enthusiasm, he made a grave technical error. He staked claim while still being the House Speaker and thus fluited Supreme Court ruling. He could also not muster requisite support. Mr Dhananjoy Singh has yet not resigned from the post. But his position has been diluted after the incident.

'Manipur developments internal matter between BJP, Samata'

NEW DELHI, MAY 21. Although the Manipur developments did not figure at the NDA meeting at the Prime Minister's residence this evening, the BJP made its position quite clear — it could consider imposing President's rule in the State, it insisted that a whip had been issued and disciplinary action could follow against MLAs who violated it, and the party would not stake claim to form a Government.

The External Affairs Minister, Mr. Jaswant Singh, briefing newspersons on the NDA meeting, responded to a number of questions on the Manipur developments and its impact on the BJP's relationship with one of its key allies, the Samata Party. He said the issue was an "internal matter between the BJP and the Samata Party" and did not concern the NDA. He also refused to accept that the Samata Party's initial reaction to the defeat of its Government at the hands of the BJP in Manipur was a "threat. The Samata had earlier in the day said it could consider walking out of the NDA Government and also withdrawing support to the BJPled Government in Jharkhand.

Mr Singh said the Manipur developments were not a betrayal by the BJP but the result of "extreme factionalism." He insisted

that "the BJP had issued a whip" to party MLAs to support the Radhabinod Koijam Government, but 24 of its 26 MLAs violated the whip.

It will now be up to the party president, Mr. Jana Krishnamurti, to consider what disciplinary action could be and should be taken against the MLAs, Mr. Singh said.

Mr. Singh also refused to accept that the Samata leader and NDA convenor, Mr. George Fernandes, had stayed away from the NDA meeting as a mark of protest. He said the reason of his absence was the national executive committee meeting of his party. But this did not explain the fact that the executive committee meeting had been fixed with the knowledge of Mr. Fernandes, and he as convenor had also called the NDA meeting. Moreover, it was known days earlier that the Koijam Government would be seeking a vote of confidence today and there was every possibility of the BJP MLAs not supporting it. The Samata Party had itself been warning of this eventuality.

Mr. Singh made it clear that a short spell of President's Rule in Manipur could be one way of getting out of the Manipur mess, but reports from Manipur suggest that the BJP- Samata crisis could deepen with the BJP staking claim to forming a Government. If the BJP continues to claim that was happening without a green signal from the central leadership, it would be tantamount to accepting that indiscipline had reached new heights in the party.

In fact, the BJP-Samata crisis could spill over to Jharkhand from Manipur, with the Samata planning to pull back support to the BJP-led Government there, but BJP may have plans to keep some of the Samata's men who are in government there — after all, it is not easy to say no to Cabinet berths offered as lollipops, and the BJP knows it only too well.

THE PRIME Minister today stepped in to resolve the Manipur deadlock as the Samata Party renewed its pullout threat from the Vajpayee Government after the BJP failed to issue a whip to its MLAs to support the Radha Binod Koijam ministry in tomorrow's trust vote.

BJP chief K Jana Krishnamurthi's promise from Mussoorie to back the Manipur Chief Minister failed to soothe the Samata's nerves, given the rebellious mood of BJP MLAs. The anxiety was duly reflected in Jaya Jaitly's tone as she said, "Krishnamurthi's assurance from Mussoorie will have to reach Manipur. Why is the BJP delaying a whip to its MLAs?"

Koijam also said the BJP should clearly spell out its stand and alleged Speaker S Dhananjay Singh was supporting the dissidents to install a BJP-led Government. He said 25 of the 26 BJP MLAs had been locked up at the Speaker's bungalow and "even their wives and children are not being allowed to meet them".

Jaitly, however, made it clear that even if the Samata pulled out of the Vajpayee Government, it would stay on in the NDA. At an hour-long meeting with Samata leader and NDA convenor George Fernandes, Vajpayee assured him that he would try to solve the problem.

Notwithstanding his leaders' promises, dissident BJP leader R K Dorendra Singh said he was preparing to win the trust vote by "all means". All the 35 legislators loyal to him have

BJP MLAs are dead against propping up a Samata Chief Minister any longer as the party's strength in the 60-member Manipur House has shot up to 26 after admitting 18 MLAs of the Progressive Manipur State Congress.

Since the Samata has only 13 MLAs, Koijam was advised to seek a trust vote after a meeting between Fernandes and Krishnamurthi, who promised the BJP would not destabilise Samata ministry.

But Manipur BJP leacers, who want Dorendra Singh to replace Koijam, told the central leadership that Koijam did not command a majority in the House.

The crisis began to unfold on May 14 after two coalition partners, the NCP and the Federal Party of Manipur (with two legislators each) withdrew support to Koijam. The Chief Minister promptly sacked four BJP and two FPM ministers, alleging that they had links with militants. Seven more ministers resigned in protest.

NEW DELHI, May 19. — The NDA government faces a serious crisis as its oldest and most trusted ally, Samata Party, today threatened to quit the coalition. The provocation: BJP's alleged attempt to destabilise the Samata-led government in Manipur.

"The BJP is bent upon breaking the coalition dharma in Manipur where our party leader Radhabinod Koijam heads the coalition government," said the Samata general secretary, Dr Sambhu Srivastava. The party's national executive will meet on Monday to decide on the issue.

Mr Jana Krishnamurthy, had assured the Samata leader and NDA convener, Mr George Fernandes, that the BJP would continue to support the Koijam government. But the latest development suggests the

But the latest development suggests the party is backing out of its stand. Mr Srivastava said: "If the BJP, the principal party in the Vajpayee government, can't honour an assurance given to the NDA convenor, what is the point in continuing in the government? The coalition government is based on trust and we expected the BJP to reciprocate the same trust that we reposed in them."

He, however, said if the Samata pulled out of

He, however, said if the Samata pulled out of the government, it would extend outside support. Mr Srivastava said if the BJP wanted Mr Koijam to be replaced by one of its leaders, it should have informed Mr Fernandes.

The relationship between the two parties were further strained today after the BJP refused to send a senior leader to Manipur on the plea that the leaders will have to attend the party's Mussorie convention to be held on Sunday and Monday

The Manipur Assembly will vote on Mr Kojam's trust motion on Monday. Mr Fernandes today wrote to Mr Krishnamurthy requesting him to issue a three-line whip to BJP MLAs in Manipur asking them to vote for the government. The BJP, however, didn't comply with it.

Warrant out for Laloo in fodder case

RJD CHIEF and former Bihar Chief Minister Laloo Prasad row before the CBI court in Ranchi. The sudden turn of events follows non-bailable arrest warrants issued by CBI special judge A B Shekhar against him as well as Jagannath Mishra and others accused in the Rs 950-crore fodder scam case.

The interim charge-sheet named 110 persons, eight out of whom have died. Former ministers Vidya Sagar Nishad, Chandradev Prasad Verma, Dhruv Bhagat, ex-chairman, PAC, Bhola Ram Toofani (dead) are the other politicians named in the chargesheet.

Though Yadav remained incommunicado, RJD national spokesman Shivanand Tiwari and Road Construction Minister Abdul Bari Sidiqqui said today that the former Bihar Chief Minister would houour the CBI court's directive and surrender.

Tiwari said the CBI had acted in gross violation of the Patna High Court full Bench's directive. The Bench had ruled in its judgment on transfer of the fodder cases to Jharkhand that the Patna High Court would decide the fate of conspiracy-angle cases, in which investigations were not

complete. The RJD leaders expressed shock over the baste. which marked the filing of the charge-sheet and procurement of the non-bailable arrest, war-Yaday may surrender tomor- rant. Documents on various cases relating to the Animal Husbandry scam were lying with the Patna High Court, they pointed out.

"We expected that the CBI would seek the Patna High Court's directive before filing the charge-sheet. The CBI, it seems, has concealed the rulings of the full Bench and the monitoring bench from the CBJ court at Ranchi". This was tantamount to contempt of court. "A contempt of court will be filed against the CBI very soon," the RJD leaders said.

Launching a scathing attack on Additional Director of CBI UN Biswas, Tiwari said Biswas had acted in league with his political masters in New Delhi and filed the case to destabilise the Rabri Devi Government.

Trying to buffress his argument, Tiwary said the timing and schedule of filing the charge-sheet would confirm such suspicions

"Biswas was given extension in service by the NDA Government. Now he is trying to repay his masters by serving their political interests. He has become a tool in the NDA and the RJD dissidents' hands." he

Armed escorts for Midnapore terror victims

THE ELECTION Commission has arranged armed escorts for political refugees of Midnapore on polling day, so that they can cast their votes.

Escorts will also be provided to people not living in refugee camps, if they feel threatened and seek the EC's help to vote.

There are three camps at Midnapore town, and one each at Garbeta, Moyna and Ghatal. There is no camp at trouble-torn Kespur, which is the place most of the refugees fled from.

Chief Electoral Officer. Sabyasachi Sen said the EC would do everything in its power to help these people vote without

Midnapore's district magistrate and SP have extensively toured the sensitive areas of Garbeta, Keshpur, Sabong and Pingla to build up confidence in voters. Paramilitary forces and state police have been keeping watch in the sensitive areas.

Patna, April 29: As the two-day national executive of the RJD ended after reposing full faith in the leadership of Mr Laloo Prasad Yadav and demanding reservation in judiciary and constitution of judicial commission by the Union government, uncertainty prevails in the rebel camp here.

The crossing over of dissident ministers Monazir Hassan and Akhitesh Singh and MLAs like Mr Sheetal Ram and Mr Surendra Prasad Singh just on the eve of the national executive meeting came as a big blow to the Laloo loyalists.

Apart from former ministers Shankar Prasad Tekriwal, Rapi Das Rai and Mr Ilyas Hussain (all MLAs) and three MLCs Upendra Prasad Singh, Mohammad Shamim and Kumar Rakesh Ranjan there is nobody left in the rebel camp here.

As Mr Hussain, Mr Rai and Mr Tekriwal are no longer the members of the Rabri Cabi net and the other three are members of the Upper House, the government faces absolutely no threat.

Although RJD spokesperson Shivanand Tiwary said that the leadership was till now not aware of any split in the RJD Parliamentary Party, the fact is that Mr Laloo Yadav is not bothered about what is going on in New



NEW DELHI, March 19. - Three Samata Party leaders, Mr Nitish Kumar, Mr Digvijay Singh, and Mr Srinivasa Prasad, who had quit the ministry in solidarity with Mr George Fernandes, today withdrew their resignations and returned to work.

Samata has major role in NDA: Fernandes

NEW DELIM MARCH 16. A day after his resignation as Defence Minister, Mr. George Fernandes, today said he opposed the decision of his Samata Party colleagues in the Union Cabinet to follow suit. He was also "hurt' by the move of the Trinamool Congress leader, Ms. Mamata Banerjee, to leave the National Democratic Alliance.

Speaking to reporters here, he said the Samata Party had a major responsibility towards the NDA Government having contested on a common agenda and urged his colleagues — Mr. Nitish Kumar, Mr. V. Sreenivasa Prasad and Mr. Digvijay Singh — not to insist on resigning from the Council of Ministers.

The three Ministers met this evening at Mr. Kumar's residence after Mr. Fernandes urged them to reconsider their decision. Mr. Prasad told *The Hindu* that they would meet Mr. Fernandes tomorrow before arriving at a final decision.

After a meeting late last night at Mr. Fernandes' residence, attended by party MPs and the acting president, Mr. V. V. Krishna Rao, the situation following the Prime Minister, Mr. Atal Behari Vajpayee's rejection of the Ministers' resignations, was discussed. The party also decided to remain in the NDA and continue supporting the Government from outside.

With Mr. Nitish Kumar taking the initiative of not remaining in the Union Cabinet after Mr. Fernandes had resigned in the wake of the charges, the other two also endorsed the decision, which was conveyed to the Prime Minister this morning, party sources said.

Commenting on Ms. Banerjee's action, Mr. Fernandes said he felt "very hurt" and claimed that after the scandal broke out, the Trinamool leader, Mr. Sudip Banerjee, had asked him not to resign, but fight the "calumny".

Mr. Fernandes said Ms. Banerjee had always turned to him whenever she faced a problem, but on this occasion she "did not even show the courtesy of talking to him".

It may be recalled, that Ms. Banerjee had sought Mr. Fernandes' assistance to highlight the CPI(M)'s "atrocities" against her party workers in West Bengal's Midnapore district last year. The issue became controversial after the Bengal Government objected to a Central Minister making inquiries in the State.

Addressing party workers and supporters at his residence this morning, Mr. Fernandes criticised the Congress and the Left parties for stalling Parliament proceedings. If the Opposition wanted him to resign, they could have made the demand in Parliament, not on the streets or through the media. He said the

Opposition parties did not have "even an iota of patriotism". Mr. Fernandes also defended Ms. Jaya Jaitly saying she was approached by the fictitious arms dealers in her capacity as the Samata president, and even then she asked them to donate the money to the party's national executive.

'Armed forces penetrated'

Turning to the defence establishment, Mr. Fexnandes said tehelka.com's operation showed that "various levels in the armed forces have been penetrated", and felt it could only benefit the country's enemies.

"I have reasons to believe that it (the portal) has penetrated the defence establishment. My extreme concern is that by creating a fictitious organisation and a story and offering five-star hotel luxuries and booze, various levels in the armed forces have been penetrated. The illegal exercise might have cost crores of rupees," he said.

The nation's security had also sought to be subverted by those preventing a discussion on the issue in Parliament, Mr. Fernandes said. Attempts were being made by certain quarters to lower the morale of the troops posted along the borders and in Siachen by ensuring that reports about the "rubbish" defence deals reached them through radio and television without any discussion in Parliament.



Samata silence after slur

New Delhi, March 13: The Tehelka revelations have not only dealt a blow to the Samata Party move to topple the Rabri Devi regime in Bihar, but also to the carefullycultivated image of defence minister George Fernandes as a "crusader" against corruption.

According to the tapes, Jaya Jaitly was given Rs 2 lakh for influencing certain defence deals. The money was accepted ostensibly for "party funds".

After the Ajay Jadeja episode last year — when she kicked up a row over an income-tax raid at her residence in connection with match-fixing charges against the cricket star — Jaitly has again come under a cloud giving rebels in the party a toehold to thank a campaign against her

There was no word from the Samata camp. All Samata leaders went underground immediately after word was out about the Tehelka tapes. Their phone calls were not answered and cellphones were switched off.

Much of the incriminating conversation Tehelka conducted was with Samata treasurer R.K. Jain, who claimed that he acted as the link between arms dealers and Fernandes and Java Jaitly

In her conversation with the Tehelka pointsman, Jaitly said money was needed for the party fund. She said party leader and Union minister of state Srinivas Prasad is hosting the Samata national council "where 500-800 people will be going". Giving details of the national council, Jaitly said: 'We need some help because he (Prasad) said 'Look I can do 50 per cent expense. You do the rest....So the rest... whatever contributions." Bits of the conversation with Jaitly were conducted in Malayalam.

R.K. Jain, a little known businessman, was made Samata treasurer two years ago by Fernandes. Known as Fernandes' "briefcase" man, the Tehelka held a series of meetings with him to strike the deal

According to Tehelka, he proved to be a "goldmine" of information on present and past defence deals.

Tehelka said the conversation "incriminated beyond redemption" the defence minister and the Samata Party. Jain said he was handpicked by Fernandes for the job. "I am close to the boss because of money matters, he has to talk to the treasurer."

Jain talked about his role in the first defence deal after Fernandes became minister. According to Tehelka, when the Samata had no money and had just come to power, Suresh Nanda of the Crown Corporation paid Rs 1 crore for help in getting the order of 250 Armoured Recovery Vehicles for a Slovakian company. The tender was worth Rs 250 crore, Jain is quoted as saying. The other competitors were a Czechoslovakian and Polish firm.

Jain also worked for the Air Jet Trainers project. He said he was approached by Mapo-MiG people. "I went to boss (Fernandes) and told him, sir, this is something. This is very big job, worth Rs 4,000 crore, Rs 3,600 to be precise."

The commission was fixed at 10 per cent and in this particular deal, the Prime Minister is also going to be involved at one stage. It needs Cabinet approval. "So my party expects at least three per cent, PM House will expect at least three per cent," Jain is quoted as saying.

Jain admitted that Jaitly gave him permission to go to Moscow to sign the deal with the MiG people.

Samata hopes to lead coalition in Manipur

NEW DELHI, FEB. 11. The Samata Party, which has the maximum number of MLAs among Opposition parties in Manipur at present, hopes it would get an opportunity to lead a coalition government in the State after the Manipur State Congress Party-led Nipamacha Government was reduced to a minority today.

In a House of 60, the Samata Party has 12 MLAs, 10 of whom led by Mr. Radha Binod Koijam joined the outfit last month leaving the Congress. The Samata is part of a five-party alliance called the Manipur Democratic Front (MDF) along with the BJP (six MLAs), the Nationalist Congress Party (two) and the Manipur People's Party (one) and Janata Dal-S (one).

"The Samata has the largest number of MLAs in the MDF and it expects to get the support of other partners to lead the coalition," the party general secretary, Dr. Shambu Shrivastwa, told *The Hindu*.

Dr. Shrivastwa was leaving for Imphal tomorrow to chalk out the strategy and assist the State unit and instal its MLA as the leader of the coalition.

Mr. W. Nipamacha, heading the coalition of the United Legislature Front, was reduced to a minority after eight Ministers left the Manipur State Congress Party. Mr. Singh's Government faced a no-confidence motion which was admitted by the Speaker of the Assembly, Mr. S. Dhananjoy Singh, on December I, last year. But it could not be taken up since the Assembly was adjourned sine aie after the motion was admitted.

The effective strength of Manipur Legislative Assembly is 59 following the death of a Samata Party MLA last month. The MDF would require support of 30 MLAs to prove its majority which it hopes to achieve with the support of eight MLAs who quit the MSCP Government today.

Much would depend on the role of the Union Minister. Mr. Th. Chouba Singh of the MSCP, who was earlier asked by the party to withdraw from the Vajpayee-led NDA Government. Mr. Singh left here this morning for Imphal.

A senior BJP functionary saw the MSCP threat pullout from the NDA as an internal matter of the party which, he said, was irked after the Samata Pety, another constituent of the NDA, had earlier a manded imposition of President's rule in Manipa

Tiffs in Samata over merger issue continue

Samata Party appears to have ended with the declaration to hold elections for the state councils of Bihar and Jharkhand separately here on January 5 in the local Vidyapati Bhavan. But dif-

ferences inside the party over the issue of the merger between the Samata Party and the JD (U) led by Sharad Yadav have not yet been sorted out.

A decision to hold the party's state council elections was taken here on Sunday by senior party leader and Union agriculture minister Nitish Kumar in consultation with the state legislature party leader Umashankar Singh and other leaders. State election officercum- spokesman of the party P.K. Sinha said that before announcing the date of elections, Mr Kumar had a long telephonic talk with the party's state chief Raghonath Jha. "In fact, it was on the suggestions of Jha that the date of January 5 for the elections was fixed," Mr Sinha said. adding that it had also been approved by the party's national election officer Ram Krishna Hegde.

In the state-level election, state president and members of the national council of the party would also be elected. Elections for both Bihar and Jharkhand would be held in Patna as the members elected to the national council would directly leave for Mysore to participate in the national council meeting to be held there on January 8 and 9.

But seven out of 12 Samata Party

But seven out of 12 Samata Party MPs, including Mr Jha, are still opposing any merger move with the JD (U). Mr Jha told this newspaper on Sunday that he was still holding the view that if Mr Kumar remained adamant on the merger proposal the party would split. Of the 12 MPs, 10 are from Bihar. "At no cost we will allow the merger to formalise," he said, accusing Mr Kumar of inviting trouble to the party. "What was the need for convening the party's legislature party meeting here by Nitish Kumar and taking an authorisation slip from party legislators for the initiation of the merger?" he asked.

His view that it was under a 'conspiracy' that the council meeting was not being convened stood vindicated with the declaration of the election date. On this issue Mr Jha said that this was a good step in the right direction, since the election of the national council of the party was also going to be held soon.

Mr Jha further stated that Mr Kumar, on the other hand, still held the same view that merger between the Samata Party and the JD (U) was the decision of the national council taken at its meeting held on January 6 last.

On the merger with the JD (U), Mr Jha said that the situation had completely changed from what existed in January last and any merger issues should be reviewed in the changed political scenario. "The JD (U) of today is a truncated one with the exit of communications minister Ram Vilas Paswan from it and his floating a new party, and any merger at this juncture would not help the alliance to consolidate backward caste votes in its favour," he stated.

Mr. Prabhunath Singh, one of the dissidents, refuted claims that the issues had been resolved just because they were attending the meeting.


"Nothing is over and we have come here only at the invitation of Mr. George Fernandes. The Samata Party will meet on January 14 to thrash out the issues and this includes the question of leadership in Bihar.

Asked whether the rebel MPs would be satisfied with the decision of Mr. Fernandes, he said 'only if it was favourable to us'' However, he expressed satisfaction over the statement of Mr. Fernandes that there was no proposal before the party for merger with any party. This issue might be treated as closed, he said.

Mr. Raghunath Jha said he had nothing personal against Ms. Jaya Jaitly, who was elected President of the party, but he would have been happy if Mr. Fernandes was elected to the post.

The Union Agriculture Minister, Mr. Nitish Kumar, said he was not affected by the developments, and added that he could not please everyone.

Samata Party is intact: Fernandes

MYSORE, JAN. 8. The Samata Party leader and the Defence Minister, Mr. George Fernandes, today denied that there was split in the party and dubbed it as media speculation.

Speaking after inaugurating the plenary session of the party's national council, Mr. Fernandes called on party members not to be swayed by media comments of a split and maintained that the party had notched impressive gains and was growing in popularity.

Jaya Jaitly reelected

Earlier, Ms. Jaya Jaitly was unanimously re-elected president of the party. Ms. Jaitly's name was proposed by the Union Agriculture Minister, Mr. Nitish Kumar, and seconded by the Uttar Pradesh unit president, Mr. Ramashree Verma. The election of Ms. Jaitly was a foregone conclusion in party circles.

Ms. Jaitly was then authorised to nominate members to the national executive and other office-bearers.

The national council is meeting under a cloud with the dissidents, led by Mr.Raghunath Jha, Bihar unit chief, having threatened to keep off. However, Mr. Fernandes, had a different story to tell. "They were expected to reach here this morning, but heavy fog in Delhi delayed their flight. They waited at the airport for more than five hours and returned home for a wash when the plane took off, and Mr. Jha and others missed the flight." He blamed the media for portraying a mere difference of opinion as a split. The issue of merging with the Sharad Yadav-led Janata Dal (U) was not

directly referred to by Mr. Fernandes, though he mentioned in passing that the party would keep its doors open and was not averse to growing with people who shared similar ideologies.

Mr. Fernandes dwelt at length to the "secular politics" being practiced by other parties and defended the NDA Government. He reiterated that the Government was committed to respecting the judgment of the Supreme Court on the Ayodhya issue.

He said even the Prime Minister, Mr. A.B. Vajpayce, had expressed similar views in his recent "musings" in newspapers and had condemned the demolition of the Babri Masjid. Yet, this was not being welcomed by the Opposition.

Criticising the Congress and the CPI(M) in West Bengal, Mr. Fernandes, said that it was during the reign of the former that more than

4,000 Sikhs were butchered in Delhi following the assassination of Indira Gandhi in 1984.

On Bihar, Mr. Fernandes, in the name of secular politics no development had taken place in the region for the last five years.

Central rule demanded

The national council passed three resolutions including one seeking imposition of President's rule on West Bengal and Manipur. The party expressed distress at the "politics of violence let loose by the Marxist Government of West Bengal against its political adversaries".

In another resolution, the party urged the Centre to make the restoration of democracy in Fiji and the reinstallation of Mr. Mahendra Chaudhary as Prime Minister a priority of its foreign policy agenda.

Samata splits for third ti By K. Balchand No In

PATNA, JAN. 5. Spurning conciliatory moves of the Defence Minister, Mr. George Fernandes, the two factions of the Samata Party, went ahead with their parallel State council meetings virtually splitting the six-year-old party for the third time today.

The only binding factor for the warring groups was that they both happen to swear by Mr. Fernandes with the stress that his decision on party matters would be acceptable. This despite the fact that the two sides remained adamant on their stands caring little for his mediation.

While Mr. Fernandes' inclinations are not known as yet, the factions led by the Union Agriculture Minister, Mr. Nitish Kumar, who has sent his resignation from the Union Cabinet to Mr. Fernandes, and Mr. Raghunath Jha, MP and State unit president, went through the motions of conducting an election process to the State unit president, the State executive and members of the national council, which is to meet in Mysore on January 8. With the two sides claiming themselves to be the real Samata Party, the showdown between the two sides threatens to shift to Mysore, till the party's central leadership cracks the whip on one of them. While the faction led by Mr. Kumar enjoys the majority support of 29 MLAs with almost 26 being on their side, and almost all the district presidents save for five, they can only count on six of the 12 MPs, including Mr. Fernandes, who, however, has not disclosed his

On the other hand, Mr. Jha's faction comprises six of the 10 MPs hailing from Bihar. Needless to say, this faction too counts on Mr. Fernandes. There were at least two legislators, one each from Bihar and Jharkhand, who attended both the meetings in their bid for a patch-up.

The attempt for a rapproachment between the

two sides continued all through the night with the arrival of the Union Minister of State for the Railways, Mr. Digvijay Singh, with the formula suggested by Mr. Fernandes. Mr. Raghunath Jha agreed to call off his meeting provided the one convened by Mr. Kumar too was postponed. Sources maintained that Mr. Fernandes had also sought an assurance from Mr. Kumar that the merger move with the Janata Dal (U) would be shelved.

Mr. Kumar apparently was reluctant to retrace his steps and went through the motions with the cor-sequence that Mr. Jha too held his meeting at a separate venue. The two sides accused each other for the split.

Mr. Singh, giving up his mediation, attended the meeting held by Mr. Kumar, where the latter was authorised to nominate the State president, the State executive and the members of the national council. By a separate resolution, the meeting also authorised Mr. Kumar to take any decision with respect to merger with any party.

The problem in the party had started soon after the legislative wing of the party had adopted a similar resolution in the last week of December, with a section of party MPs opposing it. This faction had sought the intervention of Mr Fernandes to check Mr. Kumar's moves.

Mr. Kumar announced the names of the national council members at the meeting, according to which all MPs of the party have been nominated as exofficio members. At least one of the 11 members nominated directly to the council was present at Mr. Jha's meeting.

Mr. Kumar, however, said that the State president and the executive would be nominated after consultation with all and, in particular, Mr. Fernandes. The other group re-elected Mr. Jha as the State unit chief. The Jha faction too was busy preparing the list of members for its national council.

Samata Party splits in Bihar

THE SAMATA Party today split over the merger with the JD(U), as a last minute bid by Defence Minister George Fernandes to bring about a truce failed. The two factions held their own conventions in Patna.

At its meeting, the breakaway group with six MPs unanimously elected Raghunath Jha as the State chief of what they called the 'real' Samata Party. Nitish Kumar's camp too held a meeting and authorised him to nominate the state president from Jharkhand and Bihar.

The Samata split has now been formalised. It, however, remains to be seen if Fernandes will use his negotiating skills to reunite the factions. Both groups claimed that Fernandes was their leader and they

would do anything to honour his word.

When Fernandes' emissary, Minister of State for Railways Digvijay Singh, made a concerted bid to avert the split, both factions stuck to their stands. In fact, Singh was awake till early morning shutling between Kumar's and Jha's homes, urging them to avoid a split. Singh kept Fernandes informed on the phone.

Even this morning the Railway Minister made a last ditch effort for truce, but the patch up formula did not work. Mr Singh, however, attended the State council meeting of the 'official' Samata, making it clear that Fernandes would be on Nitish Kumar's side in case of a split. In fact, Singh even criticised the rebels for holding a parallel meeting. At one point of time, it was learnt that Jha would call off the

meeting but that was not to be. In fact, Jha conceded that a suggestion to this effect was made by the Railway Minister, but I told him that I was prepared to do that only if Nitish Kumar also deferred his meeting. Since Nitish Kumar went altead with his meeting, we also decided to hold ours."

While the State council meeting called by Kumar's supporters was convened at Vidyapati Bhawan, the one by the rebel MPs was convened at the IMA hall. Out of the 10 Lok Sabha MPs from Bihar, three MPs-Nitish Kumar, Digvijay Singh and Renu Kumari — were present at Vidyapati Bhawan remaining six Lok Sabha MPs — Raghuanth Jha, Brahmanand Mandal, Mahendra Baitha, Manjay Lal, Arun Kumar and Prabhanath Singh — were present in the meeting at IMA hall.

'Accident victim can claim relief'

THE SUPREME Court has held that proof of rash and negligent driving is not necessary to claim damages in accident cases

Distinguishing "no fault liability" from the rule of "strict liability", it said that compensation on account of accident can be claimed under the common law even without the aid of a statute.

A division bench comprising Justice K. T. Thomas and Justice R. P. Sethi ruled that vehicle owners are liable to pay compensation to the victims' kin on the ground that the accident happened while the vehicle was in use.

The ruling followed an appeal by the widow of a road accident victim, Haji Mohammed Hanif. Haji had been run over by a jeep when the driver lost control.

Samata on brink of split over merger with JD(U)

NFIGHTING IN the Samata Party over the contentious question of a proposed merger with the Sharad Yadav-led Janata Dal (U) intensified on Wednesday as leaders opposed to the move, led by vocal party Lok Sabha MP Prabhunath Singh, threw their weight openly and decisively behind Bihar unit chief Raghunath Jha.

The anti-merger MPs group within the NDA constituent—which has 11 MPs in the Lok Sabha of whom 10 are from Bihar—met here at the residence of Jehanabad party MP Arun Kumar under the aegis of Mr Singh to decide on a plan of action in view of its dissent over the key issue.

Among the leaders present at the meeting were Brahmanand Mandal, Raghunath Jha, Mahendra Baitha and Manjay Lal. Party MP Renu Kumari's support was also claimed by the dissident

group.

However, Mr Singh maintained after the meeting that the group was willing to restrain from any drastic action such as splitting the party in the Lok Sabha—much in the same fashion as the JD(U), which recently cleaved apart after Mr Ram



Fernandes: Problems galore

Vilas Paswan harnessed the support of four MPs from the Lok Sabha to form the Lok Janshakti Party — before holding consultations with senior party leader George Fernandes.

"We sincerely hope that he agrees to both our proposals of vetoing a merger with the ID(U) and reinstating Mr Raghunath Iha as the state unit chief," Mr Singh said.

In reply to a query on what the group's course of action would be should Mr Fernandes not endorse these two positions, Mr Singh refused to rule out the possibility of an impending merger.

Mr Fernandes is himself expected to hold priority consul-

tations with Mr Nitish Kumar later this evening with a view to sorting out the problem.

Trouble within the Samata on the contentious question of merger has been brewing rapidly over the last few days since Mr Kumar first made the suggestion following the departure of political foe Ram Vilas Paswan from the JD(U) stable.

The dissent intensified with the approach of the date for election of the party unit chief in Bihar.

The current incumbent, Mr Jha, who has over the last week been raising his voice loudly against agriculture minister Nitish Kumar's proposal for a merger with JD (U) — the two parties contested under the same poll symbol in the Lok Sabha elections — is looking to being reinstated as party unit president in Bihar in the polls scheduled for January 5.

This, notwithstanding the op-position other local leaders, including Nitish Kumar supporters like national general secretary Rajiv Ranjan Singh.

Meanwhile, in the core problem area of Patna, Mr Singh chose to launch a frontal attack on Mr Jha for his "insult" to Mr Nitish Kumar and for seeking to be re-elected to the party state unit chief's post.
