Jogi meets PM after courting arrest Sull By Anita Joshua

NEW DELHI, OCT. 4. Taking a cue from his Punjab counterpart, the Chhattisgarh Chief Minister, Ajit Jogi, took to the streets here to-day and courted arrest along with his entire Cabinet, senior party leaders, and Congress MPs and MLAs from the State to press for Central procurement of pad-

dy from his State.

Though his pressure tactics helped Mr. Jogi get the 64-member delegation to meet the Prime Minister, Atal Behari Vajpayee, with the State's demand that the Centre instruct the Food Corporation of India to buy its entire paddy produce of the year, they returned dissatisfied as all they got was an assurance that their request would be examined.

Later briefing mediapersons, Mr. Jogi said that "when the market price is less, it is the responsibility of the Centre to procure the paddy.

Stating that the Prime Minister and the Agriculture Minister had not given a clear answer to the State's request, the Chief Minister said the State was also

ready to work as an "agent" for the Centre and procure the pad-dy; provided the Government picked up the bill.

Mr. Jogi's scheduled meeting with the Prime Minister early

this afternoon was preceded by considerable "drama with the 64-member delegation being detained when they insisted on proceeding towards 7 Race Course Road despite permission being granted only to the Chief Minister and a few oth-

The contingent led by Mr. Jogi included the AICC general secretaries, Motilal Vora and Ambika Soni, seven Congress MPs, 28 Chhattisgarh Ministers, and 26 party MLAs from the State.

The delegation was detained for violating prohibitory orders when an hour ahead of the scheduled meeting, it began marching towards the Prime Minister's residence from Chhattisgarh Bhawan on Sardar Patel Marg. Prior to marching towards the Prime Minister's residence with his Cabinet and others in tow, the Chief Minister met the Congress president, Sonia Gandhi.

While Chhattisgarh had also demanded an increase in the procurement price of paddy, Mr. Jogi's contention is that even at the existing price of Rs 550 a tonne, the Centre should buy the entire produce of the State as it had suffered a loss of Rs. 423 crores on this count last year.

CHENNAI, DEC. 30. The 'Q' Branch CID today filed a charge sheet against the MDMK general secretary, Vaiko, 172 days after he had been remanded to custody under the Prevention of Terrorism Act, for an alleged pro-LTTE speech he made at Tirunamgalam near Madurai. Eight other party leaders, Veera Ilavarasan, Bhoominathan, Madurai Ganesan, Alagu Sundaram, P.S. Manian, Pulavar Siyozthiannan, Canacamurthy, and Sivanthiappan, Ganesamurthy and Nagarajan, who were arrested earlier,

were also named in the charge sheet.

The 'Q' Branch seeks to prosecute
them under Sections 21 (2) (arranging, managing or assisting in arranging or managing a meeting with the knowledge that is for supporting a terrorist organisation and furthering its activities, or that it is to be addressed by a person who belongs or professes to belong to a terrorist organisation) and 21(3) (addressing a meeting for encouraging support for a terrorist organisation or to further its activities) of the POTA. (Mr. Vaiko has challenged Section 21 of the POTA in the Supreme Court, saying it is violative of Article 19 (freedom of speech)

CHENNAI, OCT. 31. Despite strong opposition, the controversial Prohibition of Forcible Conversion of Religion Bill was today passed by the Tamil Nadu Assembly with the AIADMK and the BJP outvoting the combined opposition of the DMK, the Congress, the Pattali Makkal Katchi and the Left

Although the Chief Minister, Jayalalithaa, maintained that the Bill was only intended to prevent forcible conversions, her arguments in the course of the three-hour debate were against conversion itself. "Conversions create resentment among several sections and also inflame religious passions, leading to communal clashes.

Invoking Mahatma Gandhi, Ms. Jayalalithaa sought to justify a ban on all conversions. Gandhiji, she said, had stated that conversions were harmful and that if he had the power to legislate, he would have stopped all proselytising activities. She claimed that conversions only led to the isolation of the converted.

Also, casteist feelings remained even af-

ter conversion.

At the end of the heated debate, the Opposition parties pressed for a division of votes, causing embarrassment to the minority members of the ruling party and its ally, the breakaway Tamil Maanila Congress (TMC) group. However, the Opposition lost the battle by 140 votes to 73.

Ms. Jayalalithaa, while claiming that the Bill was meant to prevent exploitation of the depressed classes, insisted that the ruling AIADMK would not move away from its Dravidian moorings.

In one of the fiercest and lengthiest debates in the Assembly yet, the Opposition members sparred with the Treasury benches, insisting that the Bill would create communal disharmony. Soon after the Congress floor leader, S.R. Balasubramaniam, moved the disapproval motion against the ordinance on forcible conversions, the DMK whip, E. Pugazhendi, asked the Chief Minister to name the "anti-socials and vested interests trying to exploit the depressed classes" as mentioned in the explanatory note to the Bill. As the Bill banned conversions through the grant of "material benefits either monetary or otherwise", even the reservation and other benefits offered by the State Government to the Dalits, which ensured their continuance in Hinduism, could be construed as illegal and Ministers could be proceeded against.

When Anwar Rhazza (AIADMK) pointed out that similar laws existed in the Congress-ruled Madhya Pradesh as well, the Congress and the Treasury benches were locked in a heated wrangle. While Mr. Balasubramaniam retorted that not a single case had been filed under the law in Madhya Pradesh, Ms. Jayalalithaa asked why the Congress regime had not repealed the Act

The Congress member, K. Jayakumar, charged that the AIADMK regime's intention was only to "toe the Hindutva line and protect a particular community". By fixing a higher penalty for converting the Scheduled Castes and the Scheduled Tribes, the legislation demeaned the Dalit community, the CPI MLA, G. Palanichamy, alleged. But Ms. Jayalalithaa insisted that a higher penalty had been fixed only because the Dalits were a "vulnerable section".

When the CPI (M) woman member, Balabarathi, who mounted a severe attack on the Bill, referred to the inflammatory remarks made by Hindu outfit leaders in Madurai recently, the Speaker, K. Kalimuthu, expunged her remarks on the ground that it would affect communal harmony

The Bill also triggered a face-off between the DMK and the BJP — both constituents of the NDA Government at the Centre when the BJP member, H. Raja, criticised the perceived anti-Hindu remarks made recently by the DMK president, M. Karuna-

The Assembly also adopted a Bill banning the ritual of burying drugged children alive and retrieving them a minute later to propitiate deities, practised in southern parts of the State.

Jayalalithaa justifies ordinance on conversion

NEW DELHI, OCT. 18. The Tamil Nadu Chief Minister, Jayalalithaa, today justified the promulgation of an ordinance banning forceful conversions stating that it was done in the interest of the State. Talking to reporters at the conclusion of the Chief Ministers' conference on fiscal reforms, she said, the aim was to prevent conversions by induce-

Asked what was the sudden need for the ordinance, Ms. Jayalalithaa said that "what we have done is in the interest of the State. People were forced to convert through fraudulent means and inducements and offered Rs. 2,000 to Rs. 5,000 exploiting their dire poverty. They were doing so without knowing the consequences and the Gov-ernment had to intervene to prevent this.

Asked whether her move was aimed at coming closer to the BJP at the Centre, she said: "It is a loaded question and totally ir-relevant." She did not make any request to the Prime Minister on the Cauvery issue

Asked about the CMs' conference, she said, "in my view, fisreforms and rapid development should go together." Most of the Chief Ministers were in broad agreement with

her viewpoint on many issues.

Regarding implementation of the revised pay scales and benefits to judicial officers as directed by the Supreme Court, Ms. Jayalalithaa said, "the States are not in a position to bear this burden. When the States are trying to cut back even on the existing rates of compensation. it is impossible to entertain this new burden.

The Centre has to take the lead in resolving this impasse and take up the issue with the Supreme Court.

Christian groups to observe 'prayer day'

HYDERABAD, OC. 18. The Tamil Nadu ordinance to check forced conversions had its echo in Andhra Pradesh today. In a rare show of unity, Christian groups and organisations, belonging to both the Catholic and the Protestant sects, came together to fight the ordinance.

A hectic campaign is on by these groups to mobilise the Christian public for participation in demonstrations planned at the Tamil Nadu Secretariat and the Assembly at Chennai on October 24. All churches in Andhra Pradesh, Catholic and Protestant, will observe Sunday (October 20) as "prayer day" for resolving the issue, said Jatti A. Oliver, chairman of the joint commission of the Andhra Pradesh Council of Churches and the A.P. Catholic Bishops' Council after a meeting of the highest policy-making bodies of the two sects here today. The meeting demanded withdrawal of the "draconian law", describing it as a blatant intrusion by the State into personal domain and an attempt to intimidate dalits and the poor who were struggling to free themselves from the caste system and

As part of the agitation, a number of organisations, including the All-India Christian Council, have sent telegrams and letters to the Tamil Nadu Governor, P. S. Ramamohan Rao, demanding repeal of the ordinance.

Dubious courtship

Jayalalitha tries fundamentalist approach

Think of any autocratic measure, and it will find favour with Jayalalitha; she can even cook up one herself. The latest Ordinance by her government, passed to curry favour with the ruling BJP dispensation at the Centre, belongs to the latter category. The ordinance is loosely phrased and can be used to persecute anybody associated with religious conversions. According to the ordinance, conversion through "force, allurement or fraud" will be subjected to draconian punishment, up to four years in prison and a fine of Rs 1 lakh. The formulation is itself fraudulent, as allurement or fraud in context is extremely subjective — how can administrations and courts pronounce on what is "fraud" in a theological sense, unless this is the first move towards a theocratic state? For upholders of a particular religion, any case of conversion away from it will appear vitiated by allurement or fraud rather than what it may well be, an exercise of one's personal choice. Since what is at issue is mostly the conversion of Dalits to Christianty, Islam or Buddhism, if a destitute Dalit should choose to better his material conditions of existence and free himself from the discrimination and hostility he often encounters in the Hindu fold by converting, does that count as "allurement"? Isn't this the modern world, where we are all supposed to try to improve our existence? Doubly insulting is the provision which increases the penalty for those converting women as scheduled castes. Are these categories of human beings and change deemed to be of feeble mind, less able to decide their religious affiliation and more in need of "protection"? That surely goes against another constitutional guarantee, that of equality of all citizens before the law.

It may be more interesting to speculate on reasons for Jayalalitha's timing. Having ditched the NDA before, she is now desperate for a patch-up, and is sending a series of signals designed to warm the cockles of Hindutva hearts, a recent one being when she slammed Sonia Gandhi's foreign origins. She pointedly refused to join other chief ministers in condemning Narendra Modi for sponsoring riots in Gujarat. Her government has also started serving midday meals to temple devotees, which violates the secularism enshrined in the Constitution. It could also, incidentally, constitute "allurement" — if the logic of the ordinance is followed, she ought to be put away herself. That, of course, will not happen — the yoke of the ordinance will fall exclusively on minorities, which proves how faulty it is. There ought to be a rash of court cases against the ordinance whose thrust is against Article 25 of the constitution guaranteeing freedom of religion. And the NDA must make up its mind whether it will allow itself to be fooled once again by Jayalalitha's transparent charms.

T.N. calls general strike

CHENNAI, OCT. 7. In a show of solidarity on the Cauvery issue, an all-party meeting here today decided to observe a dawn-todusk general strike on Wednesday protesting the refusal of the Karnataka Government to release water as per the directives of the Supreme Court and the Cauvery River Authority.

The Chief Minister, Jayalalithaa, told reporters that all the parties had unanimously endorsed the strike call. Although the main Opposition party, the DMK, boycotted the meeting, it announced support for the strike call.

Ms. Jayalalithaa accused the Prime Minister, A.B. Vajpayee, and the Union Law Minister, Jana Krishnamurthy, of abdicating the Centre's responsibility to ensure Cauvery water to Tamil Nadu. Although the State Government knew the general strike would not yield water, the

meeting wanted to impress upon the Centre and the Karnataka Government that Tamil Nadu was united on the issue.

We expected to get justice from the Supreme Court," she said. While the Union Law Minister had stated that it was for the two States to resolve the issue, and that the Centre could not intervene, the Prime Minister had remarked that the issue was before the Supreme Court. The Centre had thus washed its hands of the matter.

The State Government would be filing the second contempt petition in the Supreme Court tomorrow. The Centre should issue directives to the Karnataka Government under Articles 256 and 365, and if Karnataka failed to comply, the Krishna Government should be dismissed, she said.Karnataka's defiance of Constitutional authorities would lead to Constitutional anarchy in the country, she added.

Tamil Nadu bans religious conversions

Chennai: The state government on Saturday
night promulgated an ordinance banning religious conversions by "force, allurement or fraudulent means". Tamil Nadu is the first state to have such an order in place.

"No person shall convert or attempt to convert either directly or otherwise any person from one religion to another either by use of force or by al-lurement or by any fraud-ulent means," the Tamil Nadu Prohibition of Forcible Conversion of Religion Ordinance, issued by governor P.S. Ramamohan Rao, said.

Just a month ago, the

conversion of Harijans to Christianity in Madurai had made the headlines. Although it was claimed to be a voluntary exercise, there were reports of force and exploitation.

The state government said the ordinance had been promulgated to deter people from exploiting those from depressed classes. "It may also be useful in nipping in the bud the attempts of religious fundamentalists and subversive forces to create communal tension under the garb of conversion," the notification said. It also entailed that conversions should be reported to district magistrates.

Those violating the or-dinance will be imprisoned for up to three years and fined up to Rs 50,000. The jail term could extend to five years and the fine to Rs 1 lakh if the convert happened to be a minor, a woman or a member of an SC/ST.

Hailing the ordinance, Kanchi Sankaracharya Jayendra Saraswathi has called for a similar law covering the entire country. "This law will help foster peace, harmony and unity in our society," he said.

PRO-LTTE SPEECH TAPES SEIZED

Vaiko's premises raided

CHENNAI/NEW DELHI, Aug. 8. — Police today searched the premises of MDMK leader Mr Vaiko and eight other party workers. They were arrested last month under Pota for speaking in support of the LTTE at a rally in Thirumangalam on 29 June.

Police have reportedly sought permission to search the New Delhi house of Mr Vaiko, who is a Rajya Sabha member and whose party is an NDA partner. A Tamil Nadu police team visited the Lodhi Garden house this evening.

evening.

Mr Vaiko's personal secretary, Mr AS Pandya, said in Delhi: "We've a tip-off that a Tamil Nadu police team left Chennai for New Delhi in the evening. They're likely to conduct a raid here at 6 a.m. tomorrow."

The searches were conducted by the 'Q' branch police, which handles cases related to extremist outfits.

Police raided Mr Vaiko's houses in the city and his native Kalingapatti village in Tirunelveli district around 7 a.m. Among the premises raided were the MDMK headquarters in the city and the party's office in Sivakasi.

Mr Vaiko's lawyers said police had seized a copy of the speech made by the leader in Geneva recently. A few video- and audiocassettes containing Mr Vaiko's speeches and a few pamphlets on the LTTE movement, too, were confiscated. Partymen at the headquarters protested when police insisted on seizing some papers relating to income tax returns. A police officer said: "Whatever has been seized will be placed before the Pota court."

Mr Vaiko's friend and lawyer, Mr RG James, said though the state police team was reportedly carrying a search warrant, it wouldn't be allowed to search the premises unless it's accompanied by Delhi Police. "As far as we know, the local police haven't been informed. We know how to deal with Jayalalitha's puppets."

An officer said Delhi Police

An officer said Delhi Police had no information about any proposed raid by TN police at the Lodhi Garden house.

BJP reaction: The BJP today said there was no reason to raid places Mr Vaiko had visited. The government's action shouldn't look like "political vendetta", party spokesman Mr Vijay Kumar Malhotra said. The BJP and NDA are "fully with Mr Vaiko", he said.

MS. JAYALALITHAA'S ANTI-LTTE drive — which has resulted in a slew of arrests under POTA over the last three weeks --- has assumed a new significant dimension. Her demand that the MDMK leader, M. Kannappan, he dropped from the Union Council of Ministers transports the support-for-LTTE issue squarely into the lap of the Vajpayee Government. In her letter to the Prime Minister, Ms. Jayalalithaa makes two points simply and forcefully. First, that Mr. Vajpayee's Minister of State for Non-Conventional Energy is an open supporter of the LTTE, a banned organisation. Second, that his speeches at various public meeting in recent times constitute an offence under Section 21 of POTA, the very provision which has been invoked to arrest other LTTE sympathisers such as the MDMK leader. Vaiko, and the Tamil Nationalist Movement leader. Nedumaran.

In a strictly formal sense, Ms. Javalalithaa's demand for the ouster of Mr. Kannappan may not have a legal or constitutional basis. But the grounds on which such a demand is raised cannot be dismissed lightly. Union Ministers are expected to lay down and enforce the law. They are not expected to express their support or sympathy for organisations that have been specifically outlawed, particularly one as dangerous and odious as the LTTE. Mr. Kannappan appears to have missed this point completely when he clarified that his and his party's support for the LTTE is only in the nature of "moral support". As a Union Minister, he ought to have understood that any kind of support for a banned organisation is not permissible. Moreover, that he cannot allow his ideology (warped as it is on issues such as the LTTE and Tamil nationalism: to (ake precedence over the law of the land.

The basic truth of this completely overrides and remains unaffected by the other issues which Ms. Jayalalithaa's anti-LTTE drive has raised. These include reservations about the use of POTA—a

piece of legislation which undoubtedly contains a number of harsh provisions which are liable to misuse. They also include opposition allegations about the Tamil Nadu Chief Minister's motives for launching such a high-profile anti-LTTE drive the point here being that actions deserve to be judged on their merit, not examined purely in terms of possible motive. Mr. Vajpayee's Government may choose to ignore Ms. Jayalalithaa's missive, but the chances are that this is not the last it will be hearing on this issue. One part of the Tamil Nadu's Chief Minister's charge against Mr. Kannappan is explicit and clear-cut (namely, that he has allegedly committed an offence under POTA for making specific utterances) and therefore is unlikely to be forgotten or overlooked.

But there is a larger issue here — one that goes beyond the issue of letters, arrests, chargesheets, allegations and counter-allegations. One facet of this is the extremely disturbing fact that the LTTE - the organisation which carried out Rajiv Gandhi's assassination and which continues to pose a subversive threat — continues to enjoy the support of some political parties within Tamil Nadu. The other — and arguably just as important aspect — is the legitimacy which organisations which blatantly support the LTTE have come to enjoy within the political mainstream. The fact that parties such as the MDMK and the PMK have been able to strike political alliances and be accommodated cosily into coalition Governments is a reflection on the narrow and self-serving concerns of almost every section of the political class. As for the Vajpayee Government, it has been less than serious — despite its attempt to project a tough face against certain kinds of terrorism about containing the LTTE and its influence within India. If the recent happenings in Tamil Nadu set off a debate about how the LTTE and its sympathisers should be isolated and contained, then they would have served a very worthwhile purpose indeed.

DANGEROUS AND DESTRUCTIVE NO

THE DEMAND FOR the bifurcation of Tamil Nadu mooted by the PMK, with the Vanniyar-dominated districts making up a new State, is patently provocative and incendiary. For all its seeming innocuousness, the proposition as canvassed by the casteist party is not just totally unwarranted but extremely dangerous on counts more than one. To begin with, such demands for a bifurcation/trifurcation of States have almost invariably been impelled by narrow partisan and divisive considerations although they are sought to be justified on the basis of presumed grievances such as the neglect of development needs and denial of a 'fair' share in political power, employment opportunities and so on. In fact, as a general rule, the experience of smaller States has hardly been such as to vindicate the 'regional development' line of argument trotted out for bifurcation. If anything, the negative fallout in terms of fuelling fissiparous tendencies has been so overwhelming that the national need is for a reversing of the process. Viewed in this perspective, the recent creation of Chhattisgarh, Uttaranchal and Jharkhand was undoubtedly ill-advised and regressive.

What makes the PMK's demand much more reprehensible than, for instance, the one for Telengana (Andhra Pradesh) — or, for that matter, the three newly-formed States (cited by the PMK supremo, S. Ramadoss, in support of his case) — is the perniciously divisive character of its defining criterion, namely 'caste'. Already, the socio-political class of Tamil Nadu has to contend with 'active' tectonic fault lines of caste, thanks to the cynical game played by the rival caste leaders the likes of Dr. Ramadoss — in the name of political mobilisation and the aggressively provocative ways they adopted to gain their ends. One dreads to visualise the damage potential of a caste-based bifurcation of the State, the repercussions of which will certainly not be confined to Tamil Nadu but extend to other parts of the country as well.

Lending a vicious and sinister dimension to the

PMK's call for bifurcation is, above all, the imm diate political context in which it has been made. It has to be seen against the backdrop of the party obsessive support to the cause of 'Tamil Eelam' and unconcealed admiration for the outlawed LTTE and its supremo, Velupillai Prabakaran, a proclaimed offender in the Rajiv Gandhi assassination case. In the face of the Javalalithaa Government's recent crackdown on pro-LTTE elements, the high point of which was the arrest of the MDMK leader, Vaiko, under the special anti-terror law (POTA), Dr. Ramadoss struck a note of defiance by reiterating his pro-Eelam stance and sympathies for the LTTE. Clearly discernible is a concerted effort by the pro-LTTE political elements and the various extremist Tamil chauvinist and subnationalist groups (most of them draw inspiration and encouragement from the LTTE) to join forces and redraw their strategy for carrying on their insidious campaign by subtle and not-sosubtle means. A case in point is the Chennai conclave of the 'World Tamil Federation' - the ostensible objective of which is to "restore" linguistic, cultural and ethnic glory of the Tamils and ultimately to "retrieve" the land of Tamils where the forum was used for singing paens to the LTTE and Mr. Prabakaran. And this, in spite of a specific injunction by the High Court.

Obviously a ploy cast in this overall mould, the 'bifurcation' demand of the PMK is nothing but a scarcely velled attempt to promote the Tamil separatist campaign, with Mr. Prabakaran as the icon, and it has therefore to be summarily rejected by every segment of political opinion. More important, however, is that the ruling establishment at the Centre view its coalition partners, the MDMK and the PMK, for what they really are and be more aware of their sinister 'ideological' planks — as evidenced by their unabashed and obdurately overt pro-LTTE scance. The Vajpayee administration will have to take a categorical stand against this clear threat to national unity.

Pota action against Vaiko not justified, says George

Chennai: The Tamil Nadu government's action under Pota against MDMK chief Vaiko for his pro-LTTE speech was not justified, defence minister and National Democratic Alliance convenor George Fernandes said on Friday.

Mr Fernandes, who met Mr Vaiko at the Vellore Central Prison on Friday, said, "Pota was enacted to deal with terrorism in our country. What has happened (in Vaiko's case) does not come within the ambit of Pota. He should not have been imprisoned.'

The defence minister said he had listened to a tape of Mr Vaiko's speech supporting the LTTE on June 29 at Thirumangalam, and found "nothing in it to warrant his arrest under Pota

Mr Fernandes said the Centre had no proposal to intervene in securing Mr Vaiko's release. "He is a revolutionary. He does not need our support," said Mr Fernandes, a one-time supporter of the

conferences organised by the supporters of the banned group in India. Mr Fernandes, who is the first NDA leader and Union minister to meet Mr Vaiko after his arrest, also ruled out any action by the Centre against the state government.

Later in the day, he cancelled his appointments with Tamil Nadu chief minister J. Jayalalithaa and former chief minister and DMK chief M. Karunanidhi. Ms Jayalalithaa told mediapersons that Mr Fernandes had cancelled the appointment saying that he had received urgent summons from the Prime Minister.

The MDMK has been a loyal partner of the NDA and Mr Vaiko was one of the supporters of the Pota bill. However, after Mr Vaiko was arrested and the home ministry received the video clipping of the speech made by him, the Centre remained silent on the issue. Not willing to embarrass the Centre further, Mr Vaiko, too, had decided to fight the battle on his own.

The Congress was a little wary, not wanting to comment on "wire reports" that an attempt was being made to ban the MDMK. The party spokesperson, Anand Sharma, said that as far as the principle was concerned every organisation, including political parties, had to function within the ambit of the Constitution and the law of the

The BIP, on the other hand, is of the view that banning political parties was itself a dangerous thing. After all, in the system of parliamentary democracy the attempt is always to bring even fringe groups within the ambit of the legitimate political process. This happened in the case of the Akalis (despite the illegal Anandpur resolution), this was also true of some naxalite groups. As far as the Election Commission is concerned, the BJP view is that the Commission could not be allowed to function as an ideological ombudsman. While taking different positions, there is agreement between the BJP and the Congress on one point — whether POTA was applicable to Mr. Vaiko and his partymen would depend on the "evidence"

against them. The BJP, though, is inclined to think that by this action the AIADMK has already forced the MDMK to give a written explanation on its support to the LTTE, say ing it is limited to supporting the cause of Sri Lankan Tamils. That is a political victory for the AIADMK, and the BJP view is that matters should have been left there.

"I do not consider Mr. Vaiko as a rival at all. He never has been a competition to me, he never will be," she said. The arrest situation was not of the Govern-ment's choosing. "Left to me, I would rather not have taken this action," she added. Asked why police had sought non-bailable warrants when

these were not necessary under POTA, she said they felt that these were necessary.

Asked about the use of POTA against other parties such as the PMK, the DPI and the DK, which are also supportive of the LTTE, she said the statements of the leaders of these outfits were 'carefully worded'' and did not attract the provisions of POTA. But if they supported the LTTE openly in the manner of Mr. Vaiko, the Government would take action against them too.

Asked about the BIP's description of the arrest as "unwarranted", Ms. Jayalalithaa said the statement of the BJP spokesman, Arun Jaitley, was made out of "political compulsions." The arrest of Mr. Vaiko would not give "new strength to Tamil nationalist groups. The Government would put down the activities of such groups with an "iron hand."

If people like Mr. Vaiko, who glorified a terrorist and criminal like Prabakaran, were allowed to make statements in support of the LTTE, it would corrupt the mind of a whole generation. The LTTE was a terrorist organisation and its leader, Prabakaran, was a proclaimed offender in the Rajiv assassination case.

Answering a question, she said she was not involved in any way in the Sri Lankan peac process, but she had warned the . Vaiko held, vows to oust Jaya Chennai: MDMK general secretary V. Gonalasamy, popularly Hot Pota now served on Chicago-Chennai Express

Chennai: MDMK general secretary V. Gopalasamy, popularly known as Vaiko, was arrested here on Thursday evening for his recent speech supporting the Lankan ter-rorist outfit, the Liberation Tigers of Tamil Eelam.

A special police team from Madurai executed the non-bailable arrest warrant against Mr Vaiko as he emerged from the arrival lounge at Meenambakkam airport from Mumbai, where he had stopped over on his return from Chicago in the early hours of Thursday.

Mr Vaiko, who represents the Sivakasi Lok Sabha constituency, became the first member of parliament to be arrested under the prevention of terrorism act (Pota), which he had stoutly supported during its enactment in parliament earlier this year.

His arrest follows a case registered against him under Pota for his speech at an MDMK rally in Thirumangalam on June 29 expressing support for the LTTE. Eight of his party leaders have already been arrested under Pota on similar charges.

The Jet Airways flight from Mumbai landed in Chennai at 4.20 p.m. after which the MDMK leader. well aware that he would be arrested the minute he stepped out of the airport, took his time to freshen up and meet his family inside the VIP lounge. As soon as he came out of the Kamaraj domestic terminal, he was served the non-bailable warrant by investigating officer DSP Karnan and Madurai rural SP Ayushman Tiwari and taken into

"We will not fear the repression let loose by the fascist Javalalithaa government. We will fight this fascist regime with the people's force until it is thrown out. If Jayalalithaa really wanted peace in the state, she would not have instigated this. Eight thousand of my people have been arrested," the 59year-old firebrand BJP ally told the hordes of mediapersons clamouring to get his reaction.

Shouting to be heard above the din of the media, Mr Vaiko said, When Jayalalithaa was convicted in a corruption case, she instigated her supporters to burn buses..three girls were burnt alive. But we will not disturb the people. We will not disturb the peace. We will not burn buses. We will neither shut down shops nor stone them. We will not seek the Centre's help, instead we will use the people's force."

Vaiko arrested, stands by LTTE

CHENNAI, July 11. — The Tamil Nadu government today arrested MDMK leader Mr Vaiko under Pota after he landed at Chennai airport. Mr Vaiko was served the arrest warrant outside the terminal by a police team from Thirumangalam in Madurai, where he had made a pro-LTTE speech on 29 June.

Earlier in the day in Mumbai, anticipating his arrest, a belligerent MDMK chief vowed to take on Tamil Nadu's "fascist" chief minister Miss J Jayalalitha, who, he said, had let loose a "repressive regime" against her political opponents. He said he was "sup-

porting the LTTE's struggle" in Sri Lanka and was not fomenting violence in Tamil Nadu.

Mr Vaiko will be produced before the judicial magistrate at Thirumangalam tomorrow morning, the state DGP, Mr BP Nailwal, said. He is likely to be remanded in judicial custody for 30 days like his eight other party colleagues and may be lodged in Madurai Central prison.

Mr Vaiko arrived in Mumbai from Chicago at 2.00 a.m. on Thursday and later flew to Chennai in the afternoon.

The puratchi puyal (revolutionary storm) — as Mr Vaiko is referred to by his partymen — appeared bewildered as the police

contingent surrounded the terminal as he came out of the Jet Airways craft at 4.30 p.m.. But he regained his composure and talked to his wife, Mrs Renuka Devi, and other family members, for about half-an-hour in the lounge. As he came out of the airport complex, Thirumangalam police served him with the arrest warrant. He was then whisked away to Thirumangalam.

The Marumalarchi Dravid Munnetra Kazagham chief was allowed to speak to the media briefly before he was taken into custody. Picking up from where he had left in Mumbai, Mr Vaiko said: "The MDMK will not fear the repression let loose by the

fascist Jayalalitha regime. We will fight it till the end... we will not seek the Centre's assistance. But we will use people's force to throw this fascist regime out of power."

More than 3,000 MDMK partymen were taken into preventive custody from last night while MDMK supporters were flushed out of the airport. RAF and CISF jawans were deployed along with state policemen in and around the terminal. Miss Jayalalitha, however, remained incommunicado.

In Mumbai, the MDMK chief said: "I have always supported the LTTE and even said so in Parliament".

Cops on toes on Vaiko return-eve

Chennai, July 10: Tamil Nadu police are treading with caution on Vaiko's arrest in an effort to avoid a repeat of the Karunanidhi bungle, which drew allegations of human rights violations and left the administration red-faced.

The MDMK leader, an ally of the Vajpayee government, is facing arrest under the Prevention of Terrorism Act for speaking out in support of the LTTE. A non-bailable warrant was issued against him in Madurai late last night.

Eight party activists charged under the Act, including former MP Ganeshamurthy, were arrested last evening and sent to Madurai central prison. They

Madurai central prison. They had organised a rally at Thirumangalam in support of the banned militant organisation.

Late tonight, senior leader L.

Late tonight, senior leader L. Ganesan and 15 MDMK activists were held in Thanjavur.

But the police are being cautious in the case of Vaiko, who is expected to arrive here tomorrow afternoon from the US.

The city was rife with speculation that a special police team, led by Thirumangalam DSP Karnan, might take Vaiko into custody in Mumbai, where the Air-India Chicago-London-Mumbai-Chennai flight is scheduled to land around midnight.

The expectation of a "midnight drama" at Mumbai airport gained ground after Ganesan called upon workers to come to the airport in large numbers to greet Vaiko, raising the spectre of a possible law and order problem that the police would want to avoid.

However, state director-general of police B.P. Nailwal said there was "no possibility" of taking Vaiko in custody in Mumbai. "We have no control over these rumours," he said after a highlevel meeting with top officials, including home secretary Naresh Gupta. Tamil Nadu police will have to obtain a "transit warrant" and clearance from civil aviation authorities to arrest Vaiko in Mumbai, before he takes the connecting flight to Chennai. The police may not have the time for such things now.

For strategic reasons, the police are keeping the arrest plan under wraps. Asked about Vaiko's arrest being "imminent" now that a warrant had been issued, the DGP said: "I cannot say anything right now." He parried another query on whether Vaiko would be taken straight to Madurai for remand.

"Should a large crowd turn up at the Chennai airport, we will tackle the crowd and we don't expect any trouble," the officer said, adding that preventive arrests of MDMK workers could begin tonight. Security in the city has already been beefed up.

Ganesan, in a statement from Thanjavur, said Vaiko had not opposed the anti-terror law. "We continue to support that law.... We only oppose wrongly invoking the Act against Vaiko."

The ban on the LTTE existed even before the anti-terror law was enacted, Ganesan said. He pointed out that even the RSS was once an outlawed outfit, but the ban was later lifted. The ban on the LTTE could be similarly revoked, he said. Therefore, to link Vaiko's action to an "offence under the anti-terror Act" was misguided, Ganesan argued.

The Jayalalithaa Government today arrested six of the eight MDMK functionaries who had been booked under Pota for speaking in support of the LTTE at a public meeting on June 29.

The MDMK leader, Vaiko, who had been booked too, is in Chica-

An undaunted Vaiko, against whom a magistrate declined to issue a non-bailable warrant, announced that he would return to Chennai as scheduled, on July

In a statement from Chicago, Vaiko asked his party men to maintain calm.

He described the arrests as a "repressive measure" against the Opposition. The MDMK leader said that it was now clear that Jayalalithaa was out to wreak political vendetta and throttle democracy by misusing the Pota.

The arrests of the MDMK members removed any doubt that the Tamil Nadu Chief MInster might go slow in arresting Vaiko.

It is now certain that the MDMK leader will also be put behind bars when he returns here from the United States of America on Thursday afternoon.

After procuring arrest warrants from the judicial magistrate of Thirumangalam late on Monday night, police teams arrested four of the accused at Madurai and one each at Erode and Kariakudi on Tuesday morning.

All the arrested, including former MP A Ganesamurthy, were produced before the Thirumangalam magistrate.

The police are searching for two other accused though MDMK sources said they had not gone underground and were very much present at their homes.

Look at how Section 21 (3) is worded: "A person commits an offence if he addresses a meeting for the purpose of encouraging support for a terrorist organisation or to further its activities". In any case, any safeguards in this law come into force only when the court comes into the picture — in the meanwhile, those booked under the law stand to lose over six months of their lives in the cooler. Ironically, Vaiko had enthusiastically supported the passage of this Bill in Parliament although, to grant him his due, he had suggested some safeguards, including a reconsideration of the definition of a "meeting" arranged in support of a terrorist organisation, under Section 21 (2) and (3)—the precise sections under which he is currently booked. Call it intimations of incarceration or plain nemesis!





Case registered against Vaiko vo to

MADURAI, JULY 4. The Tirumangalam police here today registered a case against the Sivakasi MP and MDMK general secretary, Vaiko, and eight others, under various sections of the Prevention Of Terrorist Act (POTA), the Unlawful Activities (Prevention) Act, 1967 and the IPC. This is the first time that the provisions under POTA are being invoked in Tamil Nadu.

The others charged in the case include Veera Ilavarasan, Bhoominathan (Madurai urban district secretary), Ganesamoorthy (Erode district secretary of the party), Sivanthiappan (Sivaganga district secretary) and four others.

Mr. Vaiko and the others are charged with making pro-LTTE speeches at a meeting organised by Mr. Ilavarasan in Tiru-

mangalam on June 29. "The speech of the above said persons instigates the public, that it is not wrong to support an organisation which has been banned and exhorts the public to go against the law by supporting an outlawed organisation," says a police report to the Government which adds that "the speeches are likely to endanger the nation's security and integrity as per the provisions of the Unlawful Activities (Prevention) Act, 1967".

Police sources said the case was registered based on a specific complaint preferred by the Tirumangalam Inspector, N. Thangavelu, that "the speech of the MDMK cadre had created a panic among the people who were wondering why the Government was not invoking POTA despite introducing it".


The allegations are that Mr. Vaiko has

said in his speech that "he was, is and will continue to be a supporter of the LTTE". He is also said to have claimed that the LTTE was not promoting terrorism and its sole cause was the liberation of 'Eelam'. The cases have been registered under Section 21(2)(3) of the POTA, Section 13 (1)(a) of the Unlawful Activities (Prevention) Act, 1967, and Sections 109 (abetment) and 120(B) (sedition) of IPC against the accused. The police also claimed that Mr. llavarasan presented a memento resembling a tiger cub to Mr. Vaiko.

The issue sparked tension almost instantly in parts of the Sivakasi Lok Sabha constituency in Virudhunagar district. Suspected MDMK cadre pasted posters condemning the Chief Minister, Jayalalithaa. Three persons were arrested.

Vaiko rebuffs Jaya threat, reaffirms support for LTTE

IN A statement faxed from Chicago, USA, MDMK leader Vaiko has unequivocally reaffirmed his support to the LTTE's struggle for a better life for the Sri Lankan Tamils. He re-

called how he had made a similar statement on the floor of the Lok Sabha during the debate on POTA.

Asserting that Jayalalithaa was seeking to misuse the Act to persecute her political adversaries, he said he would not be cowed down by any show of force on the part of the state government.

At the same time, he also took care to call upon his followers to stick to the path of peace

and noted that his party had "never encouraged violence in the state."

This is not the first time since the AIADMK's return to power in June last that Vaiko has made such statements. In fact, right after the enactment of POTA a few months ago, Vaiko had dared her while speaking at a public meeting in Chennai. But no action was taken then. First, he travelled incognito to Jaffna at the height of the IPKF-LTTE confrontation, met Prabhakaran and expressed his solidarity with him, but when DMK chief Karunanidhi suspended him, he chose to lie low and got himself reha-

bilitated subsequently. Again when the LTTE was banned in the wake of Rajiv Gandhi's assassination, he contented himself with some symbolic protests.

We will arrest Vaiko, says Jayalalithaa

CHENNAI, JULY 2. While asking the Centre to take action against the MDMK leader, Vaiko, for his pro-LTTE speeches, the Tamil Nadu Chief Minister, Jayalalithaa, today declared her Government's intention to arrest him.

In a letter to the Deputy Prime Minister, L.K. Advani, the Chief Minister referred to Mr. Vaiko's speech at Thirumangalam in Madurai district on June 29 and said it attracted the provisions of the Unlawful Activities (Prevention) Act and the Prevention of Terrorism Act. "We have no other option but to proceed against the individual both under POTA and under the Unlawful Activities (Prevention) Act and to arrest the individual who has blatantly spoken in support of the terrorist outfit in total disregard and defiance of the laws of the land," she said. Noting that Mr. Vaiko was a sitting member of Parliament and leader of a political party which was a constituent of the ruling NDA at the Centre, Ms. Jayalalithaa said that ignoring Mr. Vaiko's speech would make a mockery of the Centre's efforts to take serious and deterrent action against terrorist organisations.

Mr. Vaiko had stated that he was a supporter of the LTTE and that he would continue to be a supporter of that organisation, she said. Unless such "provocative outbursts" were dealt with


TNLA, TNRT banned under POTA



In a glittering function held at the centenary auditorium of Madras University across the Marina Beach, the Governor, Mr P S Ramamohan Rao, administered the oath of office and secrecy to Miss

Jayalalitha. Even as Miss Jayalalitha and her 26 Cabinet colleagues took the oath, AIADMK workers who had crowded into the massive hall, raised slogans hailing her as the 'permanent' chief minister.
Besides AIADMK senior

leaders and partymen, the auditorium was packed with senior bureaucrats, leaders from various political parties

and several film stars.

Miss Jayalalitha's close friend, Mrs Sasikala, and her relatives were present. "I am unable to express my feelings at this time," a beaming Miss Jayalalitha told reporters at the end of the hour-long ceremony. feel an immense sense of gratitude towards the people of Tamil Nadu who have supported me and stood by me, helping me cross all the hurdles," she added. Later in the evening, the chief minister addressed a formal press conference at her office in Fort St George.
For Miss Jayalalitha, this

is the third time that she is assuming office as chief minister. Her first term, from 1991-96, was marked with controversies and ended with her facing a slew of corruption cases. CHANDIGARH, Feb. 26. Captain Amarinder Singh, scion of the royal family of Patiala, will be the new chief minister of Punjab.

A divided home let down the Akalis

OTERS in Puniab are usually very decisive, ensuring a comfortable victory for one or the other party, but this time the divide was sharper. The Shiromani Akali Dal has been left way behind, while the Congress has attained a clear majority.

The results indicate that Akalis continue to have a significant following and that the Panthic Morcha, which had launched a virulent attack on Chief Minister Parkash Singh Badal's government, may have made the difference.

"A united Akali Dal would have won hands down," said former SGPC chief Gurcharan Singh Tohra reacting to the verdict. "But it would have been possible only sans Badal," he said.

Given the close contests in some of the seats, it can be safely said that the Akalis would have certainly fared better if they had not contested against each other. Even a different outcome in a dozen constituencies could have decisively tilted the scales.

However, the issue of corruption emerged as the dominant factor and the Badal government has paid for its belligerence and couldn'tcare-less attitude on the issue.

Another significant aspect of the outcome is the drubbing received by SAD's ruling partner BJP. While the BJP had won 18 of the 23 seats contested by it in the previous elections. its tally is reduced to two while the BSP, led by

chief Kanshi Ram, failed to open its accounts.

Badal and his partymen may not have had the last laugh at the exit polls, the wide variations projected by three leading "pollsters" may actually sound death knell for the concept of exit polls in the country. Not that these had not gone wrong elsewhere in the past, the fact that the first such projections at a wider scale in this region had gone awry, has considerably dented the credibility of such exit polls.

Any such polls would surely be taken with a pinch of salt in future polls.

Yamunanagar win boosts INLD

■ CHANDIGARH: The Yamunanagar bypoll result comes as a shot in the arm for the ruling Indian National Lok Dal (INLD). All eyes were on the outcome as the polls followed parting of ways between alliance partners INLD and BIP.

Now that INLD's Malik Chand Gambhir has won, the outcome indicates the party's presence in urban areas, banishing the belief it is confined to rural pockets and needed BJP support. Haryana CM Om Prakash Chautala had thrown the party hat into the poll ring despite the fact that the BJP had already fielded its candidate for the seat as a matter of right.

In the last Assembly polls, the BJP had bagged Yamunanagar under a seat arrangement with INLD. Taking the tie-up for granted, the BJP declared Ganstryam Das as its candidate. But irked by the BJP's rejection of his party in UP. Chautala fielded his candidate.

Chautala put his legislator son Abhey Singh Chautala in charge of Yamunanagar and won over Congress stalwart Rajesh Sharma. With Sharma's exit, the Congress - that wrested the seat from the BJP the last time —has finished a poor third in the polls.

The INLD along with the Haryana Vikas Party (HVP) ate into the Congress share. The BJP, however, suffered the most. Denying Kamla Verma, who was was a Bansi Lai Cabinet minister, the ticket, BJP chose Ghanshyam Das. The party has forfeited its security deposit. MUKESH BHARDWAL

For Congress chief Capt Amarinder Singh, the problems may have just begun. Given the fact that he was virtually projected as the chief minister by the Congress and his known proximity to party chief Sonia Gandhi, it would be only a miracle if he is pipped to the post by anyone.

But the next few months could prove crucial for him. In the event of a comfortable maiority, he would have dictated the terms but the other contenders, Raiinder Kaur Bhattal and Jagmit Brar, are not likely to sit idle given

their known disposition towards him.

Much would depend on the kind of people he depends upon. As it is, the public perception is that he is not easily accessible. He has already declared that he would not trust chamchas. His lack of administrative experience and perceived lack of contact at the grassroots is likely to hamper his functioning. And it shall not be long before sharks mount an attack on him and his government. What would add to the problems is the shattered economy he is expected to inherit.


Curtains on campaign

NEW DELHI, Feb. 12. – The curtains came down this evening on the poll campaign in Uttaranchal, Manipur and parts of Uttar Pradesh, scheduled to hold polls on Thursday, as Punjab prepared to go to the polls tomorrow. The campaigning ended yesterday in Punjab and arrangements were "in place" for peaceful polls. Electronic voting machines (EVMs) are to be used for the first time in the state's 116 of 117 Assembly seats. Polling had been countermanded in Malout (Reserved) constituency following the death of the SAD-BJP alliance candidate, Sujan Singh.

Paramilitary forces staged a flag march at a few places in Punjab today, including Batala, where Congress and BJP workers clashed a day ahead of the poll, leaving 14 persons injured. The paramilitary forces staged flag marches in Moga and Baghapurana also. The Election Commission has designated one-third of the Punjab polling centres as "sensitive", which translated into numbers add up to 3,628 out of the total 10,525 centres. The EC ordered the deployment of Central forces at many places in Tarn Taran, Patti, Naushehra Panuan, Lambi and Muktsar, adds PTI from Chandigarh

The EC today expressed satisfaction with the law and order situation and other arrangements for the polls in Punjab. The EC spokesman, Mr AN Jha said that "adequate security forces" have been deployed. Some 15.6 million people (8.25 million men and 7.39 million women) will exercise their



franchise in Punjab which has 917 candidates in the fray.

In Uttar Pradesh, 12,925 centres have been identified as "sensitive" out of 28,437. Polls will be held in three phases in Uttar Pradesh, on 14, 18 and 21 February. Elections will be held in Manipur in two phases, on 14 and 21 February and in Uttaranchal on 14 February. About 22 million people will cast their ballots in UP in over 26 polling stations on 14 February. Over 34 million people will vote in 45 polling stations on 18 February and the rest, over 41 million people, will vote in over 48 polling stations on 21 February.

In Manipur, several polling stations have been marked as "sensitive" but the EC had received no complaints of the NSCN (IM) threatening voters, Mr Jha said. "The state administration is geared up to deal with the situation. Any threat to hinder the elections would be taken care of," he added. Manipur will see 8.51 lakh voters cast their votes in the first phase at 1,152 polling stations. Some 5.58 lakh more voters would exercise their rights at 849 polling stations in the final phase. In Uttaranchal, 5 million voters will exercise their franchise across 6,753 polling stations.

Politics as usual

It is clear that Prakash Singh Badal has not been a brilliant chief minister nor, given the context, was he expected to be. His main contribution seems to have been to give free power to farmers, get the minimum support price for wheat hiked by a substantial margin every year and force the Centre to procure every kilo of the stuff brought to the mandis, even when there was a record surplus. That is probably all it takes to be a chief minister of that state, given the clout the farmer lobby enjoy there. Despite this, his prospects are not said to be bright. There are widespread allegations of corruption and the Congress is going to town about the property owned by the Badals in Australia and in Delhi. The Congress manifesto also gives a list of scandals that include bogus recruitment into the handicapped category and the sale of government rest houses well below market price. The party promises to appoint a judicial commission to probe these allegations if and when in power. Badal's ideas, if they can be called such, are mundane this time around, having mostly to do with the supply of power to domestic consumers and usual sops to farmers.

But a Supreme Court order that Punjab build forthwith its portion of the Sutlej Yamuna Link Canal so that Haryana gets its 3.83 million acre feet of water from the Ravi and the Beas, has given him a classic Akali chauvinist poll issue. The canal was proposed under Indira Gandhi; it is a Congress idea and the water sharing agreement was ratified by Rajiv Gandhi and Sant Longowal in their famous accord. The Congress squirms at this, but quickly recovers to say that Badal has in fact a secret understanding with fellow BJP ally Om Prakash Chautala and deliberately arranged to lose the case. Badal counters by saying he'd rather fill jails than allow a single drop of water to flow into Haryana. The Congress does not shine by comparison on corruption either: its list of nominees has at least three people, including former chief minister Rajinder Kaur Bhattal, against whom cases are pending. To be fair to the Congress, it doesn't go overboard with sops although it espouses the other big Punjabi cause — Chandigarh. On the face of it, one doesn't see whether there is a choice in Punjab, except that Amarinder Singh is the "maharaja" of Patiala, has a few ideas on industry, isn't an old fogey like Badal. Given that both the Akalis and the Congress have relatively stable and clearly demarcated constituencies, the election may hinge upon the amount of disaffection that has accumulated against Badal over the last five years and the amount of damage rebel candidates on both sides can inflict on official ones.

The real issues get sidetracked again in Punjab

ITH Sukhbir Singh Badal, son of Chief Minister Parkash Singh Badal, filing a criminal complaint against Punjab Congress president Amarinder Singh for defamation, can it be said that political campaigning in Punjab has touched a new low? Badal Jr is reacting to advertisements in the Congress media blitzkrieg that suggest — in a forthright sort of a way - that Badal (Sr) has mortgaged the SYL waters and thereby the future of the Punjab farmer, for personal gain. Should his complaint not be addressed, Sukhbir has even threatened to take the Election Commission to court. As spectacular as this sparring is, and though many will undoubtedly hold their breath till the verdict on the defamation suit comes in, surely this cannot be the dominant question in the Punjab polls. Surely, what must draw more attention, and concern, than the depths that Campaign 2002 may have plumbed in the run-up to elections, is its sheer poverty of breadth. It is an extremely narrow electoral campaign that the main political parties have been running so far in Punjab.


While corruption is an enormous and continuing challenge in Punjab as it is elsewhere, the Akali-Congress personalised attacks on this score are beginning to look suspiciously like a smokescreen. All the noise made on corruption, it seems, is designed to drown out the deafening silence on the other issues. In retrospect, after terrorism mercifully waned in the state, no other

issue has been able to step into the vacuum in the political agenda. The failure of many of the so-called Panthic issues to make the grade is entirely welcome — it is reassuring, for instance, that the bir-burning controversy which erupted a few months ago failed to keep the embers glowing till election time. But the inability of development issues to occupy centrestage is a sad comment on the major political players and their priorities. Even the matter of the SYL canal, one that vitally affects many in the state, has been thrust upon the campaign by the Supreme Court verdict. Both the Akali Dal and the Congress had no choice but to reiterate their positions on the long-festering dispute. Both have done so in the most recklessly emotive, most irresponsible way possible. As rhetoric of "not a drop of water..." and "...rivers of blood" makes daily headlines, SAD chief and Chief Minister Badal has brandished his readiness to defy the court. A petition seeking initiation of contempt proceedings against him is slated for hearing in the Supreme Court on Friday.

So what is the election about this time in Punjab? Is it down to the competitive sop-offering by both the main contenders for power? While the SAD has improved upon the largesse it offered in its manifesto in 1997, the Congress valiantly attempts to match it, sop for populist sop. Or will the cynical voter just flip a coin? Or is there room, still, to hope that some real issues will step into this campaign?

While talking to reporters later, Ms. Jayalalithaa was at her best. For the benefit of television cameras she would repeat in Tamil what she said in English, and vice-versa. One reporter asked her to repeat her oft-repeated line: "People's verdict is

Even as she kept monitoring the "lead situation" in Andipatti, Ms. Jayalalithaa received each and every worker and official with a smile. And, after an hour, at 12 noon, she was ready to announce the final result. "I've been declared elected with a margin of 41,200," she said setting off another round of celebrations.

everytime someone actually touched her feet, Ms. Jayalalithaa would step back with a look of rebuke. For an important few, she paused and posed for photographs. Most AIADMK workers insisted on touching the ground near her feet. Security personnel had to pull away those who kneeled down a little longer. But

Ms. Jayalalithaa attributed her victory to the "unstinted support of party cadres, who, she said, had remained "united and disciplined" through a trying period. The AIADMK legislature party met in the afternoon and unanimously elected her the leader. Immediately thereafter, the Chief Minister, O. Paneerselvam, submitted his resignation. The Governor, P.S. Ramamohan Rao, asked him to continue till alternative arrangements were

Ms. Jayalalithaa took the opportunity to reiterate her promise that she would make Tamil Nadu the No. 1 State in the country in every sphere, and Andipatti the No. 1 constituency in the State. "I will not rest until I've achieved this goal," she said. God's verdict." And she obliged.

Expressing her "sincere and heartfelt gratitude" to the voters of Andipatti, Ms. Jayalalithaa said she would fulfill all the promises she made during the election campaign.
