SC rap, let-off for Jaya

NEW DELHI, Nov. 24. — The Supreme Court (coram, Babu, Reddi, JJ) today acquitted the Tamil Nadu Chief Minister, Miss Jayalalitha, of charges of corruption in the Tansi land deal case but asked her to "atone" by "unconditionally" returning the government property involved in the deal.

"We think that none of the offences charged against the accused are established. There is no ground to interfere with the order under appeal," the court said upholding the Madras High Court order acquitting Miss Jayalalitha after she had been convicted and sentenced to three years rigorous imprisonment by the trial court for criminal conspiracy, criminal breach of trust and corruption.

The court made it clear that though it had come to the conclusion that Jayalalitha was not guilty, "it is clear that property belonging to public sector undertakings was sold to firms in which she was a partner at a time she held the office of the CM."

"In view of the fact that the government headed (by her) has to give permission in respect of sale of property... there is a conflict of interest. Whatever our findings... we are clear that if officers become aware that the CM is interested in purchasing some property, bureaucracy will be over-enthusiastic to see that the sale goes through smoothly and at a price desired by such CM," it observed.

"Though we can visualise such a situation, such facts have to be established by concrete evidence to be convicted in a criminal case and (these) are difficult to get.. At any rate, it is plain that such conduct is opposed to the spirit of the Code of Conduct if not its letter," it said,

referring to the Code of Conduct for Ministers issued on July 26, 1968, by the Tamil Nadu government. Para 2(b) of the Code states that after taking office and so long as he remains in office, a minister shall refrain from buying from or selling to the government any immovable property, except where such property is compulsorily acquired by the government in usual course.

In its stinging rebuke, the court observed that many things that are not punishable are morally worse than those which are. "Criminal law merely prescribes the minimum standards of behaviour, which

ch in public life, those who hold high offices should not take shelter under," it said, referring to Miss Jayalalitha's "anxiety to save her skin" that went to the extent of denying her signature on documents which her own officials identified.

"Persons in public life are expected to maintain very high standards of probity... particularly where there is likely to be even a least bit of conflict of interest between the office one holds and the acts to be done by such person," the court held. It asked her to "ponder over whether she had done the right thing in breaching the spirit of the

Code and giving rise to suspicion that rules were bent to acquire public property for personal benefit—though trite to say that suspicion however strong cannot take place of legal proof—and take steps to expiate herself".

The High Court had overturned the trial court order convicting Miss Jayalalitha and her close confidante, Mrs Sasikala, in connection with sale of land belonging to the Tamil Nadu Small Industries Corporation Ltd to two firms, Jaya Publications and Sasi Enterprises, in which the duo were partners, allegedly causing a loss of Rs 2.76 crore.

TESTING the power's it acquired last month from an ordinance, the POTA review committee today issued notices to the Tamil Nadu Government to show cause whether the incarceration of MDMK leader Vaiko and journalist R R Gopal under the anti-terrorist law was "fit and proper."

The three-member committee, headed by retired High Court Chief Justice Arun Saharya, asked the state to respond to the notices by December 2 along with the relevant documents including police case diaries.

'NO THREAT TO THE HINDU'

We are fully complying with Supreme Court's stay orders, says Jayalalithaa

CHENNAI, NOV. 11. The Tamil Nadu Chief Minister, Jayalalithaa, today gave an assurance to the Deputy Prime Minister, L.K. Advani, that the orders of the Supreme Court staying the arrest of the representatives of *The Hindu* were being fully complied with and implemented by the State police.

In a demi official letter addressed to Mr. Advani, she said her Government was known for its record of ensuring that Tamil Nadu was one of the most peaceful States "upholding the rule of law, and maintaining perfect law and order."

Ms. Jayalalithaa's letter was in response to the Union Home Ministry's decision to deploy the Central Industrial Security Force (CISF) at *The Hindu* office. The deployment was totally unwarranted and against the spirit of federalism, she said

"There is absolutely no threat to Mr. N. Ram (Editor-in-Chief of *The Hindu*) or to *The Hindu* office as is being made out by the media. This decision of the Home Ministry would imply that the State Government cannot be trusted on a

subject which is exclusively a State subject," she added. Opposing the move on the ground that i was "sub judice at the level of the Supreme Court," she said: "This direction of yours is absolutely unwarranted and an extremely unfortunatione. I presume you have not been posted with the correct information leading to this move."

"The very fact that this has been brought up to you only after two days by Mr. N. Ram clearl shows that it is his intention to blow up the whol situation and twist it in his favour to misguide the public and try to aggravate the situation which i totally normal," Ms. Jayalalithaa said.

Mr. Ram, she said, was already accorded security on the 'X' scale by the State Government

Mr. Ram, she said, was already accorded security on the 'X' scale by the State Government "Despite this, any despatch of Central Security Force would cast a malicious slur on the State and cause irreparable damage to Centre-State relations. Chennai's tinpot dictator

HE JAIL terms ordered by the Tamil Nadu assembly against the editor and several other senior journalists of The Hindu and against the editor of a DMK newspaper, evidently at the behest of Chief Minister J. Jayalalitha, are the acts of a petty tyrant. Living in the sepulchral seclusion of her Poes Garden fortress. the AIADMK leader seems to be suffering from the delusion that she presides over a banana republic. Driven by a vindictive attitude, she seems to have lost sight of the customary freedoms which the press enjoys in a free society. It is possible that the ease with which she has managed to survive in politics despite the corruption cases pending against her has given her a sense of invulnerability. This feeling may have been strengthened by the excessive adulation she's accustomed to receiving from her sycophants, including the obnoxious practice of her admirers prostrating themselves before her, an act of debasement she seems to enjoy.

The disgraceful decision to punish journalists of a highly respected newspaper is not the first of Ms Jayalalitha's intemperate acts. As the misuse of POTA against MDMK leader Vaiko showed, she has little respect for norms and proprieties. This unfortunate propensity to ride roughshod over pre-

vailing standards of behaviour was also evident in the shocking manner in which the police acted against her political opponents, M. Karunanidhi and others, no doubt on instructions from above. The same disdain for norms could also be seen from the midnight raids against the striking state government employees, which attracted the Supreme Court's ire.

As her latest decision aimed at intimidating the press so that it refrains from criticising her shows, she has the mindset of a tinpot dictator which militates against the functioning of a democratic system. It is a matter, therefore, which goes beyond the present targets of her wrath, but affects society as a whole. The Hindu's decision to seek legal redress for the outrage to which it's being subjected raises questions that are vital not only to it, but to Tamil Nadu and, indeed, the country as a whole. If arbitrary acts of this nature by a vengeful politician are allowed without any hindrance, it will be a bleak future for all citizens. The reason is that the freedom which the press exercises in the matter of drawing attention to the foibles of politicians and others is palpably in the interest of the common man. The danger of curbing this privilege, guaranteed by the Constitution, through mean-minded actions is too obvious to be stated.

Jayalalithaa had no part in decision: Speaker 19 "

The following is the text of the statement by the Tamil Nadu Legislative Assembly Speaker, K. Kalimuthu: In all the din created by the media in the

wake of the resolutions passed by the Tamil Nadu Legislative Assembly on the Breach of Privilege committed by the Editor, Executive Editor, Publisher, Chief of Bureau and Article Writer, and Special Correspondent of The Hindu and the Editor-Publisher of Murasoli, a deliberate attempt is being made by those sentenced to mobilise support through political parties and other sections of the media to portray the Breach of Privilege and the consequent action of the Tamil Nadu Legislative Assembly as being scripted by the Hon'ble Chief Minister Selvi I. Javalalithaa. This itself reflects a desperate attempt by those sentenced to extricate themselves by totally distorting the facts in a crude attempt to mobilise media support and support of some political parties who would like to fish in troubled waters for their gain.

Since this is a matter of great public importance touching the rights of a hallowed institution like the Legislative Assembly, it is extremely essential that the right facts connected with this issue are set out clearly so that the public, who through the electoral process have reposed faith in the Legislative Assembly, are not misled.

In the first place, it is the intention of the framers of the Constitution to ensure that the Legislative Assembly is able to function in an independent and free manner. Article 194 of the Constitution clearly sets out the powers, privileges and immunities of a House of the Legislature of a State, and of the Members and Committees of a House of such Legislature. This is to ensure that members of the House can voice their opinion on issues with absolute freedom. This cannot be obstructed by distorted reporting by the media. When the functioning of the House of the Legislature is thus obstructed, the privileges of the House as a whole are affected and its very functioning jeopardised. It is the normal procedure for the House of the Legislature to refer such infractions to the Committee of Privileges of the House to go into all the facts in detail and make its recommendations to the House.

The Committee of Privileges of the Tamil Nadu Legislature Assembly is an elected Committee including representatives of the Opposition. In this case, the Committee has met on several occasions, namely 5-5-2003, 12-5-2003, 1-10-2003, 14-10-2003, 27-10-2003 and 6-11-2003, before making its final recommendations. It can thus be seen that detailed deliberations have been held on these dates and detailed proceedings have been drawn up. These recommendations of the Committee of Privilèges have thus been reached after careful consideration. Both The Hindu and Murasoli have been given adequate opportunity. They have filed written submissions. *The Hindu* has given a 16page written submission going into all aspects of their defence. The Committee of Privileges has gone into these written submissions point by point in great detail and only thereafter reached its conclusions and recommendations.

In a desperate attempt to mislead the public, the media reports have completely mixed up the three separate issues of Breach of Privilege relating to the Media considered by the Committee of Privileges of the Tamil Nadu Legislative Assembly. The first issue of Breach of Privilege relates to the blatant attempt to influence the conduct of an important member of the House. namely, the Honourable Chief Minister, within the Assembly by the use of all kinds of abusive and intemperate language while the Honourable Chief Minister was discharging her duties in the House. This constituted undoubtedly a gross Breach of Privilege and Contempt of the House as a whole. It should be noted that such an attack on an important member of the House while discharging duties in the House, constitutes an attack on the whole House. amounts to obstructing its proceedings and without doubt affects the independent functioning of the House. The Committee of Privileges after going into all aspects of the issue came to the conclusion that the reporting in a distorted manner by *The Hindu* in its issues dated 12-4-2003, 13-4-2003 and 23-4-2003, on the interventions made by the Honourable Chief Minister while replying to the debate in the House clearly constituted a gross Breach of Privi-lege and Contempt of the House. Therefore, the Committee recommended 7 days simple imprisonment for the Editor, Executive Editor, Publisher, Chief of Bureau and Article Writer and Special Correspondent of The Hindu only.

The Legislative Assembly was considering this recommendation in this report on -11-2003. At this juncture, when the Resolution came up for a decision before the House, the Honourable Chief Minister magnanimously suggested that the House pardon them as these offences related to her functioning in the Assembly. The House considered the request of the Honourable Chief Minister and dropped the punishment. The media reports are now attempting to distort the whole issue by indicating that these offences were the ones for which the punishment was imposed. This is totally incorrect. In fact, it needs to be clarified that even in the first instance, when the issue came up in the Assembly in April 2003, it was I, who as the Speaker of the House, suo motu referred the matter to the Committee of Privileges under Rule 226 of the Tamil Nadu Legislative Assembly Rules. The Honourable Chief Minister did not make any request to me as the Speaker of the House or to the House to refer these matters to the Committee of Privileges

The next issue relates to the Editorial in *The Hindu* dated 25-4-2003. In this case, I, as the Speaker of the Tamil Nadu Legislative Assembly, suo motu referred the matter to the Committee of Privileges. Here again, the Hon'ble Chief Minister did not make any request to me, as the Speaker of the House, or to the House suggesting reference of this matter to the Committee of Privileges

After detailed consideration and after taking note of the written representation of The Hindu and Murasoli, the Committee of Privileges made its final recommendations on 6-11-2003. This was considered by the Tamil Nadu Legislative Assembly on 7-11-2003. The contents of the Editorial published by The Hindu on 25-4-2003 shake the very foundation of the Legislature which is the cornerstone of a democracy. It has prejudged the proceedings of the Committee

of Privileges even when the issue was pending before the Committee of Privileges. This is undoubtedly casting aspersions on the integrity of the Committee and the House. The editorial has also gone into detail at length indicating how the Committee of Privileges should deal with this particular matter and virtually indicated the conclusions, when the matter itself was under the consideration of the Committee. The editorial has also cast a slur on my action as the Speaker of the House in referring the matter to the Committee of Privileges. It also amounted to a threat to the Committee and the House to force it to decide in favour

of the newspaper.

After careful consideration, the Committee of Privileges has concluded that this editorial published on 25-4-2003 affects the entire functioning of the House. This constitutes gross Breach of Privilege and Contempt of the House. For this offence, the Committee of Privileges has recommended 15 days simple imprisonment. The Legislative Assembly after due consideration accepted the report and awarded the punishment of 15 days simple imprison-ment. The Hon'ble Chief Minister had absolutely no part individually in this decision. Likewise, the same offence was repeated by *Murasoli* on 26-4-2003 by publishing the translation of the editorial in The Hindu. Based on the report of the Committee of Privileges, a similar punishment was imposed by the Tamil Nadu Legislative Assembly.

When these are the real facts, namely, that the punishment imposed by the Tamil Nadu Legislative Assembly is solely on account of the Breach of Privilege and gross Contempt of the House, committed by The Hindu through its editorial dated 25-4-2003 and also the *Murasoli* by publishing the same on 26-4-2003, the media is whipping up totally unwarranted personal campaign against the Hon'ble Chief Minister Selvi L Jayalaithaa. It should be noted once again that in the attack by The Hindu on her functioning in the House, for which the Committee of Privileges recommended 7 days simple imprisonment, she had graciously suggested that no punishment be imposed

and the House accepted the same.

Article 194 of the Constitution is very clear. A House of the Legislature has to be enabled to function in a free and independent manner. Its privileges, powers and immunities have to be protected to secure this. This resolution of the Tamil Nadu Legislative Assembly is only to protect its inde-pendent functioning and there cannot be any obstruction to its functioning. The powers, privileges and immunities under Art. 194 of the Constitution are to secure this independent functioning and cannot in any way be abrogated by the Press in an attempt to obtain to itself the role of ultimate arbiter. The ultimate test is public welfare and common good. In a democracy, people vote for a Legislature to secure them these guarantees. Article 194 of the Constitution is specifically enshrined to ensure that a Legislature can function in a free and independent manner to secure for the people these guarantees. The functioning of the Legislature cannot be obstructed by the Press which has no such separate rights in the Constitution such as those enumerated in Article 194 of the Constitutions.

TN Assembly orders arrest of Hindu editors

CHENNAI, Nov. 7. — Tamil Nadu Assembly today sentenced editor Mr N Ravi, executive editor Ms Malini Parthasarathy, publisher Rangarajan, and two senior journalists of The Hindu to undergo simple imprisonment (SI) for 15 days in a breach of privilege case in regard to an editorial.

A similar sentence was awarded to Mr P Selvam, editor of the DMK organ, Murasoli. In another breach of privilege case, former deputy Speaker and DMK legislator Mr Parithi Ilamvazhuthi was sentenced to 30 days' SI.

Speaker Mr K Kalimuthu announced the verdict of the privileges committee after the leader of the House and finance minister Mr C Ponnaiyan moved separate resolutions in this regard. Mr Ilamvazhuthi, who was present at the House, was arrested immediately after the announcement. The Speaker said arrest warrants and warrants of commitment for the others had been issued.

Following the announcement, police searched The Hindu office for the employees against whom the warrants had been issued.

The editor-in-chief of *The Hindu*, Mr N Ram, said he had reported the matter to the Centre. He described the arrest warrants as an assault on democracy and treedom of press in Tamil Nadu, and vowed to move court over the matter. "We expect the Prime Minister, the Deputy Prime Minister, the ruling parties in all other states and Opposition parties here to speak for us. I would be surprised if any party, other than the AIADMK -- within which some could be left out --- would say this is right," Mr Ram said. He also alleged that police had visited his uncle Mr Rangarajan's residence and intimidated his family. He said he would file a criminal case against police.

Earlier, in the Assembly, Mr Kalimuthu said the sentenced employees of The Hindu had "committed a gross act of contempt and breach of privilege of the House and the Speaker by publishing an editorial on 25 April 2003 titled 'Rising Intolerance' on the style of functioning of the Speaker, based on reports by Mr Jayanth and Ms Radha Venkatesan".

While the committee awarded seven days SI to Mr Ravi and others as they were found guilty in another breach of privilege case, chief minister Miss Jayalalitha said the relevant reports were concerning her and that she was not pressing for action. Mr Ponnaiyan moved a resolution and action was dropped in the case.

The Editors Guild of India termed the action against The Hindu employees as "undemocratic", reports PTI.

CHENNAI, NOV. 7. The decision of the Tamil Nadu Assembly to jail the Editors and journalists of *The Hindu* and *Murasoli* followed an order to arrest the DMK member, Parithi Ilamvazhuthi, also on a charge of breach of privilege and for intimidating the AIADMK member, G. Kumaradoss, leading to protests from the Opposition.

Amid the continuing protests, the Speaker, K. Kalimuthu, announced the verdict of the Privileges Committee after the Leader of the House, C. Ponnaiyan, said the Committee had concluded that the Publisher, Editor, Executive Editor, Chief of Bureau and Special Correspondent of *The Hindu* had committed breach of privilege. He then moved a resolution, stating that the House sentenced them to 15 days' simple imprisonment for gross contempt and gross breach of privilege of the House as a whole.

The decision of the House pertained to an editorial published by the newspaper on April 25, 2003, which was based on an article and a news report. The editorial had attributed motives to the decision of the Speaker, the privileges committee and therefore, lowered the dignity of the entire House, the resolution said.

The Assembly had considered two resolutions against *The Hindu*, during its sitting on Friday evening, one on breach of privilege relating to the Chief Minister, Jayalalithaa, and another of the House as a whole Mr. Ponnaiyan moved a resolution, recommending seven days' simple imprisonment on the breach of privilege relating to the Chief Minister. Ms. Jayalalithaa rose to say that she did not want to pursue the matter relating to her and that it could be dropped.

The Leader of the House took up the second resolution, which stated that the editorial sought to justify the contents of the article and the news report. This constituted a "gross act of contempt of the House as a whole" and a "gross act of breach of privilege of the House as a whole". Therefore, the Editor, Executive Editor, Publisher, the article writer, V. Jayanth, and the Special Correspondent, Radha Venkatesan, were liable to be punished.

The resolution recommended that they be sentenced to 15 days' simple imprisonment for breach of privilege. The Assembly passes issued to the newspaper were also being suspended for 15 working days. The House met at 4.30 p.m. on the last day of its current session and took up the Bill, amending the Tamil Nadu Essential Services Maintenance Act.

At about 5.20 p.m., the Speaker announced that a matter of grave importance was to be taken up and no one should leave or enter the House. He called the Leader of the House to present the findings of the committee on a breach of privilege issue concerning Mr. llamvazhuthi, and the resolutions followed.

Nov. 17. — The strained relations between the Congress and Mr Mulayam Singh Yadav in Uttar Pradesh are heading for a formal split, AICC sources said, amidst indications that the Congress is looking at the BSP as its new suitor in the state.

The Uttar Pradesh government taking a political U-turn and filing an affidavit before the Supreme Court sparing top BJP leaders including Mr LK Advani of the conspiracy charge in the Babari Masjid case and backing a similar CBI affidavit, proved to be the last straw for the Congress, so far unenthusiastic in extending support to Mr Yadav.

Though "sudden action" by the Congress was averted today after the Yadav government, following criticism from its "secular allies",

removed the government's standing counsel in the apex court and disowned the controversial affidavit saying it was not in tune with the "draft", the AICC is clearly preparing the ground for a "well-timed" pull out.

Party sources said the Uttar Pradesh Congress leaders' frontal attack on the state government and questioning its'secular credentials (which was followed by the state government's clarification) had been on the instructions of the high command. Madhumita killer held, in Lucknow

THE CBI achieved a major breakthrough in the Madhumita Shukla murder case after its sleuths arrested the alleged killer of the poet from Lucknow on Monday morning. The assailant, Prakash Chander Pandey, has been remanded in judicial custody for 14 days by a CBI court.

CBI sources said Pandey, who had shot the poet at her residence in Lucknow six months ago, was arrested following sustained interrogation of Rohit Chaturvedi and Santosh Kumar Rai, alias Satya Prakash.

The CBI had arrested the two on November 6. Following the arrests, Madhumita's servant Deshraj, the lone eyewitness in the case, identified Rai as Satya Prakash, the man who had accompanied the killer to Madhumita's house on May 9.

Former UP minister Amarmani Tripathi, an accused in the case, has already been arrested by the CBI.

Sources said Pandey, a resident of Gorakhpur, is a criminal and was on the run after the CBI began the probe. Rai had been contacted by Chaturvedi after Tripathi's wife, Madhumani, decided to "get rid of" the poet as she was bearing her husband's child. Sources said that after custodial interrogation of Chaturvedi, the noose tightened around Madhumani.

According to CBI sources, cellphone details of Chaturvedi and Madhumani were indicative of circumstantial evidence in the murder. A Lucknow court had directed the CBI to arrest Madhumani only after the agency had concrete proof of her involve-ment in the murder.

Mulayam Singh almost scores a century A

Mulayam Singh Yadav has broken all records by swearing-in a council of 97 ministers. Counting himself, the UP chief minister fell just short of a century, which he would have definitely scored if two potential candidates — Amarmani Tripathi and Raja Bhaiya — had not been in jail. The size of the ministry is a disgrace. According to some estimates, the additional burden on the exchequer may be Rs 98 crore annually. And then there will be fights for portfolios. Even in the past many departments have been split to create more portfolios, now some will be split further. One complaint that will not be heard is that the new ministers do not have enough work to do, as long their perks

are not tampered with.

Mulayam Singh is not the first chief minister to have a jumbo-sized ministry. In fact all ministries in UP since 1997 — from Kalyan Singh, Ram Prakash Gupta, Rajnath Singh to Mayawati — have been huge. The runner up to Mulayam's 97 was Kalyan Singh with 93, and the cause for inducting so many has been defections. Each of these governments has been formed by either splitting existing parties, forming coalitions or both. In such situations every small party demands berths for extending support, as do independents and defectors. They are aware that the larger party will have no option but to give in, particularly as their majority is so thin. Out of the 40 MLAs who defected from the BSP to the Samajwadi Party, 30 have been made ministers. In a combined house strength of 511, the UP ministry should ideally not be of more than 51 ministers. The states too urgently need to have limits imposed on them like the Centre whereby the council of ministers cannot be more than 10 per cent of the strength of the House.



HE Mulayam Singh Yadav's government in Uttar Pradesh on Friday foiled the much-hyped VHP's Sankalp Sabha at Ayodhya by arresting the outfit's top leader Ashok Singhal at Ramsevakpuram and by sealing the temple premises.

Ramsevakpuram is VHP's central office and was the venue for the meeting.

Following a script drafted by the Centre, Mr Singh allowed a few Ram bhakts to have darshan in small groups, barring Mr Singhal and other leaders. The state police resorted to lathicharge, burst teargas shells and used rubber bullets to disperse the mob asembled at Ramsevakpuram. The venue of the meeting wore a deserted look with the police preventing the VHP activists from entering the ground.

However, the RSS, which played the peacemaker's role, was miffed with the government for not allowing the Ram bhakts to hold the meeting. It conveyed its unhappiness to deputy prime minister L.K. Advani. Sangh leaders said the organisation's joint general secretary, Madandas Devi, told Mr Advani that the massive security arrangements in the temple town was unwarranted. The development was a setback of sorts for the VHP as it once again demonstrated that the organisation does not have the necessary wherewithal to mobilise people for the campaign. The


The final breakthrough came after the CBI tracked down one of the assailants in Pilibhit jail and extracted strong evidence against Tripathi.

On Sunday evening, the CBI team questioned Tri-pathi at his Hazratganj residence for nearly an hour before serving the arrest warrant. He was quizzed about his associates allegedly involved in the murder and asked why he had been evading the CBI's calls last week. The former minister, it is understood, had installed a caller ID system to avoid taking calls from the investi-

At around 6 p.m. on Sunday, Tripathi convened a press conference at his home and told journalists that he was being dragged into the Madhumita murder case as part of a deep-rooted con-spiracy. "I cannot face my children and relatives be-cause of the baseless reports being published in the media about my involvement in the murder case," he said.

THE SUPREME Court on Thursday directed the CBI to verify within a week and submit a report on the assets of the four people suspected to be involved in the Rs 175crore Taj heritage scandal.

Sources said the CBI has named Mayawati in its report submitted to the SC on Thursday. "The former chief minister, who also held the environment portfolio, had knowledge of everything about the project," said a senior official.

The court directed the CBI to find out how the initial amount of Rs 17 crore released for the project had been spent and who its beneficiaries were.

The court expressed its displeasure with the CBI, which deviated from the SC's August 21 order asking it to find out the "known and unknown assets" of the persons named in the agency's interim report.

"What have you (the CBI) done to find out the assets of the persons?" asked the court. Additional Solicitor General Altaf Ahmed, representing the CBI, told the court that the agency would take time to gather credible information which could lead to identification of assets. Such a probe was a wide and painstaking exercise, he argued.

When the court said the pace of investigation was very slow, Ahmed said the CBI would complete the task with a week. The court said at the CBI's present pace, the case would drag on for months. "By delaying, everything will be lost and nothing will be recovered. Collection of evidence regarding assets is much more important," the court said.

Representing the UP government, senior counsel Rakesh Dwivedi insisted the CBI should first probe into the assets of the officials to ascertain how the Rs 17 crore was spent.

Taking note of the CBI

LUCKNOW, Sept. 6. — The BSP in Uttar Pradesh formally split today with 37 Thakur and Muslim MLAs forming a new party, Loktantrik Bahujan Dal (LBD), and later merging it with Mr Mulayam Singh Yadav's Samajwadi Party. Speaker Mr Kesri Nath Tripathi tonight recognised the merger.

Mr Rajendra Singh Rana, elected

Mr Rajendra Singh Rana, elected leader of the breakaway group, handed over to the Speaker a letter signed by the 37 MLAs. The letter claimed that the LBD was formed on 26 August, a day after Miss Mayawati had recommended dissolution

of the Assembly.

Mr Rana also presented a second letter claiming the support of another six MLAs who could not be present today. If the figure of 43 is taken into account, the Samajwadi Party's strength goes go up to 184

in the House of 402.

The SP national general secretary, Mr Amar Singh, and state general secretary, Mr Shivpal Singh Yadav, accompanied the breakaway MLAs to the Speaker. Among them was Mr Amarmani Tripathi, involved in the controversy over the murder of poetess Madhumita Shukla. Mr Amar Singh said the SP would like all supporting parties, including the Congress, to join the new ministry.

With the split in the BSP, second since 1997, the BJP becomes the main Opposition party in the As-

sembly.

As many as 13 of the 16 Thakur MLAs have switched side and so have nine of the 15 Muslim MLAs.

its formation was the result of a split in the party BSP Legislature Party leader Swami Prasad Maurya, who filed the caveat, said: "There has been no split in either the state or the national unit of the BSP and hence the move of some of MLAs to form a separate outfit is against the law.

BSP state chief Barkhu Ram Verma alleged his legislators were being "co-

erced" to extend support to Mulayam in the trust vote. "Three of our MLAs complained that local SP leaders, helped by the police, were threatening them to vote for Mulayam."

Sources said the BJP's decision to is-

sue the whip was primarily driven by two considerations — Mulayam's apparent success in splitting the BSP to rustle up the necessary numbers for a majority, and Mayawati's latest remarks against any possible alliance with the Congress.

The BJP top brass took "specific note" of the BSP leader's remarks at a press conference in the capital where she gave enough indication that she was warming up to the BJP again. BJP insiders said the party should not push Mayawati to the Congress's arms when she is still undecided on future allies.

Mayawati could cut into the Conress's Dalit votes in Madhya Pradesh, Rajasthan or Chhattisgarh by putting up BSP candidates — and it suits the BJP not to antagonise her by appearing to help Mulayam. Venkaiah Naidu told party leaders that UP leaders with the BJP's experiences with the BSP as "sweet and sour, but overall positive", indicating that the last may not have been heard of BJP-BSP ties.

CBI grills Maya in Taj case

Chief secy, bureaucrats may turn approver

FINALLY, THE CBI quizzed the Mayawati for over three hours on Monday in connection with the Rs 175-crore Taj Heritage Corridor project. A CBI team led by DIG P Neeraj Nayan reached the former chief minister's 13, Mall Avenue residence at about 1 pm and grilled Mayawati till about 4.15 pm. A woman CBI officer was present all through the process of interrogation.

Reports said the CBI team went to her house well prepared. Besides a long list of questions, the CBI sleuths carried some important files which had signatures of her principal secretary P.L. Punia. The CBI team had prepared about two dozen questions on the basis of their scrutiny of documents and investigations done so far.

Sources said as and when Mayawati feigned ignorance about certain points, the CBI sleuths confronted her with the files and documents to establish that she had knowledge of the issues in question. The CBI sleuths also reportedly asked Mayawati who had authorised former transport and excise minister Naseemuddin Siddiqui to deal with

the files of the environment department.

ment department.
Siddiqui had signed several files and documents in connection with the project though Mayawati, herself, held the environment portfolio. Siddiqui is also being blamed for tampering of files and documents. The role of Union Secretary for Environment K.C. Mishra is already under the CBI's scanner for alleged tampering of documents.

When the CBI sleuths supplementary questions and sought clarifications on issues concerning the financial sanction and so on, Mayawati replied to only some of them and refused to anothers. Though Mayawati remained cool, she did not clarify certain points that indicated her involvement in granting clearance to the project. Mayawati said she would not like to speak more than what she had already said. The CBI sleuths immediately recorded her point indicating that she was not willing to answer the question any more.

Sources in New Delhi said there was a strong possibility that two senior UP bureaucrats — Chief Secretary D.S. Bagga and P.L. Punia, former Principal Secretary to Mayawati — might turn approvers.

BJP to wait till Sept 8


move by the All-India Muslim Personal Law Board to challenge the ASI report was "deplorable and unfortunate." It should accept the historical truth, he added.

Mulayam to head one-man govt till trust vote

NEWLY-APPOINTED Uttar Pradesh Chief Minister Mulayam Singh Yadav is suffering the pangs of power even before settling down in office.

After cobbling together many parties and individuals to cross the magic figure of 202 needed for a majority in the 403-member Assembly, Yadav is learning that his third stint as chief minister is no bed of roses.

Since taking his oath on Friday as the only member of his Cabinet so far, Yadav has been devoting all his time and energy to preparing for a test of majority on the floor of the House by September 11.

Until then, the composition of the rest of the Cabinet is open to negotiations based on whoever supports Yadav on the House floor.
"The expansion of the Cabinet will take place only after we prove our majority in the House," he told reporters on Monday, his first full working day in office after assuming charge as chief minister.

Many observe that this is an unprecedented situation. "It has never happened before that there is no cabinet even three days after the chief minister took oath," remarked a senior leader of the Congress, which is yet to decide whether it should participate in the new government.

"As far as our legislators are concerned, they are keen to be in the government," he added. He may be confident but his party leadership in New Delhi is still in two minds, demonstrating just how difficult a job Yadav is in for.

Yadav had made no bones of his

obvious constraints when he chose to take the oath of office and secrecy alone Friday.

secrecy alone Friday.

His well-known political skills are being tested to the hilt with multiple pressures from key allies — Kalyan Singh's Rashtriya Kranti Party (RKP), Ajit Singh's RLD and the Congress apart from smaller political groups and independents. Samajwadi Party is the single largest group with 142 members. The RLD with 14 members has backed him and the Congress with 16, apart from the 13 rebel members from the BSP of former chief minister Mayawati that lost power last week.


Though the RKP has just four members, its chief Kalyan Singh's role in pushing Yadav's case with Governor Vishnu Kant Shastri has gained him a role of some significance in the new dispensation.

Central secy tampered with Taj files, says CBI

New Delhi 31 AUGUST

C. Mishra, secretary, Union environment and forest ministry, has been accused by the CBI of tampering with files pertaining to start of work at the controversial Taj Heritage Corridor project at Agra. According to CBI, which is carrying out a thorough investigation on the direction of the Supreme Court into the alleged irregularities and malpractices in the construction of the Rs 175 crore project, Mr Mishra made "interpolations and tampered with the file in order to cover up his omissions." The investigating agency has accused the senior official of tampering with the files to cover up his lapses in failing to approve the "proposal of the joint secretary and special secretary" to ask Uttar Pradesh government to proceed with the work of the project only after getting statutory clearances and approvals

Efforts to get Mr Mishra's comment on the CBI allegation did not succeed as he refused to take calls. Though during questioning by CBI, he is reported to have denied having tampered with files but the agency has still stated in its report that he did "interpolations" of files. On the directive of the Supreme Court, the "interpolated and tampered" files were being sent to the Central Forensic Science Laboratory (CFSL) for verification by a handwriting expert of the notes made on the files. Meanwhile, CBI is now planning to question former chief minister Ms Mayawati, as it found that the work was started at the site only after her office gave the go ahead for the project. According to CBI, the project was started with undue haste by the Mayawati government and the work at the site

began on the basis of "oral orders" issued by the then state environment secretary R.K. Sharma.

The CBI has so far not found any basis for assessing the cost of the project at Rs 175 crore and alleged that work on the banks of river Yamuna was started without "preparation and approval of techno-feasibility report, detailed project report, detailed drawings and cost estimates." Accusing the Mayawati government of not sending the techno-feasibility report and other related documents to the central government for clearance before commencing work, CBI said that the work at the site was started without signing of any agreement between the state government and National Project Construction Corporation (NPCC).

Questioning several persons who dealt with the project papers including then environment minister Naseemuddin Siddiqui, the agency claimed to have found papers which were interpolated and tampered with by him to cover up his sanction order for release of Rs 20 crore for the project in May, 2003. — PTI

MULAYAM'S TASK AHEAD

BY STATING THAT cases against political leaders under the Prevention of Terrorism Act (PO-TA) will be withdrawn immediately, the new Uttar Pradesh Chief Minister, Mulayam Singh Yadav, has conveyed his determination to undo one of several instances of abuse of power by the Mayawati dispensation to settle scores with its political rivals. Among others, Raghuraj Pratap Singh, independent MLA, will be set free. His arrest and detention under POTA by Ms. Mayawati was a glaring case of abuse of a draconian law to settle partisan scores. Mr. Singh was arrested soon after he began gathering MLAs to pull down the Mayawati regime. But then his track record cannot be glossed over. Raja bhaiya, as he is known, has come to represent a tendency in the politics of the region that considers it legitimate to put down all forms of assertion by the socially oppressed classes. Mr. Singh has been accused of murder and other criminal acts. Hence it is imperative for Mr. Yaday scrupulously to ensure that the law takes its course.

This imperative assumes a lot more importance in the larger context of the regime change in Uttar Pradesh. The Bahujan Samaj Party as a political platform and Ms. Mayawati in particular exemplify a socio-political process that is rooted in a Dalit exclusivist agenda fashioned by Dr. B.R. Ambedkar in the midst of the freedom struggle. The inability of the major parties in Uttar Pradesh to internalise the concerns of the Dalit masses during the decades after Independence helped this agenda gain credibility and strike roots across the State. This facilitated the emergence of the BSP as a force on the Uttar Pradesh political scene. A sense of enduring bitterness against other social groups, cultivated among Dalits by Mr. Kanshi Ram and Ms. Mayawati after they founded the BSP in 1987,

helped the party develop into a powerful electoral force. Starting with 10 per cent of the vote in the 1989 Assembly election, the BSP moved into the 20 per cent band within a decade. While this undoubtedly represents political success, the bitterness that marks the socio-political scene in the State and the resultant cleavages and tensions place Dalits in a vulnerable position, especially when the BSP is out of power. This at least is the widespread perception. Much of Ms. Mayawati's politics revolves round this theme. It explains the nature of the campaign she has already launched: instead of finding the reasons for her downfall in her own imperiousness, misgovernance and abuse of power, she attributes it to a diabolical 'conspiracy' against Dalits by 'manuvadi' parties. However, Ms. Mayawati's self-serving agenda must not be allowed to obscure basic social realities. The spectre of attacks on, and intimidation of, Dalits is not something conjured up, especially in a State where caste cleavages and tensions are directly expressed in politics.

Mr. Yadav, who has become Chief Minister for a third time, must show the way to his party and its allies in handling a potentially volatile situation. He must not allow the BSP supremo's provocative and, at times, paranoid style to set the terms for his governance. He must apply a calming hand to the politics of India's most populous State. He must not allow his party, which has suffered many wrongs at the hands of Ms. Mayawati, to resort to tit for tat. He must ensure that the ideal of social justice, a tradition inherited by the Samajwadi Party, is not reduced to an empty slogan. He must instruct his administration to do everything in its power to ensure that the Dalit masses, especially in rural U.P., feel secure and at ease, notwithstanding Ms. Mayawati's high-decibel campaign.



Mulayam in Pota bailout

New CM avoids annoying BJP on Ayodhya trials

MOMENTS AFTER being sworn in as Uttar Pradesh Chief Minister on Friday, Mulayam Singh Yadav revoked the Pota cases against Independent MLA from Kunda, Raghuraj Pratap Singh alias Raja Bhaiyya, his father Uday Pratap Singh, Independent MLA Dhananjay Singh and MLC A.P. Singh.

Later, at a news conference, Mulayam announced a review of all criminal cases filed by the police under Pota, the Gangster Act, Goonda Act and other laws.

But he ducked a question whether he would reverse the Mayawati government's decision on the Ayodhya demolition case and issue a fresh notification for resumption of trial of all the accused by the special CBI court in Lucknow instead of Rae Bareli. "This question would be

"This question would be collectively decided when we have a full Cabinet," the new chief minister said. He, however, vaguely indicated that his views on the Ayodhya issue remain unchanged, saying everyone should abide by the court verdict

the court verdict.

The BJP cautioned Mulayam against shifting the trials from the Rae Bareli court, saying if this was done, Yadav would face "political exile". The Supreme Court is to begin hearing on September 1 a petition challenging the Mayawati government's decision. BJP spokesman Mukhtar Abbas Naqvi said, "It is a political case and he would go into exile again as had happened earlier in 1995 after his second term as chief minister if he repeats what he had done earlier."

4A. NEW REGIME IN UTTAR PRADESH

BY INVITING THE Samajwadi Party leader, Mulayam Singh Yadav, to form a Government, the Uttar Pradesh Governor, Vishnu Kant Shastri, has played it by the book. After the fall of the Mayawati Government, democratic convention required the Governor to explore the prospects of an alternative Government before contemplating any drastic steps. In deep trouble over the scandalous Rs. 175 crore 'Taj Heritage Corridor' project being probed by the Central Bureau of Investigation under orders from the Supreme Court, the Bahujan Samaj Party supremo decided to vent her fury by recommending dissolution of the State Assembly. The Samajwadi Party, the single largest party in the State Assembly, alone had the potential to form an alternative Ministry. The potential was actualised through the smaller parties in the Assembly conveying their willingness to support Mr. Yadav's Government. The fact that Mr. Shastri did not waste any time after this has helped avert uncertainty. Fortunately, the sequence of events following Ms. Mayawati's desperately adventurist play saw all the major political players in the State respond with a sense of sobriety. For one thing, it was the BJP Legislature Party leader, Lalji Tandon's preemption of Ms. Mayawati's move for dissolution by informing the Governor of the party's decision to withdraw support that paved the way for Mr. Yadav's Chief Ministership.

Such constructive spirit was all the more necessary given the fragmentation of the polity in Uttar Pradesh during the past decade. The political arithmetic in the Legislative Assembly reflected caste cleavages in society. The Bahujan Samaj Party-Bharatiya Janata Party coalition, put in place after the fractured verdict of February 2002, was an unstable arrangement by any yardstick. Ms. Mayawati's Chief Ministership was an essay in imperiousness, repression, con-

tempt for the norms of coalition ethics, and unashamed abuse of power. She made a costly miscalculation by serving an ultimatum on the Prime Minister to throw the Union Tourism Minister, Jagmohan, out of the Union Cabinet. It quickly became clear that her hostility to Mr. Jagmohan had everything to do with his proper and timely opposition to the Taj Heritage Corridor project. With the Prime Minister, Atal Bihari Vajpayee, and his senior colleagues in the BJP deciding to reject the ultimatum, Ms. Mayawati found herself a sitting duck - with the CBI on her trail and the Central Government studiously refusing to save her. With the CBI enquiry reportedly finding evidence of her approving the Tai Heritage Corridor project, which gives the lie to her earlier protestations, the filing of a criminal case against Ms. Mayawati could be imminent.

On the other side, Mr. Yadav's task now may not be as difficult as it appears on paper. The Samajwadi Party, with 142 members in the Assembly, is a strong force with well-organised support and major resources. The smaller supporting groups, including the Congress and Ajit Singh's Rashtriya Lok Dal, will find it difficult to pull the rug from under his feet. To make up a majority and run a stable government, Mr. Yadav will need to muster support from other quarters. The track record suggests that power in the hands of a strong man like Mr. Yadav could be an irresistible magnet. The BSP seems to be cracking up, but the number of MLAs willing to cross over from its ranks will need to be at least 37 for the defectors to avoid disqualification under the anti-defection law. The imponderables notwithstanding, the fact that Uttar Pradesh has been liberated from Ms. Mayawati's awful ways of governance and will not be obliged to go to the polls a year and a half after the last Assembly election will come as a major political relief.



Mulayam claims support of 212 MLAs

LUCKNOW, AUG. 27. The Uttar Pradesh Governor, Vishnukant Shastri, continued to weigh his options even while the Samajwadi Party leader, Mulayam Singh Yadav, tonight rallied the support of 212 MLAs, including 14 from the Bahujan Samaj Party, to substantiate his claim to form an alternative Government in Uttar Pradesh.

The State Assembly has an effective strength of 402 members.

Leaders of all major political parties, excepting the Bharatiya Janata Party and the BSP, accompanied Mr. Yadav to the Raj Bhavan to urge Mr. Shastri to invite Mr. Yadav to form the Government. They said more than 50 per cent MLAs had already met the Governor to extend their support to Mr. Yadav and there was no doubt that he would prove his majority on the floor of the Assembly.

Mr. Yadav told newspersons after coming out of the Governor's chamber that he was quite hopeful that he would be invited to form the Government. The Governor had told him that he would take a decision keeping in view the facts before him, he said.

The SP leader evaded a direct reply to the question if he had submitted a list of his supporters to Mr. Shastri as he had asked him to do in his letter written yesterday. The Governor had the list of all MIAs who had called on him during the day with their letters to support his claim, Mr. Yadav added.

Those who accompanied Mr. Yadav to the Raj Bhavan tonight to support his claim included,

Earlier during the day the leaders called on the Governor one by one and handed over to him letters extending their support to Mr Yadav. Their main logic was that MLAs irrespective of their party affiliations were against fresh elections and that Mr. Yadav would be able to prove his majority on the floor of the Assembly. They urged the Governor to invite him to form a Government without any more delay as that was necessary to

uphold democratic traditions.

The last to call on the Governor to extend their support to the SP leader were some MLAs belonging to the Bahujan Samaj Party. They came to meet Mr. Shastri along with the SP general secretary, Shiv Pal Yadav, and said the Governor should invite Mr. Yadav to avoid elections. According to them, Mr. Yadav alone was capable of having a majority support in the House.

To the dismay of the outgoing Chief Minister, Mayawati, the rebel BSP members said the number of their party MIAs coming to support Mr. Yadav

could ultimately go up to 40. Ms Mayawati had only yesterday claimed that her party was united like a rock and any efforts to split her party would not succeed.

While the number of MLAs presented before the Governor had already exceeded the 50 per cent mark, if the MLAs belonging to the BSP are excluded from the list, the support to Mr. Yadav would be found marginally deficient. There is speculation that the number of BSP rebels could soon go up to a level where a formal split could be formalised in the party.

U.P. Governor as Mulayam for list

LUCKNOW, AUG. 26. The Uttar Pradesh Governor, Vishnu Kant Shastri, today asked the Samajwadi Party leader, Mulayam Singh Yadav, to submit a list of his supporters in the Assembly to substantiate his claim to form a government in the State. Mr. Yadav has been asked to submit the list by tomorrow.

The SP leader had earlier called on the Governor to stake his claim to form a government as his party was the single largest group in the Assembly. He had cited various examples in the past when the single largest party alone had been invited to form the government. He told the Governor that he would prove his majority on the floor of the Assembly when needed.

The Chief Minister, Mayawati, who had yesterday recommended the dissolution of the Astoday tendered her resignation, simultaneously expressing her unwillingness to continue as the caretaker Chief Minister

Ms. Mayawati seemed to have taken the move to resign to pre-empt the imposition of President's rule in the State. She said she had deliberately taken 24 hours to resign after she recommended the dissolution of the Assembly. Had she resigned yesterday, her action would have led to constitutional problems, making it difficult for the Governor to impose President's rule.

Talking to newspersons after handing over her resignation letter to the Governor, Ms. Mayawati said the leaders of the BJP and other parties had been "propagating" that she was power-hungry and wanted to cling to the post. But this was contrary to her nature or principles. For, her political power was only to fulfil her social objectives.

'Support to NDA withdrawn'

Replying to question, Ms. Mayawati said the BSP's support to the National Democratic Alliance Government in Delhi had automatically been withdrawn with her severing ties with the BJP in Uttar Pradesh.

Ms. Mayawati alleged that horse-trading had already started to allure MLAs from other parties. As many as 40 BJP MLAs were on the verge of leaving the party. They were ready to form a party of their own and would bargain with any one who

was invited to form the next government. She had urged the Governor to see that no one was allowed to play with democratic values.

Asked what would happen if the Governor did not accept her recommendation to dissolve the Assembly she said this would only affect the political health of the BJP. Some dissident BJP MIAs had established contacts with her own party legislators to allure them to support an alternative government. The BSP MLAs had, however, refused to fall into the trap, she added.

She ridiculed the BJP leaders for their claim that they had withdrawn their support to her Government before her recommendations to dissolve the Assembly. If their contention was correct, how was it that BJP Ministers were present at the Cabinet meeting where she had taken the

Also, no BJP Minister had resigned from her government till today. "How can they continue as Ministers in my government, if the BJP had withdrawn its support to me?," she asked. 

Temple-like structure existed, says ASI report

Lucknow: Giving the saffron brigade a shot in the arm, the Archaeological Survey of India (ASI) has concluded the existence of a temple-like "massive structure", belonging to 10 AD onwards, beneath the disputed site in Ayodhya in its 574-page report.

The ASI report, submitted on August 22, was opened by the three-member full bench, comprising Justice S.R. Alam, Justice Khem Karan and Justice Bhanwar Singh on Monday. The bench has given the contesting parties six-weeks' time to file their objections on the sensational revelations made by the ASI in its two-volume report.

"Viewing in totality and taking into account the archaeological evidence of a massive structure just below the disputed structure and evidence of continuity in structural phases from the tenth century onwards up to the construction of the disputed structure alongwith the yield of stone and decorated bricks as well as the mutilated sculpture of the Divine Couple, 50-pillar bases in association with the huge structure, are indicative of remains which are distinctive features found associated with the temples of north India," concluded the ASI in its report.

The ASI team, led by Hari Manjhi and B.R. Mani, had excavated the disputed site for nearly five months between March 12 and August 7 on the March 5 order of the high court. In its report on the excavations, the ASI has dwelt at length on the period from circa 1000 BC to 300 BC and from Sunga (first century BC) to Kushan, Gupta, Post-Gupta up to the Medieval Sultanate level (12-16 century AD).

The ASI report makes mention of a huge

halls), with at least three structural phases and three successive floors attached with it was constructed later on. "There is sufficient proof of existence of a massive and monumental structure having a minimum of 50 x 30 metre in north-south and east-west directions, respectively, just below the disputed structure," claims the report.

To prove its point, the report says that during the course of digging, nearly 50 pillar bases with brickbat foundation below calcrete blocks topped by sandstones, were found. Significantly, it also suggests the existence of an original sanctum sanctorum or a place of importance. But it could not excavate the spotted area because of the presence of the Ram Lala makeshift temple.

Ironically, the ASI report did not give any weightage to the glazed wares, graves and skeletons of animals and human beings found during the excavations. Similarly, the celadon and porcelain sherds and animal bones, skeletons recovered from trenches in northern and southern areas belong to the late and post-Mughal period, it adds.

In drafting its report, the ASI has also given importance to carbon dating to ascertain the period of soil and artefacts found during digging.

Mayawati recommends dissolution of U.P. House

LUCKNOW, AUG. 25. The month-old Bharatiya Party-Bahujan Samaj lition in Uttar Prade came to an end with the bir withdrawing its support to the Government headed by the Chief Minister, Mayawati, and the latter recommending to the Governor, Vishnu Kant Shastri, the dissolution of the Assembly to seek a fresh mandate from the people.

The Governor later told

The Governor later told newspersons that he was examining the two letters — one from the leader of the BJP legislature group, Lalji Tandon, informing that his party had withdrawn support to Ms. Mayawati and the other from the Chief Minister recommending the dissolution of the Assembly. Mr. Shastri, however, stressed that he had received the letter from Mr. Tandon much ahead of that of the Chief Minister giving a

hint that there was little chance of his accepting the recommendation of Ms. Mayawati to dissolve the House.

eticulous plan

In what looked like the execution of a meticulously prepared plan, Ms. Mayawati had called a meeting of the Cabinet at 10 a.m., an hour before an All-India Convention of BSP workers was to begin at the Ambedkar Maidan here. After some routine matters were dispensed with at the Cabinet meeting the Chief Minister announced that she had decided to resign and recommend the dissolution of the Assembly, throwing the BJP Ministers into a state of shock.

The issue was hurriedly discussed with the pational BJP leaders in New Delhi when a decision was taken to write to the Governor to withdraw the party support to Ms. Mayawati. Accordingly, Mr. Tandon drove to the Raj Bhavan to hand over the

letter. Ms. Mayawati reached half an hour later with her letter.

'Political instability'

In her letter, Ms. Mayawati claimed that she had a clear majority in the Assembly but the Opposition was trying to create an atmosphere of political uncertainty in the State making financial allurements to the MIAs.

She said nearly three dozen MLAs of the Samajwadi Party were ready to quit for the sake of ministerial posts and monetary considerations. Nearly three dozen MLAs of the BJP had established contact with the Opposition and were ready to cross to its side. Added to these were 14 MLAs of the Rashtriya Lok Dal who were bargaining with both the sides.

She pleaded that it was necessary to dissolve the Assembly to end this state of political instability in the State.

THE PROBLEMATIC BAHUIAN Samai Party-Bharatiya Janata Party alliance in Uttar Pradesh has collapsed. Such a collapse was built into this unprincipled alliance. A durable coalition has to be an alliance of compatible social forces. Ms. Mayawati's social base, consisting overwhelmingly of Dalits, has little in common with the BJP's constituency, mostly the forward castes. It was a convergence of political compulsions that brought the BSP and the BJP together after the Assembly poll in February 2002; both were determined to keep the Samajwadi Party, the largest party in the new Assembly, out. National and regional calculations prompted this Faustian bargain. Although the BJP's central leadership prevailed, a section of the U.P. BJP, especially those close to the former Chief Minister, Rainath Singh, remained unreconciled to the alliance and continued to wage a cold war against the Mayawati regime. Ms. Mayawati did little to endear herself to her detractors within the BJP; on the contrary, her style of functioning alienated even her supporters. For instance, the Prime Minister had to publicly chide, during the no-confidence motion debate in the Lok Sabha, the U.P. Government for carrying out "excise raids" against the supporters of the Samajwadi Party. On its part, the BJP was becoming less and less dependent on Ms. Mayawati's goodwill, especially after the Ayodhya "conspiracy case" got going at the Rae Bareilly court. Then, the Taj Heritage Corridor controversy squared off the BSP with the Central Government; here, again, Ms. Mayawati would not accept the reality that the Centre's capacity to influence the CBI's enquiry, ordered by the Supreme Court, was limited. The coalition dharma was just not working as the two partners had run out of political reasons to stay together. From these circumstances flowed Ms. Mayawati's decision to seek an early dissolution of the State Assembly M In the normal course, the Governor would have been obliged to accept the Chief Minister's recommendation on the dissolution of the Assembly. However, the BJP leaders were smart enough to beat Ms. Mayawati to the Raj Bhavan in Lucknow by a few hours, submitting a letter to the Governor pre-emptively withdrawing the party's support to the Chief Minister. Under the circumstances, the Governor is entitled to invoke his discretion in the matter of accepting - or not accepting - the advice of a Chief Minister who has lost majority support. The Chief Minister has argued that only a dissolution and another Assembly poll will deliver Uttar Pradesh out of its current deadlock. There is no guarantee that another election, within the next few months, will be able to sort out debilitating caste animosities to enable the electorate to give a clear-cut majority to one or another party. The U.P. Governor cannot take at face value Ms. Mayawati's advice on dissolution. The Constitution imposes on a Governor the obligation to guard the State and the electorate against a reckless invocation of Article 174(2)(b). The Governor is enjoined, constitutionally and morally, to explore the possibility of putting in place an alternative government. And given the fact that the Samajwadi Party has the largest number of MLAs (142) the Governor has no option but to ask its leader, Mulayam Singh Yadav, to try to cobble together a Ministry. This may not necessarily suit the BJP's political interests and, in the recent past, the Governor has given the unfortunate impression of being very mindful of the BJP's preferences. This is no time for partisanship; rather, it is time for Governor Vishnukant Shastri to summon the requisite constitutional statesmanship and to explore sincerely the alternative government option. Bringing the State under the Governor's Rule should be a last resort.

The Taj factor...

Aug. 25. — The raging controversy over the UP government's Rs 175-crore Taj Heritage Corridor project seems to have played a role, among other factors, in sparking off the current political turmoil in the state.

The already strained relationship between the BSP and the BJP reached a critical point on 28 July when Ms Mayawati demanded Mr Jagmohan's dismissal accusing him of colluding with her detractors to dislodge her government over the Taj project scandal. Less than 24 hours later, she backtracked from her demand in the wake of some tough talking by Mr Atal Behari Vajpayee. The stormy episode, however, introduced a major element of distrust in the relations between the two coalition partners.

The media, along with Mr Jagmohan had raised a stink over the Taj project in June, which ultimately forced Ms Mayawati to stall it. Not surprisingly, on 30 July, Ms Mayawati convened an emergency meeting of the BSP legislature party where she bluntly asked her MLAs to get ready for fresh elections. She also vented her spleen against the BJP for not backing her government in Parliament when the Opposition slammed it over the Taj issue. She also gave a shade of suspense to the already volatile state political scenario by seeking a postponement of the Assembly Budget session from 7 August to 28 August. Meanwhile, Mr LK Advani made it clear that Mr Vajoay-ee had not given any "assurance"

to Ms Mayawati on her complaint in the Taj matter.

Ms Mayawati's discomfiture over the Taj project grew after the Supreme Court ordered the CBI to inquire into alleged "irregularities and illegalities" in the scandal. On 21 August, the apex court directed the CBI to interrogate four to five "high and mighty" persons named in the CBI's interim report for their alleged complicity in the construction of the project without any clearance from the Centre. The court asked the CBI to probe even their assets as the UP government had released Rs 17 crore to launch the project.

The allegations involving payment of kickbacks have already been doing the rounds. The court told the agency to complete the inquiry "expeditiously" and submit its final report by 11 September.

Taking note of allegedly interpolated documents relating to the case as indicated by the interim CBI report, the apex court also ordered the director of the Central Forensic Science Laboratory to conduct a handwriting analysis of the material.

Yesterday, the CBI questioned the UP environment minister, Mr Naseemuddin Siddiqui, known as Mayawati's "favourite minister", in connection with the scam. It has already examined Mr RK Sharma, suspended environment secretary, Mr DS Bagga, chief secretary, and other senior officials. Mr Sharma has accused Mr Bagga of clearing the Taj project and releasing Rs 17 crore.

Amar Singh, who was in Jaipur, airdashed to the capital, while Ajit Singh was on the phone with senior Congress leaders and former U.P. Chief Minister, Kalyan Singh.Amar Singh conferred with Congress president, Sonia Gandhi, Ajit Singh and Kalyan Singh. The Opposition made it clear



ting this project implemented by sub-contractors and you have used the NPCC for getting the contract without a tender," Mr Agarwal claimed Mr Sharma had told some people. Mr Agarwal was the advo-

cate on record for the UP government in the Taj Heritage Corridor case but was removed "within four days of communicating the complaint to the chief secretary" against P.K. Sharma

T was a tawdry sight as Mayawati's I was a tawury signt as many for flock forces successive adjournments in the Lok Sabha, baying for Union minister Jagmohan's scalp. The climax of a sorry drama starring a misconceived project and a government on the run. Ever since the Taj Heritage Corridor project was bared by an alert media, everyone has wondered how the monumental folly reached the stage it did. Just who sanctioned those criminally tasteless plans to construct a shopping complex in the vicinity of one of the world's most beautiful monuments in the first place? Just what was the Uttar Pradesh government doing anyway? On her part, Chief Minister Mayawati has been furiously trying out scapegoats. It was one unfortunate bureaucrat, her former secretary of environment, who was wholly responsible and must be suspended forthwith, earlier this month. It was Union Minister for Tourism and Culture Jagmohan now. He was guilty, presumably, for not having held the state government's hand before it could sanction the crime. He was also guilty, Mayawati screamed, of a grand design to destabilise her government, and BJP-BSP relations, too.

Sorry, Behenji, the glove did not fit, again. It stretches the credulity to believe that the chief minister of the state was the last to know of construction activities so impossible to keep under wraps. It carries even less

weight that the Union minister and the Archaeological Survey of India should be the one to take the rap for something that happened under the UP government's nose. And then there's the in-your-face normlessness of Mayawati's tirade. The press conference in Lucknow, to read out for all to hear the contents of a letter she has written to the prime minister, before he has a chance to respond. The attempt to bully and blackmail in Parliament even while a CBI inquiry into the case is in progress, ordered by the Supreme Court.

There is obviously more to this mess than meets the eye. The unfolding drama has much to do with the turbulent state of always-rocky BJP-BSP relations in the coalition government they run in UP. As if on cue, a group of BJP MLAs from UP have reiterated their demand for the BJP leadership to snap its ties with the BSP. It is also not incidental that all of this is playing out in an election year. NEW DELHI, JULY 29. The fragile alliance between the Bharatiya Janata Party and the Bahujan Samaj Party which is keeping the Mayawati Government going in Uttar Pradesh reached the breaking point today but the crisis blew over quickly after Ms. May-awati retracted her earlier demand for the dismissal of the Union Tourism and Culture Minister, Jagmohan, on the issue of the Taj Heritage Corridor project.

In fact, after retracting her demand for the dismissal of Mr. Jagmohan at a press conference in Lucknow, Ms. Mayawati rushed to Delhi and met the Prime Minister, Atal Behari Vajpayee, to personally assure him that she wanted the alliance to survive and that she continued to support the National Democratic Alliance Government led by him at the Centre

This meeting was preceded by a BJP "high command" meeting where the Prime Minister, the Deputy Prime Minister, L.K. Advani, the party president, Venkaiah Naidu, the Human Resource Development Minister, Murli Manohar Joshi, and the Finance Minister, Jaswant Singh, were pre sent. Reports suggest that the top BJP leadership has decided to take a "tough stand" and warn Ms. Mayawati that they will not tolerate this kind of behaviour in the future. In fact, when Ms. Mayawati arrived at the Prime Minister's residence shortly after 8.30 p.m. — and the meeting continued till about 10 p.m. — the "big five" of the BJP stayed on to do some frank talking.

Mayawati beats a hasty retreat

HE BJP on Tuesday got the better of the BSP in the UP poker game when it forced the Uttar Pradesh chief minister Ms Mayawati to back out from her demand for the dismissal of Union culture minister Jagmohan by threatening to pull down her government.

The party which has for long been at the receiving end of Ms Mayawati's muscle-flexing today succeeded in calling the Uttar Pradesh chief minister's bluff by putting up a calibrated show of aggression and indicating that the party would prefer to pull out of the Uttar Pradesh coalition rather than appease her with the scalp of Mr Jagmohan. While Mr A B Vajpayee told the chief minister over phone that he would not like any intrusion into a turf that belongs exclusively to the prime minister, deputy prime minister L K Advani said that his party's members are unhappy over the relentless attack on their leaders.

The prime minister also chose to make public his annoyance with the UP chief minister at the meeting of the BJP's parliamentary group. The meeting saw the leadership allowing as many as 21 MPs to vent their anger against the UP chief minister and their demand for the withdrawal of support to the Mayawati government. This was promptly shared with the media at the routine briefing by spokesman Mr V K Malhotra. "The prime minister told the meeting that there was no question of asking Mr Jagmohan to resign from the government. He enjoys the complete confidence of the prime minister." Mr Malhotra said. At another briefing, party president Venkaiah Naidu said Mr Jagmohan is an honest and efficient minister. "He will con-

tinue in the government," Mr Naidu said.

The plain talk by the big two of the government as well as tough mood in the BJP, Ms Mayawati called a press conference to make the conciliatory noises. Announcing the climb-down at Lucknow, the chief minister was a picture of accommodation and reasonableness as she asserted her desire not just to continue the association with the BJP and NDA but even to upgrade it by a partnership for the Lok Sabha polls. The press conference, which was preceded by heavy drama in Lok Sabha where her colleagues grounded proceedings to a halt demanding the resignation of Mr Jagmohan, also saw Ms Mayawati washing her hands off the agitation in Lok Sabha. "I never asked them to stall Parliament. It was not the right way to express their feelings. I have asked them to ensure smooth conduct of Parliament," the chief minister said. She also used the press conference to claim that she shared a cordial relationship with the BJP.

Climbdown irks Congress

AYAWATI'S climbdown in the confrontation with BJP over her demand for the scalp of Union culture minister Jagmohan has disappointed Congress which was expecting the spat to snowball into a crisis for the NDA: Congress was clearly expecting an escalation of tension and its anticipation was betrayed fully by its members who cheered on the agitating BSP contingent when it forced its way into the Well of the Lok Sabha to demand the ouster of Mr Jagmohan.

The visible glee came from the expectation that the latest of a series of BSP-BJP spats would strain the credibility of NDA as a stable arrangement, besides creating complications for BJP's gameplan to reap a good tally of seats from Uttar Pradesh by partnering Ms Mayawati.



LUCKNOW, JUNE 11. The Opposition parties in Uttar Pradesh have been forced to wait till at least September to fight it out with the Government on the floor of the Assembly, with the Governor, Vishnu Kant Shastri, rejecting their demand to either dismiss the Chief Minister. Mayawati, or direct her to seek a fresh vote of confidence. The last session of the Assembly ended in March.

Breaking his silence over the Opposition claim that with the Rashtriva Lok Dal's withdrawal of support the Mayawati Government had been reduced to a minority, the Governor said that no details had been placed before him which could prove prima facie that the present Government was not in a majority. A press statement issued selectively last night from the Raj Bhavan said that the Governor was not satisfied with the Opposition claim.

Giving details of the sequence of events during the past fortnight, the statement said that on May 30 a delegation led by the RLD chief, Ajit Singh, and the leader of the party in the Assembly, Kokab Hamid, called on the Governor and submitted a letter stating that the RLD was withdrawing support to the Government. On May 31, the Congress Legislature Party leader, Pramod Tiwari, demanded a fresh vote of confidence by Ms. Mayawati in the House in another letter to the Governor.

The State BJP chief, Vinay Katiyar, later called on Mr. Shastri and stated that the Government enjoyed a clear majority in the Assembly.

The leader of the BJP legislature group and Minister for Ur-Development, Tandon, told the Governor that in the past too the Opposition had claimed to have the support of some BJP MLAs. If a list of such MLAs was submitted, the Governor should call them to verify the claim, he said.

Newspaper reports on the Opposition's claim had been appearing all through but no details had been submitted to the Governor which could prove that the Government had lost its majority, the statement added.

The Governor's stand has created problems for the RLD which had shifted its group of MLAs to Srinagar to prevent "poaching". Presently, the RLD legislators are camping in Shim-la. How long the party will be able to protect them is anyone's

U.P. Opposition urges Governor to dismiss Mayawati Govt. FO4

LUCKNOW MAY 30. The Opposition parties in Uttar Pradesh today demanded the dismissal of the Mayawati Government saying that it had been reduced to a minority after the Rashtriya Lok Dal, a constituent of the BJP-led front in the State, had withdrawn support to the ruling coalition. They also expressed their resolve to form an alternative government and claimed that they had an adequate support of MLAs.

The RLD leader, Ajit Singh, accompanied by the Congress general secretary, Nawal Kishore Sharma, and the Samajwadi Party leader, Amar Singh, called on the Governor, Vishnu Kant Shastri, to inform him of his party's decision to withdraw support to the Government. They urged the Governor to dismiss Ms. Mayawati and invite the

Opposition to form an alternative government. Talking to presspersons later, Mr. Ajit Singh said the coalition Government had been formed only after his party had pledged support to Ms.

There were two pillars — the BJP and the RLD supporting the Government till now. With the withdrawal of the RLD support today one of the pillars had collapsed and the coalition government no longer has a majority. The Government should be dismissed and the Opposition allowed to form an alternative Government."

Mr. Sharma and Mr. Amar Singh supported the

RLD chief's contention claiming that technically the Governor had no option but to dismiss the

Mayawati Government. Asked about the number of Opposition MLAs, they said they had enough to form a Government and prove its majority on the floor of the Assembly

Asked who would lead the new government, they said the issue would be decided soon after the Government was removed.

The Governor's stand was not immediately

Earlier in the day, Mr. Sharma, Mr. Amar Singh, Mulayam Singh Yadav, Kalyan Singh and Mr. Ajit Singh had detailed discussions among themselves. Mr. Mulayam Singh and Mr. Kalyan Singh later left authorising Mr. Amar Singh to represent them before the Governor.

While the technical options before the Governor could be debated, the arithmetic in the Assembly has totally changed since the Mayawati Government was installed last year. The main reason being the split in the Congress, eight of whose MLAs quit the party earlier this year. Seven of them later joined the Government and were given ministerial posts. MLAs from smaller par-ties and a group of nine MLAs had also supported the Government on the floor of the Assembly during the last session.

Reports meanwhile suggested that the RLD was in danger of suffering a split in its legislature group, with the Minister for Urban Development, Lalji Tandon, claiming that at least five MLAs of the party were in contact with him.

Ms. Mayawati is presently on a foreign tour.

At sea, Ajit looks for Sonia lifeline

New Delhi, May 28: Rashtriya Lok Dal leader Ajit Singh today met Sonia Gandhi for half-anhour, setting off speculation on the emergence of a "broader" Opposition unity in Uttar Pradesh that could impact the BSP-BJP government in the state.

If the 14-member RLD pulls out, the Mayavati-led coalition will have a majority of just nine in the 403-member Assembly. As if to prepare the road, five RLD ministers have resigned from the Mayavati Cabinet. (See Page 5)

Sources close to Ajit Singh, who recently resigned as Union agriculture minister, said he spoke about regrouping of forces that would include Mulayam Singh Yadav's Samajwadi Party, the Congress, Kalyan Singh's Rashtriya Kranti Party and his RLD. Samajwadi general secretary Amar Singh also met Sonia today.

Congress sources said Sonia was "non-committal" and met Ajit Singh only because he sought an appointment after resigning from the NDA government. The Congress' plan, they added, was to "wait and watch". According to the sources, Ajit Singh's overture was a "survival tactic" to keep his flock together by propping up the illusion of an alternative government in which the RLD would call the shots.

But given the Congress' experience with toppling a government, party sources said the central leaders are cautious this time. The party had helped dislodge the Kalyan-led BJP government on the eve of the 1998 elections, but failed to sustain an alternative regime.

The Opposition in Uttar Pradesh, the sources said, is wary of Ajit Singh's propensity to switch sides. But RLD sources claimed that Ajit Singh was in touch with the Samajwadi and Kalyan.

Rather than toppling the government immediately, the Opposition is looking at a new equation for the Lok Sabha polls involving the Congress, the Samajwadi, the RLD and the RKP. The number of MLAs in the four parties totals 176, 26 short of a majority in the Assembly.

BJP-BSP coalition to continue in UP

Mayawati sacks minister

Tripathi figures in Madhumita murder

Chief Minister Mayawati has been forced to drop a minister as he figures in the sensational murder of young Hindi poet Madhumita Shukla, shot dead at point blank range last week. Amarmani Tripathi is a great favourite of the chief minister and is said to be her Man Friday, but Mayawati had no option but to let him go in the face of mounting pressure from the Opposition as well as her ally the BJP, objecting to the negative image the controversy was giving to the government. But not to be outdone, Mayawati has shifted the case to the Crime Branch of the CID and asked them to complete investigations within a month. The department is known to be Mayawati's pocket borough and is often used as cold storage for high-profile cases. Tripathi's confidence that he will get a clean chit and Mayawati's promise that the moment his name is cleared he would be re-inducted into the Cabinet are tell-tale signs of a case in which politicians routinely get away with murder.

Tripathi is an old offender with 54 criminal cases pending ag-

ainst him. This is also not the first time he has been dropped from a ministry. In December 2001 he was dropped from the Rajnath Singh ministry after his name figured in the kidnapping of a Gorakhpur businessman. He is a brazen example of the criminalisation of politics in India. Politicians who live life on the edge do as they please and are not in the least bothered about controversies; they always get away with crimes. In the early 90s the tandoor murder case in which a Youth Congress leader had murdered his wife, cut up her body and stuffed it into the tandoor at Hotel Kanishka in New Delhi created a sensation. Since then many such cases have come to light. The murder of journalist Shivani a couple of years ago bears great resemblance to the Madhumita case in which the girls paid the price of illicit affairs with people in power. Criminalisation of power and politics has become a part of the system. The perpetrators have enormous clout and are able to get things hushed up. The crime is talked about for a few months and forgotten. Criminals get away, and it is the bereaved family which it left to deal with their loss without any justice.

Allahabad HC stays Mulayam's arrest MPs deplore 'political vendetta' in UP

THE ALLAHABAD High Court on Monday stayed the arrest of Samajwadi Party president Mulayam Singh Yadav and six others till May 16 in connection with the FIR filed against him in the videocassette case.

A Lucknow Bench of the court, comprising Justice Vishnu Sahay and Justice R.C. Pandey, while hearing the petition of the SP chief, stayed the arrests, adding that In the meantime, the opposite party may file its counter-affidavit, it observed. The petitioners, including senior leaders Azam Khan, Shivpal Singh Yadav, Balram Yadav, Ambika Chaudhary, O.P. Singh and C.B. Singh, had petitioned for

quashing the criminal case filed by the BSP state presi-dent K.K. Sachan on April 14. It was alleged that SP got a BSP in-house meeting shot on video and subsequently released "doctored" CDs of it.

Mulayam's counsel argued that as the FIR was concocted and malafide, hence no case could be made out of it. He said on the ground of parity with the observations of the court on a similar petition filed by SP general secretary Amar Singh, whose arrest had also been stayed, the court should stay the arrest of these leaders.

Meanwhile, cutting across party lines, members of all political parties castigated the Mayawati government in Parliament and asked the Centre to convene an all-par-

ty meet to thrash out a code of conduct for all state gov-ernments so that the "principles of parliamentary democracy" are adhered to.

Raising the issue in the

Lok Sabha, Mulayam Singh urged the Speaker to bring to the notice of the House the "politics of revenge" that Mayawati had unleashed on SP leaders in UP.

Congress chief whip P.R. Das Munshi said there is a "reign of terror" in UP and the developments in the past few weeks have been a shocking revelation. Endorsing his views, Somnath Chatterjee (CPM) and Ram Vilas Paswan (LJP) said the Mayawati government had taken re-course to the politics of revenge which should be put

an end to immediately.
In Rajya Sabha, the MPs demanded the dismissal of the Mayawati government, saying she was indulging in political vendetta by targeting SP leaders. Opposition leaders said the Centre should intervene immediately.

Describing the situation in UP as alarming, Opposition leader Manmohan Singh said the Centre must intervene to stop victimisation of political opponents. SP leader Amar Singh sought protection saying there was threat to his life. Parliamentary Affairs minister Sushma Swaraj said she will convey the issue to the Home Minister and inform the House after ascertaining facts.

Countering the "malicious campaign" attributing political motives to her move, she also emphasised that she was against the anti-conversion law, a subject dear to the Bharatiya Janata Party. She alleged that Mr. Yadav had "flouted" rules while sanctioning money from the Chief Minister's discretionary fund. The then Governor, Motilal Vora, too had granted Rs.18 crores out of the fund he was not entitled to dip into. Her Government had instituted an inquiry into such cases.

"If I was of a vindictive nature, I should have put Mu-

layam Singh Yadav behind bars for the brutal attack against me on June 2, 1995, since I became the Chief Minister a day later," she told a press conference here.

During his tenure, Mr. Yadav had violated the rules for the grants from discretionary funds by giving money over and above the limit of Rs. 35,000. The ceiling was raised after the rules were amended later. "Whether it is Mr. Yadav or Mr. Vora, we will act in accordance with the law and Constitution."

THREE MONTHS ago, UP Chief Minister Mayawati gave herself an enormous birthday party at government expense that even awed Lucknow, the city of nawabs. A few days ago, she exhorted the faithful not to bother with idol worship, but said her followers may erect her statues and that of BSP founder Kanshi Ram! Not stopping at these signs of self-glorification, the chief minister has now instituted over 140 criminal cases against principal political rival Mulayam Singh Yadav. In utter disdain of constitutional provisions, she has also ordered a probe into the conduct of senior Congress leader Motilal Vora relating to the time that he was UP governor.

Rarely, if ever, has such full-blown megalomania been seen in any Indian politician. Even Ms Jayalalitha, the vainglorious Tamil Nadu leader, does not come close, remarkable though her excesses have been. In sheer crassness and single-minded abuse of power, Ms Mayawati's conduct demonstrates that



Ayodhya: A high-level Archaeological Survey of India team arrived here late on Sunday to carry out fresh ex-cavations at the disputed site in the Ram Janmabhoomi complex in compliance with a high court directive. The team will start work from Monday.

A special full bench of the Allahabad high court at Lucknow had directed the ASI on March 5 to begin the excavation within a week to ascertain if a

temple existed at the site on which the Babri mosque stood.

The advance team comprising more than half-a-dozen senior archaeologists is led by superintending archaeologist B.R. Mani. The team is likely to be joined by two world-

class experts from a Canadian company, Tojo Vikas International Pvt Ltd, in a day or two. Tojo Vikas had recently conducted a ground penetrating radar survey of the disputed site on the directives of the court.

The district administration intends to screen the excavation from the peering eyes of the media. Sources said the experts would start their work with

a geographical survey of the area to determine the exact site on which to carry out excavations.

They said that once the desired area was identified, work on mapping the site would start, followed by identification of spots for laying the "trenches". The initial survey and mapping work prior to the digging of the trenches was likely to take a fortnight, the sources said.

Meanwhile, the district administration is reported to have completed all the necessary arrangements required to support the work of the ASI team.

Security in and around the complex has been tightened with the deployment of central forces at important temples of the pilgrim city.

The members of the team and others authorised to visit the site will be issued photo-identity cards. Antiquities and other material, if recovered during the excavation, will be well-guarded, Faizabad SSP

Prashant Kumar said.

Meanwhile, a Jain body has staked claim to the dis puted site saying the demolished structure was built on the remnants of an ancient Jain temple. The Jain Samata Vahini, a social organisation, said in Jodhpur on Sunday that the excavation would prove that a Jain temple existed at the site. SP-BSP battle out on streets

MAYAWATI AND Mulayam's nerve-racking row is now spilling over onto the streets from the Assembly.

Even as the Uttar Pradesh Chief Minister is in a hurry to book Samajwadi Party workers in cases for non-utilisation or misutilisation of CM's discretionary fund distributed by Mulayam Singh Yaday, the SP has started distribution of the controversial video-tape showing Mayawati asking for money from the MLA's development fund.

Nonetheless, both are highlighting misuse of government funds by people in power. SP workers are organising public show of the video tape in different parts of the state. The first one was held on Friday in the SP office in Rampur — the home district of the leader of Opposition, Mohd Azam Khan. As more skeletons are likely to tumble out of the politicians' cupboards, SP leaders are claiming to have yet another video-tape showing "Mayawati's corrupt deeds".

Azam Khan said the party would release the tape at a politically appropriate time. "This was just a cracker. The next one is going to be a bomb," he said, claiming that thousands of CDs showing Mayawati's direction to party MLAs to share their "booty" from development fund had

Mulayam fears arrest under Pota

MULAYAM SINGH Yadav sparked off a storm in the Lok Sabha on Friday by alleging that Mayawati was planning to get him arrested under Pota. He claimed that the UP Police have raided his brother's house.

When BSP members protested, Margaret Alva of Congress complained that the Lok Sabha was becoming hostage of the political troubles in UP.

Earlier, SP's Akhilesh Singh had sought adjournment of Question Hour to raise the UP problems in the House, which was refused by the Speaker. He, however, permitted the matter to be discussed during Zero Hour. Unhappy with the decision, several SP members went to the well of the House and squatted there.

RJD leader in the House, Raghuvansh Prasad, protested against Samajwadi MP Prabhunath Singh's raising of



"state issues" in the House. Singh had got the Speaker's permission to discuss the "collapse of law and order" in Bihar where a party leader had been murdered on Thursday.

already been distributed. "Every MLA, MP and office bearer of the Samajwadi Party has the CD," he said. Some CDs had even been given to friends in the ruling coalition, he added.

Khan said the party will sell

the CD for a nominal price from various stalls. "And for the public shows, we will hire vehicles and projectors," after the party's national executive meeting in Agra later this month. He alleged that the government had raided some shops in the city where the CDs were copied. Asked who provided the SP with the original CD, he said: "Some officer in the CM's huge secretariat."

About Mayawati's allegation of misutilisation of funds distributed by Mulayam from the discretionary fund, he said: "We believe the beneficiaries had used the funds, not misused them." The BSP workers too are unlikely to lie low. "Tension is palpable with the tempers running high on both sides. We do apprehend violent clashes between SP-BSP workers in the coming days," said a senior police officer.

The developments in UP had rocked Parliament on Thursday, with the Opposition in the Lok Sabha demanding the dismissal of the Mayawati government and their counterparts in the Rajya Sabha blocking listed business in order to force a discussion on the issue. This resulted in adjournments in both Houses.

The Samajwadi Party and the Congress were at the forefront of the Opposition charge, riding the contention that the constitutional machinery had broken down in UP. While the Rajya Sabha was adjourned twice, the Lok Sabha was adjourned for 15 minutes after lunch break, when Akhilesh Singh of the SP threatened to resign in protest against the inaction of Parliament and threw his coat on the official reporters' table.

No-trust motion against Mayawati Govt. defeated 401

LUCKNOW, MARCH 5. The Opposition-sponsored no-confidence motion in the Uttar Pradesh Assembly was rejected today by voice vote amid chaos and scuffles between the security staff and members of the Samajwadi Party who were protesting the manner in which S. C. Srivastava, who was in the Chair, rushed through the day's agenda.

The motion was moved following allegations that the Chief Minister, Mayawati, had appealed to the MPs and the MLAs of the Bahujan Samaj Party to contribute handsomely to party

The Opposition had claimed that it had videotapes to prove the charge.

There was no debate on the motion as also on the motion of thanks to the Governor's address, the supplementary budget for the current year, and the vote on account and appropriation bill relating to six months

of next year's budget. While the Opposition wanted the debate on the no-confidence motion to be put off, the Government was determined to finish the business of the Assembly today itself.

The House was adjourned sine die after Mr. Srivastava announced that the no-confidence motion had been defeated.

The eight-hour proceedings were plunged into chaos, forcing adjournments at frequent intervals.

During the earlier part of the day, the interruptions were caused by the BSP members protesting certain remarks made by the Leader of the Opposition, Azam Khan, against a party member, Haji Yaqoob. Each time Mr. Khan stood up to speak, the members forced adjournments.

The Speaker, Kesri Nath Tripathi, who was in the Chair for a brief time after question hour, allowed Mr. Khan to table the motion. The BSP members, however, did not allow him to speak which necessitated adjournments.

Mr. Srivastava then proceeded with the business of the House even while protests from the BSP benches continued.

A fresh meeting of the Business Advisory Committee was called and a proposal moved to finish the entire business of the current session, including the debate and voting on the noconfidence motion, today itself. The Opposition members of the committee resigned in protest.

Atug of war ensued when the House reassembled, with Mr. Srivastava rushing through the business and the SP members trying to stop him by raising slogans, throwing paper missiles and making efforts to reach his podium.

And every time the SP members got close to his Chair, Mr. Srivastava adjourned the House for a few minutes.

When the House reassembled, he again rushed the agenda. When he called out the names of the Opposition members at the fag-end of the day to speak on the motion, the SP members were still fighting the security personnel.

The motion was then put to vote and defeated.

Even after the House was adjourned sine die, the SP members were sitting in the well to protest Mr. Srivastava's action

U.P. imbroglio finds echo in

NEW DELHI, MARCH 5. The Uttar Pradesh imbroglio continued to cast its shadow on the proceedings in Parliament. The Prime Minister, Atal Behari Vajpayee, and the Home Minister, L.K. Advani, had a tough time persuading Oppositions MPs not to insist on the tabling of the letter sent by the U.P. Chief Minister, Mayawati, in the Lok Sabha. The Government had been directed by the Lok

Sabha Speaker, M.M. Joshi to get a report from Ms. Mayawati on the incident regarding the video expose relating to the misuse of the MP Local Area Development Scheme (MPLADS) funds. Mr. Advani told the House that he was in receipt of a letter from Ms. Mayawati but pleaded with members not to insist on the letter being tabled.

He said the letter contained several allegations against the Samajwadi Party leaders and it would

not add to the prestige of Parliament to have it become a part of parliamentary record. His plea was initially resisted by Priyaranjan Dasmunshi (Cong.) and Akhilesh Singh (SP).

Later, Mr. Vajpayee intervened to urge the members not to insist on it. He said his Government was prepared to hand over the letter to the Speaker and would be guided by whatever he decided in the matter. Mr. Advani also pointed out that the U.P. Assembly was seized of the matter and it should be left to deal with the issue.

The former Prime Minister, Chandra Shekhar, agreed with the Government that the letter should not be allowed to become a part of the official records.

However, he referred to the "grave situation" in U.P. and said most people feared a "civil war" in the State. He urged the Government to look into the situation.

HC orders excavation of Ayodhya complex

A SPECIAL bench of the Allahabad High Court on Wednesday directed the Archaeological Survey of India (ASI) to excavate the disputed Ramjanmabhoomi-Babri Masjid site in Ayodhya. The ASI has been given one month to complete the task.

The excavation is aimed at discovering whether there was a Ram temple at the site and the mosque was constructed after its demolition. The court while asking the ASI to undertake the excavation also directed it to provide technical help to Tojo-Vikas International (Pvt) Ltd, which has already done a ground penetrating radar survey of the disputed site.

The survey has apparently shown "anomalies" that suggested there were layers of buried structures at the disputed site.

The three-member Bench of Justice Sudhir Narain, Justice Rafat Alam and Justice Bhanwar Singh issued the order after the company suggested archaeological excavations at the site.

The court said the excavation had to be carried out without disturbing the makeshift temple where the idol of Ram Lalla was installed. The excavation should spare the area of the Ram *chabutara*, the order said.

Some of the parties involved in the litigation raised doubts about the ground penetrating radar survey report. They said the report could not be taken to be acceptable evidence, since the Supreme Court had already passed orders saying the status quo had to be maintained. They also said any interference at the site should not be allowed. The argument went that the custodian of the disputed site, the divisional commissioner of Faizabad, had been directed to maintain the status quo.

day hear the Centre's plea for the reconsideration of the apex court's order that no religious activity could be carried out on the land acquired by the government in Ayodhya.

In a cautious response to the high court order, the Opposition parties and secular allies of BJP said it should be accepted by all; the Sangh Parivar outfits welcomed it.

"It is a court order. The matter is under adjudication. It has been the stand of the Congress that the judicial verdict should be accepted and respected by all concerned," party spokesman Anand Sharma said.

Mayawati briefs PM on U.P.\developments

NEW DELHI, MARCH 8. With the controversy over the tape episode and developments in the Uttar Pradesh Assembly refusing to die down, the Chief Minister and Bahujan Samaj Party chief, Mayawati, continued to counter the campaign against her Government.

Ms. Mayawati called on the Prime Minister, Atal Behari Vajpayee, here today to present her views on the episode, which has exercised not just her political rival, Mulayam Singh Yadav, and his Samajwadi Party, but also the Opposition MPs.

She later told correspondents that she had communicated her position in a letter to Mr. Vajpayee and the Deputy Prime Minister, L.K. Advani.

She also indicated that at an "appropriate time," the contents of the letter would be made public.

Responding to the Opposition demand that it make a statement on the developments in the Uttar Pradesh Assembly, the Centre, however, reiterated that it would prefer not to table Ms. Mayawati's letter.

Ms. Mayawati said she had briefed Mr. Vajpayee on the developments in the State over the last few days.

The Prime Minister had told her that the BJP-BSP coalition was working smoothly in Uttar Pradesh and that she should continue to maintain the arrangement. However, Mr. Vajpayee's aides just said he gave Ms. Mayawati a "sympathetic hearing."

The Lok Janshakti Party chief, Ram Vilas Paswan, meanwhile, criticised Mr. Vajpayee and Mr. Advani for extending support to a "corrupt Government" in Uttar Pradesh.

Instead of allowing a debate on an issue that concerned MPs and allegations of misuse of their funds, both the leaders had "diverted" the issue on a "technical point."

Addressing a press conference, he said the issue was not one that concerned just Ms. Mayawati and Mr. Yadav, but all the MPs and the MLAs.

He took offence to the reported statement of Ms. Mayawati describing the MPs and the MLAs as "bikau maal" (saleable commodity) and demanded the dismissal of her Government.



Tapes edited to misrepresent my statement: Mayawati

LUCKNOW, MARCH 4. The Uttar Pradesh Chief Minister, Mayawati, said here today that the video tapes, suggesting that she had asked the MPs and the MLAs of her Bahujan Samaj Party to contribute "handsomely" to the party funds, had been thoroughly edited to present her statement out of

context.

The Opposition Samajwadi Party alleged on Monday that Ms. Mayawati had, at a BSP meeting in 2001, charged her MPs and MLAs with receiving hefty commissions for releasing money from their constituency funds for the implementation of welfare schemes and appealed to them to contribute to the party funds. And, to support its allegation, the SP handed over a tape allegedly containing the recording of the meeting to the Governor, Vishnu Kant Shastri, along with a memorandum urging him to dismiss Ms. Mayawati and order her prosecution. Though the members of the SP delegation, led by their general secretary, Shivpal Singh Yadav, evaded reporters on coming out of the Raj Bhavan, the tapes were supplied to some news channels and telecast later in the night.

Ms. Mayawati said in a hurriedly-convened

Ms. Mayawati said in a hurriedly-convened press meet this morning that the latest attempt to malign her was the result of the SP's "frustration" over its failure to press the motion of no-confidence against the Uttar Pradesh Assembly Speaker, Kesri Nath Tripathi. "They (SP members) have hatched this conspiracy only to hide their

She also levelled counter-charges of corruption against the SP leader, Mulayam Singh Yadav, when he was the Chief Minister and hinted at a probe into the "misuse" of the State Government contingency funds during Mr. Yadav's rule. The

MPs and MLAs of the SP had handsomely contributed "ill-gotten" money towards the construction of a school in Etawah in the name of the former Chief Minister's father, she alleged.

In the Assembly, the Opposition members tried for most part of the day to have a discussion on the issue. Equally determined BSP members resisted their attempts.

The clashes resulted in frequent adjournment of the House, leaving little time for any substantive discussion.

The Leader of the Opposition in the Assembly, Azam Khan, and other leaders of the SP and the Congress were on their feet as soon the House assembled in the morning. They demanded that question hour be dispensed with and the issue be taken up for discussion.

The Presiding Officer, Harish Chandra Srivastava, said the matter could be taken up as an adjournment motion after question hour. The Opposition, however, insisted on an immediate discussion. At this, the House was adjourned till the end of question hour.

As the proceedings resumed, Mr. Khan was allowed to speak on the admissibility of the motion. It was now the BSP's turn to interrupt the proceedings. It led to further adjournment of the House.

Mr. Srivastava finally rejected the motion on the ground that the issue referred to a meeting held in 2001 and did not require urgent attention. But the Opposition did not allow him to proceed further. Shouting from both sides resulted in further adjournments.

At the fag end of the day, official business was transacted amid the uproar and the House was adjourned for the day.

The SP leader, Amar Singh, at a press conference, demanded a CBI enquiry into the allegations against Ms. Mayawati.

NEW DELHI/LUCKNOW, March 4. — Mr Mulayam Singh Yadav's exposé on Miss Mayawati rocked both the Lok Sabha and the Uttar Pradesh Assembly today. While Opposition MPs demanded that the chief minister resigns for allegedly asking her party MPs and MLAs to hand over part of their constituency funds to the BSP account, the Samajwadi Party in the UP Assembly served

a no-confidence notice against the government.

In Lucknow, Miss Mayawati decided to skip the Assembly and instead attacked the Opposition at a press conference at her Kalidas Marg residence. She claimed that both the video cassette and CD given to the Governor by the SP were "distorted" and she had been "quoted out of

context". Promising to "take action against those who made this accusation", she ordered an inquiry into alleged "large-scale bungling" in distribution of money from the Chief Minister's Discretionary Fund by Mr Mulayam Singh Yadav in 1995.

In the Lok Sabha, the Opposition led by the Congress demanded a CBI probe. The Congress also said it would support the SP to try and prop up a secular alternative in UP in the event of the fall of the BSP-BJP government. Mr LK Advani is due to make a statement in the House tomorrow.

The BJP demanded that the Prime

Minister or Lok Sabha Speaker should convene a meeting of leaders to discuss the issue. However, party spokesman Mr Vijay K Malhotra refused to take a stand on the allegation, only saying that it was highly objectionable. Also linked to the issue was the funding of political parties: he demanded that all donations to political parties should be made by cheque.

Opposition MPs took exception to Miss Mayawati's reported remarks about collecting money for party coffers. SP members

trooped into the Well of the House and demanded the cancellation of Question Hour to discuss an adjournment motion on the matter and alleged that the chief minister was "encouraging corruption".

The Samajwadi members, supported by RJD leader Dr Raghuvansh Prasad Singh and Congress chief whip Mr PR Das Munshi

and others, said the chief minister's reported statements "lowered the dignity of Parliament", and demanded a privilege notice against her. But the Speaker rejected the motions, moved by Mr Akhilesh Singh and Mr Ramjilal Suman, and asked the government to make a statement. Then Mrs Sushma Swaraj informed the House that since Mr Advani needed a day's time to collect the facts, he would make a statement tomorrow.

Later Congress spokesman Mr Jaipal Reddy said the Mayawati cassette and CD

Thakurs united against Pota 'misuse'

Feb. 20. — The slogan appears to be "Kshatriyas of India, unite". The All India Kshatriya Ekta Parishad is doing exactly that in protest against the Mayawati government for slapping Pota on Mr Raghuraj Pratap Singh aka Raja Bhaiyya and his father, Mr Udai Pratap Singh.

The Parishad is planning to hold a conference here on 8 March to motivate kshatriyas in the country to launch an offensive for withdrawal of Pota against them. The Parishad president, Mr Pratap Singh, claimed that those scheduled to attend the meet included Samajwadi Party general secretary Mr Amar Singh, Maharani Gayatri Devi and former test cricketer Hanumant Singh of Banswara.

The former Parishad convenor, Mr CN Singh, is a Samajwadi MP. The Samajwadi was very active when the Independents, led by Raja Bhaiyaa, rebelled against the coalition government. Mr Singh said, the kshatriyas were feeling "insulted" and the struggle was to restore their pride. A recording of Miss Mayawati abusing the Thakurs will be played at the conference.

Mr Amar Singh will be the chief guest and will be honoured at the conference. The Parishad leaders were keen to point out, the meet was not to project the Samajwadi leader as a Thakur leader. But it was in recognition of his taking up the cudgels on behalf of Raja Bhaiyya, they said.

The Parishad leaders said, their's was an apolitical organisation, and so would be the gathering at the Laxman Mela grounds here. The president, however, made some very political statements while announcing the programme. The BJP was hand-in-glove with the BSP to harass Raja Bhaiyya. The BJP had used Raja Bhaiyya to prop their government but they had dumped him after the Assembly polls. In the two bye-elections slated later this month, Thakurs were not going to vote for BJP, he said.

He said, the misuse of Pota had led to protests in different parts of the country. As mark of disapproval, the Parishad would blacken the effigies of those leaders who were supporting Pota.

Days and hours of discussions and meetings today led to an uneasy truce between the two ruling coalition partners in Uttar Pradesh, Bahujan Samaj Party and Bharatiya Janata Party, but not before the Prime Minister, Atal Behari Vajpayee, stepped in to say that both the parties must learn to trust each other.

The BJP apparently conceded the BSP complaint that the State BJP leaders were behaving as if they were in the Opposition and making all sorts of charges against the BSP Government headed by Mayawati. This must stop, Ms. Mayawati is believed to have said, and this the BJP promised.

The Chief Minister was at the residence of the Deputy Prime Minister, L.K. Advani, for two hours this morning and was closeted with other BJP leaders, including the party president, Venkaiah Naidu, and the Hu-man Resource Development Minister, Murli Manohar Joshi, and party leaders from Uttar Pradesh. The venue then shifted to Mr. Vajpayee's residence where all the leaders and Ms. Mayawati discussed over lunch the issues that have become irritants in the smooth running of the State Government.

The only tangible decision taken at the meeting was that a group of three State leaders the BJP State president, Vinay Katiyar, the 'prabhari', Kalraj Mishra, and the BJP legislature party leader, Lalji Tandon — would meet Ms. Mayawati at least once a fortnight to discuss the State Government's policy issues, people's problems and issues, people's p. . . . the political situation.

However, Ms. Mayawati made it quite clear that she

would not backtrack on the use of the Prevention of Terrorism Act against the independent legislator, Raja Bhaiya, and his father — an issue that has been exercising the BJP leaders considerably as they feel it has af-fected their 'Thakur' base. While they reportedly told her that POTA was meant to be used against terrorists alone, Ms. Mayawati had come prepared with a file on all the charges against Raja Bhaiya.

The day began with confabulations at Mr. Naidu's residence where Dr. Joshi as well as the three State-level leaders, Mr. Katiyar, Mr. Mishra and Mr. Tandon, were present. They then moved to Mr. Advani's residence where Ms. Mayawati joined them.

'We conveyed the feedback we had received from our State leaders to Ms. Mayawati," Mr. Naidu told reporters later de-scribing the discussions as "very

At the end of the discussions, we agreed that three of our State leaders will regularly interact with the Chief Minister, at least once a fortnight." He was confident that the new "informal arrangement (not a formal coordination committee) would help strengthen the Government and help in running it smoothly.

The meeting also reviewed the numerical strength of the coalition and concluded that there was no danger to the May-awati Government in the face of the no-confidence motion the

Opposition is expected to move.
The truce was expected — Ms. Mayawati needs the BJP support to remain in office and the BJP wants a tie-up with the BSP for the Lok Sabha elections next year to boost its falling graph in Uttar Pradesh.

4 breakaway Cong. MLAs in U.P. Cabinet

LUCKNOW, FEB. 4. The Uttar Pradesh Chief Minister, Mayawati, on Tuesday inducted into her Cabinet four breakaway Con-

gress MLAs who had joined her party on Monday.

Earlier during the day, she had dropped 13 Ministers belonging to her Bahujan Samaj Party to make room for the new entrants, but reinducted four of them after downgrading their status. So far, these four were Ministers of State with independent charge but now they would be subordinate to Cabinet Ministers.

The four former Congress MLAs — Shyam Narain Tiwari, Kameshwar Upadhaya, Kazim Ali and Virendra Singh Bundela

- who were inducted today, were sworn in as Ministers of State with independent charge.

Later, talking to newspersons, Ms. Mayawati said that the doors were open for Opposition legislators to join her Government. And that she meant what she said was evident from the fact that at least five vacancies in the Council of Ministers have not been filled.

(The Congress boycotted the swearing-in ceremony in protest against Ms. Mayawati's 'undemocratic and uncalled for actions," a PTI report said quoting the party spokesman, Akhilesh Pratap Singh.)

Eight Congress MLAs had left the party last week to form a new outfit called Akhil Bharatiya Congress Dal. Four of them joined the BSP on Monday evening and were quickly offered ministerial berths.

The remaining four legislators continue to remain as ABCD members, but have professed their support to the Mayawati Government

The Cabinet reshuffle does not affect the other coalition partners and that was given as the reason why these parties were not consulted before the decision to induct the new Ministers was taken by the Chief Minister.

Ms. Mayawati had, during the day, secured the resignation of 13 BSP Ministers — one Cabinet Minister, eight Ministers of State having independent charge and four Ministers of State. The resignations were im-

mediately forwarded to the Governor who promptly accepted them.

The BSP Ministers who have been dropped are - Gaya Charan Dinkar (Cabinet Minister), Om Prakash, Abdul Mannan, Sharda Prasad and Anees Ahmed Khan (all Ministers of State with independent charge), Ilam Singh, Ayodhya Prasad Pal. Ram Het and Vinay Shakya (all

Ministers of State).
Ram Achal Rajbhar, Ram Bhajal, Mahendra Singh and Haji Yaqoob were also among those dropped but were induct-

ed later.
Ms. Mayawati insisted that all her Ministers had given resignation letters to her even before they had joined her Government and not today.

Cong. to move, or no-trust motion against U.P. Speaker

NEW DELHI, FEB. 3. After strained relations in the last couple of years, the Congress and the Samajwadi Party have begun to smoke the peace pipe, thanks ironically to the Uttar Pradesh Chief Minister, Mayawati. The breakthrough came at the 90-minute meeting late on Sunday between the Congress president, Sonia Gandhi, and the SP chief, Mulayam Singh Yadav.

Though both sides refused to divulge what transpired at the meeting, they have moved closer. As a beginning, they will pool their efforts in unseating the Mayawati-led Government.

The Congress has decided to move a no-confidence motion against the Assembly Speaker, Kesrinath Tripathi, with the "active cooperation" of the SP and other secular parties. "We will seek the support of all the secular parties," said Pramod Tewari, Leader of the Congress Legislature Party leader.

Unlike as in the past, the leadership of both the parties

have established a line of communication and have reportedly been in touch for some time. Sunday's meeting, though held at the initiative of Mr. Yadav, was necessitated by the events in Lucknow, especially Ms. Mayawati's decision to split the Congress.

Keen on building on the breakthrough, Ms. Gandhi is also likely to host a dinner for Opposition leaders, probably later this week.

As far as Sunday's meeting is concerned, according to sources, both sides appear to realise the need to put the past behind them and work together. The idea of an electoral understanding between also reportedly came up. "Various possibilities were discussed," said a senior leader of the party.

Ms. Gandhi today consulted

Ms. Gandhi today consulted senior party leaders. They were briefed about her meeting with Mr. Yadav. Those present were Manmohan Singh, R.K. Dhawan, Motilal Vora, Arjun Singh, Ambika Soni and Ahmad Patel.

Ambika Soni and Ahmad Patel. Earlier in the day, Ms. Gandhi held a long meeting with her party MLAs from U.P., the CLP leader, and the PCC chief. She also held a separate meeting with the former PCC chief, Salman Khurshid, known for his strong views against Mr. Yadav.

The Congress is, meanwhile, drawing up plans to actively involve the MLAs in party work and most of them are being sent as election observers to Himachal Pradesh.

The party is also planning to hold several district and block level conventions throughout the State.

A national-level convention of booth presidents will be held in the capital in March. Plans are under way to stage a public rally here to "protest against the NDA Government's policies".

Mr. Yadav too appeared cagey and clarified that his relationship with the Congress was limited to issue-based support. He sought to rule out the idea of forging a front with the Congress.

Key witness in Raja Bhaiya case shot dead

LUCKNOW, FEB. 3. A key witness in the controversial POTA case against the jailed independent legislator, Raja Bhaiya, and his father was shot dead by unidentified persons at Kunda in Pratapgarh district of Uttar Pradesh today.

Rajendra Yadav, on whose complaint a POTA case was built against the MLA and his father, Uday Pratap Singh, was shot at by two motorcycle-borne assailants around 10.15 a.m. when he reached Kunda from Baand Mau village, the Additional Director-General of Police, Vikram Singh, said. Kunda is the constituency of Raja Bhaiya. Mr. Yadav, who had also witnessed the searches conducted at the Bethi Palace of Raja Bhaiya last month, died before he could be taken to hospital, Mr. Singh said.

Police said the killing would not affect the case

as Mr. Yadav's statement had already been recorded.

'No review of POTA case'

Sticking to her earlier stand, the Uttar Pradesh Chief Minister, Mayawati, turned down a request of the senior BJP leader, Kalraj Mishra, to review her decision of invoking the provisions of POTA against Uday Pratap Singh. Ms. Mayawati reportedly told Mr. Mishra that she was convinced that the action taken against Uday Pratap Singh was correct as she had documentary proof of his antecedents.

Mr. Mishra told PTI that he had requested the Chief Minister to review her decision as Uday Pratap Singh was a public personality with political stature.

Cong. rebel MLAs recognise as separate group in U.

LUCKNOW, JAN. 28. In a new twist to the power equations in Uttar Pradesh, eight Congress legislators today announced their de-cision to sever their links with the parent body and form a separate group Assembly. in the State

The Speaker, Kesrinath Tripathi, formally recognised the group as a separate entity saying that under the provisions of the Anti-Defection Act, they had fulfilled all the conditions for a split. Eight out of the 24 Congress MLAs had written to him that, displeased with the policies of the party on whose ticket they had won the last elections, they had decided now to form a separate group, Mr Tripathi told newspersons. After considering in detail the facts and circumstances of the case, he had recognised the new group to be known as the Akhil Bharatiya

Congress Dal.
A shocked Congress leadership, reacting sharply to the Speaker's decision, said his action was against all norms of honesty and law and amounted to murder of democracy.

In fact, the Speaker's chamber itself witnessed some unsavoury moments with the Congress Legislature Party leader, Pramod Tiwari, making seriagainst remarks

Tripathi. He threatened to bring a motion of no confidence against the Speaker and challenge his decision in court.

This Government could not be saved in any case and would fall the very day the Assembly is called to session," Mr. Tiwari said in the presence of the Speaker.

The Speaker's decision was announced after several hours of suspense when the Congress MLAs remained closeted with him in his inner chamber. First, the eight MLAs came out to announce their decision to form a group in the interest of political

stability and development in the State. Then Mr. Tiwari emerged from the inner room of the Speaker's office and angrily accused Mr. Tripathi of acting

in a dishonest manner.
Mr. Tiwari said Akhilesh Singh had been expelled from the party long ago. The fact had been duly conveyed to the Speaker who later gave his ruling to declare Mr. Singh as an unattached member. But today, Mr. Singh's name had been included in the list of eight defecting members only to increase their strength to one third of the total number of Congress MLAs

in the Assembly, he charged.
According to Mr. Tiwari, his party had 23 members excluding Mr. Singh and a strength of eight among them was necessary to formalise a split.

While Mr. Tiwari was still addressing mediapersons in his outer chamber, the Speaker came out for his formal briefing. He condemned the "intemperate manner" in which the Con-gress leader had reacted against him. While it was any member's right to move a motion of no-confidence against the Speaker, Mr. Tiwari had no right to use uncivilised language, Mr. Tripathi said.

Justifying his decision to recognise the Congress "split", the Speaker said according to the Supreme Court judgment in the G. Vaidyanathan case, the Anti-Defection Act did not recognise any member as "unattached". The description of "unattached" was only for the functioning of the legislature and as far as the Tenth Schedule of the Constitution was concerned, such a member would continue to be considered as a member of the party on whose symbol he had won the elections. Thus, while Akhilesh Singh was an unattached member for the convenience of the functioning of the Assembly, he continued to be a Congress member in terms of the Anti-Defection Act.

Tamil Nadu chief minister Jayalalitha has served notice on Atal Behari Vajpayee to drop Kannappan from his Council of Ministers pending action against him under POTA. After Jayalalitha made her intention known, the minister has been reiterating his support to the banned LTTE, responsible for the assassination of Rajiv Gandhi. Vaiko, leader of the MDMK, along with eight party colleagues, had been jailed for more than a year now by the Jayalalitha government for committing the same offence.

The open stand taken by Kannappan regarding the LTTE is clearly violative of Section 3(1)(b) and 21(1)(a),(2) and (3) of the POTA and is liable to be punished with imprisonment for a term which shall not be less than five years but may extend to life term and shall also be liable to fine. The LTTE has also been declared an unlawful association under the Unlawful Activities (Prevention) Act, 1967, and banned under the Criminal Law Amendment Act, 1908, by the Tamil Nadu government. Kannappan and Vaiko had voted for POTA in Parliament and cannot be unaware of its harsh provisions. Although banning of the LTTE dates back to the NDA coming to power, it has extended the ban at least twice in the last four years. Since Kannappan is not in sync with the NDA government's policy towards the LTTE, the honourable course for him would be to resign and face the consequences of supporting the banned organisation thus avoiding the odium of having another of Vajpayee's ministers being arrested by the Tamil Nadu police.

NEW DELHI, JULY 24. The Supreme Court today persuaded the Tamil Nadu Government to reinstate from tomorrow all the dismissed employees, except the 2,200 employees who were arrested and those against whom FIRs had been lodged.

A Bench, comprising Justice M.B. Shah and Justice A.R. Lakshmanan, virtually extracted an undertaking from the senior counsel for Tamil Nadu, K.K. Venugopal, that the 1.76 lakh dismissed employees would be reinstated on certain condi-

They are: The reinstatement in service from July 25 would be subject to the employees expressing an unconditional apology as well as giving an undertaking that they would abide by Rule 22 of the Tamil Nadu Government Servants Conduct Rules, 1973, which says that "similar activities" shall be deemed to include the absence from work or neglect of duties without permission.

The Government would proceed under the Disciplinary Rules only against those employees who have indulged in violence and who have incited other employees to go on strike.

Mr. Venugopal said that for the employees who would be re-instated in service with regard to the period for which they remained absent, an appropriate order would be passed by the Government for the regularisation of their absence. However, this would not be treated as a 'break in service.'

The Bench recorded this undertaking and ordered accordingly. The Bench made it clear that employees would get their salary from tomorrow.

The Bench said that further

orders and directions would be passed on the batch of five petitions challenging the dismissal and the ordinance amending the Tamil Nadu Essential Servic-Maintenance Act, would be passed on July 31.

When arguments began this morning, Mr. Venugopal submitted that the State Government spent Rs. 13,160 crores on salaries and pensionary benefits of the employees with paid holidays for about 169 days a year. The employees thought they were a "class apart" and due to their agitation on five occasions about 312 mandays had been lost in the last two years. "At some stage, the State Govern-ment had to make up its mind and say that this far and no

more," he said.

He said the court could not pass an interim order directing the reinstatement of all the dismissed employees as that would be contrary to the earlier orders passed by the apex court. The Government would consider the representations of the employees individually and pass appropriate orders and till such time they could be given subsistence allowance.

However, the Bench did not accept this and said that since the employees had realised their "mistake," it was now the Gov-ernment's turn to show "some grace." In the end, counsel gave alternative suggestions these were recorded.

Earlier, P.P. Rao, another Senior Counsel for Tamil Nadu, argued that since none of the dismissed employees was before the court, trade unions representing them had no locus standi to file the petitions. He said the DMK and other political parties had rushed to the apex court against the High Court judgment to gain political advantage when the employees federation had passed a resolution not to do so, but to approach only the Chief Minister.

The Senior Counsel for the employees' unions, T.R. Andhyarujina and P. Chidambaram pointed out that the employees struck work only when they were "pushed to a corner." Mr.

Chidambaram submitted that on July 26, 1991, the State Government had itself asked its employees to be absent from duty for a day in the Cauvery issue.

The arrests took place on June 30 last prior to the commencement of the strike, culminating in the promulgation of an ordinance and dismissal of employees. When he said the provisions of the ordinance were harsh, the Bench told Mr. Venugopal that "before drafting a legislation you must consult proper coun-sel." It also said that "in a democracy you cannot say that we leave the decision to one per-

When Mr. Venugopal insisted that the Government should have the liberty to take action against those who indulged in violence and deal with misconduct, Mr. Chidambaram said "this would result in victimisation." The judges said that "if The judges said that "if you misuse in that manner the results would be different.

The Bench observed that the High Court ought to have exercised its extraordinary power (Article 226) in an extraordinary situation like this and should not have asked the dismissed employees to go to the tribunal as it would be an impossible task for the tribunal — which had only one member — to decide all to decide all these cases. The Bench while indicating its mind said this aspect would be dealt with in the final order to be passed on July 31.

All but 2,200 to be reinstated

Delhi after the court proceedings, held a meeting of all department Secretaries late in the evening and instructed them to issue reinstatement orders to the sacked employe after getting an apology from them for having participated in the strike and an undertaking that they would not resort to any strike in future.

A model format of the apology letter and undertaking has been sent to the "appointing officers." The officials have been told that those who were jailed and against whom first information reports had been lodged should not be reinstated.

THE MADRAS HIGH Court, by rejecting the petition filed by dismissed Tamil Nadu Government employees, has caused deep disappointment not only among the large workforce but also in a much wider community concerned about fairness and basic rights. Although the Court's order to release arrested employees on bail will be greeted with relief, the substance of the ruling in this landmark case amounts to denial of justice. This is particularly so in the light of observations made by the Judges in the course of the hearing, emphasising the core issue as one of justice and not merely of law and expressing doubts as to whether there had been application of mind in the summary dismissal of about 200,000 employees. The ruling does not seem to reflect the perception that the questions involved in the petitions were of too fundamental a nature to fall in the realm of administrative tribunals.

For the State Government's actions in the past week, by any yardstick, were an extraordinary case of deployment of State power against its own employees. The Tamil Nadu Essential Services Maintenance Act (TESMA) 2002, itself a draconian law, was first invoked in response to an indefinite strike by employees in pursuance of demands relating to pension benefits that had been curtailed on grounds of a resource crunch. The Government then came up with an ordinance giving itself the summary power of dismissal en masse, without any application of mind and without giving the employees an opportunity to be heard. The ordinance, which amended TESMA (Section 7), provides for treatment as "deemed participation" in the banned strike any absence of employees irrespective of the actual reason for their abstention from duty after the promulgation of the ordinance. Midnight arrests of employees and their leaders, ret-

The Tamil Nadu Chief Minister, Ms Jayalalithaa, acted within her rights in declaring in the course of negotiations that her Government would concede the demands only to a specified extent. But nothing, including a fiscal crisis (which, by its nature, involves many factors such as taxation, devolution of Central funds, and effective management of public finances), can justify resort to an ESMA-plus ordinance of the kind introduced in the State. It is relevant in this context to note that the Second National Commission on Labour, which submitted its report to the Centre last year, recommended the withdrawal of the Centre's own ESMA, enacted in 1981. It suggested an alternative scheme whereby, in the case of an unresolved dispute in "essential services," a strike was to be "deemed to have taken place" once a strike ballot received the support of 51 per cent of employees, and the dispute would be referred to compulsory arbitration. The clear opinion against ESMA thus pronounced by the Commission and its emphasis that India had an obligation to fulfil the International Labour Organisation's four-point Declaration on Fundamental Principles of Rights at Work 1998, show how ESMA is by universal standards a lawless law. In this day and age, when in the manufacturing and service industries human resource development and employee empowerment are cited as the most effective ways of improving efficiency, summary dismissal and the overnight arrest of hundreds of thousands of employees have no place. Such powers and actions are in profound conflict with fundamental rights, the basic norms of democracy, and enlightened self-interest.

Karunanidhi demands probe into medical treatment for Maran

CHENNAI, JUNE 15. The DMK presider t, M. Karunanidhi, today demanded an enquiry by the Union Health Ministry into the medical treatment given to the ailing Union Minister, Murasoli Maran, at the All-India Institute of Medical Sciences, New Delhi, and the Apollo Hospitals, Chennai.

Mr. Maran had been in a serious condition in a U.S. hospital since last November. He had undergone a valve replacement surgery in the AIIMS in July last. A fungal growth in the replaced valve — which manifested in the form of high fever and chest pain while he was in the AIIMS — led to his being hospitalised again, this time at the Apollo, on September 23. The hospital carried out an emergency high-risk replacement of the mitral valve on September 25.

Mr. Karunanidhi told the media here that the operation, which lasted eight-nine hours, affected the functioning of his kidneys.

Ever since, Mr. Maran's condition did not improve much. Hence, his family shifted him to the Methodist Hospital, Houston, U.S., on November 15 last year.

The Apollo treated Mr. Maran's heart ailment earlier in November 2000, following complaints of chest pain. Then, specialists had used the 'alcohol ablation' technique to bring him back from the brink.

Mr. Karunanidhi said it was

found at the Houston Hospital that excess dosage of medication was given to "paralyse" Mr. Maran at the Apollo (so that he did not remove the tubes that were attached to his body). He could not be revived from this. "After all the medicines, the treatment and the exercises

there (the U.S. hospital), Mr. Maran could not overcome the paralysis."

The charge against the AIIMS related to sanitation and the conditions prevailing there. "How did he contract the fungal infection? Did the infection set in because maintenance was

bad?" Mr. Karunanidhi had asked the Health department and the Union Minister of State for Health, A. Raja, to take up the issue.

He would write to the Prime Minister, Atal Behari Vajpayee, on the need for an early enquiry.

Tracing the sequence of the Union Minister's hospitalisation, Dr. Reddy said Mr. Maran was admitted to the hospital with high temperature in September last after undergoing the mitral valve replacement surgery at another hospital.

An echocardiography done on the day of his admission revealed vegetation in his heart and the blood cultures were positive for fungus, indicating fungal septicaemia.

"After consultation with the surgeons at the primary hospital, the team at Apollo Hospitals, Chennai, performed an emergency high-risk operation to replace the infected valve with a new prosthesis and clear the surrounded infected tissues". Because of multi-organ failure, he was moved to the ICU for continuous support including ventilator and

renal dialysis. His liver was supported using MARS dialysis "for the first time in the country".

"He was supported continuously with lifesaving measures with the guidance of our consultants and international specialists on fungal septicaemia".

In November, when Mr. Maran was shifted to the U.S., he was accompanied by a team of specialists from the Apollo Hospitals.

Dr. Reddy also recalled that Mr. Karunanidhi, who visited the hospital during Mr. Maran's acute phase, had thanked the hospital's team of doctors and paramedical staff, and said that the care provided by them was comparable with the best medical centres across the world.

As regards the treatment given to Mr. Maran in late 2000, the hospital chief said the Union Minister was admitted to the hospital in October that year due to hypertophic obstructive cardio-myopathy (enlargement of the heart).

In the critical situation, Apollo cardiologists "for the first time in the country" performed a ventricular septal ablation. Mr. Maran made a "miraculous recovery" and resumed normal duties. He subsequently led the Indian delegation to the WTO meeting at Doha, Dr. Reddy added.

Lawless in Tamil Nadu

508 Time ripe for regime change 14/4

The arrest of MK Stalin, a DMK member of the Tamil Nadu assembly and twice Mayor of Chennai, on trumped up charges in a midnight operation, has again demonstrated the AIADMK government's utter disregard for norms laid down by the Supreme Court in 1994 and 1997 in the Joginder Kamar and the DK Basu cases on pre-trial detention. When his father, M Karunanidhi, was similarly arrested in a midnight swoop on flimsy charges two years ago, the Union home ministry warned the state government to refrain from "deliberately creating a situation of conflict, leading thereby to a constitutional crisis at a future date". The Centre had also detailed steps which the state government must take to ensure there was no recurrence of the unfortunate events under any circumstances. The Centre had described the arrests of a large number of the DMK activists as an attempt to suppress political dissent and curtail the right of political adversaries of the ruling party.

Politics of vengeance has been characteristic of the AIADMK government of Jayalalitha ever since it was returned to power in 2001. Vaiko, general secretary of the MDMK and an ally of the DMK, continues to be held in custody under POTA for a speech he made on 29 June in support of the LTTE even after the Attorney-General, Soli Sorabjee, filed an affidavit in the Supreme Court that the impugned speech would not attract Section 21 of POTA. Stalin invited the lady's wrath by entering Queen Mary's College compound and extending support to students agitating against the decision to demolish its buildings to make room for a new secretariat. Although the DMK and MDMK continue to be constituents of the BJP-led National Democratic Alliance, the Tamil Nadu unit of the BJP is functioning as a close ally of the AIADMK. But that is no reason why the state government should be allowed to flout the rule of law as established by the Constitution.

κη^ν^ο Ω¹ RISING INTOLERANCE

WITH EACH PASSING day, the Jayalalithaa administration in Tamil Nadu seems to be scaling new heights of intolerance. The crude use of state power against various sections including political opponents and the independent media shows a contempt for the democratic spirit that is deeply disturbing. Perhaps because she was at the receiving end of a series of criminal cases filed by the previous DMK administration, she sees her return to power as an opportunity to wield the sanctioning and prosecuting power of the state blatantly to her political advantage. In the process, the law and order machinery is working overtime and the administration seems to be trampling on the basic rights of the people. The Government should feel secure with its huge mandate and use the opportunity to concentrate on the tasks of governance without even the distractions of a political challenge. Ironically, it is instead behaving like an administration which is unsure of itself and is living from day to day. Its inordinate appetite for political confrontation is bound to take a heavy toll in terms of diminution of democratic rights and the welfare of the State as a whole. The courts can no doubt be counted upon to protect the rights, but the disturbing frequency with which people have had to resort to courts for relief and the fact that respect for democratic norms has to be brought home through court rulings reflect poorly on the style of governance.

At one time, along with the Chief Ministers of neighbouring States, not even the Prime Minister was spared from Ms. Jayalalithaa's vehement attack — a development that the Supreme Court took serious note of and made her withdraw. A far more serious attack was launched against her political opponents within the State in the form of prosecutions, arrests and detentions. The media too have come under pressure with a slew of defamation cases that are quite unparalleled. The latest in this pattern of functioning is the privilege issue taken up by the Tamil Nadu Assembly over three reports of its proceedings published in The Hindu. A series of descriptive phrases, mostly about the Chief Minister's speeches, strung together from separate reports have been collectively referred to the Assembly's Privileges Committee, and given its composition, the outcome hinges critically on the attitude of the AIADMK members. The phrases objected to in a statement made by the Speaker include "stinging abuse", "unrestrained attacks on the opposition", "fumed", "incensed", "chastisement" and "diatribe", all used in different contexts in describing Ms. Jayalalithaa's speeches on different occasions. These phrases are described as indecent and their use is said to be motivated by a desire to diminish the goodwill and fame that the Government enjoys. The phrases are said to constitute baseless accusations and their publication is said to be derogatory to the dignity of the House and a breach of its privilege.

It is useful to note in this context that the device of privilege of the legislature exists to protect its free and independent functioning, and not to protect the reputation of the Government or of individual members. This was made clear by the Speaker of the Lok Sabha with reference to the remarks of Rajaji that the Congress had declined and its legislators "were such people whom any first class magistrate would round up." He was following a ruling in the House of Commons that "hard words used against persons and parties are dealt with, if necessary, by the law of defamation and it is only where the House as a whole is affected... a question of privilege arises." The House of Commons on whose practice the privileges of legislatures are still based does not allow privilege issues to be raised over reports of proceedings unless they relate to proceedings behind closed doors or expunged portions of any speech. Because of its extraordinary nature and because the legislature sits in judgement on its own cause or in the matter of an important member, it ought to be used only rarely when there is real obstruction to its functioning, and not in a way that sets legislators above ordinary comment and criticism. To invoke it lightly or to ward off innocuous, even if unflattering, comments on individual legislators would be grossly offensive to the democratic spirit and would inhibit independent reporting and assessment of the performance of legislators. The tone of the speeches, the quality of debates, the behaviour of the legislators, the nature and importance of the business transacted, violence, walk outs and the space allowed for the opposition are all matters that are legitimately commented upon in all democracies. The Supreme Court while upholding the constitutional validity of parliamentary privilege, observed that "we are well persuaded that our Houses, like the House of Commons will appreciate the benefit of publicity and will not exercise the powers, privileges and immunities except in gross cases" and it is incumbent on legislatures not to act in a way that betrays that trust.

"WE HAVE accomplished a major feat," Chinese Prime Minister Wen Jiabao declared on Monday night at a banquet held in honour of Prime Minster Atal Bihari Vaj-payee. Just before the banquet, India and China had signed two major documents — the first a joint declaration by the two Prime Ministers, and the second, even more significantly, an agreement on cross-border trade.

Vajpayee is due to meet Chinese President Hu Jintao on Tuesday afternoon, so neither the Indian side nor the Chinese authorities are willing to release the draft of either document till that meeting has been concluded. Nor are diplomats permitted to talk about them.

But the mood of relaxed confidence and the bonhomie at the banquet told their own story. The considered an important move-ment forward because it is believed to include a tacit admission by the Chinese of Sikkim as a part of India.

At present, China is the only country in the world that still refuses to recognise Sikkim's accession to India.

Indian diplomats had believed that China would link the Sikkim accession to the border dispute, asking for concessions Tawang in Arunachal Pradesh. In fact, the Chinese made no attempt to link Sikkim to the complex border issue.

A story by the official Chinese news agency had suggested that India had made concessions on Tibet but that now seems to have been misleading. The document signed today is believed to only recognise the People's Republic of China's claim to the 'autonomous

Tibet region'. The phraseology makes it clear that all of Tibet is excluded from the scope of the agreement and the reference to the People's Republic clarifies that no historical claim has been recognised.

Monday's developments suggest that the Vajpayee government's China policy is working. The regime had concentrated on sidelining the contentious border and Pakistan issues till a framework of constructive trust was established. The Chinese willingness to make concessions on the Sikkim issue suggests that Beijing is responding positively to this approach.

Even the joint declaration is believed to be a small victory for the Indian side, with the Chinese finally agreeing to a nuanced document of the sort that Delhi had always wanted.

Chamling's windfall Solution of the state o

Pawan Chamling. Atal Behari Vajpayee's announcement of a Rs 500-crore special package after a four-day visit may not have measured up to the expectations raised, but it comes as a windfall and recognition of the 10-year-old ruling Sikkim Democratic Party as a progressive force. The largesse comes after years of waiting and is essentially the peace bonus Chamling was demanding for maintaining communal harmony and keeping the state insurgent-free. It is to be hoped that the BJP's seeming magnanimity is no favour for a toehold the national party has been seeking since 1994.

The SDF is not an ally of the NDA but supports it.

Despite financial problems, the Chamling government has been able to move fast enough on industrialisation, education (free up to the college level) and fighting poverty. The emphasis is on building and strengthening economic infrastructure. Although there has been objection to construction of Pakyong airport, for which Rs 110 crore was allotted, Chamling is keen to see Gangtok included in the air map. Tourism, the biggest growing industry, will get the required boost with two big hotel chains setting up shop. The government may allow them to run casinos. The annual earning from the state-run lottery, which was Rs 15 crore, has increased substantially with the entire system going on line last year.

Speedier attention to the people's grievances notwithstanding, the SDF has still not been able to convince the Centre to abide by the letter and spirit of Article 371F which confers a special status on Sikkim. Restoration of reserved seats for Sikkimese Nepalese in the Assembly is one of them. Chamling has rightly pointed out during the Prime Minister's visit—that Sikkim is part of the Indian Union but a huge gap exists between Delhi and Gangtok with little prospect of emotional integration. It may serve the Centre well to take a momentous decision.
