HC rejects appeal for Bakery retrial

Reasons to be given after vacation

THE GUJARAT High Court on Friday dismissed the state government's "amended" appeal seeking a retrial of the Best Bakery case, but cited no reason for the judgment which is likely to have far-reaching consequences.

far-reaching consequences.

"We could assign the reasons, but as today is the last day before the winter vacation, the reasons would follow later (when the court reopens)," the Division Bench of Justices B.J. Sethna and J.R. Vora said.

A fast-track court had on June 27 acquitted all the 21 people accused in last year's Best Bakery riots, in which 14 Muslims were burnt to death in Vadodara. The state had filed the "amended" appeal at the behest of the Supreme Court, which had condemned its original appeal against the acquittals as "eyewash".

Commenting on the High Court judgment, defence advocate Sushil Kumar said, "The dismissal of this appeal will have an effect on the legal history of India as the entire judicial system was on trial." Eminent lawyer and human rights activist Girish Patel said, "It means that the chapter is closed in Gujarat."

The state government can, however, ask for special leave to appeal in the Supreme Court. But it may not do so on the pretext that it has already fulfilled its Constitutional obligation of abiding by the Supreme Court's directive. The victims' families, too, can approach the apex court with an appeal for justice.

He questioned the "very presence" of Zaheera at the site of the incident, and contended that one of her family members had said in a statement to the police that she was 100 km away in Chhota Udepur when rioters torched the bakery.

In her statement to the police, Zaheera had said her sister-in-law Yasmin Bano was in Chhota Udepur, whereas her affidavit says Yasmin was at the site of the rioting, Kumar maintained. He said Zaheera had claimed in her statements she was injured and profusely bleeding, but the state government's appeal said "she did not receive any injuries".

Indian Muslims are not a minority: Saudi Arabia

ISLAMABAD, OCT. 20. The Saudi Foreign Minister, Saud al-Faisal, has told Islamabad not to consider Indian Muslims as a "minority" who needed "outside help" to resolve their problems.

Prince Faisal was provoked into making these remarks at a press conference here on Sunday when a Pakistani journalist attacked India for its alleged atrocities against Muslims in general and Kashmiris in particular.

"I would hate to think of the Muslims in India as a minority coming from a country that had less Muslims. These Muslims are not scattered in

the wind. They are people with substance. They are people with courage and with enough of that courage to stand up for their interests by themselves and not to wait for the help of others."

Asked by the scribe what Saudi Arabia was planning to alleviate the "sufferings" of Indian Muslims, Prince Faisal said they neither needed the help of Saudi Arabia nor Pakistan even as the Pakistan Foreign Minister, Khurshid Mehmood Kasuri, looked on.

On the Kashmir issue, the Prince said Saudi Arabia thought "a wise leadership from Pervez Musharraf in seeking peaceful settlement with India is the right way to go. We will do everything we can to help in bringing about this peaceful settlement".

The main problem that divided India and Pakistan and threatened peace in the region was Kashmir. "So anything we can do for peace and to settle the issue of Kashmir, we will certainly do that," he added.

Prince Faisal's remarks must have come as an embarrassment to the Pakistani establishment as it would like the rest of the world to believe that Muslims in India were not only a minority but also a helpless community.

A 'CRISIS' DEFTLY DEFUSED NOVO

THE LATEST ROUND of Ayodhya-centred mobilisation spearheaded by the Vishwa Hindu Parishad has made one thing clear to political India. It is that, in India's most populous State and also elsewhere, the Ramjanmabhoomi movement does not evoke anything like the mass response the campaign to demolish the Babri Masjid did more than a decade ago. This is the principal reason for the "sankalp sammelan" programme flopping. No doubt, considerable pressure was put on the State and its resources by tens of thousands of VHP activists threatening to congregate at the site where the Babri Masjid used to stand. But what was conspicuous by its absence was any kind of groundlevel popular support for the programme. In Uttar Pradesh, the BJP's political stock has declined perhaps to the lowest level witnessed in the past decade and a half. The VHP leaders are openly at odds with the BJP-led Central Government and not a week passes without Ashok Singhal or Praveen Togadia or some other senior VHP functionary hurling abuse and insult at Atal Bihari Vajpayee and his "pseudo-Hindu", power-inebriated" and "secular" ways.

The other reason for the frustration of the communal troublemakers is the firm but deft way in which the recently installed Government of Mulayam Singh Yadav responded to their challenge. Adopting a sober and cool stance and making his intentions clear in advance, the U.P. Chief Minister sought and won cooperation all round. An unassailable weapon in his armoury was the Allahabad High Court's directive of October 14, 2003 asking the State Government not to allow the VHP or any other organisation to hold a meeting at, or in the vicinity of, the 'disputed' site. With the law firmly on his side, Mr. Yadav succeeded in winning the practical cooperation of the Vajpayee Government. The Cen-

tral Government fulfilled its responsibility by sending in more than 100 companies of Central paramilitary forces, which is actually more than what the State Government sought to help keep the peace. The police as well as civil administration in Faizabad did the U.P. Chief Minister proud. Such no-nonsense but restrained and indeed bloodless handling of potential trouble has rarely been witnessed in recent law enforcement history. Interestingly, testimony to the Mulayam Government's success has come from the BIP president, M. Venkaiah Naidu. He has responded to the VHP's predictable demand for the dismissal of the Mulayam Singh Government by saying "there is no need for it" since there has been "no major untoward incident".

What next? The VHP leadership, identifying secularism as "the biggest enemy" of the nation and declaring itself ready for "any sacrifice" to "wipe out" secular ideology and install "Hindu Rashtra", has issued yet another ultimatum to Mr. Vajpayee: "If you don't come to us, we will abandon you." The provocation for this is the reiterated 'no" from the BJP to the VHP's demand for special legislation to facilitate the construction of a temple at the site where the mosque stood. Significantly, the Deputy Prime Minister, L. K. Advani, whose 1990 rath yatra provided a powerful boost to the Ramjanmabhoomi campaign, has ruled out such legislation as politically unfeasible. Further, the Central Government is bound by the Supreme Court's March 2003 ruling ordering that the status quo be maintained at the disputed site until the title suits are adjudicated by the special bench of the Allahabad High Court, True to type, the VHP has promised more Ayodhya-related fireworks. Fortunately for democratic India, there is every indication that these, like the "sankalp sammelan" programme, will fizzle out.

ORDERS RELEASE OF 'RAM BHAKTS'

VHP bid to hold meet in Ayodhya foiled

AYODHYA, OCT. 17. The Vishwa Hindu Parishad-sponsored congregation here today fizzled out as the security forces sealed the temple town and prevented 'Ram bhakts' from gathering at Ramsevakpuram, venue of the proposed assembly.

Though by and large Ayodhya and the rest of the State remained peaceful, Karsevakpuram, the complex housing VHP's central office, witnessed a lathicharge and the firing of rubber bullets by police against VHP cadres and supporters in the morning after the Parishad leader, Ashok Singhal, was arrested.

Later in the evening, the Uttar Pradesh Chief Minister, Mulayam Singh Yadav, told presspersons in Lucknow that he had ordered the release of over 30,000 VHP activists, including Mr. Singhal.

Mr. Singhal accused Mr. Yadav of "using the Central forces to persecute and beat innocent kar sevaks". He said the time had come for enacting legislation for the construction of a Ram temple in Ayodhya. Mr. Singhal refused to leave Karsevakpuram until he had 'darshan' of Ram Lalla.

After his release, Mr. Singhal conducted a symbolic 'Sankalp Sabha' at Karsevakpuram in the presence of over 1,000 activists from difference States, VHP sources said.

Before the start of the 'Sankalp Sabha' (meeting to take a pledge), police rounded up the senior VHP leader, Ram Vilas Vedanti, and a few thousand activists and ferried them outside Faizabad, foiling their plans.

Around noon, Karsevakpuram appeared deserted with police barricading the area and arresting the 'Ram bhakts' at various locations in the town. As thousands trooped in through various points, including along the railway tracks, police prevented them from reaching the venue. But in many places, despite the police clampdown, hundreds of 'Ram bhakts' sneaked into the town. They were seen moving in small groups towards the venue. Some of them damaged a Government bus and squatted on the roads protesting the arrests.

Angry over the police action, the VHP gave a call for a 'Bharat bandh' on Sunday in "protest against police atrocities on the Ram bhakts". Though their plan was defeated, the VHP leadership claimed that the turnout was a 'moral victory' despite attempts at repression by Mr. Yadav.

Mr. Yadav said his Government had passed the 'agni pariksha' (ordeal by fire) when it foiled the plans of "communal forces" to disrupt peace. The Centre's role in the entire episode was worthy of appreciation and exemplified the federal set-up of the country.

The Commissioner, Faizabad division, and receiver of the acquired land at Ayodhya, J.P. Sharma, said normality has been restored. He said that had the Central Government stopped all the trains to Faizabad and Ayodhya, the situation could have been more peaceful.

In Lucknow, the Chief Secretary, A.P. Singh, said that all the detained persons would be re-

leased and the barricades and blockades erected at different places would be lifted immediately. The situation in Ayodhya was peaceful and normal 'darshan' was under way at the disputed site. In the first shift from 7 a.m. to 11 a.m., altogether 1,127 devotees had 'darshan'.

Mr. Sharma said that Mr. Singhal had refused to heed the request of the administration to move to the Sugar Corporation Guest House here from Karsevakpuram.

Police were forced to arrest Mr. Singhal as he was leading about 1,000 people, violating Section 144. He said that in Ayodhya, 800 VHP activists were arrested in the morning from the railway station while 1,000 more were arrested from Karsevakpuram later.

Mr. Singhal, who was sporting a saffron outfit, admitted that he had been tacitly camping in the temple town for the past three days.

The Inspector-General of Police, V.N. Rai, said that police had not wanted to use force and remove Mr. Singhal in view of his age.

The VHP office has been cordoned off and workers have been prevented from approaching it. While the VHP leaders claimed that thousands of cadres were arrested, police put the figure at around 4,000. They have been taken out of Faizabad for release.

More than 35,000 people had been arrested in the State during the past couple of days. — PTI, UNI

Gujarat riot rapes under CBI scanner

New Delhi, Dec. 16: The Supreme Court today directed the Central Bureau of Investigation to probe cases of mass rapes during the Gujarat riots last year.

A three-judge bench of Justices S. Rajendra Babu, A.R. Lakshmanan and G.P. Mathur, which ordered the CBI probe, directed the bureau to file a status report within eight weeks.

The Gujarat government had initially opposed a probe by the bureau but relented after the judges said if the state did not order a CBI inquiry, the apex court would. At this, additional solicitor-general Mukul Rohtagi, who appeared for the Gujarat government, said the state would request the Centre for a probe by the CBI.

The order came in a case of alleged gangrape of a pregnant woman, Bilkis Yakoob Rasool. Rohtagi also said the government would order a CBI probe into other cases, especially the alleged gangrape of women from the minority community at Panivala village six days after the Godhra train massacre.

The additional solicitor-general told the court that the CBI would "confine" itself to these cases as the state police was competent to probe other cases.

Analysts felt the govern-

Analysts felt the government's decision to agree to a CBI probe was a "strategic move". Human rights activist Girish Patel said the decision was not prompted by a "desire for justice" but the "compulsion not to displease the Supreme Court".

The Congress termed it a defeat for the Narendra Modi government, which was forced to bow down before the apex court. However, both BJP spokesman Suresh Gandhi and government spokesman Saurabh Patel claimed they were not aware of the state government's commitment to the Supreme Court.

Riots kill six in Hyderabad

WIDE AREAS of Hyderabad were placed under an indefinite curfew on Sunday after six people died and 31 were injured in communal clashes on Saturday night, the 11th anniversary of the Babri Masjid demolition.

The violence, provoked by a black flag raised in front of a place of worship at Gowlipura, spread soon to wide areas, including Sultan Shahi, Aliabad, Shah Ali Banda, Hari Bowli and Nasheman Nagar where warring mobs fought with stones, looted shops and set fire to houses. The situation almost went out of hand after hoodlums set fire to three transformers, plunging

extensive areas into darkness and started attacking shops and hotels. Police fired over 150 rounds after tear gas and a lathicharge failed to disperse the rioters who had come armed with lethal weapons. Thirteen people were injured in the police firing; 18 others were injured in stabbing, arson and stone-pelting.

Senior police officers led reinforcements, including several RAF platoons to the riot-hit areas. They also had to call in fire tenders before the situation was controlled around 1.30 am — five hours after rioting began.

Areas under eight police stations — Chandrayangutta, Falaknuma, Chatrinaka, Moghalpura, Shah Ali Banda, Bhavaninagar, Rein Bazar and Dabeerpura — were placed under curfew and prohibitory orders under Section 144 clamped on another 12 police station areas. Chief Minister N Chandrababu Naidu announced a judicial probe.

Minority Movement

Original and outspoken, he is one of India's most outstanding scholars. Political psychologist Ashis Nandy in conversation with Ameena A Saeed on the Muslim question in India: (11.1)

What are the reasons for the failure of the Indian Muslim leadership?

There is no pan-Indian Muslim leader but

there is no pan-Indian Hindu leader either. There are regional and local leaders and there is nothing wrong with that. Ethnic nationalism or religious nationalism smothers the natural process of displacement of traditional leadership. Middle class Muslim nationalism sabotaged the natural process of electoral democratisation. This natural process of democratisation has not taken place in Pakistan too where electoral process is still dominated by the feudal class. Today, we are faced with a new breed of leaders who have not tasted power for centuries and when they do they will remain in power come what may. Mayawati, Mulayam Singh Yadav, Laloo Prasad, Vajpayee are all examples.

Again, when we talk of Muslim leadership, we generally refer to north Indian Muslims. But can a northern Muslim really represent the interests of a Tamil or Malayalam Mus-

lim? I don't think so. Even among Hindus, a northern leader is not acceptable in the south.

How far is Partition responsible for the present conflict bet-ween Muslims and non-Muslims?

Partition took away the political

bargaining power from the Indian Muslims. They say Jinnah was myopic since he left behind a large chunk of Indian Muslims. I don't think so. He knew that the Muslims of India will be sacrificed for Pakistan. Though I must add that all classical liberals, both Hindus and Muslims, of the 1930s were myopic. They didn't comprehend that nation-states have their own logic. Look at history. None of the Asian states followed the European model. They didn't even copy each other's model. Kashmir is a separate problem, an isolated tragedy. Truth is, no one is interested in Kashmiris, neither Indians nor Pakistanis.

How is the conflict with Pakistan responsible for tensions between Indian Muslims and Hindus?

The two are not related. This association has been deliberately built up by Hindutva propaganda. And Pakistan's role in this process is not helpful either. Maulana Moudoodi, a religious Pakistani scholar, once said, "I don't care if Indian Muslims are treated like untouchables." This is the direct result of Jinnah's concept of nation-state — essentially a Bombay corporate lawyer's concept.

Is the media responsible for propping up

the hardliners?

Yes, to a great extent the media explosion has made leaders out of Togadia and Shahi Imam. They are the media's gift to us. The secular media is more at fault since it is ignorant and contemptuous of religion. It also looks for easy divisions. Global Islam is not interested in the affairs

of the Indian Muslims — whether it is the demolition of Babri mosque or the Gujarat carnage. What explains this?

There is an urban floating mass of Muslims who are looking for ideology. This religious fervour is a metropolitan phenomenon. The Babri demolition had more impact in Bombay and Birmingham than in Kerala or the villages of India with a large Muslim population. The uprooted NRI is more troubled by India than the average Indian here. I remember Arafat once said he can handle the Israeli Jews but the real problem is the American Jews. Fanatic torchbearers of Hindutva are more numerous in America than in India. Just as there are more fanatic Muslims in America than in Pakistan or Saudi Arabia. It might surprise you that 90 per cent of Hindutva leaders in India are secular and 90 per cent of NRIs abroad are religious zealots. They support extremist

parties here in an effort to hold on to their identity electronic means.

The real logues are VHP and Bajrang Dal leaders. Their constituency: 'modern' Indians and well-todo technocrats the USA — the IT professional who

lives in America, makes decent money, sees himself being Mc-Donalised and does soul-searching on Sundays. To atone for their sons marryyoung Christian women, producing Eurasian children they look for an ideological package. This package is simplified by the VHP and Bajrang Dal who tell them to continue to make their dollars, join yoga, listen to bhajans and sermons on hi-fi systems and contribute \$100 monthly to these organisation to reinforce their Indian roots.

What is the future of the Indian Muslim leadership?

There are local and regional leaders who cater to the needs of the community. Please recognise that there are regional non-English speaking leaders we don't know about... But I do see two potential Muslim leaders of the future — Mehbooba Mufti and Omar Abdullah. In them, I see a new generation of Muslim leaders


What is the future of Muslims in India?

Their future is bright. There is tremendous churning and soul-searching going on among Muslims. Gujarat did cause a temporary withdrawal but the influx of Muslim talent into the mainstream will continue, despite the BJP.

Kunkuri\Pathalgaon: Is Ajit Jogi a Christian? It shouldn't really matter, except that this is election time and his opponents are the Sangh Parivar. Indeed, the only doubt here seems to be about Mr Jogi's denomination. The Parivar claims he is a Catholic, but the Catholics say he belongs to the Church of North India.

In Chhattisgarh, where conversion has replaced Islamic terrorism as the BJP's main political issue, the target of all attack is the Catholic church.

Interestingly, the "religious war" is being fought for the minds of those people who are not supposed to have a mind of their own. And most local leaders who can articulate their views to the outside world are in the church.

The church, too, has braced itself against the Parivar's attacks. There is an attempt to forge a tribal identity to break the religious barrier and bring forth political leadership from a homogenous group that has both Christian and non-Christian tribals. The Adivasi Vikas Parishad has become active lately in Ithis sphere.

On Sunday, the Parishad held a meeting at Pathalgaon

On Sunday, the Parishad held a meeting at Pathalgaon to discuss social and political issues. Around 50 youngsters, both Hindus and Christians, participated. "We debated the political situation and finally decided to support Mr Jogi," said Vinay Kumar Ekka, the Parishad's local general secretary. After all, Mr Jogi is the Parishad's chief patron.

The Sangh's allegations of conversion fall flat in the face of the work done by the church: 186 schools; 47 pri-

mary health centers; two hospitals; two leprosaria; ohe old age home; one centre for the handicapped; 510 village health workers; 491 self-help groups and more in just the Raigarh diocese.

Founded in 1951 in Kunkuri, this diocese comprising Jashpur and Raigarh districts is the biggest in the state with 2.4 lakh followers. The cathedral here has been made famous by the Sangh's claims that this is the second largest in Asia. "We have never got it confirmed. It has a capacity of 5,000," said Vicar General Paul Toppo. He points out that Catholics comprise hardly six lakh of the state's two crore population.

However, the socio-economic imbalances like the bureaucracy being dominated by Christians has added to the alienation of the deprived non-Christian tribals.

GANDHINAGAR, Nov. 24. — In complete contrast to the Best Bakery case, 15 people were today convicted for the post-Godhra killing of 14 people in the fields of Ghodasar village in Kheda district on 3 March 2002. Forty-eight others were acquitted.

The conviction of the 15 accused, 12 of whom have been found guilty of murder, was announced today by district and sessions judge Mr CR Rane at Nadiad, the district headquarters. All the accused were present in the court at the time of the judgment. Three of the accused have been convicted for unlawful assembly and violence.

The Ghodasar village killings were done brutally in open fields, even as people tried to escape the wrath of the angry villagers. The majority of those killed were old people who could not make good their escape. The dead also included two women.

The sentence in the case is expected to be pronounced tomorrow.

Out of the 64 accused in the case, one died a natural death during the trial. Forty-six witnesses deposed before the court. Earlier the sentence in the case was expected on 6 October, but it kept on getting postponed.

Trouble had started in Ghodasar village on 1 March when a mosque was burnt in the aftermath of the Godhra train massacre. The following day when three members of the majority community were found murdered, people from the minority community fled the village. They were hounded and killed in the fields.

Till now only seven families have returned to the village.

This is the second conviction in cases related to the post-Godhra violence in Gujarat. Three accused, in what is known as the Lal Akhada case, of Vadodara, were convicted about a month ago for Pankaj Chauhan's murder in the last phase of violence in the city which carried on till April 2002.

Mr MS Hassan Jowher, from the Society for Promotion of Rational Thinking welcomed the Nadiad judgment: "I am glad. This restores faith in the system thereby preempting retaliatory terrorist thinking." He said, "Both communities will also realise that the law will ultimately catch up."

Supreme Court stays proceedings in 10 Godhra-related cases By J. Venkatesan riae, Harish Salve, that a special investigation team headed by a retired High Court Judge be constituted to look into all the cases independently without the State's interference and report

NEW DELHI, NOV. 21. Disapproving of the manner in which the Narendra Modi Government in Gujarat was conducting the trial of 10 Godhra-related cases, the Supreme Court today stayed all further proceedings in them

The cases are a fallout of the Godhra train carnage in Gujarat on February 27, 2002 when the State witnessed large-scale communal violence

in which hundreds of people were killed.
A three-judge Bench, comprising the Chief Justice V.N. Khare, Justice S.B. Sinha and Justice A.R. Lakshmanan, stayed the proceedings on a petition from the National Human Rights Commission seeking the transfer of these cases for trial outside Gujarat.

The NHRC had sought the transfer of trial in all major cases - such as Godhra, Best Bakery, Gulbarga Society, Naroda Patia and Sardarpur which hundreds of people were killed, to neighbouring Maharashtra or any other State, appre-

hending gross miscarriage of justice.

The Bench gave two weeks' time to the Narendra Modi Government to file a status report in all these cases.

The Bench asked the Gujarat Government to respond to suggestions made by the amicus cuently without the State's interference and report directly to the Supreme Court whether appeals in the cases which ended in acquittals were necessary or not

When Mr. Salve narrated incident after incident of "gross miscarriage of justice" and how the State had not preferred any appeal, the Chief Justice said: "If this is the state of affairs, then we will transfer all cases outside the State."

The Chief Justice told the Additional Solicitor General, Mukul Rohtagi, appearing for Gujarat, "Don't you know that it is the duty of the State to file an appeal in such cases? Why did you not come to this court? He said: "Several times, High

Courts might err, but is it not the duty of the State to come in appeal? How many times should we

remind you of your duty?"

Mr. Rohtagi said that, "since bail was granted to an accused by the High Court exercising its discretionary power, how can the State Government be blamed for the same?" He further said that it would not be possible to prefer a special leave petition against every interim order.

The Bench then fixed December 19 for further hearing and monitoring of the case.

NEW DELHI, NOV. 18. The Uttar Pradesh Government today filed a fresh affidavit in the Ayodhya case that the Babri Masjid was demolished "due to a criminal conspiracy of some organisation." The affidavit stated that since the trial of the demolition case was before the Special Judge in Lucknow, "no further comment on the case was necessary."

The affidavit described the demolition of the Babri Masjid as "barbaric, shameful, condemnable and against the national interest and integrity of the nation."

On the charge that political pressure was applied on the CBI to drop the conspiracy charge against the Deputy Prime Minister, L.K. Advani, and others, the affidavit said that it was something that had to be determined by the apex court, which was now seized of a review petition.

Keen on limiting the damage caused by the affidavit filed yesterday, the Uttar Pradesh Chief Minister, Mulayam Singh Yadav, today disowned it, and replaced the advocate who had filed it.

Mr. Yadav said that yesterday's affidavit had been filed by the lawyer concerned on his own "without consulting either him or the Advocate General of the State."

Seemingly stung by the reaction to yesterday's affidavit, particularly from his allies, the Left parties, Mr. Yadav mounted a vigorous defence of his secular credentials. "All my life I' have fought the communal forces, I can never have any understanding with them."

He said that he had been judged hastily, especially by his friends.

"I am particularly hurt by the criticism from the Left parties. We have worked together for years, they should have at least verified the facts from me before jumping to conclusions."

He reminded the Congress and the Left parties that when it came to actually fighting the BJP it was the Samajwadi Party which was in the forefront, "The BJP does not exist in the areas where the Left is strong. I am the one who is fighting them in their stronghold. Where is the Congress or the Left in Uttar Pradesh?"

Mr. Yadav said that it was the Samajwadi Party, which was leading the battle against the communal forces. "I have fought them all my life and have paid a big political price for opposing them... it is out of place to accuse me of being soft on them."

Interacting with the media on the occasion of the Uttar Pradesh Day at the India International Trade Fair, he said the power situation in the State had improved and investment was beginning to flow.

However, the law and order situation left a lot to be desired, and he accused the Sangh Parivar of trying to foment trouble every time he was at the helm. "They never spoke of Ayodhya while the BJP was part of the Bahujan Samaj Party-led coalition Government in the State, but the moment I came to power they upped the ante," he said.



NEW DELHI, OCT. 16. The matter of the Archaeological Survey of India's report on its excavation in Ayodhya is sub-judice and should not be interpreted to suit anyone's interests the Lucknow Bench of the Allahabad High Court said today.

While passing the orders on a petition from the Sunni Central Wakf Board, a three-Judge Bench said the court was yet to decide "whether the ASI report is to be confirmed or rejected or how it will be dealt with".

the ASI report or interpret or twist it to suit his interest." "no one is allowed to derive any advantage out of the situation and that the Supreme Court's order to maintain the status quo of the site was upheld.

The U.P. Chief Minister's announcement reported from Lucknow that the VHP's gathering would be permitted 5 km from the disputed site falls in line with the court's October 10 direction "not to allow congregation on or around the disputed site".

The court, however, also directed the Government to ensure that "no religious activity of any kind by any one, either symbolic or actual" is permitted "at or around the disputed site".

Gathering of Ram bhakts thwarted in Lucknow raj Kishore, was among those chartered by the police. had been taken

LUCKNOW, OCT. 15. The Vishwa Hindu Parishad's "Ram bhakt" rally and "shobha yatra" in Lucknow were conducted in a low-key manner today as a determined Uttar Pradesh Govprevented ernment largescale gathering.

The rally remained limited to a small meeting within the precincts of the Saraswati Shishu Mandir, run by the Rashtriva Swayamsevak Sangh, in the Nirala Nagar locality at which the senior VHP vice-president, Giriwho addressed the gathering.

Around noon, the activists, many of them wearing saffron scarves, came out of the Shishu Mandir in vehicles and on foot. As they started marching ahead in an apparent bid to take out the announced "shobha yatra" they were stopped a little away by the police who had erected barricades.

The slogan-raising VHP activists, a majority of whom were outsiders, waited for some time and then courted arrest. They were taken away in five buses

While Giriraj Kishore and another senior VHP leader, Purushottam Narain Singh, were detained in the State Guest House in the Dalibagh locality, about 300 arrested VHP workers were sent to jail, the Chief Secretary, A.P. Singh, said, briefing newspersons in the evening.

Giving details of the situation prevailing in the State in the wake of the VHP programme at Ayodhya on Friday, Mr. Singh said that arrests of VHP workers going to Ayodhya were continuing and so far 15,500 people

had been taken into custody all

over the State.

About 10,600 people continued to be detained while the other arrested activists had been released. The largest number of arrests was made in Varanasi (2,788). More than 1,000 people each had been arrested in Kanpur, Jhansi and Allahabad. In Faizabad, 480 people were arrested today.

Flag march in Ayodhya

AYODHYA, OCT. 15. A curfewlike situation prevailed here today in view of the VHP's proposed 'Ram Darshan' programme on October 17 even as paramilitary forces staged a flag march.

The Faizabad Commissioner, J.P. Sharma, said the flag march was taken out in the major areas of Ayodhya, including Hanumangarhi, Naya ghat, Ramghat and the area surrounding the disputed site.

With 25 arrests today, a total of 1,887 persons have been rounded up here.

The District Magistrate, Deepak Kumar, claimed that the VHP was yet to seek permission for holding its programme and said puja at the disputed site and other temples was not affected today.

The Centre has rushed in over 100 companies of Central Para-Military Forces (CPMF) to strengthen the security arrangements in and around Ayodhya. Over 75 companies of the forces have reached Ayodhya while the rest are on their way from other States, and will be deployed soon. -- UNI

Rail traffic to and from Ayodhya remained almost static with the authorities having diverted only two trains - the Sabarmati Express and the Doon Express. Other trains were running through Ayodhya as usual.

The Chief Secretary said the situation was under continuous observation and more trains could be diverted during the next two days, if necessary.

AYODHYA TRAINS NOT TO BE STOPPED

PM seeks to defuse tension

NEW DELHI, Oct. 14. — The Prime Minister today convened a meeting at his residence to discuss ways to defuse tensions arising ahead of the VHP's Ram Temple campaign in Ayodhya on 17 October. The VHP, however, continues to hold Mr Atal Behari Vajpayee responsible for the Centre's "anti-Hindu" attitude.

Mr Vajpayee conferred with Mr LK Advani, Mr Jaswant Singh and Mr Venkaiah Naidu on how best to contain the fallout of the VHP's insistence on congregating in strength in Ayodhya. They decided not to do anything that could be construed as putting up hurdles in the VHP's way. The meeting also decided not to stop or divert any train to Ayodhya because that would inconvenience the public.


Ayodhya: With an eight-layer "impregnable security cover" already enforced by the district administration to prevent the entry of Ram sevaks in the pilgrim city, the defiant Vishwa Hindu Parishad (VHP) said here on Monday that no force on earth could deter Rambhakts from reaching Ayodhya on October 17 to participate in

the Sankalp Sammelan.

The entire VHP leadership, which has gone underground, is believed to have asked its rank and file to adopt cross-country routes to reach Sammelan Sthal.

Closing the main gates of its sprawling campus of Karsevakpu-ram—the VHP headquarters in ram—the VHF neaught. Ayodhya—for the outsiders, including journalists, the VHP spokesperson, Sharad Sharma, said that thousands of activists from across the country would manage to reach Ayodhya

Sealing the borders of Faizabad division which comprises four districts Faizabad, Barabanki, Sultanpur and Ambedkarnagar, the administration has virtually made the pilgrim city as "no-entry" zone for outsiders. Only local residents having passes especially issued for the occasion, and of course, the journalists are allowed to enter within the municipal limits of Ayodhya described as yellow zone for security purposes.

Though there is no ban on the tary and RAF in the ninorijes of Ramlalla at the makeshift temple in the RJB complex, which stands fortified from all corners by the paramilitary, the number of visitors to the temple has gone down due to lack of pilgrims.

17.

About 450 people were picked up from trains

at the Ayodhya and Faizabad railway stations, 400 in Varanasi and 350 in Allahabad as the authorities hinted at taking the Army's help if the situation so warranted. About 4,000 karsevaks have so far been detained in the

The Additional DGP (Law and Order), Bua Singh, told reporters that 100 companies of paramilitary troops were deployed in Ayodhya and neighbouring areas to ensure law and order. Mr. Singh reviewed the situation in a meeting with top PAC, CRPF, ITBP and BSF officials.

In Lucknow, the Chief Secretary, A.P. Singh, said the temple town was peaceful and that all necessary steps were being taken to deal with any eventuality. The status quo would be maintained at the disputed site as per the directives of the High Court, he said and denied the VHP's allegations that karsevaks were being ill-treated.

The Additional DGP, IGP (Lucknow), V.N. Rai, and other senior police officials went round sensitive places in the city as prohibitory orders were promulgated in Basti, Jaunpura and Sant Kabirnagar districts adjoining Faizabad. Mr. Rai said buses and heavy vehicles would not be allowed to enter Faizabad without the permission of the district authorities. However, the district administration's representations to the Centre and the Railway authorities for a complete ban on the rail traffic here failed, and only the Sabarmati Express and the Doon Express had been rerouted.

In Allahabad, police intensified searches of trains and buses passing through the town and arrested 324 VHP activists. Over 100 activists

In New Delhi, the Union Minister of State for Home, Swami Chinmayanand, told reporters that the Centre would extend all possible help to the State Government in tackling the situation. The State had demanded 100 companies of paramilitary forces and " have given 105", he said.

Even as the authorities diverted trains and stopped buses to prevent karsevaks from heading towards Ayodhya, the VHP organising secretary, Rahgavulu, told reporters in Allahabad that his organisation was determined to hold the proposed meeting even if the entire State was converted into a jail. 
CM seeks info on Centre's preventive x'' measures

ALARMED BY the influx of VHP activists in Ayodhya, a worried Uttar Pradesh Chief Minister Mulayam Singh Yadav on Monday got in touch with the Centre and demanded to know what steps it was taking to prevent the law and order situation from getting out of hand.

Yadav first tried to speak to Deputy Prime Minister L.K. Advani. The harried chief minister called up Advani's North Block office and then at his residence, but was unable to speak to him because of the Deputy PM's busy schedule.

He then spoke to Minister of State for Home Swami Chinmayanand who had allegedly organised the VHP's October 17 programme at Ayodhya. Yadav and Samajwadi Party leader Amar Singh had described this act as "shame-ful" on Sunday. Chinmayanand was closely associated with the VHP's Ram temple movement and was a member of the Sangh out fit's Marg Darshak Mandal.

Confirming that Yadav spoke to him over the phone, Chinmayanand said he had told the UP chief minister that the VHP's programme and his outburst against him should not be "turned into a politi-cal issue". The minister said, "I told him that, in the past, whenever political capital had been sought to be made, the situation worsened. His comments will only vitiate the atmosphere further"

Yadav also sought to

know what steps the Centre was taking to prevent the prevailing situation in Ayodhya from worsening. He is also believed to have sought additional Central paramilitary forces

Home Ministry sources said that the Uttar Pradesh chief minister's request "has been considered", but it was unlikely that it would be met at this juncture because plans were being prepared to dispatch security forces to the five states Madhya Pradesh, Chhat-

tisgarh, Rajasthan, Delhi and Mizoram — where elections are to be held in December. Already, 12 companies of the CRPF have moved from Jammu and Kashmir to Ayodhya.

Security tightened

The Central security forces have stopped the movement of people from the adjoining districts of Barabanki, Gonda, Basti, Sultanpur, Gorakhpur and Bahraich to Ayodhya. The police have also issued permits for en-

try into the temple town. However, the Faizabad administration claimed that there was no scarcity of essential commodities in Ayodhya. Vehicles carrying essential commodities were being allowed entry.

So far, the state government has deployed 120 companies of security forces. The Central government has provided 80 companies. The Central security forces have been deployed in the adjoining districts where there is a fear of mo-bilisation of activists. "We will not permit movement of people beyond these districts", said the state Director-General of Police, VKB Nair. However, reports said a large number of sadhus from all over the country has already reached there.

Ayodhya has been divided into four zones, which have been further divided into 16 sectors and 36 subsectors. Every zone would be looked after by an officer of the rank of police superintendent, while deputy SPs would be in-charge of sectors and sub-sectors.

The Railways have also decided to bypass all trains to Faizabad. Tight security arrangements have been made at all stations en route to Faizabad. Gujarat owns up to Bakery trial lapses

SC orders vetting of prosecutors

ACTION REPORT

THE GUJARAT government on Thursday departed from its earlier stand in the Best Bakery case and admitted before the Supreme Court that it had made serious mistakes in handling riot cases.

But while stating that the truth had not come out before the trial court, the state asked the three-member bench to close the Best Bakery case in the Supreme Court. The court rejected the plea and, signalling its intention to tighten its monitoring of riot trials, appointed former Solicitor-General of India Harish Salve as amicus curiae (friend of the court) to assist it with these cases. In a show of lack of confidence in the state government, the court asked it to get all its special public prosecutors for riot cases vetted by the Attorney-General of India.

The state government had argued for closure of the case saying the situation had improved a lot in Gujarat. It said the prosecution had filed chargesheets in other sensitive cases and engaged an IGP to co-ordinate between lawyers and the police for smooth conduct of proceedings.

"We will not close the case. Keep us informed about the development of the appeal," the CJI said. The court posted the next hearing for October 17.

The Gujarat government, in its appeal for a retrial of the Best

Bakery case, blamed the trial court for the accused being acquitted. First, it had failed to examine four eyewitnesses and wound up proceedings very quickly, the state argued. Second, the trial court accepted the FIR containing a general statement about the incident instead of taking into account the statement of Zahira Sheikh, who had given a specific statement to the police, naming the accused.

Senior counsel P.P. Rao, representing the National Human Rights Commission, took exception to the contention and told the court that the Best Bakery case had failed because the investigation agency was not able to gather evidence that could lead to conviction. He asked for a CBI probe into the case.

New Delhi, Oct. 9: The Supreme Court today appointed former solicitor-general Harish Salve amicus curiae to assist it in monitoring trials in Gujarat riot cases, particularly the one involving the

Best Bakery massacre. Chief Justice V.N. Khare and Justices S.B. Sinha and A.R. Lakshmanan, who took a serious view of the Narendra Modi regime's lacklustre handling of the cases, also ordered that the state government could not appoint public prosecutors

The bench said lawyers of impeccable quality should be appointed in consultation with attorney-general Soli Sorabjee and asked him to "vet" all the ap-pointments of public prosecutors in riot cases

The judges directed the state government to furnish the names of the special prosecutors to Sorabjee but warned that persons who had earlier conducted trial of riot cases should not be appointed again as public prosecutors. "Do not associate old public prosecutors who prose cuted the cases before the trial court," the bench said.

Additional solicitor-general Mukul Rohtagi, who appeared for the Gujarat government, agreed to all the proposals.

The apex court asked the am-

icus curiae to "go through all pe-

titions and paper books" filed in the court in riot cases and give his recommendations by the next hearing. October 17 has been fixed for further hearings.

The court treated a petition by the National Human Rights Commission as a public interest litigation so that various recommendations on ways to prevent witnesses from turning hostile could be examined and guidelines set for the future.

In the Best Bakery case, most of the witnesses had turned hostile. It resulted in the acquittal of all the 21 accused of burning alive 14 people at the Vadodara bakery in March last year. The witnesses later complained that they were forced to turn hostile.

Rohtagi told the court that the state government has already amended its appeal before Gujarat High Court against the trial court order acquitting the accused.

The court clubbed two other petitions, one filed by danseuse

Mallika Sarabhai and the other by Zakia Jafri, the widow of for-mer Congress MP Ehsaan Jafri, who was burnt alive by a mob on

February 28. Sarabhai contended that compensation given to riot victims was inadequate and less than that given to the victims of the Uphaar fire tragedy in Delhi and the Bhopal gas tragedy. The bench asked the state government to respond to the complaint within six weeks and posted the matter for further hearing after eight weeks.

The judges, however, told senior counsel Indira Jaisingh, who appeared for Sarabhai, that she was going too far when she said the two-member Nanavati commission probing the riots should be expanded to include members from the minority community.
"This is too much," the bench said and asked Jaisingh to limit herself to legal arguments.

Jaisingh also appeared for Ehsaan Jafri's widow, who was present in court today. She said her petition demanded a CBI probe rather than an investigation by state police. She said Jafri had repeatedly called the police control room when a mob surrounded his bungalow, but no help arrived.

The counsel alleged that the current Gujarat law minister, Ashok Bhat, was "sitting" in the police control room and "virtually" monitoring the riots which included the one at Gulbarg Society, where Jafri was killed.

Sangh attacks rights panel

New Delhi, Oct. 4: Rashtriya Swayamsevak Sangh chief K.S. Sudarshan today questioned the National Human Rights Commission's objectivity and virtually called it "anti-Hindu" for its intervention on behalf of the Best Bakery massacre victims.

The double-barrelled attack also targeted Madhya Pradesh chief minister Digvijay Singh for "promoting a sense of alienation in the minds of tribals" to create a vote bank for himself.

In the customary Vijaya Dashami-eve address delivered by the RSS chief at the Sangh's Nagpur headquarters, Sudarshan compared the Best Bakery case with the acquittal of those accused of killing the Hindus of Radhabai Chawl in Mumbai in 1993 for want of evidence.

"In the Best Bakery case, when the accused were set free because the main eyewitnesses turned hostile, the NHRC rushed to the Supreme Court saying that justice cannot be rendered to the victims in Gujarat and hence the case be retried in a court outside Gujarat," he said.

"Why did not the NHRC come

"Why did not the NHRC come forward to take that case also to the apex court?" he asked, referring to the Radhabai Chawl incident. "Is it because those killed in the Radhabai Chawl episode were all Hindus...? Will not the extreme concern for Muslims and Christians and utter disregard for Hindus by the NHRC make people question the impartiality of it?"

Sudarshan said another manifestation of this mindset was seen in the treatment given to the photograph of Qutubuddin Ansari which showed him pleading with his attackers to spare his life during the Gujarat riots.

his life during the Gujarat riots.

"After three days, there appeared another picture of the same boy, this time with a smiling face, thanking god for saving his life. A question crops up as to how a murderous crowd, which was alleged to have not even spared pregnant women, could become so benign in that frenzied situation to let go of the boy unharmed."

Sudarshan's solution for changing this mindset was to redefine the notion of who minorities and Dalits were.

"In reality, minorities are those who migrate from other countries and settle here. In that sense, only the Jews and Parsis fall under the category of minority. But they refused to call themselves minorities...," he said. Christians and Muslims, on the other hand, were converts, he added.

Sudarshan made a plea for merging the Dalits into the "mainstream". "How far is it appropriate to call a section of our own people Dalits...?" he asked.

"Being the chief minister of Madhya Pradesh, he should at least have known how Rani Durgawati had fought the Mughals and attained martyrdom.... HRD MINISTER Murli Manohar Joshi said on Saturday that he would wage his own legal battle to clear his name in the Babri Masjid demolition case. Joshi's lawyers would file a petition in Alla-habad High Court on Monday against the Rae Bareli special court's decision to frame charges against him

Sources close to Joshi said the minister's decision to go it alone does not mean he is determined not to withdraw his resignation. Joshi himself brushed off the question whether he would continue in the ministry, terming it "hypothetical". He argued that the ball is in the Prime Minister's court, and that his fate will be known only after Atal Bihari Vajpayee returns on Sunday.

But Joshi's decision to plough a lone furrow is being seen as a statement by itself. Despite the initial talk about a common legal stand, the party has kept Joshi in the dark about any progress on

this front.

The absence of any communication from the BJP high command on the Ayodhya case has been a significant feature of the Joshi resignation drama, which has now entered its eighth day. Joshi's move to file his own petition would make it clear to the Prime Minister how strongly he feels about the at-tempt to marginalise him within the party. Joshi was not invited to meetings of senior ministers, convened by Deputy Prime Minister L.K. Advani, before and after the court order.

Whether Joshi continues in office will be decided the same day his petition is submitted before the court. Vajpayee is likely to meet him on Monday. Like most Cabinet members, Joshi is likely to be at the airport to receive the Prime Minister

on Sunday night.

On Saturday, Joshi attended the inauguration of the Swabhiman Sports Festival to observe the 96th birth anniversary of Bhagat Singh, but did not make any political statement.

Steins murder case

Sa S Justice must be seen to be done

To no one's surprise Ravindra Pal, alias Dara Singh and his twelve associates have been found guilty of first degree murder of the missionary Graham Steins and his two minor sons by setting the jeep in which they were sleeping, on fire on the night of 22 January 1999. The case of Dara Singh is distinguished from his accomplices and while they go to jail for life, Dara is sentenced to death subject to confirmation by the High Court under the CrPC. Dara evaded arrest for a year and was nabbed only in January 2000. The trial began on 1 March that year and has lasted three years with 56 prosecution witnesses and 25 defence witnesses examined. The CBI must be complimented on their investigation and for their conduct of the case — both were thorough, professional and competent. That Dara is supposed to have an ailing father and a not quite normal brother is neither here not there. That he failed to heed the cries of the two young children suggests that he was not normal either. The fact that he was cool, calm and confident he was doing the right thing supports the judge's finding that this was one of those rarest of rare cases that deserves the death penalty. Nor does it help to suggest that Dara was consumed by religious frenzy. The judge's quotation from Swift is apt — We have just enough religion to make us hate one another, not enough religion to make us love one another. It was said that Dara was a hero to Bajrang Dal supporters and this may lead to at least one conclusion. When religion degenerates into bigotry and hatred, reason and tolerance fly out of the window.

It may be recalled that within a few days of the horrendous incident, when suspicions of involvement of the Bajrang Dal and also perhaps the VHP were voiced, Home Minister LK Advani pitched in with his comment that he knew these organisations well and they were incapable of such an act. Events as they have developed, point to caution in pronouncing on matters which lie within the province of law enforcement, specially on the part of those whose departments are not unconcerned with due process of law. Within days of Narendra Modi's exploits in Gujarat, Advani was in Ahmedabad and complimenting the Chief Minister on controlling the riots within 72 hours. The National Human Rights Commission had no difficulty in concluding on the evidence, not mere perceptions, that the claim was untenable. Two points survive. One, Advani has a reputation to lose, he is prime minister in waiting; he ought not to wear his loyalty to colleagues and all their works upon his sleeve; it could cause embarrassment. The other is thought-provoking. Whether Dara Singh was acting alone or was influenced at the very least, by the Bajrang Dal is of less moment than to remember that no one, not even the plainly demented, could have alleged that Dara Singh was influenced by the Ramakrishna Mission, for instance! Why not? Because it is all a matter of reputation. And of being entirely predictable.

Gladys Steins has forgiven Dara and the others. This elevates her above the rest of us and commands respect. It cannot however be a substitute for law enforcement. Whether or not the death penalty should be retained is a proposition that can be debated till the cows come home. But as long as it is on the statute book, the law declared by the Supreme Court that it should be applied in the rarest of rare cases will prevail and the High Court can confirm the sentence or amend it but it cannot amount to a retrial. Nor should Orissa emulate the West Bengal case where a politically influential convict on death row is still alive, years after the sentence on the plea that the government cannot find

PM calls, says decision should be deferred

Joshi may take judicial way back

NEW DELHI, Sept. 20. — Mr Murli Manohar Joshi stayed away from his office today but indications are that he "may be back soon". One option easing his way back could be judicial. Mr Joshi and the six others charged in the Babari Masjid demolition case by the Rae Bareli special court will appeal against the court's decision, BJP sources said. The appeal could come as

early as Monday.

Politically, Mr Joshi received assurance from party leaders. The Prime Minister, visiting the USA, called Mr Joshi from New York. Mr Atal Behari Vajpayee told Mr Joshi that he should not take any decision till he (the PM) comes back. The PM returns from his foreign tour on 28 September. BJP sources said that Mr Vajpayee was a party to the decision that no minister should resign if charged by the Rae Bareli court. A meeting on the Ayodhya ruling fallout is likely to be held on 29 September, with the PM attending. Mr Joshi reportedly told the PM that he wanted to "discuss certain issues" with him.

Other senior party leaders also pitched in. Mr LK Advani, who has not been charged by the court, wanted to meet Mr Joshi today but could not as the latter left for Allahabad, a BJP leader said. The two could meet on Monday.

At the post-court ruling strategy meet yesterday at Mr Advani's residence, BJP leaders, among them the party president Mr Venkaiah Naidu, had decided on

appealing against the Rae Bareli court's ruling.

A BJP leader present at that meeting said the consensus was that if and when a stay was obtained, the case for Mr Joshi withdrawing his resignation, or better, the Prime Minister rejecting his resignation, would become stronger. Other BJP leaders today reiterated that Mr Joshi can and should continue in the Union cabinet. Repeated assertion by the BJP on retaining Mr Joshi as minister could form the basis for a second "reason" for withdrawing or rejecting the resignation.

Mr Joshi can say, according to a senior BJP leader, that since the party wanted him to continue, he, as a "disciplined party man", is

"bowing to its wishes".

Support for Mr Joshi came from Ms Mamata Banerjee as well. The Trinamul leader had sent a party leader to Mr Joshi's house as a sign of solidarity, a BJP leader said. Mr Shanta Kumar, BJP leader and former Union minister, also called. As did other BJP leaders.

Cadre support too was visible. Mr Joshi's loyalists travelled from Haryana and UP and had set up a musical support group at his residence. Gujarat yes to Bakery case retrial

Syed Liaquat Ali New Delhi September 19

IN A major climbdown from its earlier stand, the Gujarat government on Friday agreed to fresh investigations and retrial in the Best Bakery case. It admitted that witnesses in the case might have been "coerced or won over" to turn hostile, leading to acquittal of the accused, but firmly refused to hand over the probe to the CBI.

Representing the state government, additional solicitor-general Mukul Rohatgi told the apex court that there was no need for a CBI probe. The government would amend its appeal to seek the high court's directions for fresh investigations by the state police, retrial and collection of additional evidence, he added.

Chief secretary P.K. Lahiri assured the court that the government had decided to amend its appeal to incorporate these additional prayers. In an affidavit, Lahiri said the state's advocate-general would argue the case in the high court. The government was in the process of appointing special public prosecutors to assist in other sensitive riot cases, the affidavit added.

The trial court, while acquitting all 21 accused in the case, had castigated the police for doing a shoddy job.

Hindus can pray at Bhojshala MP High Court allows prayers at premises on Tuesdays

MADHYA PRADESH High Court on Thursday upheld the April 7 ASI order, allowing the Hindu community to access the Bhojshala-Kamal Maulana Mosque premises free of charge to offer pravers every Tuesday from sunrise to sunset.

Justice Arun Mishra dismissed the writ petition moved by Qazi Zakullah, Haji Muneer Ahmad, Haji Ata Mohammad, Farooque Mohammad and Sayyed Ahmad seeking directions to stay the execution of the Union and state governments' recent orders permitting Hindus to offer prayers at the site on Tuesdays.

While dismissing the plea, the HC on Thursday, held that a writ petition is not an appropriate procedure to examine that Bhojshala-Kamal Maulana Mosque is exclusively a Kamal Maulana mosque and only the Muslim community has the right to access it - and not the Hindu community.

The high court said no observations or findings recorded in its order should come in the way of the petitioners, any other person or either of the community to establish their rights over the monument owned by the Government of India, in the civil court.

Besides, the court refrained from entering into other disputed questions raised out of facts mentioned in the petition, stating that a writ petition was not the proper procedure to seek relief for restraining the entry of the Hindu community into the monument.

There is a sense of deja vu; it has started again. VHP lays down an ultimatum that if appropriate legislation is not enacted by 15 October to build a Mandir in Ayodhya thousands of Ram bhakts (no longer kar sevaks after the Babari Masjid demolition) will descend on the holy city for the purpose, coupled with a threat of violence. This is a repeat of 1984 to 1992 when finally on 6 December the Babari Masjid was demolished. For a while it fell silent and then revived ahead of every election. With elections round the corner, the Sangh parivar seems to have no other issue in hand. The bankruptcy of thinking is painfully apparent.

VHP sets 15 Oct The deadline for Ayodhya legislation

NEW DELHI, Sept. 15. — The VHP today demanded parliamentary legislation before 15 October to hand over the disputed site in Ayodhya for temple construction. On that day, lakhs of "Ram Bhakts" (devotees of Ram) would organise a peaceful march from Delhi and Lucknow to Ayodhya if the demand was not met through convening a special session of Parliament.

The RSS has given full support to the VHP's plan of action, the organisation's working president, Mr Ashok Singhal, said after a meeting of the Ram Janambhoomi temple construction movement committee that concluded today.

The meeting was attended by the RSS general secretary, Mr Mohan Bhagwat, who has assured that RSS workers would participate in the temple agitation. Mr Singhal said.

The BJP will not participate in the temple movement, the party president, Mr M Venkaiah Naidu, has clarified. The party spokesman, Mr Mukhtar Abbas Naqvi, said the ASI report had strengthened the temple cause and the need to resolve the issue through court or negotia-

A gathering of about 200,000 Ram Bhakts is planned in Ayodhya on 17 October, the chairman of the committee for temple construction, Mahant Avaidyanath, said after today's meeting.

Mr Singhal said that the agitation would be peaceful and not the same as the one in the 1990s. It was merely a show of support to the temple cause. He described the agitators as "Ram Bhakts" and not "Kar Sevaks" (a term used for construction by devotees). He demanded that Mr Mulayam Singh Yadav should exercise restraint and not impose prohibitory orders.

As part of the mass mobilisation programme before the deadline, 85 groups of religious leaders comprising 100 sadhus each will tour the country to address "sankalp sabha" (meeting for taking pledge) between 6 and 12 October, Mr Singhal said.

He said the VHP would not talk to the BJP on the issue. "We do not have any hope from the BJP. It has not done anything in the last five years. Rather it has dropped the three important issues, including Ayodhya, from its agenda." He also refused to refer to his earlier statement demanding the Prime Minister's resignation for failure on the Ayodhya front.

SENTENCE IN STAINES CASE ON 22 SEPTEMBER

Dara, 12 others convicted

BHUBANESWAR, Sept 15. — The District and Sessions Judge of Khurda, Mr Mahendranath Patnaik, today convicted Ravindra Pal, alias Dara Singh, and 12 others in the Staines murder case and posted the hearing on sentences for 22 September. He, however, acquitted Anirudha Dandapat, one of the accused in the case.

Pronouncing his verdict in a packed courtroom, the judge found all 13 guilty of conspiring to murder Graham Staines. They were convicted under Sections 302, 148, 149, 435, 436 and 120B IPC. Dara Singh was also separately convicted for direct murder under Section 302.

Due to lack of evidence Anirudha Dandapat is acquitted of the charges, the judge said.

Those convicted are Dara Singh, Rajat Kumar Das, Mahendra Hembram, Thuram Ho, Renta Hembram, Ojen Hansda, Umakanta Bhoi, Rabi Soren, Daya Patra, Mahadeb Mahanta, Harish Mahanta, Surat Nayak and Kartik Lohar. Chenchu Hansda, a minor, was earlier sentenced by the Juvenile Justice Bench.

The crowd inside the courtroom prompted the judge to observe that "people are standing like matchsticks in a match box". He wanted the

crowd to clear out from the area around the dock. Lawyers, media persons, an Australian diplomat and several others jostled for space.

Even outside the court, a huge crowd had gathered to have a glimpse of the accused and listen to the verdict. People had lined up along the road leading to the court giving the police a tough time since morning.

Australian missionary Graham Staines and his two minor children, Philip and Timothy, were burnt alive when they were asleep inside their station wagon at Manoharpur on 22/23 January 1999. The missionary had gone to Manoharpur to attend a "jungle camp".

The case was handed over to the CBI. A commission of inquiry was also ordered and it was conducted by Mr Justice DP Wadhwa. His report was submitted in the same year.

Dara Singh had evaded the police for nearly one year. He was arrested by the Mayurbhanj police in January 2000.

The CBI chargesheeted 18 persons, of whom Ghanashyam, Ramjan and Buddhi Nayak were shown as absconding.

Mrs Gladys Staines, widow of Graham Staines, refused to comment on the verdict. She iterated that she had "forgiven" the accused persons four years ago.



'Hindu movement'

Temple cry in Sangh Chorus

New Delhi, Sept. 14: The VHP today said it would unleash a "Hindu movement" and build a Ram temple at Ayodhya amid indications of endorsement from the Sangh and winks from at least a section of the BJP as election time draws near.

After a meeting of the VHP here, its leader Praveen Togadia declared: "We are not seeking the permission of any political party for building a Ram temple. We do not care if it pleases or displeases anybody."

The statement was clearly targeted at the BJP and the Vajpayee government, which has frequently been embarrassed by the acts and announcements of the VHP. "A Hindu movement has been unleashed to put an end to jihad." Togadia announced.

to jihad," Togadia announced.

The VHP is going to lay down an action plan to make good its pledge to build a temple at its margdarshak mandal meeting beginning here tomorrow.

A less strident, but an equally determined, vow came from the Sangh. In Bhopal, RSS spokesman Ram Madhav said that if the road was not cleared for temple construction, the Sangh would launch a "massive mobilisation of national will".

His comments and Togadia's ultimatum came a day after a meeting between top BJP and RSS leaders where the Ayodhya issue as well as the question of "greater co-ordination" with the VHP were discussed.

VHP were discussed.

BJP chief M. Venkaiah Naidu today said the party was committed to the temple movement, which, he claimed, had received a moral boost after the Archaeological Survey of India said a structure existed at the spot where the Babri Masjid had stood.

There was no deviation from the party's and the government's stand, though, that a legislation to hand over the disputed site for temple construction could not be enacted because it will be defeated in the Rajya Sabha where the BJP does not have majority.

ASI report spurs Sangh Parivar

BJP to push for Temple

NEW DELHI, Sept. 13. — Buoyed by the ASI's report on the excavations at the disputed site in Ayodhya, the BJP and the rest of the Sangh Parivar today decided to intensify their campaign for construction of the Ram Temple.

Mr LK Advani and two senior RSS leaders, Mr Mohan Bhagwat and Mr Madandas Devi, today met at BJP president Mr M Venkaiah Naidu's house to deliberate on the need to evolve better coordination between various Parivar outfits over Ayodhya.

The meeting, which lasted about three hours, also discussed the situation which might arise if the special Rae Bareli court orders framing of charges against the Deputy Prime Minister and other senior BJP and Parivar leaders in the Babari Masjid demolition case, sources said. The meeting came barely two days before the VHP's Ramjanambhoomi Committee is scheduled to hold a conference here.

The BJP and RSS leaders also discussed the Supreme Court's indictment of the Narendra Modi government in the Best Bakery case and also the BJP's preparations for the November Assembly elections in five states. Yesterday, Mr Naidu had

dismissed Mr Modi's resignation on the issue. The RSS too had played down the Supreme Court's observations, saying protecting the people and punishing the guilty are the responsibility of all state governments, not just of Gujarat.

The decision to convene today's meeting was taken after Mr Naidu held consultations with the Prime Minister last night.

The ASI report has clearly helped Parivar outfits to close their ranks again for the cause of the Ram Temple. A few days ago, Mr Advani had said the report was a "vindication" of the BJP's stand on Ayodhya.

After today's meeting, BJP general secretary Mr Pramod Mahajan said that in light of the ASI report, it was decided that the temple campaign should be stepped up. He, however, reiterated the BJP's stand that the party wanted an early resolution of the issue through negotiations or court verdict or a legislation, though its coalition compulsions did not permit it to bring in a legislation.

Seeking to bury the hatchet with the VHP, Mr Mahajan said the BJP had no problems with the latter's agitation in support of an Ayodhya legislation.

The defence counsel, while accusing the CBI of working under the "influence of the rival political parties" said the agency had listed over 800 witnesses and 700 documents in the composite chargesheet filed by it in the special CBI court at Lucknow but had chosen to list only 149 witnesses in the case.

Staines verdict after 4 years

Bhubaneswar, Sept. 7 (PTI): Four years and seven months after Australian missionary Graham Stuart Staines and his two sons were killed at Manoharpur village in Orissa, all eyes are focused on a local court that will pronounce its judgment tomorrow.

District and sessions judge of Khurda M.N. Patnaik will give the verdict after hearing the case for about two-and-a-half years.

Staines and his sons—Philip, 11, and Timothy, 7—were asleep in their station wagon at Manoharpur in Keonjhar district on the night of January 22, 1999, when it was attacked. A mob set it ablaze, burning the missionary and his children to death even as terror-struck villagers watched in fear, the prosecution lawyers had told the court.

Based in Baripada, the district headquarters of neighbouring Mayurbhanj, Staines had been running a home for leprosy patients. With his two sons and friends, he had gone to Manoharpur to conduct a camp for the villagers — an annual gathering of Christians for fellowship and teaching.

The killings sparked outrage within and outside the country. The Centre had set up a judicial commission headed by Supreme Court judge D.P. Wadhwa to inquire into the crime.

The commission concluded that prime accused Dara Singh alias Ravindra Kumar Pal was responsible for the crime as he had motivated tribal youths to attack the missionary. The act of murder was inspired by Dara and no authority, organisation or any other person played any role in the killings, the report, submitted in June 1999, said.

The commission also said that though Staines was involved in spreading the gospel as a missionary, he was not involved in conversions, an accusation held against Dara during the trial.

When the commission held him guilty, Dara was still at large, roaming the forests of Mayurbhanj and Keonjhar, and had turned into a sort of local legend. He was nabbed by police a year after the incident.

Two months after the triple murders, the investigation was handed over to the CBI. The agency submitted its charge-sheet against 18 persons, including Dara, on June 22, 1999. Fifteen of them were arrested. Three are absconding.

Chenchu Hansda was tried in a juvenile court and convicted. He is now in a remand home. The 14 others who faced trial, besides Dara, were Rajat Kumar Das alias Dipu Das, Aniruddha Dandapat alias Andha Nayak, Mahendra Hembram, Ojen Hansda, Umakanta Bhoi, Kartik Lohar, Rabi Soren, Dayanidhi Patra, Mahadeb Mahanta, Harish Mahanta, Thuram Ho and Surath Nayak.

The trial began on March 1, 2001. The CBI had submitted a list of 108 witnesses, which included Gladys Staines, the missionary's widow.

The court proceedings took a twist on February 1, 2002, when Hembram shouted from the dock that he wanted to confess. He claimed responsibility for the murders, saying he had set the station wagon on fire.

However, this April, Patra confessed that he was part of the group that attacked Staines. He added that Dara had set fire to the vehicle.

The case took an ugly turn towards the fag end when a defence witness, Hemalata Karua, claimed that the missionary had attempted to molest her a day before his death. Curfew in Godhra after class

GODHRA, Sept. 5. — At least 23 people, including three policemen, were injured and two vehicles torched and several damaged as communal violence broke out after two groups pelted stones at each other when a Ganesh immersion procession was passing through Polan Bazar here, forcing police to clamp curfew in parts of this communallysensitive town.

According to police, trouble began in Polan Bazar when a Ganesh immersion procession was weaving its way through the locality and the devotees raised provocative slogans. It escalated into a stone pelting spree and then a clash between two groups.

Police fired three rounds in the air, lobbed tear-gas shells and swung batons to quell the violent mob, official sources said. At least 10 people, who were part of the procession, were injured, the sources said adding three policemen, including a DSP, also received injuries when a police picket was attacked. The mob went on the rampage setting two trucks ablaze, damaging several other vehicles and attacking properties, prompting authorities to clamp curfew on violence-hit areas. The situation was under control and Ganesh immersion at other places of the town passed off peacefully, sources said.

Director General of Police Mr k Charavarthi said a company of Rap id Action Force had been deployed in sensitive areas to prevent any un toward incident. He said the Inspec tor General of Police (Vadodar: range) was supervising the situation One company of Rapid Action Pe lice had already been deployed in the town for additional security measures during the Ganpathy celebrations apart from local police.

The devotees were carrying Ganesh idol and nearing Rani Masjid when trouble broke out, the sources said. As violence flared up, police intervened and fired in the air to bring the situation under control.

ASI findings: Opposing sides line up experts

Udayan Namboodiri New Delhi, September 4

BOTH SIDES to the Ayodhya divide have lined up experts to comment on the Archaeological Survey of India (ASI)'s findings at the disputed site.

Lucknow Bench of the Allahabad High Court had given the litigants six weeks to file their observations. The pro-temple group's Devendra Swaroop, a senior RSS ideologue, told *Hindustan Times* that they have already held a meeting of experts to finalise their response.

On the other hand, Jafaryab Gilani, counsel for the Sunni Central Wakf Board, said the ASI report had been circulated among several archaeologists for inputs. Swaroop said his side would defend not only the ASI's report, which vindicated the temple theory, but the institution as well. "Leftist scholars are bent upon destroying the credibility of the ASI, which is not right," he said.

In reality, however, there are no "Leftists" in the Opposition. None from the group of the JNU historians who rallied behind the Babri Masjid Action Committee — R.S. Sharma, Suraj Bhan, D.N. Jha and Athar Ali — have been approached by the Wakf Board. Bhan, the lone archaeologist, said he would be happy to assist the litigant if he is approached.

The eminent expert on medieval India, Irfran Habib, had claimed from the SAH-MAT platform last week that what the ASI dug up was actually a mosque. This, however, is not at the heart of the Wakf Board's case. Bhan, the only archaeologist in the former JNU group, told *Hindustan Times* that Habib was just putting forward a theory.

Former director of archaeology with the Bihar government, Sitaram Rai, who is advising the Sunni Wakf Board, said their argument would mainly be based on the issue of glazed tiles, which never existed in pre-Islamic India, the lack of icons on the brick structures dug up and the presence of lime-surki mortar, which

SC gives Mulayam Advani headache

New Delhi, Sept. 1: The Supreme Court today refused to stay the Rae Bareli trial against L.K. Advani but took up a petition that challenged the CBI's action of "dropping" conspiracy charges against the deputy Prime Minister in the Babri Masjid demolition case.

The court has issued notices to several respondents, including the CBI and the government of Uttar Pradesh, where Mulayam Singh Yadav assumed power only last week.

The Congress, which is keeping Mulayam Singh on tenterhooks over sharing power, tightened the screws as soon as it was known that the court did not dismiss the conspiracy-charge petition.

"No decision has been taken to join the Samajwadi Party-led government. We will certainly be discussing the issue when the state government finalises its response to the Supreme Court notice," Congress spokesman Abhishek Singhvi told reporters.

The Rae Bareli court has been hearing the case against Advani and a few others since May 30, after the CBI filed a fresh chargesheet.

A controversy had erupted when the Opposition alleged that the Indian Penal Code's Section 120 b, which relates to criminal conspiracy, was dropped to dilute the charges against the accused.

Today's court notices were issued on a petition by lawyers Wajahat Ansari and C.M. Shukla, who contended that the CBI had acted "under political pressure" and dropped the conspiracy charge.

They said the trial should have proceeded on the basis of the composite chargesheet filed by the CBI in 1993 which had the conspiracy charge.

But, the petitioners said, taking advantage of an apex court ruling in 2002, which permitted the trial to proceed in the Rae Bareli court, the CBI had submitted a truncated chargesheet.

The two lawyers alleged that the public prosecutor, who was pleading the case since 1993, was "suddenly" replaced by an advocate who assisted a Union minister in legal practice.

The judges issued notices on this petition but did not entertain another filed by Mohammad Aslam alias Bhure until "offensive portions" were deleted. Bhure, the spearhead of several pleas linked to the Ayodhya dispute, had filed a petition contesting the transfer of the case from Lucknow to Rae Bareli.

NEW DELHI, Aug. 31. All-India Muslim Personal Law Board today said it would challenge the ASI report on Ayodhya excavations even as it declared that it would accept the court's final verdict "whatever it be".

Board president Syed Mohammed Rabey Hasani Nadvi described the ASI report, which suggested the existence of a temple beneath Babari Masjid, as "concocted and politically motivated". He also said the board's doors were open for any further "result-oriented, positive negotiations" to resolve the tangle.

An internationally-renowned Islamic scholar, Maulana Nadvi said the recovery of things during the excavation did not indicate the existence of any temple beneath the site. The ASI's interim reports on this line, he noted, is contradicted by its final report.

Condemning violent and terrorist activities, Maulana Nadvi said these acts of aggression are against the Islam. He stressed on the need to build up an atmosphere of love, harmony and trust between communities. Referring tionship, he said efforts have to be made to bridge this gulf. "The teachings of Islam make this clear that we have to take others' interest into account before thinking of pursuing our own concerns".

Maulana Nadvi denied the charge that the Board was preoccupied with only "sentimental and confrontational matters" at the cost of "the Muslim community's real issues". He said the Board has been trying to focus on social and economic development of the

community.

The maulana said the Board had not been contacted following the breakdown of the Kanchi Shankaracharya's Avodhva initiative, to take forward the process meant for a negotiated settlement of the dispute. He told a news conference here that he was unaware of any negotiations currently underway.

Smoking gun? Reading too much into ASI report

The RSS and friends are celebrating too soon at the Archaeological Survey of India reporting the excavation of a 'structure' below the demolished Babri Masjid. The ASI findings are sketchy and wholly unconvincing; their tentative conclusion is that some of the items discovered may have a resemblance to other temples found generally in north India. That is all. The sangh parivar still needs to prove - that the 'structure' was indeed a Ram temple, and that the temple was demolished by Mir Baqi, Babar's general, in order to make way for the Babri Masjid. Even if these propositions are proved beyond doubt, and that looks virtually impossible at present, it still doesn't hold water. If one were to assume that any edifice that has come up after demolishing another must in its turn be demolished and the original structure resurrected, that would have funda-mentally destabilising effects. Virtually every historical building in the country, and a lot of more recent construc-

tion, would be in instant jeopardy.

The proposition is easily testable: King Solomon built a Jewish temple at the site where Jerusalem's Al Aqsa mosque now stands, but not even a hardliner like Prime Minister Ariel Sharon — a man rightwingers close to the BJP profess to admire — is proposing that the Al Aqsa mosque be razed to make way for a new temple of Solomon. Israeli security does a far superior job of safeguarding the Al Aqsa mosque than the Indian government did in protecting the Babri Masjid. For very good reason, therefore, the legal case rests only on who has title at present to the disputed land. It is surprising that even the Congress should find the ASI report to be an "input" in deciding the Babri Masjid case — it is a manifestation of the "soft Hindutva" line the party has been peddling of late. This is self-defeating as the BJP is likely to flaunt the ASI report in its election campaign as "evidence" justifying its aggressive posturing. Congress would have been better employed showing up the hollowness of that socalled evidence.


NEW DELHI, MAY 3. Calling upon the people to resolve issues through mutual negotiations, the Prime Minister, Atal Behari Vajpayee, today assured minorities that his Government was opposed to any discrimination on the basis of religion. He said he personally looked into complaints based on religious discrimination.

Inaugurating a national convention on "Educational and economic development of minorities" organised by the Central Wakf Council, the Maulana Azad Education Foundation and the Ministry of Social Development and Empowerment, here today, Mr. Vajpayee said that all issues could be resolved amicably through consultations. "If the solution does not come immediately, we should wait for the right time instead of rushing to look for a solution. But it is necessary to observe restraint, both by the majority and minority community," he said.

necessary to observe restraint, both by the majority and minority community," he said. The Constitution gave equal rights to people of all communities and there was no harm in the will of the majority prevailing but it was important that the voice of the minority be heard particularly, though both the communities had equal rights under the Constitution.

"We have special provisions for the minority, which do not come as a favour but it can be described as the Indian way of living together in a family," he said.

Criticising those who propagated that the NDA Government was "antiminority", Mr. Vajpayee said it was a huge country with a large number of people who had complaints and grouses, "There is nothing that cannot

be resolved through talks. People are running a campaign to malign the Government," he said adding that not everyone believed in these allegations.

"There are times when people feel dejected and frustrated in their country but India belongs to everyone and each one of us has a role to play in its development," he said.

Stressing the need for education for the economic development of the minorities, Mr. Vajpayee said that any other kind of backwardness could be compensated later but educational backwardness could never be overcome.

It was not necessary that

minorities always remained a minority in politics. His party was a minority in Parliament for several decades but came into a majority eventually.

"I don't know how long I will stay in majority because one never knows when the allies decide to snap ties," he said adding that nothing can be certain in politics but hoped that his flock would stay together.

The Civil Aviation Minister,

The Civil Aviation Minister, Syed Shahnawaz Hussain, called upon the minorities to be wary of the attempts being made to use them to malign the NDA Government.

"Whenever the issue of minorities comes into focus, it revolves round a few issues such as riots and the Government spends its resources on denying allegations invariably heaped on it while the real problems remain unaddressed," he said.

Referring to a negative campaign being launched against the Centre's policy on madrassas (Muslim seminaries), Mr. Hussain said the Government had done exemplary work in giving grants to such educational institutes as well as increasing subsidy to the Haj pilgrims.

ku (THROUGH IT'S PERSISTENCE with the "trishul ny, the Vishwa Hindu Parishad diksha" cere is not only accompting a nationwide mobilisation of the adherents of Hindutva, but also cultivating religious fanaticism and sowing seeds of communal violence. Apparently unshaken by the experience in Rajasthan, where its international general secretary, Praveen Togadia, was arrested for defying a ban on tridents, the VHP is deliberately raising apprehensions in the minds of the minorities and throwing a challenge to law-enforcing agencies in different parts of the country under the guise of organising a religious ritual. The VHP international president, Ashok Singhal, claims "trishul diksha" is a right under Hindutva, and the VHP vice-president, Giriraj Kishore, says the ceremony is entirely religious in nature. But the tridents, in the hands of workers of the VHP and other Hindutva outfits, have a record of aggressive display and provocative politics. Even senior leaders of the BJP distanced themselves from the "trishul diksha" finding it difficult to defend the sale and distribution of sharp-edged weapons in public places. Indeed, there was no consensus on this issue at the three-day conclave of RSS affiliates in New Delhi where the different members of the Sangh Parivar agreed on coordinating their activities. The Sangh Parivar organisations though united in their goals, are divided on the means, and not all of them found the VHP activities

And, just as there is no agreement among RSS affiliates on "trishul diksha", so too there is no concurrence among Congress Chief Ministers on how best to deal with the trident distribution of the VHP. While the Rajasthan Chief Minister, Ashok Gehlot, ordered the arrest of Mr. Togadia, and the Delhi Chief Minister, Sheila Dixit, demanded a ban on the trident programme, the Kerala Chief Minister, A. K. Antony, has given the go-ahead to the VHP in Kochi. On critical

issues such as these, it is important that Chief Ministers do not allow political considerations to play a part in decision-making. Of late, there have been accusations that Mr. Antony favours a soft approach to Hindutva outfits. Evidently, the political compulsions of the Congress in Rajasthan and Delhi, where the BJP is the main rival, are different from the political compulsions in Kerala, where the Left is the chief opponent. But, what makes any decision on ceremonies such as "trishul diksha" difficult for the Government is the invocation of religious symbols. In the same way it exploits for political purposes the "trishul diksha" ceremony, the VHP would seek to capitalise on a ban on trident distribution by whipping up religious sentiments. In either case, the very nature of the activities of the VHP ensures trouble for the law-enforcing agencies. The greater the resistance from the state, the more determined the VHP becomes in carrying through its brand of provocative politics. There are now plans for "trishul diksha" in two lakh villages across the country, according to a VHP officebearer, Surendra Jain.

While VHP leaders have assured the National Commission for Minorities that they would not undertake activities that hurt the feelings of minorities, the experience of the past, particularly with respect to rabble-rousers like Mr. Togadia, has been very different. Indeed, the practice of Hindutva organisations such as the VHP is to take advantage of the democratic space available to push their majoritarian agenda. For the VHP, any public programme is a means to create a communal divide. And the result of the hate campaigns of the VHP was very much in evidence in Gujarat. As the VHP invokes Hinduism in the cause of Hindutva, the Government would have to be cautious and firm at the same time. There is a need to rein in the Hindutva outfits firmly, underlining the supremacy of the rule of

Minorities panel holds talks with VHP

NEW DELHI, MAY 5. The National Commission for the Minorities today held a dialogue with the top brass of the Vishwa Hindu Parishad (VHP) as part of an exercise to "restore communal amity and mutual understanding between the majority and minority communities."

The two-hour long session attended among others by the VHP vice-president, Acharya Giriraj Kishore, and the International Secretary, Praveen Togadia, focussed on several issues such as the nationwide "trishul diksha" (trident distribution) programme that recently been recently launched by the VHP, on the one hand, and the type of education provided by "madrassas' (Muslim seminaries), on the other.

Briefing reporters at the end of the meeting, Tarlochan Singh, chairman of the Commission, said the meeting was very fruitful as it helped both sides understand each other's views better. It resulted in agreement on several points.

While the VHP leaders assured the NCM that they would not make any remark or undertake any activity that hurt the feelings of minorities or create a fear psychosis among them, the commission agreed to review the syllabus of 'madrassas' schools and ensure that if there was any references that were anti-national they would be removed.

The commission also agreed to take up with leaders of the Muslim community the VHP's demand that they should avoid using words such as 'jehad', 'kafir', and 'darul Islam'. The VHP

also urged that minority communities should condemn in strong words whenever there was a terrorist attack, particularly in Jammu and Kashmir

Acharya Kishore, who was also present at the press conference, emphasised that the 'trishul diksha' programme was only religious in nature and no other motive should be attached to it. The 'trishuls' that were being distributed were harmless. They were less than six inches in length, much smaller than what was permitted by law.

The VHP, he added, was for communal harmony and would respond positively whenever the commission wanted to have discussions aimed at promoting communal amity. Surinder Jain, former Bajrang Dal chief and presently a senior office-bearer of the VHP, also participated in the meeting.

The commission chairman parried a question whether the VHP leaders were asked to give up their 'trishul diksha' programme. In its invitation to the VHP for the talk sent 10 days ago, the commission had stated that, "the communal fabric (in the country) stands shattered and the prevalent situation through the country is rather volatile."

Stressing that the need of the hour was to make all possible efforts to create an atmosphere for peaceful co-existence of all communities, it said, "it is imperative to evolve ways and methods for removing all the irritants causing disharmony in the society."

Togadia in custody, warning war

VHP leader Pravin Togadia was sent to judicial custody today for two days in connection with "violation" of prohibitory orders and a ban on distribution of tridents in Rajasthan after a local court rejected his bail application.

Magistrate Lata Gaur remanded Togadia to judicial custody after declining police request for custody of the VHP leader for two days. He will be produced before the court again on April 16, District Collector Niranjan Arya said.

Speaking to reporters, Togadia threatened to wage a relentless struggle against the



"anti-religious" Ashok Gehlot government of the state. "I shall now rest only after he is out of power," he said.

Meanwhile, Gehlot asserted that the government would foil the Sangh Parivar's "conspiracy" to disturb peace in Rajasthan. He alleged that the Sangh was trying to cause disturbances in order to create

political dividends for the BJP.

'At no cost will the Parivar be allowed to disturb the peaceful atmosphere of this state like they did in Gujarat. No one will be allowed to cause bloodshed," the CM said.

Togadia was arrested last night in Ajmer district. A case was registered against him under Section 4/25 of the Arms Act for possessing and distributing a banned weapon, under Section 188 of the IPC for violating prohibitory orders, and Section 153 (A) of the IPC for inciting communal passion.

Three VHP leaders and a former Bajrang Dal president were rounded up apprehending a possible breach of peace in view of tomorrow's VHP-organised Rajasthan bandh to

protest against Togadia's arrest, police said.

DSP B.L. Jain said VHP leaders Amritlal Khemka, Chheetarmal Agrawal and Suresh Goyal were taken into custody, but later released in view of their old age.Ex-Bajarang Dal chief Subhash Baheti was arrested under Section 151 of the CrPC.

Meanwhile, condemning the arrest of their leader, the VHP's Punjab unit today said its activists would march towards Rajasthan. "If Togadia is not released immediately, about 5,000 activists of the Punjab unit of VHP carrying tridents will march towards Rajasthan to register their protest," Punjab VHP in-charge Vijay Singh Bhardwaj said.



Gujarat governor holds back anti-conversion b NA

Gandhinagar: Even a week after it was passed in the state as-sembly, Gujarat governor S.S. Bhandari has not given his assent to the controversial Gujarat Freedom of Religion Bill, 2003, seeking to ban forced conversions. This has left the state government guessing about Raj Bhavan's intentions.

Speaker Mangaldas Patel said on Tuesday that while the other six bills, also passed by the assembly on March 26 amidst pandemonium over exhome minister Haren Pandya's murder, had been duly signed, the anti-conversion bill remains with the governor.

The reason for Raj Bhavan's refusal to sign the bill is not far to seek. Archbishop S. Fernandes, during his meeting with the gov-ernor last week, had expressed fears of harassment to minority religious leaders, who under the bill are supposed to take permission for conducting conversion ceremony from the district magistrate. This means the process of conversion can depend on the

'sweet will' of the district magistrate, who is also the district collector. Only when the district collector is 'satisfied' that no force or allurement is involved, can a person be converted.

The bill's provision is stricter than that of the anti-conversion law enacted in Tamil Nadu last year which just requires the person conducting the ceremony to inform the district official

about the deed.

Meanwhile, sources said the state government had decided to incorporate certain clauses in the bill that would allow Hindus to get converted to Buddhism, Jainism and Sikhism, and vice-versa, without seeking any permission. A top ministerial source told TNN that Buddhism, Jainism and Sikhism were part of the Hindu personal law. "Therefore, there would be no need to take permission for those coming under the Hindu code."

This verdict is welcome

But solving the Ayodhya crisis entails not a tidy judicial verdict, but political sagacity

THE Supreme Court's firm rejection of the Union government's application in the Ayodhya case is entirely welcome. Status quo in Ayodhya, the apex court has laid down, must be maintained till the title suits are finally disposed in the Allahabad High Court. There can be little doubt that the proposal that the government hand over the undisputed land to any other body or trust for conducting religious activity was fraught with unfathomed dangers; the five-judge bench is wise to reiterate that there has been no change in the ground situation to justify the uncoupling of the undisputed land from the disputed area. The VHP's plans to barge into Ayodhya after having secured Gujarat have fortunately been foiled. But in this happy scenario, there's that familiar, niggling question again. The apex court has certainly given the nation a breather, but can't we hear the clock ticking still? Will the final resolution come, as the SC has indicated, with the disposal of the title suit by the Allahabad High Court? Will the roiling controversy be calmed once the ASI has finished with its digging and the high court has determined whether or not a temple preexisted the masjid?

Or does the solution to the Ayodhya issue ask for something more? This is the moment once again to underline that the festering dispute cries

dut for a political solution and that a craven political leadership is stead-fastly shirking the effort. It is time once more to point out that the excavation ordered by the high court is not going to unearth the anticipated full stop to the controversy. Many have already pointed out that even if the ASI were the best equipped for the task at hand, archaeological findings don't always yield certitudes. Archaeology is an uncertain science at best and the results of the digging would be vulnerable to partisan interpretations. The high court's initiative promises to solve nothing — it only sets an extremely dangerous precedent. O

The government must impress upon the VHP that it is not above the law of the land. But, more than that, it must make another attempt to revive a process of negotiation. NHRC moves SC for re-trial

NEW DELHI, JULY 31. Expressing deep concern at the acquittal of the accused in the 'Best Bakery case' relating to the Gujarat riots of last year, the National Human Rights Commission today moved the Supreme Court seeking fresh investigation of the case by an independent agency and re-trial by a competent court outside Gujarat.

In a special leave petition (SLP) against the Vadodara trial court's order, the Commission said the acquittal had damaged the credibility of the criminal justice delivery system and negated the human rights of the victims.

The Commission also filed a separate application seeking the transfer of four other cases relating to the Godhra, Chamanpura (Gulburga society) and Naroda Patiya incidents and the Sadarpura case in Mehsana district for trial outside Gujarat.

On June 27, the fast track court of H.U. Mahida acquitted all the 21 accused in the case on the ground that there was no evidence to prove their guilt

evidence to prove their guilt.

It also pulled up the prosecution for its shoddy investigation. Subsequently, the key witness, Zaheera Sheikh, approached the Commission seeking its intervention for reopening of the case.

The SLP said the decision to seek the Supreme Court's intervention was based on the report submitted by the Commission's team sent to Vadodara for a spot assessment. Further, there had been repeated requests from the media regarding the action taken by the Commission in the case.

The SLP said the concept of a fair trial had been explicitly recognised in Articles 14, 19, 21, 22 and 39 A of the Constitution as well as various provisions of the Cr.P.C. and hence any violation of this right was a violation of the fundamental right.

The right to fair trial had also been recognised in the International Covenant on Civil and Political Rights ratified by India.

Expressing its "anguish" over the manner in which the trial was conducted, the Commission said that "whenever a criminal goes unpunished, it is society at large which suffers because the victims become demoralised and criminals encouraged. It therefore becomes the duty of the court to use all its powers to unearth the truth and render justice so that the crime is punished".

The Commission, in the interests of justice, urged the apex court to lay down guidelines and directions on the protection of witnesses and victims of crime in criminal trials, which could be adhered to both by the prosecuting and law enforcement agencies as well as the subordinate judiciary.

'Too early to comment'

GANDHINAGAR, JULY 31. The Gujarat Government has declined to make any comment on the National Human Rights Commission's move to approach the Supreme Court for a re-trial of the Best Bakery case and for trying the Godhra carnage case and four other major cases outside the State.

While there was no immediate word from the Chief Minister's office, the State Law Minister, Ashok Bhatt, said it was too early to comment without studying the papers and documents before the NHRC and the Supreme Court.

However, Kashiram Rana, Union Rural Development Minister who hails from Gujarat, virtually described the move as a "censure" of a lower court's judgment.

REFORM-ORIENTED CHANGES

THE LATEST BJP-SPECIFIC reshuffle Atal Behari Vajpayee has made in his Council of Ministers is essentially a continuation of the 'Operation Revamp' attempted less than eight months ago - and left unfinished due primarily to resistance from quite a few of those whom the party leadership wanted to shift for organisational work — in pursuance of the BJP national executive's decision at its Goa conclave, which itself was imbued with what the party called 'Poll Vision 2003-04'. In the process, there has also been a 'correction', so to say, as reflected in the re-induction of Arun Jaitley, who along with M. Venkaiah Naidu had quit office to take up party work last time around, and in the exit of Pramod Mahajan for assuming organisational responsibility. It looks as if, with the BJP returning to power in Gujarat, Mr. Jaitley's job was done and the party leadership believed that Mr. Mahajan, credited as he is with organisational skills, is the man of the moment when a string of politically important Assembly elections, as in Rajasthan and Madhya Pradesh, are ahead. It is, however, a moot question whether, given his persona, Mr. Mahajan, as general secretary, would be absolutely comfortable working with Mr. Venkaiah Naidu as the party chief, one considered to be not so senior as he is in the party.

At the end of the two-phase revamping exercise, if Jana Krishnamurthi, the man who was required to step down as party president making way for Mr. Venkaiah Naidu, finds himself in a limbo, as it were, it is because the Prime Minister was keen on stripping him of the 'Law' portfolio — and restoring it to Mr. Jaitley — and he himself was not willing to settle for anything else. Even at the time of the last reshuffle, one may recall, Mr. Krishnamurthi was allowed to have his way (with his demand for the Law portfolio) only after some hard bargaining and as a sop to his sense of hurt on

being asked to relinquish the party presidentship. In deciding to get Mr. Jaitley back as the Law Minister, Mr. Vajpayee and possibly also the Deputy Prime Minister, L.K. Advani (who has of late been playing a dominant role), must have factored in the new 'ultimatum' the VHP has issued to the Centre for handing over the 'acquired land' in Ayodhya and the serious implications it has for the Government and the party alike. After all, Mr. Jaitley, during his earlier tenure, handled a similar situation as it evolved last year.

To those who were looking for a message on the economic front, the changes effected in the Ministry carry a distinct and strong signal that the Vajpayee regime intends to stick to the path of reforms. While the exit of Mr. Mahajan convevs its own message, the fact that a vigorous champion of reforms like Arun Shourie has not only been allowed to retain charge of Disinvestment (against powerful lobbying by presgroups) but also entrusted Communications and Information Technology two other key areas — is seen particularly as a clear reaffirmation of the Government's commitment to reforms. Interestingly, Mr. Jaitley too has been given additional charges, Commerce and Industry (besides Law and Justice), and with this the BJP has brought within its fold most of the major economic Ministries. And Sushma Swaraj, divested of Information and Broadcasting, has taken over Parliamentary Affairs along with Health and Family Welfare, held hitherto by Mr. Mahajan and Shatrughan Sinha respectively. Whether the vesting of such important and heavy portfolios in the three, which at one level reflects the confidence the Prime Minister has in them, is only a matter of political expediency or administrative exigency or is an emerging pattern in the context of the party leadership's avowed rejuvenation effort remains to be seen.

CBI comes under Cabinet Secretariat

NEW DELHI, JAN. 30. Because of reports in a section of the media that the Central Bureau of Investigation had been entrusted to the Union Home Ministry in Wednesday's Cabinet reshuffle, an official spokesman clarified today that the investigative agency had, in fact, been transferred to the Cabinet Secretariat which, in turn, functions under the Prime Minister.

The confusion arose because the Rashtrapati Bhavan communique last night mentioned, correctly, that L.K. Advani would also be Minister for Personnel. The CBI has traditionally been part of the Department of Personnel.

the Department of Personnel.

However, it is learnt that it had been made clear to Mr. Advani that he could not be entrusted with the CBI, primarily because of the Ayodhya case. Mr. Advani himself was a party to the decision that the CBI be brought under the Cabinet Secretariat.

This proposed change, however, required an amendment in the Rules of Business, which, in turn, required Presidential consent. The process

of amending the Rules of Business began today, with the "file" going to the President for his signature.

Meanwhile, it was felt that the official spokesman should put the record straight before the confusion spread further. This "clarification" itself is being interpreted in many quarters as yet another manifestation of the unresolved power struggle within the Vajpayee Government. In another significant development, the Gov-

In another significant development, the Government tonight decided to shift the empowered Foreign Investment Promotion Board (FIPP) from the Commerce and Industry Ministry to the Finance Ministry.

Also, another press communique from the Rashtrapati Bhavan announced the changes/additions in the allocation of portfolios of the following ministers: O. Rajagopal (Minister of State in the Ministry of Parliamentary Affairs and Minister of State in the Ministry of Defence); Vallabbhai Kathiria (Minister of State in the Ministry of Human Resource Development), and Pon Radhakrishnan (Minister of State in the Ministry of Urban Development and Poverty Alleviation).

NEW DELHI, JAN. 29. The exit of four Cabinet Ministers and four Ministers of State, the return of two recently "axed" Ministers and the induction of six new faces marked the latest reshuffle of the Union Cabinet undertaken by the Prime Minister, Atal Behari Vajpayee. The BJP-cen-tric reshuffle of Ministers and portfolios is considered the BJP way of gearing itself for the coming electoral battles — in the States and at the Centre in the next 18 months.

The new entrants were administered the oath of office by the President, A.P.J. Abdul Kalam, at the Rashtrapati Bhavan this evening. The Prime Minister and his senior government and party colleagues attended the ceremony. At the end of the day, seven Cabinet Ministers, three Ministers of State (with independent charge), and 19 Min-isters of State found additions/deletions in their

Talking to mediapersons after the brief ceremony, the Prime Minister described the changes as "part of a natural process". He said "some people in the Government had been drafted for party work and some from party have been taken in the Government".

Most prominent among the evening's dramatis personae was Pramod Mahajan, who was asked to give up his high profile job as Communications Minister and to take up, instead, a party assignment. Though Mr. Mahajan will continue to have his working address on the same street, Ashoka Road, the decision to shift him to the party headquarters, a few bungalows up the road, reveals the BJP's changed priorities — from creditable governance to electoral preoccupations.

Mr. Mahajan is widely respected for his organisational skills and is expected to more than fill the "vacuum" caused in the BJP by the departure of Arun

Jaitley for ministerial responsibilities.

Besides Mr. Mahajan, three

Ministers leaving the Government — Uma Bharti, Vasundhararaje Scindia and Raman Singh - have been inducted for organisational responsibilities in their States, viz., Madhya Pradesh, Rajasthan and Chhattisgarh. Another departee, Jana Krishnamurthy, preferred to put in his papers rather than move from Law to another Ministry, as was suggested to him by the Prime Minister.

The Prime Minister has left undisturbed key Ministries such as Home, Finance, Defence, External Affairs; among the senior Ministers only Sushma Swarai has been moved from the portfolio of Information and Broad-casting to the equally crucial assignments of Health Ministry and Parliamentary Affairs.

Apart from Mr. Mahajan, the two Aruns — Shourie and Jaitley

- have caused the most excitement. They will be new hands-on Ministers. Between them, the two will have, for now, crucial portfolios with the former handling Disinvestment, Communications and Information Technology and the latter Law and Justice and Commerce and Industry.

According to the Deputy Prime Minister, L.K. Advani, the Prime Minister was keen on having Mr. Jaitley back in the Cabinet once the Gujarat elections were out of the way. Equally noteworthy is the independent charge of Ministry of Information and Broadcastics. Information and Broadcasting for Ravi Shankar Prasad, known

for talent and integrity.
On the other hand, while the shifting of Shatrughan Sinha from the Health Ministry had been long overdue, the return of C.P. Thakur is inexplicable. Seven months ago, he was deemed unfit to continue in the Cabinet.

but today he is back and has been made Minister for Development of the North-Eastern Region (besides Minister of Small-Scale Industries).

Two aspects of the reshuffle stand out. First, the increasing assertiveness of the Deputy Prime Minister in matters that are classic domain of the Prime Minister. Mr. Advani has finally succeeded in prying the Depart ment of Personnel away from the Prime Minister; but, it is learnt, that the most crucial "charge" of that department, the Central Bureau of Investiga-tion, would continue to be with the Prime Minister. For administrative purposes, the CBI is being asked to report to the Cabinet Secretariat.

It is pointed out that Mr. Advani could not possibly be given control over the investigative agency, given the fact he (along with another Minister, Murli Manohar Joshi,) remains teck nically a suspect in the Babri Masjid demolition case being investigated by the CBI.

The second aspect, less vis-

ible but quite pronounced, is the shadow of corporate warfare on the reshuffle and reallocation of portfolios.

The unsuccessful attempt to divest Mr. Shourie of the Ministry of Disinvestment is traced to corporate ministerial within the Vajpayee Govern-ment; this axis had to be content with ensuring that the Minister, Singh, did not have to part with the Department of Company Affairs. Nor could Ram Naik be divested of the Petroleum Ministry.
