Bereft of ideas Trinamul bandh plan is self-defeating

That there is no end to the problems confronting the Trinamul Congress is evident from a proposal to call a bandh some time in January apparently to protest against the "anti-people" policies of the state government. The Left Front's abject failures in key areas like health, education, industry, employment and improvement of infrastructure has produced a considerable degree of disenchantment in both rural and urban areas. But the question is whether the answer lies in a Trinamul-sponsored bandh that will again cause hardship only in terms of a day's production and to those deprived of a precious day's earnings.

Trinamul has been in sorry shape for some time and its pathetic performance in panchayat and municipal elections has served to throw its cadres into disarray. Mamata Banerjee normally takes it upon herself to hold the party together but in recent months she has been more than concerned about her own position in the Union cabinet. It cannot be of any help that she functions without a portfolio when there is strong speculation that parliamentary elections may be advanced to April-May.

The bandh idea may be one way of injecting new steam into the party. But surely Trinamul has sensible leaders to convince her that it would be more rewarding to strengthen the party in the districts where the Left Front, especially the CPI-M, is firmly entrenched with Trinamul virtually absent and Congress offering no real challenge,

except in Malda and Murshidabad.

It is still a mystery why Mamata has failed to extract any political mileage from the prevailing disillusionment. While Anil Biswas loses no opportunity to mock her efforts to mend fences with the NDA in order to find a cabinet berth, Trinamul has of late lost the will to assert itself on issues of popular concern. On the contrary, it allows Subrata Mukherjee to run the KMC on his whims dropping the water tax on his leader's orders but claiming that the Kolkata Gate proposal is still alive whether or not LK Advani comes to inaugurate it.

Now the mayor has engaged in a running battle with the state government by suggesting that it is depriving the KMC of its financial dues. Promptly the municipal affairs minister, Ashok Bhattacharya, produces figures to prove that Subrata is indulging in a mindless duel. The KMC elections are just over a year away and Subrata may find it necessary to engage in some brinksmanship to conceal his embarrassment at being conspicuously unpopular in his own party. At the same time, the figures produced by the minister are no proof that the Left Front's financial dealings with the KMC leave no room for complaint. The Left Front's financial mismanagement that has taken the state to the brink of bankruptcy is no secret. Now it is merely a matter of damaged egos at the minister not being invited to inauguration of ADB-funded projects. Subrata Mukherjee and Ashok Bhattacharya may reduce all this to

a petty quarrel.

All this does no harm to the Left Front while emphasising that Trinamul may be losing the only opportunity it has been given in the last five years to prove its worth with sheer performance and organisational competence. A bandh in January can only be self-

You experimented with negative roles at the height of your career. Do you feel the Hindi film industry today is working enough on new ideas?



VAIKO MAY have lost his war against Pota in the Supreme Court but could have scored a significant victory in the battle against its misuse. The SC, while rejecting his contention that Section 21 of Pota militated against freedom of expression had, however, held that mere moral support in the form of speeches to a banned outfit would not constitute an offence.

Vaiko, from the beginning, had claimed he had only extended moral support to the LTTE in the form of speeches and had not aided or abetted in any of its militant activities to invite action under Pota. The Supreme Court has now upheld that line of his.

Since the Supreme Court has said the Pota court should keep this interpretation in mind while pronouncing its verdict, Vaiko's lawyers are confident he will be acquitted in the Pota case. "So far, the prosecution has nowhere come up with proof of any ly sought to prove that Vaiko spoke in support of a banned outfit. That alone would not suffice to convict him after the SC verdict", pointed out one of his lawyers.

Now that the SC has eased the bail procedures for those held under Pota for more than a vear. Vaiko could be convinced to come out on bail, as well, sources said. "He has made his point in not applying for bail, so far, but it's time to take full advantage of the relief provided by the Supreme Court," said a senior MDMK functionary.

Bail makes greater sense since it would be a while before the Pota review committee can take a decision on the Vaiko case. It has to deal with the objections raised by the Tamil Nadu government challenging its powers to interfere with the judicial process before the Pota court. The SC's latest interpretation could also lead to the revival of pro-LTTE propaganda in the state, which had been on the wane ever since Vaiko was arrested.

Pota court rejects rejects Vaiko's plea

CHENNAI, Dec. 12. — The Pota court today rejected an application filed by the MDMK chief, Mr Vaiko, seeking permission to participate in the debate and voting on the Pota Amendment Bill in Parliament, on the ground that the plea was beyond the jurisdiction of the court.

Mr Vaiko and eight party colleagues were detained under Pota by the Jayalalitha government in July last year, for speaking in support of the LTTE at a public meeting.

The designated judge, Mr L Rajendran, dismissed Mr Vaiko's appli-cation, saying that "the comprehensive relief called for by the petitioner is beyond the ambit of jurisdiction of the special court." The Special Court was set up to try cases under Pota and the relief sought by Mr Vaiko did not fall within the ambit and scope of Pota, the Criminal Procedure Code, Prison's Act or Tamil Nadu Prison rules, he said.

The court noted that Mr Vaiko had on two prior occasions obtained

permission from the Madras High Court in similar circumstances. "Without specially assigning any reason and provision of law, the petitioner chose this forum, which professes no jurisdiction," the judge said, adding that Mr Vaiko, moreover, had not substantiated his claim within any provision of law

Later, advocates for Mr Vaiko said that they would discuss the option of moving the Madras High Court for relief.

Mr Vaiko was brought under heavy police escort to the high security court at Poonamallee, in the city suburbs.

Meanwhile, hectic preparations are on in the DMK camp for the state-wide agitation on 15 December to demand repeal of Pota. In a statement here today, the DMK president, Mr M Karunanidhi, said the party MPs were exempted from participating in the picketing programme.

The MPs were required to be in New Delhi as the Bill to replace an Ordinance giving more teeth to the Pota Review Committee was coming up for discussions in the Parliament.

Elusive portfolio

 \checkmark Mamata can only blame herself

The customary on the part of Trinamul leaders to describe Mamata Banerjee's meeting with the Prime Minister over the weekend as "just routine" on the eve of Parliament's winter session. But everything points towards growing restlessness in her party over her failure to secure a Union cabinet portfolio of her choice three months after being sworn in as a minister. For the record, Mamata Banerjee claims that cabinet berths are of little consequence as long as Trinamul continue to be a force to be reckoned with as the main opposition party in West

However, in the context of the latest results in the municipal elections, even this claim is likely to be questioned in several quarters. There are differences between municipal, assembly and parliamentary elections but that does not explain the washout for Trinamul which comes close on the heels of several poll defeats in the recent past. All this can only lead to considerable demoralisation in the ranks which can only be strengthened if she succeeds in getting a portfolio of her choice. Sadly, this has eluded her.

With the prime minister now scheduled to leave on a foreign tour on Thursday, it does not seem likely that Mamata Banerjee's her meeting with Atal Behari Vajpayee will yield a positive result in the immediate future. In any case, the BJP must now be totally absorbed in the prospects of government formation in four states. This cannot be the best time for the BJP leaders to think of accommodating the Trinamul leader who does not appear to enjoy the confidence of all sections of the BJP leader-

A bigger problem is that Mamata's options are becoming fewer. She could not have bargained for such a long wait. At one point there must have been the need to keep the NDA flock together under all circumstances. Now if the BJP does better than expected in the assembly elections, it may have other calculations in mind rather than promoting a coalition partner whose stocks are rapidly sinking in West Bengal and where the BJP can only have few political ambitions. To that extent Mamata may regret that she didn't accept what she was offered by the prime minister because there can be hardly anything more embarrassing than going into next year's parliamentary poll campaign as what may be perceived as being an unwanted member of

Mamata makes it worse with a style that has become unpredictable. It does no credit to her or to Trinamul to produce speculation of "drastic action" after a meeting of the parliamentary party in Delhi. Or to cancel a trip to North Bengal to address party workers so that George Fernandes can drop in for a "social visit" laced with tender inquiries about her fate in Delhi. Mamata can only blame herself for all the wrong moves since the last assembly election which have cost her and the party dearly. She can only strive to renew the confidence she had enjoyed in the NDA and with the people. Given the Left Front's record of misrule, opportunity still beckons. The questions remains as to whether she can use the cabinet portfolio - if and when it comes - to bring out a muchneeded revival.

PMO freezes Mamata foray

New Delhi, Nov. 28: Mamata Banerjee's foray into national politics in the heart of power has come unstuck, courtesy the BJP and the Prime Minister's Office.

The Trinamul Congress chief failed to show up today for two public meetings scheduled in Delhi. The party has fielded Devdas Sonkar from Karol Bagh and Bhai Mahinder Kumar Bala from Pahargani here.

The pullout and the resultant washout occurred after the PMO rang her up, asking her not to address the rallies. The BJP had earlier failed to get Mamata to withdraw her candidates.

Sonkar, a meat and fish trader originally from Bihar, was hoping "crowdpuller *Didi*"

would do the trick for him. Last night, he had said: "I have made all the arrangements. If Mamata Banerjee does not come, I will get he boot."

Today, however, he appeared econciled. "Because of some fie in Calcutta, she is not coming. But it is my job to fight whether he comes or not," he said. "I know Bengali, too," Sonkar added. Party MLA Tapas Pal, who is


Party MLA Tapas Pal, who is an actor, was also scheduled to address the meeting, but backed out on the excuse that the flight he was to take got cancelled. No party MP turned up either.

Without Mamata, who was to arrive here last night, the public meetings were converted into padayatras, led by party general secretary Mukul Roy and youth It appears Mamata, who received the fateful call from an aide of the Prime Minister, was never serious about the Delhi polls. She was apparently trying to get even with the Marxists as the CPM had decided to field three candidates from the national capital.

Trinamul, however, did not put up any candidate from Bengali-dominated areas in Delhi such as Chittaranjan Park,

Kalkaji, Geeta Colony and Gandhi Nagar.

Asked why Mamata did not come, the party's poll in-charge, Chandranath Mukherjee, said she had to visit a colony ravaged by fire. Trinamul MPs, he added, were busy campaigning for the civic elections in Bengal.



lling out its candidates at the eleventh hour. The last date for withdrawal of candidates is over and any move now would flout the model code of conduct, he said. "We will contest. The CPM also has fielded two or three candidates. We are in the NDA at the Centre," Roy said.

Senior BJP leader and Union minister Tapan Sikdar and Bengal BJP chief Tathagata Roy were both irked by Trinamul's attempt to poach their territory in Delhi and wanted Mamata to withdraw her candidates.

Roy, however, wondered what the fuss was about because other NDA allies such as the Samata Party, the Janata Dal (United) and the Shiv Sena were also in the fray.

MURASOLI MARAN, 1934-2003 110-10

FOR SOMEONE REGARDED as the quintessential backroom strategist, Murasoli Maran found himself pitch-forked on to centrestage on quite a few occasions. Television clips of an incensed Mr. Maran challenging the Tamil Nadu police during the notorious midnight arrest of his uncle, the former Tamil Nadu Chief Minister, M. Karunanidhi, remain fresh in public memory. When the former Commerce and Industry Minister returned from Doha, where he represented India in the Fourth Ministerial Meeting of the World Trade Organisation (WTO) in 2001, it was to a hero's welcome. His clear-sighted and nononsense bargaining strategy in favour of India and other developing nations was a wake-up call for the developed countries. It seemed to herald a new balance of power within the 140odd-member organisation. Much earlier, Mr. Maran was detained for a year as a prisoner of conscience during the Emergency under the Maintenance of Internal Security Act (MISA). He handled this experience coolly and with aplomb, drawing attention through his writings to the unjust and draconian nature of preventive detention, detention without trial. However, for the greater part of his political life, which saw him serving the last 36 years as a Member of Parliament, Mr. Maran was notable for his reticence and shyness. His relatively low public profile was at odds with the tremendous clout he enjoyed within his party, the Dravida Munnetra Kazhagam, and the influence he wielded from time to time on the course of national politics.

In line with some other leaders who belonged to the Dravidian movement, Mr. Maran was also a journalist and scriptwriter for films. But he had the vision to venture into the satellite television field and was the spirit behind the Sun Network, his family's major stable of news and entertainment channels in Tamil and other South Indian languages. He shot into political

prominence when he won a byelection to the Lok Sabha from South Madras in 1967. He was victorious in four more Lok Sabha elections, was a member of the Rajya Sabha for three terms, and was a Cabinet Minister during the V.P. Singh Government (1989-90), the Deve Gowda and I.K. Gujral Governments (1996-98) and the NDA dispensation from 1999. Mr. Maran was exceptionally close to the DMK chief, Mr. Karunanidhi, but unlike his uncle he did not enjoy working up crowds or mass campaigning or building up a grassroots base. He made up for this through his political acumen, his studious and reasoned style, and his intelligence - attributes that helped him become the DMK's foremost ideologue and (as he has sometimes been described) a one-man think-tank. He was also the party's face in national politics, a task he undertook by projecting and guarding its interests at the Central level and, in the era of coalition politics, by shaping the direction it would take.

At a national level, he will be remembered most of all as an efficient and resourceful administrator and a strong and unapologetic votary of economic liberalisation. His final tenure as Commerce and Industry Minister was marked by a number of initiatives to give a new thrust to exports. His international reputation was built around the positions India staked out at Doha, where he led the developing countries to their first real success at the WTO. The positions Mr. Maran adopted at Doha were vindicated recently at the Cancun meeting of the WTO, where more than 70 developing countries successfully resisted European Union pressures to bring certain sensitive areas relating to investment and competition under the umbrella of the WTO. His passing, after a long and multi-stage illness that he fought robustly before it finally overcame him, leaves a void not only in the DMK but also the sphere of national politics and in governance.

Murasoli Maran dead

CHENNAI, NOV. 23. The Union Minister and senior DMK leader, Murasoli Maran, died here this evening of multiple organ system failure.

He was being treated at the Apollo hospitals here on his return from Houston, U.S., where he was flown for advanced treatment of a fungal infection he contracted after a valve replacement surgery. The end came a little after 7 p.m. He was 69.

Mr. Maran was flown back to Chennai on September 7 from the U.S. by a special air ambulance and had been receiving treatment at the Apollo hospitals.

The body was first taken to his house and later to the residence of his uncle and DMK president, M. Karunanidhi, at Gopalapuram later in the night and kept for public homage. The funeral with full state honours will take place on Monday evening.

The Prime Minister, Atal Bi-

The Prime Minister, Atal Bihari Vajpayee, who was on an election campaign, called up Mr. Maran's sons and conveyed his condolences.

Apart from his long political innings, Mr. Maran donned different roles as journalist, filmmaker and the man behind the first regional cable TV channel, Sun TV.

Born in Tirukkuvalai (Thanjavur district) in 1932 to Shanmuga Sundaram and Shanmugasundari (Mr. Karuna-



nidhi's sister), he rose from humble beginnings to become one of the pillars of the DMK, its veteran parliamentarian, besides a Union Minister. An articulate person who never hesitated to speak his mind, Mr. Maran was inducted into the National Front Government of V.P. Singh in 1989 as Minister for Urban Development.

He represented the DMK again at the Centre in the United Front regime from 1996 to 1998 and joined the NDA Government in 1999 as the Minister for Industries and Commerce.

When Annadurai vacated his Lok Sabha seat (South Madras, in 1967) to become Chief Minister of Tamil Nadu, he selected Mr. Maran to contest the seat. His nomination was proposed by the three political giants of that time — Rajaji, Anna and Quaid-e-Milleth.

The imposition of internal Emergency was a testing time of political loyalties. Mr. Maran

stood solidly behind Mr. Karunanidhi, and was jailed for a year under the provisions of the draconian Maintenance of Internal Security Act (MISA).

Both as a parliamentarian and then as a Minister, Mr. Maran travelled widely abroad and never hesitated to look at the right models for India to adopt. Despite his 'pro-reforms' tag, Mr. Maran did not hesitate to take on the developed countries at Doha to defend the rights of the developing countries under the WTO. Ultimately, some of India's views were accommodated in the consensus.

dated in the consensus.

In November 2000, Mr. Maran was hospitalised in Chennai following complaints of chest pain. Cardiac specialists then used the alcohol ablation technique to bring him back from the brink.

On July 22, 2002, he was again admitted, this time to the All-India Institute of Medical Sciences, where he underwent a valve replacement surgery.

A fungal growth in the replaced valve led to the third serious hospitalisation again at the Apollo hospitals here on September 23 the same year.

After a partial recovery, he was taken to the Methodist Hospital in Houston in November 2002 for special treatment.

He is survived by his wife, Mallika, two sons — Kalanidhi and Dayanidhi — and a daughter, Anbukkarasi.

CHANDRABABU READY TO FIGHT EXTREMISM. OBSTRUCTIONIST OPPR

NDHRA Pradesh will go to the hustings much ahead of schedle, with the ruling Telugu Desam Party (TDP) deciding to seek a stronger mandate to counter what it calls the "twin threats" of extremism and obstructionist Opposition parties. TDP chief N. Chandrababu Naidu and other top

leaders finally articulated the decision, first at a party politburo meeting and later in a political resolution moved at an emergency meeting of the party general body on Thursday afterafter month-long noon. speculation on early polls.

The state Cabinet, which is expected to meet on Friday, will discuss the issue and decide to meet the governor on the same day or on Saturday, seeking the disso-

lution of the Assembly. The political resolution moved by Andhra Pradesh home minister T. Devender Goud was unanimously passed by the 5,000 odd party delegates. It did not specify the timing, but it appears to be preparing to face the

electorate in February next year.

Besides the political resolution, the general council of the party passed two other resolutions. One condemning the attack on the party president, Mr Naidu, in Tirupathi on October 1 and the other condoling the deaths of 104 TDP leaders and activists at the hands of Naxalites, rivals belonging to the Congress, and due

to natural causes.

Replying to a three-hour long debate on the political resolution, Mr Naidu said he had no other choice but to go the people's verdict, as both the Naxals and the Opposition parties, particularly the Congress and TRS, were blocking the government's gameplan.

In fact, he went to the extent of accusing the Congress of being more dangerous than the extremists. He enunciated

> what his government had done over the last eight years for the development of the state and the welfare of poor, the down-trodden, women and farmers.

> After the general council's meeting, the strategy is now clear. First, it wants to highlight the Naxals' violence and how it is disturbing the law and order situation in the state. It also wants to highlight their abortive attempt on the life

of the "development-oriented" chief minister like Mr Naidu, of course to gain sympathy. Second, it wishes to project the main Opposition party, the Congress, and the fledgling Telengana Rashtra Samithi (TRS) as being hand-in-glove with the Naxalite movement, citing their demand for the government to hold talks with the extremists. And third, it wants to seek a fresh and decisive mandate from the people so that a fitting reply is given to both the Naxals and the Opposition parties, thereby facilitating the TDP to continue with its developmental and welfare programmes.

HE announcement of the TDP's intention on Thursday to advance the poll schedule in Andhra Pradesh, has put the Congress in a quandary over the touchy issue of state-hood for Telengana. This is despite the decision being a widely expected one.

The sounding of the poll bugle in the state has forced the Congress to shed its ambivalence on the issue -– which the party had been avoiding so far for fear of antagonising the rest of the state. The party had been walking the tightrope on the subject, fanning hope to Congressmen from the region by saying that the issue would be taken up in due course. However, it was reassuring partymen from the rest of the state by avoiding any definite position on the issue.

Senior leaders, who have been camp ing in the capital, have been unable to get an audience with Sonia Gandhi so far. But Thursday's development in Hyderabad makes it clear that the party cannot afford to continue to be ambiguous on the issue and will have to take a position on the issue soon.

The problem before the party is how to fashion a stand that will address the sentiments of the people of Telengana and, at the same time, will not turn the rest of the state hostile towards the Congress.

Naidu rings / poll bell for party in

Hyderabad, Nov. 9: The Andhra Pradesh chief minister today announced his intention to go for early polls, coming clean for the first time since he hinted at riding the "sympathy wave" generated by last month's Naxalite attack on him.

N. Chandrababu Naidu, however, did not disclose the schedule while addressing workers of his Telugu Desam Party via satellite on the TV programme, Dial Your President.

He told them to be prepared for early polls to face fresh challenges posed both by extremists and the Congress-led Opposition. "It is time for you to act and galvanise support from all sections of society," he said.

Naidu also told party work-

ers to complete scrutiny of the electoral rolls. A decision and "other actions" will follow soon, he said, citing a discussion on polls at the last cabinet meeting.

The Congress, however, appeared irked by the Desam's "delay tactics" and called off its bus yatra in the state's coastal districts.

The party's Mahboobnagar legislator, G. Chinna Reddy, said the Desam was delaying a decision for fear of extremist threat. Most ruling party legislators, he said, were touring their constituencies under police escort in Karimnagar and Nizamabad districts. "The police also advise them on the routes they should take to avoid unnecessary risk," he said.

The change in plans followed yesterday's announcement by the Congress' Telengana legislators, who have formed the Telengana Congress Forum, that they would quit the party and tie up with the Telengana Rashtra Samiti. "The Congress leaders are delaying a decision on Telengana due to compulsions of certain groups in the PCC opposing

our demand for a separate PCC and a state," Reddy said.

The forum members warned the party leadership that "though we are Congressmen, we will oppose and also place obstacles in the way of the *yatra*" if it entered the Telengana districts.

Another reason cited for the cancellation was "the rift in the Congress groups in Krishna and Guntur districts... as the high command wanted to avert a public display of groupism in the party ahead of (likely) early polls", a senior leader from Krishna district said.

Naidu's statement to party workers caught many senior leaders napping. Yesterday's emergency cabinet meeting had fanned rumours that he was apprehensive of holding polls after the sympathy wave had given way to

a surge in anti-incumbency feelings.

Today, however, Naidu harped on the state's growth rate and improved socioeconomic conditions with the execution of a Rs 35,000-crore World Bank programme for power, economic reconstruction and infrastructure development.

Political stability for the last eight years was the key to success, he told the workers. "People look at the TDP for continuation of political stability and peace to promote industry and education in the state." He urged them to revive contacts with all self-help groups for women and promote awareness of the state's programmes for them.

The chief minister also urged the people to interact with extremists and bring them back to the mainstream. "Let the extremists face us politically rather than attack and kill political activists at random."

Extremist groups, he said, had killed 330 political leaders, including 140 of the Desam's elected representatives, in the last 10 years.

Mamata reverses mayor's decisions

KOLKATA, Nov. 9. — Miss Mamata Banerjee today gave a veiled warning to Mr Subrata Mukherjee that he should either implement Trinamul's policy decisions pertaining to Kolkata Municipal Corporation or quit as mayor. At today's stormy meeting of the party's Kolkata MPs, MLAs and KMC councillors, major decisions taken by the mayor were reversed by Miss Banerjee.

The first relates to the party's demand that the mayor will have to maintain status quo in regard to the slapping of water tax and that he will not be allowed to impose additional water tax. The mayor has also been asked to keep domestic consumers using 10 mm and 15 mm ferrules beyond the purview of water tax.





■ The second is on whether owners of market stalls will have the right to bequeath property to their heirs. Though the mayor had decided against this, today's meeting rejected the idea and asked the mayor to retain the heir's right of inheritance of a stall owner's property.

■ The party decided to form a review committee to look into the huge escalation in trade licence fees and underscore the need for the committee being



represented by party members and trade associations.

Whether Mr Debasish Som, KMC commissioner, should be allowed to continue. The party felt that there was an immediate need for his removal. Having sensed the vehement opposition from the Trinamul chief and party MPs and MLAs, Mr Mukherjee said he would need 48 hours to decide on whether to con-

tinue as mayor.

That the Trinamul chief is bent on making the

MAMATA AND RSS

THE immediate response to Mamata Banerjee's decision to shower encomiums on the RSS is understandably one of disbelief, given that she maintains that the Trinamul subscribes to the secular objectives of the NDA. That is also why her party claims a sizable minority vote-bank despite the tenuous links with the Sangh Parivar. Her own secular credentials are not in question. But Monday's function in Delhi was the first time in five years that she has interacted with RSS leaders or shared a platform with them and described them as "true patriots". There must have been two things on Mamata's mind at the release of a book that listed the "crimes" of communists in India and Nepal. One, it would reinforce her battle against the CPI-M in West Bengal. In other words, she is more interested in getting support from whatever source to fight the Marxists who she says, are terrorising the people. Two, her presence at the function may induce a favourable rethink on her cabinet portfolio. However, her party colleagues are thoroughly alarmed fearing long-term consequences. The limited objective of her encounter with the RSS at this stage may not impress. Does ideology matter to any party contesting elections? It is winning that counts.

Anil Biswas' reaction is typically crude and heavily distorted. He makes it a point to comment on everything Mamata says and does, pointing to an unhealthy obsession and confirming that the Marxists consider her as the biggest threat. What the CPI-M state secretary also does is to draw the most outrageous conclusions from the Trinamul leader's actions to demean her before the public. "The day is not far off when Mamata Banerjee will call Mir Jafar a patriot or Gandhi an anti-national", says Biswas who knows how to play on middle class sentiments. Mamata's friends and allies will wonder whether she has played into Alimuddin Street's hands. But even her critics outside the Left Front will not be impressed by the moral position that Biswas takes. Mocking Mamata has become a regular pastime. Even while it lacks taste, Biswas is perhaps obliged to perform a ritual believing that some political mileage is to be had. What help Mamata will secure from the RSS to fight CPI-M-sponsored violence in West Bengal is far from clear. But, if it does help to land a Cabinet job of her choice, Biswas and Alimuddin Street may have to step up their ritual mockery.

Mamata seeks RSS help to fight 'Communication's fight 'Communist terror'

NEW DELHI, Sept. 15. — The Trinamul Congress chief, Miss Mamata Banerjee, and the Union defence minister, Mr George Fernandes, today joined hands with the RSS in condemning alleged "Communist terrorism" in the country.

Speaking at an RSS function here today, Miss Banerjee described Sangh leaders as "true country-lovers". "Now that I've got the chance to meet so many RSS leaders, I can say that they are really seized of the problems gripping various regions".

The function, attended by senior RSS leaders, including Mr

Mohan Bhagwat and Mr Madandas Devi, was organised to release a compilation of articles in a book form entitled Communist Atankwad (Terrorism) edited by Mr Tarun Vijay, editor of the RSS mouthpiece Panchjanya. These articles dealing with "reign of terror and violence" allegedly unleashed by the Communists, Naxalites and ultra-Left forces resulting in "bar-baric killings" of thousands of people, focus on the situation in three "Communist-affected states" — West Bengal, Kerala and Jharkhand - besides Nepal. The book seeks to project "Communist terror along with Islamic and Christian militancy" targeted only against the

Hindu community.
Miss Banerjee "welcomed" Panchjanya's efforts from "her heart". She repeatedly sought RSS assistance to rid Bengal of Communist "misrule and atrocities". She described the CPM as a "fascist party of murderers, criminals, rapists, and anti-na-

She asked the RSS to organise more such programmes, offering her help to make available documents and video cassettes. The Sangh accepted her offer, saying it supports her struggle against "Left campaign of terror and hatred". She was termed as "Bengal tigress" and a "Durga taking on the Marxists" by some speakers.

alliance at the Centre are only superficially the story of a maverick politician; they actually expose the underside of coalition governments. Coalition politics often compels governments to take decisions which have little to do with issues of governance. Nothing else quite explains the manner in which Ms Mamata Banerjee was reinducted in the Union cabinet. Her appointment as a minister without a portfolio does no good to the credibility of either the National Democratic Alliance government or the Trinamool Congress leader herself. Her return to the cabinet had been anticipated many times since she returned to the NDA after a dramatic separtion from it and a brief honeymoon with the Congress. But the fact that the prime minister, Mr Atal Bihari Vajpayee, could not find a suitable ministry for her even now suggests that her return to the NDA is still bedevilled by bad faith on both sides. It is no secret that many in the Central leadership of the Bharatiya Janata Party, including the deputy prime minister, Mr L K Advani, do not trust her as an ally and would have been happy to see her outside the cabinet. In reinducting her in the cabinet in this unconvincing fashion, Mr Vajpayee probably sought to repair the damage done to the NDA's unity by the desertion of former allies like the Bahujan Samaj Party, the National Conference, the Rashtriya Loktantrik Dal and the Lok Janshakti.

Ms Banerjee cannot be complaining too much though. Thanks to her flip-flop politics, the fighter of yesteryears has been reduced to a supplicant who can neither get a ministry of her own choice nor afford to decline an offer she does not like. Having lost her battles against West Bengal's ruling Marxists, she desperately needed a cabinet berth to boost her own — and her party's — declining morale. No matter what she pretends to the contrary, she cannot be excited about the way she has been taken back into the cabinet. It is also unlikely that her latest ministerial cap would add to her abilities to fight the Left Front in next year's Lok Sabha polls. On the contrary, the Marxists would surely want her to explain why she returned to the government which still has the defence minister, Mr George Fernandes, whose resignation she had demanded, following the Tehelka exposures of alleged corruption in defence deals. She would also be reminded of her own promise not to return to the Union government unless the Centre revoked the bifurcation of the Eastern Railway. Ms Banerjee will have her answers to these questions, but they may sound hollower than before.

Mamata sinks party troika

DELHI/KOLKATA, NEW NEW DELHI/KULKAIA, Sept. 8. — Miss Mamata Banerjee and Mr Gingee N Ramachandran today staged a comeback to the NDA government. While the Trinamul chief took oath as a Cabinet minister and chose to remain a minister without portfolio, the MDMK leader took oath as a minister of state and was allocated the textile ministry under Syed Shahnawaz Hussain. The reshuffle also effected changes in portfolios of Mr BC Khanduri, Mr Bandaru Dattatreya, Mr Sripad Naik, Mr Basangouda R Patil, Mr Pon Radhakrishnan and Mr Santosh Gangawar.

During a meeting with the Prime Minister, Miss Banerjee listed railways, surface transport and civil aviation as her preferences, but was finally offered coal which she refused and said she would prefer to be a minister without portfolio. Sources said she refused coal as the ministry had negative implications for unionised West Bengal witnessing closure of coalfields. The BJP top brass appreciated her concern and deliberations were on to zero in on a portfolio of her liking at the earliest.

Courtesy Miss Banerjee, the ministerial hopes of the troika of Trinamul MPs — Mr Sudip Bandopadhyay, Mr Akbar Ali Khondakar and Mr Ajit Panja — were dashed today.

Apprehending that her party colleagues may develop power centres of their own, Miss Banerjee preferred to keep them out of the government. That, at least, was the opinion of most Trinamul leaders who spoke to The

Though the politics of the day is to ask for more ministerial berths, she preferred to keep her MPs away from power because, said a party source, of the fear that choosing one may irk others, which in turn could eventually split her party. namul may even be offered three berths when Miss Banerjee refused to join the ministry in May this year. That was indication enough of his willingness to have not only Miss Banerjee but some other Trinamul MPs as well in the government. However, she wanted to be the sole representative of the party in the NDA government, a reflection, her critics pointed out, of her desire to re-establish her grip over the Trinamul parliamentary party.

Her decision not to go in for

a second ministerial slot stymied Mr Bandopadhyay's chance of becoming a minister. As for the other two names doing the rounds, Mr Khondakar and Mr Ajit Panja, she was prudent enough to realise that making either a minister could lead to the formalisation of a "dissident" camp within the party, comprising Mr Bandopadhyay, Mr Bikram Sarkar and Mrs Krishna Bose, not to mention Mr Ranjit Panja who opposed Mr Ajit Panja's re-entry into the Trinamul.

So, she didn't allow her MPs to throw their hats into the ring and the BJP, reeling after the BSP fiasco in Uttar Pradesh, was only too happy not to interfere in her party's affairs.

And the Prime Minister, keen on a "smooth, hassle-free Cabinet reshuffle" got precisely that, thanks to the ever-unpredictable leader's latest move.

The Prime Minister described the reshuffle as the last before elections, but declined to specify whether he meant Assembly or Lok Sabha polls. "It is the last. There will be no more expansion before the elections," Mr Vajpayee said. He refused to speak about the timing of the next parliamentary polls.

The Congress slammed the reshuffle, describing it as "immoral, unprincipled and opportunistic". The party asked Mr Vajpayee to explain the circumstances under which Miss Banerjee and Mr Ramachandran had resigned in the first place, apart from the rationale behind their re-induction. Miss Banerjee must "justify" her return to the ministry, AICC spokesman Mr Anand Sharma said.

Mamata's wait for a berth over

NEW DELHI / KOLKATA, Sept. 7. — Trinamul Congress chief Miss Mamata Banerjee's wait for a Cabinet berth will be over as Mr Atal Behari Vajpayee has decided to undertake a minor expansion and reshuffle tomorrow.

(Miss Banerjee tonight met Mr Vajpayee and later said that she had put no conditions for joining the Union Cabinet tomorrow, adds PTI. "I've put no conditions. I will be joining the Cabinet," she told reporters after the 50-minute meeting in response to a question if she had discussed the issue of the portfolio being given to her.)

Earlier, following a call from the Prime Minister, Miss Banerjee left Kolkata for Delhi this evening reportedly for discussions on her reinduction into the Union Cabinet. She is learnt to have been intimated about her ministerial prospects by Mr George Fernandes, NDA convener, last night.

Former minister of state for finance Mr Gingee Ramachandran of the MDMK is also slated to stage a comeback but with a different portfolio. He had to step down following corruption charges against his personal staff in transfer and postings of revenue officers. The CBI's clean chit to him is lying with the Prime Minister, sources said.

The decision came after a meeting of senior BJP leaders, including Deputy Prime Minister Mr LK Advani, Union finance minister Mr Jaswant Singh and party president Mr M Venkaiah Naidu at Mr Vajpayee's residence yesterday. They decided that the reshuffle should be carried out before the

Prime Minister leaves for his foreign tour on 16 September.

Mr Vajpayee had called Miss Banerjee for a discussion on the portfolios and number of ministerial berths which would possibly be allotted to her party. A minister of state of her choice from the Trinamul Congress may be accommodated if she gives the name, sources said.

Miss Banerjee had refused to join the ministry when offered by Mr Vajpayee four months back. The reason for her refusal was that she had been kept in the dark with regard to BJP's decision to have Mr Sudip Bandopadhyay inducted into the Union ministry as a minister of state. Peeved at the BJP move, she had then asked the PMO, Mr Fernandes and Mr Venkajah Naidu to drop Mr Bandopad-hyay from the ministry. At this, the BJP decided not to induct both Miss Baneriee and Mr Bandopadhyay, sending the message that she should resolve her differences with Mr Bandopadhyay and come to Delhi for fresh talks on ministerial berth.

Miss Banerjee's second stint in the government may begin in the coal ministry since a new ministry of animal husbandry is likely to be created for the low profile coal minister, Mr Karia Munda, sources said. She would return to the Cabinet after 30 months of hibernation.

Miss Banerjee quit the government as railways minister on 16 March, 2001 following the *Tehelka* revelations. She pulled out of the NDA government demanding resignation of Mr George Fernandes, who along with the BJP president, Mr M Venkaiah Naidu, have been instrumental in her return.

Trinamul for economic emergency anue from civic bodies. Green light

to persuade the NDA government to impose Article 356 on West Bengal, the Trinamul Congress today demanded that financial emergency be declared in the state.

The party leadership raised this demand at a two-day party session which began today. They said that the Centre must declare a financial emergency at the earliest, in order to protect the interests of the people.

We have urged the Centre to declare the economic emergency and save the fate of millions." Panja's return suggests give and take


I'may have come as a surprise that Mamata Banerjee used the party's rally on 21 July to announce the lifting of the suspension order on Ajit Panja after a gap of two years. She made the concession in return for an assurance of good behaviour. On Panja's part, it was the only option after failing to impress the BJP leadership to make him an offer of ministership. The last straw was the drubbing received by his daughter, Mahua Mondal, as the Congress candidate in the Vidyasagar assembly by-election. Remaining in the Trinamul fold gives him the only chance to retain his Kolkata North-East parliamentary seat; any other ticket would have left him sev-

mentary seat; any other ticket would have left him severely handicapped. Realism has triumphed.

Mamata has shown again that she is the boss and can take decisions on her own. The Marxists were openly using Panja as a tool against Trinamul, the jury is out on the question whether he was aware of it. The potential for mischief in the run up to the parliamentary elections was obvious. The point is that it is not enough for Mamata to sort out isolated problems in the party. Mamata ends two-year suspension of Panja

HAKEN by a series of electoral reverses and intraparty upheavals, Trinamool Congress chief Mamata Banerjee has decided to embark on a peace mission. The West Bengal leader on Monday began the process of mending fences with her estranged colleagues by deciding to withdraw the suspension of former union minister Ajit Panja.

The decision to re-induct Mr Panja in the party, most political observers feel, has been necessitated by the realisation that internecine fights among the leaders of the Trinamool Congress, alongwith the frequent political somersaults undertaken by the party chief, had only served to weaken the party. As its image as a political party — serious in its mission of dethroning the Communists from Kolkata — took a beating, the Trinamool Congress found itself in the danger of losing its space to the Congress.

Ms Banerjee's woes began with her decision to sever her ties with the NDA at the Centre and the BJP in the state, in wake of the Tehelka revelations in March, 2001. With assembly elections in the state round the corner, the

Trinamool Congress chief found it convenient to ditch the saffron party in favour of the Congress to take on the might of the combined left. But the voters were clearly not impressed with her decision. In the elections that followed soon after, they made their displeasure known by returning CPI(M) party supremo Mr Buddhadeb Bhattacharya with a thumping majority.

Her abrupt volte-face on the eve of the assembly elections left not just the BJP in the lurch, it had many of her colleagues questioning her decision. Mr Panja emerged as her most vocal critic. His jibes against the whimsical ways of Ms Banerjee culminated in his suspension from the party.

But this could not quell the murmurs of dissent within the party. Her decision to stay away from the Union Cabinet in protest against the Centre's decision to bifurcate the Kolkataheadquartered Eastern railway, and the imminent induction of Sudip Bandopadhyaya in the Union council of ministers without her consent, left her seething with anger. But these steps also served to increase the differences between her and the rest of her colleagues. A manifestation of this was the growing uneasiness

among her party MLAs in West Bengal against her decision to stay away from the proceedings of the state assembly.

As she continued to grapple with intra-party rumblings, the people gave vent to their disillusionment with her style of functioning by giving thumbs-down to the party in all these elections.

With the elections to the Lok Sabha just a year away, Ms Banerjee is faced with a stark choice. Unless she gets her act together most political observers feel that she'll find it extremely difficult to retain even a fraction of the nine seats her party had won in 1999. Her decision to patch-up with Mr Panja and other estranged colleagues is being seen as part of the attempt to regain the space that she has yielded to the Congress in the last couple of years so as to emerge as the principal tormentor of the Communists once again.

Announcing the revocation of Mr Panja's suspension at a Trinamool Congress rally in Kolkata on Monday, Ms Banerjee said that he had issued a statement expressing his willingness to return to the party fold and "acceptum to the party fold and "accepting my leadership." Among those present at the rally were Mr Bandopadhyaya and other leaders.

DMK AT CROSSROADS

Family Above Party, The Preferred Option

f all political parties in the country, the Dravida Munnetra Kazhagam can take legitimate pride in holding organisational elections regularly. How democratic, free and fair these elections are another matter. Key office bearers are elected by 'consensus', a method developed by Congress under Indira Gandhi and copied elsewhere. Woe betide any aspirants in the party who insist on a free ballot.

All in the family

The just concluded twelfth organisational elections of the 54-yearold DMK is no different, particularly those held after Muthuvel Karunanidhi captured the party leadership and the chief ministership of Tamil Nadu in 1969 following the death of Annadurai, who founded the party in 1949. Since then, the presidentship has remained firmly with Karunanidhi, somewhat like a democratically elected constitutional monarchy. Karunanidhi decides who should be general secretary, treasurer and district secretaries of the party. VR Nedunchezhiyan, groomed by Annadurai to succeed him, was given the number two slot of general secretary till he deserted the party in 1977 to join the breakaway AIADMK led by MG Ramachandran.

One of the founder-leaders of the DMK, K Anbazhagan, became general secretary in 1977, a post he still holds. Though both president and general secretary have crossed their 80th birth days, dramatic advancements in healthcare have kept them on their feet.

In keeping with geriatrics holding the two top posts, Arcot Veerasamy, not lagging far behind in age, was re-elected treasurer. The only change at the top was the induction of the youth wing leader of the DMK, MK Stalin, himself a grandfather and son of Karunanidhi, as the senior deputy general secretary, a post lying vacant since the death of Nanjil Manoharan more than two years ago. Ever since Karunanidhi became DMK president in 1969, he has been assiduously grooming Stalin as his political heir. Though his additional post of deputy general secretary ranks only fourth in the DMK hierarchy, Anbazhagan and Veerasamy have already conceded the number two spot to Stalin.

If Karunanidhi takes pride in claiming that he has experience, both in power and out of power, for the last 44 years, it only means that he had one year of experience repeated 43 times. He has grown old and has to depend on a walking stick to move about, and has not been able to shed antediluvian

Yet Karunanidhi wants to give Azhagiri an important post in the DMK once he comes out of jail.

minal, has preferred to stay out of politics and instead inherit her father's literary mantle. She has already carved out a name for herself in the Tamil literary firma-

Karunanidhi's single-minded objective of making Stalin his political heir has driven many a talented party worker out in search of pastures new. While some joined the splinter AIADMK, Vaiko, who had all the makings of succeeding Karunanidhi, was driven out of the party 10 years ago, after accusing him of plotting to assassinate Karunanidhi.

Vaiko launched the Marumalarchi Dravida Munnetra Kazhagam in 1993. A sizable chunk of the younger generation of party workers joined him. Though the exit of Vaiko and exodus of youthful workers considerably weak-ened the DMK, the MDMK failed to make any waves in Tamil Nadu politics. However, it could take partial credit for driving the DMK out of office in the 2001 Assembly election. Vaiko's exit drove home the point to aspiring DMK men that the top post was out of bounds for anyone outside the Karunanidhi family.

Rising sons, setting sun

The excessive in-breeding has left the DMK bereft of fresh thinking and new strategies to cope with the aggressive entrenchment of the AIADMK under the dynamic Jayalalitha. She has no immediate family to pass on her political mantle. Therefore she can draw on the best talent available to fill key positions.

Lucknow\New Delhi: Rashtriya Lok Dal president Ajit Singh on Friday withdrew support to the Mayawati government in Uttar Pradesh.

Accompanied by national general secretary of the Samajwadi Party Amar Singh, Congress UP leader Nawal Kishore Sharma, CLP leader Pramod Tewari and party MLA Kokab Hamid, Mr Singh met governor Vishnukant Sharma at 4.30 p.m. and informed him of the RLD's decision.

He told the governor that since the BSP-BJP coalition government had been reduced to a minority, it should be dismissed, and said the opposition was in a position to form the government. The governor assured the opposition leaders that he would act according to constitutional provisions.

Later, talking about the formation of an alternative government, the RLD leader said the Samajwadi Party, the Congress and Kalyan Singh's Rashtriya Kranti Party were on a common platform on the issue but evaded a direct response on who would head the coalition if and when a new government was formed.

It was left to N.K. Sharma to state that the issue would be decided once the governor called on them to form the government.

Rattled by the unprecedented opposition unity, the

ruling BJP-BSP coalition is chalking out a contingency plan to thwart any attempt at poaching on its MLAs.

An indication to this effect was given by BJP legislature party leader Lalji Tandon on Friday after speaking to chief minister Mayawati, who is currently on a five-nation tour. "We have at least seven berths left in the cabinet from our quota after the RLD pulled out of the government. Naturally, we would like to fill our quota once the CM returns from her foreign tour," he said.

Mayawati herself is unlikely to cut short her foreign trip. A senior official accompanying her told TNN that 'madam' had been briefed about the political developments, but she had given no indications of rushing back home. Mayawati is obviously banking on numbers, which seem to rule out a successful toppling game.

Had Mr Ajit Singh withdrawn the support of his 14strong RLD party before the Congress suffered a split a few months ago, the Mayawati government could have been in serious trouble.

But the Congress lost nine MLAs from its 25-member group to the CM in the split. At the final count, the Samajwadi Party-led front—along with the backing of the remaining 16 Congress MLAs—has a tally of 188 in the 402-member assembly. In this grouping, the SP is the single largest party with 142 MLAs

But Mamata's anarchic genius should not be shackled by ministerial responsibility

Onced in an almighty tantrum, and all is well with the world. Thank heavens. For a while there she had us worried. Calcutta, May 25: Many of Trinamul Congress leader Mamata Banerjee's decisions in the past have dismayed her party colleagues — quitting the Vajpayee ministry after the Tehelka revelations, teaming up with the Con-gress for the 2001 Assembly election only to break again.

Not this time. Trinamul supporters rallied behind Mamata as she and leaders close to her weighed the options for dealing with rebel MP Sudip Bandopadhyay.

The combative mood was summed up by Shakti Mondal, a district leader who was in the st-eady stream of supporters from outside Calcutta to Mamata's home or the party's new office.

We may be small compared to them (the BJP), but we do not lack self-respect or dignity," Mondal said.

Whoever wrote the script that disintegrated into a farce last evening when Trinamul did not join the ministry — and authorship is being attributed to deputy Prime Minister L.K. Advani — grossly misread the consequences.

Crisis in Trinamool

KOLKATA, MAY 24. The Trinamool Congress, headed by Mamata Banerjee, faced a grave crisis today as Ms. Banerjee, billed as a certain entrant into the Vajpayee Government till Friday, opted out to quell a rebellion in her backyard.

Ms. Banerjee had cancelled her trip to Delhi after she learnt that

the BJP leadership had mounted efforts — allegedly at the behest of the Union Home Minister, L.K. Advani — to make the Trinamool chief whip, Sudip Bandyopadhyay, a Minister in the Central Minis-

"The proposed induction would go against the basic 'dharma' of coalition politics," she said.

The meeting recommended to the party's disciplinary committee to deal with the "anti-party activities" of Mr. Bandyopadhyay. He had been lobbying for a berth for himself knowing Ms. Banerjee's reservations about him.

MAMATA SAYS NO AGAIN Bid to pacify Didi insulted at PMO invitation to Sudip

AFTER DECIDING to board the 9.30 am Jet Airways flight to Delhi on Saturday for the swearingin, Mamata Banerjee late on Friday night decided against accepting a Cabinet berth since the PMO has sent Sudip Bandopadhyay's name to the President to be inducted as minister of state for railways without consulting her.

Taking this as an attempt by the BJP to split the Trinamool parliamentary party, she said: "How can they send the name of a party MP without consulting me? Under the circumstance, it's not possible for me to accept a berth." All nine MPs, barring

Earlier in the day, all seemed to be going well for Mamata. She had received a call from the PMO at 9.30 am asking her to come to Delhi on Saturday. Sources said the Prime Minister might offer her civil aviation, but Mamata had expressed interest in rural development on the ground that it help her take on the CPI(M).

mentary party on Friday morning, she had decided against allowing any Trinamool MP into the Cabinet as minister of state (MoS) primarily because she

KOLKATA, May 15. — Miss Mamata Banerjee submitted her resignation as Trinamul Congress chief this evening. However, it was rejected by majority of the members at an emergency working committee meeting of the party late tonight.

Miss Banerjee was not present at the meeting which called for her continuance as Trinamul chief.

Earlier, party MLAs turned against their *Didi* in the wake of the worst-ever performance of the party in any rural poll and her tactics in its aftermath by questioning her decision to ask MLAs to boycott the Assembly. An incandescent Miss Mamata Banerjee hit back with a threat to "resign and form a new party". "There's no reason why I should continue as the Trinamul chief if I am to be questioned like this. I will resign. I will float a new Trinamul... for that, I don't need anybody."

MLAs toned down their criticism following this outburst and fell in line with her decision to boycott the Assembly, but not before Mr Nirbed Roy, Trinamul Youth president, who was one of those who had raised the issue, told her that he would resign as an MLA once the boycott is called off.

The boycott issue boiled over towards the end of the meeting. Everything was in order to begin with as the MLAs and four MPs she had asked to be present listened patiently to her post-mortem of the polls. The criticism began when she broached the idea of boycotting the Assembly as the Communists had done in 1972.

Mr Arunava Ghosh, MLA, asked her how long the boycott would continue and urged her to spell out the reasons the party could offer to the public for ending the boycott. She was about to respond when Mr Nirbed Roy questioned Didi's decision outright. "What of our party MPs and KMC councillors? And what about our panchayat representatives? If it's in solidarity with them... it sounds weird that they will function while MLAs won't land up."

Public opinion is Mamata's best bet

Mamata Banerjee is not the best of strategists. Current moves to reinduct her into the Union cabinet would have been unnecessary had she not insisted on the railway portfolio during the last reshuffle. Nitish Kumar has been allowed to go ahead with the railway bifurcation. She will now take what she gets as Trinamul is going through a lean patch after the assembly election and may fall apart if Mamata doesn't join forces with the NDA. She is faced with an equally tricky situation in the light of the widespread violence during panchayat elections that claimed more than 32 lives. The CPI-M has worked overtime to ensure that opposition is extinguished in the running of panchayats which are dens of politicised corruption and control substantial amounts of Central funds unaccounted for during the last 25 years. The Left Front has also made shameless use of the administrative machinery and appointed a chief electoral officer who speaks Alimuddin Street's language. The question is, what can Mamata do? There is every need to make the point that this panchayat poll was something of a joke in the sense that 20,000 seats went uncontested and large numbers of villagers watched helplessly as cadres ran amuck. But there is also the need to make the CPI-M answerable for the virtual collapse of police and administrative machinery.

The options before Mamata range from boycott of the assembly and resignation of Trinamul MLAs, to a call for another Bangla Bandh. Clearly, none of these measures will do her any good and may instead allow the CPI-M to get away easily after mounting a blood-stained hoax on the electorate. Nor does it help to appeal to the RSP and other disgruntled Left parties who have been insulted and abused by Big Brother to join a new anti-CPI-M front. Whatever the junior partners may do, they will not commit suicide and Alimuddin Street knows that. The panchayat elections have confirmed that the CPI-M has never been short on strategy to remain on power by hook or by crook, even as it needs to encourage a "friendly" Congress to get the better of Trinamul. Mamata can at best consider a counter-strategy to expose the Marxists who talk of peace in the city while cadres mount a bloodbath in the countryside. Public opinion against the cynical abuse of democratic principles is her

best bet. She can make the best use of it.

NC backs Hurriyat demand for talks

IAMMU, May 12. — The National Conference, an important constituent of the ruling NDA, today supported the Hurriyat demand of initiating an unconditional dialogue with them on the pattern of the Naga rebels talks.

Today's National Conference statement has surprised political analysts, as this party was one of the staunchest critics of the separatist conglomerate when it was in power. Dr Mehboob Beig, National Conference provincial president, told a news conference in Srinagar today that there should not be any hesitation in talking to Kashmiri rebels, when the Centre had no problems in holding a dialogue with Naga rebels in and outside the country.

Supporting the Hurriyat stand of unconditional talks, Dr Beig said that the Centre's talks with mainstream politicians and parties would not bring about the desired peace and prosperity in the region. "The Centre has talked an umpteen number of times with Naga rebels in and outside the country. It should talk to Kashmir rebels also, using the same vardstick." he said.

Lashing out at the People's Democratic Party, which heads the coalition government in the state, Dr Beig wondered how Ms Mehbooba Mufti was criticising security forces, while her father, chief minister Mr Mufti Mohammed Sayeed, was congratulating them.

AJMER, APRIL 19. The muchawaited hearing on the bail application moved by the Vishwa Hindu Parishad general secretary, Praveen Togadia — who has been in judicial custody since April 14 — was postponed till Monday by a sessions court here today after Mr. Togadia's lawyer sought time demanding the transcript of his allegedly inflammatory speeches recorded by the police.

The investigating authorities have slapped additional charges of damaging communal harmony and challenging the State Government's authority on the firebrand VHP leader, on the basis of his speeches delivered during a "Dharma Sabha" here on April 13 and elsewhere.

The bail plea came up this morning before the Additional Sessions Judge, Devendra Kachawa, as the District and Sessions Judge, Hari Singh Punia, was on leave. Bail was earlier denied to Mr. Togadia by a lower court which did not have the jurisdiction to deal with the charges of offence — punishable by life imprisonment — added by the prosecution.

Mr. Togadia's counsel, Onkar Singh Lakhawat, sought the court's direction for supplying the transcripts of speeches to his client and asked for time to submit the judgments of higher courts as judicial precedents in this connection. The VHP has been claiming that Mr. Togadia's public speeches were quoted "out of context" to frame him on false charges.

However, the Public Prosecutor, Zafar Ahmed Khan, opposed the defence counsel's contention and pointed out that an accused had no right to get copies of evidence collected by the official agencies during the course of investigation, before the chargesheet was filed in court.

The judge posted the case for hearing on April 21 and directed the Public Prosecutor to bring the case diary as well as the transcripts of speeches to the court on that date for "facilitating an appropriate order". Meanwhile, about a dozen Sangh Parivar functionaries from Gujarat - who had arrived here on Friday - returned to Ahmedabad today after the majority of them failed to meet Mr. Togadia in jail. They included the BJP MLA from Godhra and the former Bajrang Dal leader, Hareesh Bhatt, and the general secretary of the VHP's Gujarat unit, Dilip Trivedi.

"We had come here to extend our moral support to Mr. Togadia, but the prison authorities did not allow us to meet him," Mr. Bhatt told this correspondent. He said Mr. Togadia's "struggle" would be taken to its "logical end" and a new team of VHP and BJP activists would arrive in Ajmer on Monday.

The district administration is keeping a close watch on the activities of outsiders after its crackdown on local VHP activists. The Additional Superintendent of Police, P.C. Nyola, said the law and order situation in the town was fully under control and no one would be allowed to vitiate the atmosphere.

Govt. machinery geared up to tackle SARS

NEW DELHI, APRIL 6. As the killer pneumonia infection — severe acute respiratory syndrome (SARS) — continued to increase its global spread, the Centre today made it mandatory for all air passengers to furnish their health and travel details in the prescribed proforma upon arrival at any international airport in the country.

Addressing a press conference here after chairing a review meeting of officials of her Ministry and the Airports Authority of India, the Union Health Minister, Sushma Swaraj, said there was no need to press the panic button as the Government health machinery was fully geared up to tackle the deadly viral infection.

machinery was fully geared up to tackle the deadly viral infection.

The apprehensions of a SARS infection in Bhopal had turned out to be "false" and it was a case of plain pneumonia, she added.

Denying that the Government response had been slow, Ms. Swaraj said it had acted with "supersonic speed" to despatch a specialist team from Delhi, get the lab tests done and make the results available in less than a day.

"We have taken all precautions to meet any eventuality. We have time and again checked our preparedness and identified the hospitals in all major cities where an infected person can be treated in isolation."

Immigration officials have been advised to wear masks and gloves as a precautionary measure.

And health officers from the Directorate-General of Health Services would be posted at the immigration counters to go through



"It will help us in screening their symptoms and also gotting their symptoms."

"It will help us in screening their symptoms and also getting to know which countries a passenger has been to in the past week as the deadly virus has an incubation period of about a week," she said adding that all Indian embassies and missions have been advised on the SARS. The Minister said that a set of primers, an essential item in the diagnostic kit, had been imported from Germany and would be shared by the National Institute of Communicable Diseases and the National Institute of Virology, Pune.

The Infectious Diseases Hospital here had also been asked to remain fully geared up to meet any situation.

Asked if the high-level delegations from Singapore and Sri Lanka, slated to arrive here this week, would also be asked to fill up the proformas, she said: "Anybody and everybody who arrives at any of the international airport will be required to do so".



Uddhav heir to Sena throne

BAL THACKERAY hates democracy and has said so publicly. But, succumbing to the Election Commission's directive to parties to conduct organisational elections, the Shiv Sena on Thursday elected Bal Thackeray's son Uddhav as its new working president.

Thackeray, however, continues to be the Shiv Sena chief, even if he did not face the intra-party electioneering.

The election was held at Mahabaleshwar, near Satara, as part of the party's two-day conclave. Names of other party office bearers and second rung leaders, called *up-Neta* in the party, would soon be made public through the party mouthpiece *Sqamna*.

At Mahabaleshwar, however, Thackeray said there was complete democracy in the party. "There is no autocracy in the Shiv Sena. Uddhav has been named working president through the democratic procedure.

The decision was not imposed on the party but has been taken after consultations with everyone concerned. I would never force my son on the party." Thackeray said.

Uddhav's election amounts to Thackeray anointing a successor and Raj Thackeray is probably out of the reckoning.

Thackeray also saidthat the decision would not create any rift between Uddhav and Raj.

This time though, an ailing Thackeray seems to have become distrustful of old faithfuls like Manohar Joshi and Narayan Rane, both of whom he resents for their clout.

Mamata cry for economic emergency Bid to woo Trinamul

Calcutta, Jan. 6: Trinamul Congress chief Mamata Banerjee today urged the anti-Left forces in Bengal to unite before the panchayat polls and pleaded the smaller partners in the Left Front to desert Big Brother CPM.

Addressing a Trinamul rally on the Brigade Parade Grounds here — her first major public meeting at the venue more than three years after she unveiled the much-hyped 'Bengal package' — she asked Centre to slap an "economic emergency" on the state.

But the show of NDA support for Mamata at the rally was, at best, token. Samata Party leader and defence minister George Fernandes showed up but none of the BJP's central leaders did. State BJP president Tathagata Roy hardly made up for the absence of his high command.

Mamata took on the state government — for once without mentioning former chief minister Jyoti Basu — and hinted that she would join hands with the state BJP for the rural body polls scheduled for May.

Launching a scathing attack on the Buddhadeb Bhattacharjee government, she said: "Baamfront sharikder bolchhee. Kiser ato moho? Shorey aashun (I urge the Left Front partners to snap out of their CPM infatuation).'

Like in so many of her public speeches, Mamata pleaded all political forces inimical to the CPM to come together.

From Bapi Sen, the Calcutta police sergeant who gave his life for an unknown girl who was being teased by drunk consta-

bles on the night of December 31, to the government's cash crunch, water tax, higher stamp duty, unemployment, distress sale of paddy, closed factories, power tariff hike, deaths of children in hospital, and CPM "atrocities" - Mamata left nothing out.

Fernandes criticised the front for its inability "to improve the quality of life and woo investment".

The state BJP chief emphasised the need for an alliance with Trinamul to unseat the Left.


"In the panchayat polls, we will fight 1:1." Mamata said. hinting at an alliance with the state BJP. She demanded that an "economic emergency" be imposed in the state and urged the Centre to intervene.

Sudip Bandopadhyay, the former Trinamul chief whip in the Lok Sabha, was present at the rally despite his strained relations with the party chief. But, perhaps for the first time, he was not invited to speak at a party meet.

Thousands of Trinamul supporters converged on the ground from various points in the city and outside this morning. Private buses, trucks and matador vans packed with supporters triggered a traffic chaos. Mamata arrived at 1.45 pm. The ground was full by then.

Trinamul claimed 500,000 people attended the rally. The police put the estimate at around 100,000.

Front chairman Biman Bose came down heavily on Mamata for organising the rally on a working day. "She had earlier promised not to hold rallies and meetings on weekdays because they disrupt life. She failed to keep her promise."

BJP ties on the brink

Calcutta, Jan. 6: The BJP high command sidestepped Mamata's return to Brigade. Though the Trinamul Congress continues to be an ally, the signal was clear: she is on the margin and not as

Mamata Banerjee and her men jiggled their networks in Delhi many a time in the past few weeks to get central BJP leaders to address the rally but the efforts bore no fruit.

Defence minister George Fernandes was there but Mamata's efforts to show the electorate in the run-up to the panchayat elections that she was still valued in Delhi's power circles turned a damp squib.

The absence of the central BJP leaders from the rally also revealed the real position of state party president Tathagata Roy in Delhi.

The Tapan Sikdar-Muzaffar Khan combine, the rebel group in the state BJP, now appears to have a better access to the central leadership. Mamata and a section of her party had hoped that Roy would help them secure Delhi's blessings. That did not happen.

The Trinamul chief tried hard to rope in a star BJP leader to attend today's rally. But her move was countered by the Sikdar-Khan group, which has been accusing her of "humiliating" the BJP and the NDA leadership by walking in and out of the ruling coalition in the Centre.

Through December. Mamata had tried to get either Prime Minister Atal Bihari Vajpayee or his deputy, L.K. Advani, to attend the rally. When it became clear that neither would be available, she drew up a second list, which included BJP president Venkaiah Naidu and general secretary Arun Jaitley.

When these efforts failed as well, she made a desperate bid for another BJP general secretary - and the party's most prominent minority face - Muktar Abbas Naqvi.

"The central BJP's rejection shows it has a long memory. In the past, Mamata had on several occasions played Opposition party to us and the the NDA," said a state BJP leader.

support för PDS bandh

Calcutta, Jan. 6: Mamata Banerjee today declared her party's support for the 12-hour bandh called by the Party for Democratic Socialism on January 10.

The PDS is breakaway CPM and "it is our responsibility to strengthen the outfit so that we can form a grand alliance in future with such breakaway leftist groups," she said at the Trinamul Congress rally today.

PDS general secretary Samir Putatunda welcomed Mamata's gesture. "We want support from all anti-CPM and secular democratic parties for the dawn-todusk bandh," he said.

"We have called the bandh to protest the government's decision to increase court fees and impose water tax, the hike in power tariff and various other issues," Putatunda added.

Mamata's offer to support the PDS-sponsored bandh came as a surprise to the political circles. Earlier, she had said Trinamul would back the SUCI call for a Bengal bandh on January 27.

Political observers said Mamata will stand to gain in the panchayat polls in the event of an alliance with the PDS as it has a strong base in South 24-Parganas. Putatunda happens to be a former secretary of the CPM's South 24-Parganas unit.

Mamata is apparently keen on roping in fringe CPM supporters who have a soft corner for the PDS.

Mamata's support to the bandh is also being interpreted in political circles as her reluctance to forge an alliance with the SUCI and a desire to unite breakaway Marxists under its banner.
