## Judev quits, PM orders CBI probe into VCD 'authenticity'

NEW DELHI, NOV. 17. The Prime Minister, Atal Bihari Vajpayee, today accepted the resignation of the Union Minister of State for Environment and Forests, Dilip Singh Judev, who finds himself embroiled in an alleged bribery affair. The Prime Minister also ordered a probe by the Central Bureau of Investigation into the whole gamut of issues concerning the "authenticity" of the video compact disc (VCD), purportedly showing Mr. Judev accepting wads of currency from a mining "agent,

Later in the night the President, A.P.J. Abdul Kalam, accepted Mr. Judev's resignation with immediate effect.

The VCD has generated a runaway controversy, throwing out of gear the BJP's election campaign in the four northern States going to the polls later this month.


The decision to cut the ruling party's political losses was taken at a high-level meeting at the Prime Minister's residence this morning.

It was agreed that after the VCD had been released and aired by almost all television channel in the country, the BJP could no longer be seen as finding excuses for not seeking Mr. Judev's resignation.

It was also decided that the CBI should be asked to go into, what one participant called, "a whole range of suspicious circumstances" surrounding the damning VCD.

However, it is understood that even before the senior leaders confabulated this morning, Mr. Judev had been asked to send in his letter of resignation. Though Mr. Vajpayee had cautioned last night that Mr. Judev should not be pre-judged till a probe was carried out, the enormity of the Minister's culpability was obvious by this morning. The avalanche of negative images and sound-bytes from the Judev VCD provided another reason to show him the door.

After the meeting, the party president, M. Venkaiah Naidu, announced Mr. Judev's resignation. The CBI probe was announced by the Prime Minister himself at an "Iftar" party hosted by the Union Textiles Minister, Syed Shahnawaz Hussain. Mr. Vajpayee, however, avoided saying anything on the matter; he merely observed that the

"images were not very clear." Asked if the controversy would have any impact on the poll outcome, he said that "it will be known only after the votes have been counted."

Till the Prime Minister returned home late on Sunday night from his overseas trip and gave sufficient indication that Mr. Judev would have to go if found guilty, the BJP leadership found itself confused on the ethical issues arising out of the episode.

Till Mr. Vajpayee spoke, the party was stoutly defending the Minister. The delay in the resignation has denied it an oppor-

tunity to occupy the high moral ground. Curiously enough, the party continues to insist that Mr. Judev has done nothing wrong and that he ias been "framed" in a "cospiracy", hatched allegedly by the Chhattisgarh Chief Minister, ljit logi. Mr. Judev is one of the chief ministerial hopefuls if he BJP wins the Assembly pills in Chhattisgarh.

The Government and the ruling party are united in detecting the "hidden hand" of Mr. 'ogi. The decision to have a CBI probe has been taken in the hope that it would enable the BJP to keep alive the "conspir-

acy" theory as well as to ask the Congress leadership to make Mr. Jogi also resign as Chief Minister since he is also an "FIRed" person. The Congress has already aggressively sought Mr. Judev's prosecution under the Prevention of Corruption Act.

By getting Mr. Judev to resign and by having a CBI probe instituted, the BJP establishment has acknowledged that the VCD has indeed queered the pitch in not just Chhattisgarh but also Madhya Pradesh.

# Atal jumps to Judeo probe

New Delhi, Nov. 17: Forced to hit the ground running from Damascus close to midnight, Prime Minister Atal Bihari Vajpayee displayed this evening a "voluntary resignation" by Dilip Singh Judeo and delivered a lightning announcement of a CBI probe into the cash-on-disc scandal.

Asked about the likely impact of the storm on the roundthe-corner Assembly polls, Vajpayee said: "That will be known after the counting of votes."

But the BJP was already squirming under a feeling made all too familiar by the Tehelka scandal. In a throwback to the defence scam days, television channels today kept strafing drawing rooms with ghostly images from the compact disc.

The VCD purportedly shows the just-resigned Union minister of state for environment and forests—and the BJP's favourite for Chhattisgarh chief ministership—accepting cash from a man who appears to be acting on behalf of a foreign mining company.

Asked whether he had seen the footage, the Prime Minister said: "Saaf nahi hai (It is not clear)."

But it was crystal clear that his government wanted to take few chances. The Prime Minister, who returned from a weeklong foreign tour only last night,

set a frenetic pace. (See chart)

At the airport itself, Vajpayee said Judeo will have to go, "if found guilty" — in sharp contrast to a BJP bid to brazen out the storm that broke on Sunday morning when a Delhi daily splashed the news.

Less than 24 hours after he landed, Vajpayee told reporters on the sidelines of an iftar hose by minister Shaknawaz Hussain: "There will be a probe and the CBI has been entrusted with it."

Officialdom matched the alacrity of the political establishment — the inquiry notice from the cabinet secretariat reached the CBI within a few hours and the agency started collecting material soon after. Judeo said in Raipur he had resigned on "moral grounds".

BJP sources, too, stressed that Judeo had not quit "under pressure". "He informed the Prime Minister that until he was absolved of the charge, he would leave the ministry. He requested for a probe," a source said.

for a probe," a source said.
Sources claimed that the CBI investigation would "expose" the "machinations" of an Opposition chief minister who, they said, had "laid the trap" for Judeo.

"There is circumstantial evidence suggesting that certain persons were put on the job by the chief minister to ensnare Judeo. The CBI will nail the plot and the chief minister will have to answer a lot of questions," a cabinet minister said.



In the interlude, he will campaign. "He will be the campaign in-charge," the source said. The party will underscore a line that Judeo resigned "even though no "FIR or complaint was lodged against him".

However, the source admitted that Judeo would not share a platform with "star" campaigners from the Centre but "go about it on his own". He will not be present at the kickoff meetings which will be addressed tomorrow in Chhattisgarh by deputy Prime Minister L.K. Advani and BJP general secretary Pramod Mahajan.

### Judeo quits, PM orders CBI probe

New Delhi: Confronted with a second case of a party leader caught taking bribe on camera, and that too on the eve of key assembly elections, the BJP moved into damage control mode on Monday. Prime Minister Atal Bihari Vajpayee ordered a CBI probe to establish the veracity or otherwise of the VCD showing Union minister of state for environment and forests Dilip Singh Judeo taking a bribe, even as he forwarded the latter's resignation to the President for acceptance.

Mr Vajpayee, who returned from a foreign tour on Sunday night to the BJP's latest crisis, took these decisions after a meeting on Monday morning with senior colleagues. Those who met at the PM's residence included deputy PM L.K. Advani, finance minister Jaswant Singh, BJP president M. Venkaiah Naidu, general secretary Pramod Mahajan, party chief whip in Lok Sabha V.K. Malhotra and I&B minister Ravi Shankar Prasad.

Later, at an Iftar hosted by Union textiles minister Shahnawaz Hussain, the PM confirmed in reply to a question, "The CBI will inquire into it." On whether he had seen the Judeo CD, Mr Vajpayee said: "Saaf nahin hai (It is not clear)." Asked if the Judeo episode would damage the BJP's prospects in the assembly elections, Mr Vajpayee said cryptically, "Ginti ke baad hi pata chalega (That will be known only after the votes are counted)."

Still reeling from the shock and only too aware of how the Bangaru Laxman tape (showing him accepting a wad of notes) had damaged the party after TV channels

played it day after day, party leaders said they were yet to gauge the political fallout of this latest bribery-on-tape episode.

Till then, the party has decided to adopt a two-pronged approach—take the sting out of the Congress campaign by ordering a CBI inquiry and accepting Mr Judeo's resignation and then go on the offensive in all the states going to polls. "Compare Mr Judeo, who has resigned, with Chhattisgarh CM Ajit Jogi, who has not resigned even after a CBI indictment for reportedly forging documents," a minister said.

The attempt will be to deflect attention from Mr Judeo by targeting Mr Jogi, rather than permit Mr Judeo to be a stand-alone case of corruption. Simultaneously, the BJP plans to brazen it out, by permitting Mr Judeo—considered a possible BJP chief ministerial candidate in Chhattisgarh—to continue campaigning in the state.

'All efforts for a negotiated settlement have failed. Therefore, I am of the firm view that concerned parties should wait for court's verdict for resolution of the issue," Yadav said in interview to Malayalam daily Mathrubhumi here.

He said communal parties were raising the issue time and again to gain political mileage.

New Delhi: A fresh, if low key, attempt to resolve the Ayodhya issue is being made with Mahant Nritya Gopal Das and Mahant Awaidhnath, both religious leaders from Uttar Pradesh, being assigned to speak to representatives of the VHP and the Muslim community. However, the formula is the old one—to get the Sunni Waqf Board to withdraw its claim to the disputed land and pave the way for the construction of a Ram temple. In "exchange", the VHP will give up its "claim" to two historic mosques in Kashi and Mathura, shrines whose status cannot be changed according to a 1993 act of Parliament.

Chinmaynanda—a former member of the VHP marg darshak mandal—who had been asked by the Centre to deal with the VHP in the run up to the organisation's October 17 rally.

Sources close to him said the government would step in only when a concrete proposal mutually acceptable to both sides emerged. His job is to take the issue forward from where

it was left off by Swami Jayendra Saraswati, the Shankarachrya of Kanchipuram, in July. But this time round, it is unlikely that the Kanchi Shankaracharya's services will be

used, sources said.

Sources said the two UP religious leaders had already spoken to repre-

sentatives of the Muslims. However, it is not clear who they spoke to whether they are members of the All India Muslim Personal Law Board and the All India Babri Masjid Action Committee, both of which had earlier negotiated for the community with the VHP and the Centre's interlocutors. The next round of talks

will begin after Diwali.

BJP sources said the process should be resumed now as the Muslims did not protest when the VHP held its sankalp sabha in Ayodhya. "The Muslims are now prepared to give up their claim in Ayodhya provided the VHP gives up on Kashi and Mathura. They don't want any more confrontation. So this is a good time to strike," a senior BJP functionary said.

### PM returns Joshi

resignation

NEW DELHI, Sept. 30. — Within minutes of Allahabad High Court granting stay on proceedings against Mr MM Joshi until disposal of the revision petition, the Prime Minister "returned" the HRD minister's resignation letter to him. The latter withdrew it with "humility" and announced that he would resume office tomorrow.

Mr Joshi had yesterday filed a review petition in the Lucknow Bench of the High Court against the Rae Bareli special court's order allowing framing of charges against him in the Babari Masjid case. The petition argued that Mr Joshi's case stood at par with that of Mr LK Advani, who was discharged.

The High Court's order saved the day for both Mr Joshi and the Prime Minister. Mr Vajpayee had reportedly taken the stand that the resignation was not needed. The face-saver of stay would not allow the Opposition to raise the

issue which a blanket rejection would have permitted, BJP sources said.

The Prime Minister did not consult BJP leaders formally, sources said. The reason being that he did not want to send an impression that he was acting at the behest of party leaders.

Other accused such as Miss Uma Bharati and Mr Vinay Katiyar have been advised to approach the court in the same way.

Soon after Mr Vajpayee returned Mr Joshi's resignation, Congress spokesman Mr Jaipal Reddy asked the Prime Minister "to explain whether Joshi would be asked to quit again if the stay is vacated on 4 November. And whether the Deputy Prime Minister would be asked to resign if the Rae Bareli special court order discharging him in the case is stayed by a higher court". But the BJP asserted there would be no change in the party's stand even if the court vacated the stay later.

Mr Joshi said he had resigned on moral grounds. "If there is a charge against a minister, he should resign but the charge must be proved in court. There has to be a balance between governance and morality." He denied there were any dirrences within the party on the resignation issue. "It was a media creation."

Mr Reddy alleged that the CBI's "deliberate failure" to file a caveat in the High Court had led to the grant of stay on proceedings against Mr Joshi.

WITH THE HEARINGS on in the Rae Bareli court on the Ayodhya case, a controversy has broken out over the Central Bureau of Investigation's admission that it has no taped evidence of the allegedly inflammatory speeches made by highranking Bharatiya Janata Party leaders such as L.K. Advani, Murli Manohar Joshi and Uma Bharti. But what really deserves attention is an antecedent and much more serious issue. This is the manner in which conspiracy charges were dropped against these and five other Sangh Parivar leaders, who were accused by the CBI of plotting the events that eventually led to the demolition of the Babri Masjid. The Centre's defence, most vociferously articulated by the Union Law Minister, Arun Jaitley, is that nothing of the kind happened. The conspiracy charge, he asserted, was "never there in Rae Bareli." The charges and counter-charges have caused considerable confusion among the public, in the media, and in political circles. This is not surprising considering that they relate to a long, complex and tortuous process of bringing those guilty for demolishing the Babri Masjid to book. However, a close look at the salient facts in what is a protracted legal story reveals that the Centre's protestations of innocence are anything but convincing; actually, Mr. Jaitley's spin on the legal narrative conceals more than it reveals.

At the heart of the issue are a few crucial questions. Were the charges against Mr. Advani and others diluted? If so, what are the circumstances in which they were watered down? Does the Government's claim that no charges were dropped against the eight Sangh Parivar leaders have any factual basis? To answer these questions, it is important to begin at the very beginning. On December 6, 1992, the day the Babri Masjid was demolished, two First Information Reports were filed in the Ram Janmabhoomi police station. One (FIR No. 197) accused lakhs of unknown kar sevaks under a slew of Indian Penal Code sections that related to the demolition of the Masjid. The other (FIR No. 198) accused the eight Sangh Parivar leaders, including Mr. Advani, only under those sections usually used against people who make provocative speeches. These offensive speeches were made from a makeshift dais at Ram Katha Kunj, not far from the Masjid, on the morning of December 6, 1992. The origin of the present confusion lies in the manner in which these two cases were assigned. A week after the demolition, the first case was transferred to the CBI. The second case against Mr. Advani and others remained with the Uttar Pradesh police.

The U.P. CB-CID filed a charge-sheet in this case at Rae Bareli in February 1993. However, the legal course of the case was altered after the State, then under President's Rule, requested the Centre to have all Ayodhya-related cases transferred to the CBI. As a result, a special court was set up in Lucknow and a formal notification to this effect was issued after consulting the Allahabad High Court. Among the cases transferred to the Lucknow court was the conspiracy case (relating to FIR No. 197) and some 47 relatively less significant cases relating to the assault of media personnel. Case No. 198 was omitted even though it had already been handed over to the CBI. It was included by an amending notification later but the process of consulting the High Court was overlooked, an oversight that would prove costly for the prosecution and the cause of justice. Meanwhile, the CBI had filed a consolidated charge-sheet that covered the eight Sangh Parivar leaders and 32 others. This charge-sheet clearly accused the eight leaders of being a part of the criminal conspiracy to demolish the Mosque. Specifically, it charged that Mr. Advani's involvement with the conspiracy went back to the 1990 Rath Yatra and traced a pattern of events that ended with his speech on December 6, 1992, and the Mosque's demolition soon afterwards.

Charges were framed in 1997 against the ac-


cused, but revision petitions in the Allahabad High Court led to another legal twist. In 2001 the Court held, quite properly, that the amending notification, which sought the inclusion of the case against Mr. Advani and others, was "bad in law" as the prior sanction of the High Court had not been obtained. At the same time, the High Court made it clear that the "defect was curable." Perhaps even more significantly, it upheld the validity of the CBI's consolidated charge-sheet and the Lucknow special court's order framing charges against the accused. From here on, matters assumed a blatantly partisan dimension with two Chief Ministers, the BJP's Rajnath Singh and later the BJP's ally Ms. Mayawati, turning a deaf ear to demands that the technical "defect be cured." This could easily have been done by issuing a fresh notification with the consent of the High Court and would have resulted in Mr. Advani and the other Sangh Parivar leaders being tried for conspiracy in the Lucknow court. Rather than do this, the U.P. Government transferred the case against the eight leaders to a special court in Rae Bareli, where the CBI recently filed a charge-sheet. Significantly, this charge-sheet limits itself to accusing the eight leaders of making provocative speeches. It makes no mention of their alleged role in the conspiracy to demolish the Masjid.

What does this narrative establish? First, that the Centre is pulling the wool over the nation's eyes by claiming there was no dilution of charges. "Section 120 B [conspiracy] was never a charge in the Rae Bareli case and so there is no question of dropping it," declares Mr. Jaitley. Factually, this is correct as far as it goes but the Law Minister is being too clever by half. It turns out that his reference points are both misleading and meaningless. What is the purpose of comparing the CBI's recent charge-sheet with the one originally lodged in the Rae Bareli court by the U.P. police? Surely, it is the two CBI chargesheets — the consolidated one filed in Lucknow and the recent one in Rae Bareli — that should be compared in order to determine whether the charges have been diluted or not. The answer is: with the conspiracy angle abandoned, the charges have clearly been watered down.

Mr. Jaitley has suggested that the expansion of the charges to include conspiracy against Mr. Advani and others was a result of the Narasimha Rao Government's desire to foist the demolition charge on the BJP leadership. The merits of this allegation are irrelevant at this juncture. What is material is that the Lucknow special court framed charges on the basis of the CBI's composite charge-sheet and the Allahabad High Court upheld these charges and the validity of the charge-sheet. As for the CBI, it has maintained a deafening silence during this controversy. Its attitude to the case — evidently shaped under the shadow of the government of the day — is riddled with contradictions. It was only recently that the CBI pleaded unsuccessfully with the Lucknow court for the inclusion of the eight Sangh Parivar leaders in the case flowing from FIR No. 197. Significantly, a review petition filed by the CBI in the High Court is still pending. Having struggled until recently to make the conspiracy charge stick, it is deplorable that the same investigating agency should now file a charge-sheet that makes no mention of it. During the Rajiv Gandhi administration in the 1980s, the CBI was complicit in the cover-up of the Bofors corruption scandal; the political pressures continued in a different way during the Chandra Shekhar interlude and the Narasimha Rao administration in the 1990s. During much of the last decade, the CBI has done a valiant job of saving and taking forward the Bofors criminal case against heavy odds. The gain in credibility and reputation for independent, fearless investigation and prosecution is being undone by the way in which grave charges against the Deputy Prime Minister and other powerful persons have been compromised

in the most recent period.

ON THE FACE of it, the Prime Minister, Atal Behari Vajpayee's formulation that a solution to the vexed Ayodhya dispute lies in depoliticising it and letting the contentious issues be settled amicably by the religious leaders of the Hindu and Muslim communities does make eminent sense. But then, the irony is that the one who is rooting for "freeing" Ayodhya from politics is none other than the patriarch and officially acknowledged No. 1 leader of the very party that is primarily responsible for pushing it into the quagmire of partisan politics. It was the BJP that used the Ram temple issue as a vehicle for political mobilisation and capturing power. For all the image of a 'moderate' (in relation to the Sangh Parivar's ideology) that attaches to him, Mr. Vajpayee has never been found wanting, when it came to the crunch, in playing the partisan political game, although he did make it a point to come out, off and on, with statesman-like observations. So frequent has been the switch between contradictory approaches on Ayodhya (and this goes also for several other issues that have a bearing on the BJP's core ideology) by the Prime Minister and other leading lights of the party that one is left with the inescapable impression that they are but a part of a grand strategy to concretise the majoritarian communal agenda. If Mr. Vajpayee is really serious about his 'depoliticisation' proposition, he could, for a start, get his own party to remove 'construction of Ram temple at Ayodhya' from its agenda, an objective which it has only kept in abeyance to sustain itself in power.

As a general rule, negotiation is undoubtedly the best method of resolving conflicts. But, given the context of the twists and turns the decades-long Ayodhya dispute has taken, not to speak of the national outrage perpetrated by the frenzied mob on December 6, 1992,

when it pulled down the Babri Masjid, the very suggestion of it by the protagonists of Hindutva becomes suspect. First of all, in a milieu where the VHP and other forces are relentlessly running their campaign for the building of the temple in open defiance of authority, there can be absolutely no scope for any fair negotiation or display of true give-and-take and the representatives of the Muslim community cannot be expected to be able to negotiate on a level field. Secondly, for the BJP or any of its ideological affiliates, there is invariably a non-negotiable factor, even if not spelt out, whenever they talk of negotiation, and that is: the Ram temple must be built on the site where the mosque had stood, since it is a matter of 'faith'. What according to them is open to negotiation are issues that are in the nature of the 'price' the Muslim community is willing to settle for. And this clearly is a position that seeks to add insult to the injury caused to the minority community and legitimise the brazen misdeed of revanchist forces.

More fundamentally, there are some disturbing questions about the religious leaders who are supposed to be negotiating on behalf of the two communities. Given the fact that there are any number of spiritual leaders, quite a few of them self-styled, on either side and that the writ of no single religious leader runs through the entire community, be it Hindu or Muslim, the question arises: what sanctity will attach to whatever settlement is reached — if at all --- by those who have assumed the role of interlocutors? In the circumstances, the 'negotiations' route, despite its undoubted theoretical merits, stands little chance of producing a durable solution and the judicial route being pursued by way of title suits appears to be the best bet, something that has found favour with major political parties.

### New faces in Vajpayee Ministry, Mamata Banerjee stays out By Harish Khare

NEW DELHI, MAY 24. Rajnath Singh, B.C. Khanduri and Subodh Mohite are the new Cabinet rank Ministers in the Atal Behari Vajpayee Government. Prime Minister, Atal Behari Vajpayee, also inducted five new Ministers of State, besides making changes in the portfolios of a number of his Ministers.

The Minister of State-level entrants are: Chinmayanand Swami (BJP), Kailash Meghwal (BJP), Nagmani (Rashtriya Janata Dal-Democratic), Prahlad Singh Patel (BJP) and P.C. Thomas (Indian Federal Democratic Party). Mr. Khanduri gets promoted to Cabinet rank, while Mr. Mohite comes in place of his Shiv Sena colleague, Balasaheb Vikhe-Patil. The new Ministers were administered oath of office and secrecy by the President, A.P.J. Abdul Kalam, at the Rashtrapati Bhavan this evening.

The most exciting element in the reshuffle of portfolios is the independent charge of the Ministry of Civil Aviation for Rajiv Pratap Rudy (who was Minister of State in the Ministry of Industry and Commerce). The elevation of Maj. Gen. (retd.) Khanduri to Cabinet rank (in the same Ministry of Road Transport and Highways) is conceded as recognition of a high level of integrity.

However, the much awaited Cabinet expansion lost its sheen when Mamata Banerjee of the Trinamool Congress refused to join the Union Cabinet. Ms. Banerjee's proposed induction was being cited as the original provocation for this expansion. However, Ms. Banerjee baulked at taking oath because the BJP bosses appeared determined to jettison the existing NDA convention that permits the leader of an alliance partner the final say on who shall represent the party in the Union Government. The BJP leaders were insistent on including Sudip Bandyopad-hyay, a "dissident" who had developed a warm working relationship with the ruling parworking ty when Ms. Banerjee herself was playing distant and cold.



RIME Minister Atal Behari Vajpayee today hinted that Trinamool Congress chief Mamata Bannerjee might join his cabinet which would soon be expanded. When pressed to disclose the date for expansion, Vajpayee said in a lighter vein, "Koi achha sa muhurat dekh kar kareinge. Main saare rahasye kaise khol sakta hoon" (Shall do so after choosing an auspicious time. How can I disclose all the secrets).

Vajpayee was talking to mediapersons minutes before he flew back to Delhi after a six-day sojourn here. Members of his family and the National Security Advisor Brajesh Mishra accompanied him to Delhi.

The PM said that the country had not initiated the peace process with Pakistan under any compulsion and efforts were on to end cross-border terrorism. "We are firm on our stand that terrorism should end," he said.

Apropos the planned cabinet, expansion, Vajpayee said that some of his ministers were overloaded and needed to be relieved



of the extra load and some new faces would also be added. Asked whether Mamata Bannerjee would be joining the cabinet, he said smilingly, "Sambhavna to hai" (the possibility is there).

In Kolkata, Trinamool Congress circles expressed happiness at the PM's hint that Mamata may return to the Union cabinet. "We are happy at the prospect that Mamata rejoins the cabinet", senior TC leader and party legislator Saugata Roy said. "There has been talks of cabinet reshuffle for some time and it was generally known that she might be re-inducted. Now that PM himself had said it. it only reconfirmed what we have been hearing," he said. The West Bengal unit of the BJP also welcomed the PM's move.

# Ramachandran and Ajit resign

May 23. — Mr Ajit Singh, agriculture minister, and Mr Gingee Ramachandran, MoS for finance, resigned today, setting the tone for tomorrow's Cabinet reshuffle. Mr Ramachandran's personal assistant, Mr R Perumal Swamy, was caught yesterday taking bribes from an IRS official.

Mr Singh resigned to pre-empt his being dropped from the cabinet, his party leaders said. The agriculture minister has had major differences

with the finance minister, Mr Jaswant Singh, over farm handouts and this is apparently one reason the Prime Minister was willing to drop the Jat leader. BJP leaders say the departure of Mr Ajit Singh is not likely to affect the party's fortunes in western UP "too much".

(PTI adds: Mr Singh has called a meeting of his party MLAs from UP tomorrow to consider withdrawal of support to the Mayawati government. He held late night parleys with RLD leaders to discuss the party's strategy following his resignation).

Political calculations and corruption allegations will also play major roles in other changes tomorrow.

Two BJP Cabinet ministers and two BJP ministers of state are reportedly under scrutiny. Officials said that whether or not they get the axe will depend partly on political factors – heavyweight ministers may be spared this time.

Trinamul Congress chief Miss Mamata Bane-

Trinamul Congress chief Miss Mamata Banerjee may get agriculture, while Mr Shahnawaz Hussain's may be removed from civil aviation. Mr Mukhtar Abas Naqvi may replace Mr Hussain as the "Muslim face" if the former dropped.

Major-General BC Khanduri, MoS in charge of surface transport, is likely to be elevated to cabinet rank. BJP sources said that he may retain surface transport, where he has been shepherding the golden quadrilateral project or be given another "important" ministry. Miss Banerjee's party MP, Sudip Bandopadhyay, may be inducted as MoS, railways. This, BJP leaders feel, may "upset" Miss Banerjee but senior ministers from the party are reportedly keen on Mr Bandopadhyay. The current MoS, railways, Mr Bandaru Dattaraya, may be dropped and asked to concentrate on BJP affairs in his state, Andhra Pradesh.

Some senior ministers are reportedly keen to have portfolio changes and some others are

changes and some others are scrutiny. BJP sources said this list includes Mr Anant Kumar (urban development), Mr Ram Naik (petroleum), Mr Arun Jaitely (law), Mr Shatrughan Sinha (shipping), Mr Karia Munda (coal) and Mr Digvijay Singh (MoS, external affairs).

When contacted, Mr Omar Abdullah, National Conference leader, said that his father, Dr Farooq Abdullah, had not received any intimation from Delhi about a ministerial post as yet. Some BJP leaders are keen to have Dr Abdullah in the cab-

Prime Minister Atal Behari Vajpayee and Deputy Prime Minister L.K. Advani were today briefed separately by CBI director P.C. Sharma on the developments leading to the arrest of the minister's PA.

Meanwhile, the CBi hopes to get more information from Chennaibased chartered accountant A. Krishnamurthy, who is being brought to Delhi tonight. Krishnamurthy acted as the conduit in the case.

The CBI arrested a third person, Padmanabhan, a project associate at the centre for Atmospheric Science, IIT, Delhi late last night. He had apparently driven Swamy to the residence of IRS official Anurag Vardhan and was allegedly present when money changed hands yesterday.

NEW DELHI, APRIL 6. The Rural Development Minister, Shanta Kumar, has resigned from the Union Cabinet. He met the Prime Minister, Atal Behari Vajpayee, this evening and submitted his resignation, official sources said.

The Prime Minister has accepted his resignation and forwarded it to the President, A.P.J. Abdul Kalam, for acceptance, sources said. On the advice of the Prime Minister, the President later accepted Mr. Kumar's resignation.

The resignation of Mr. Rumar, who hails from Himachal Pradesh, had been doing the rounds in party circles ever since the ruling BIP suffered a humiliating defeat in the recent

Assembly elections there. Mr. Kumar invoked the wrath of the party bigwigs after his outspoken criticism of the BJP-led Prem Kumar Dhumal Government which, he said, had failed to perform to the satisfaction of the people in the hilly State. ### Jumbo ministries Cabinet sets 10 per cent limit, but not quite

Jumbo ministries are out, or so the Union government likes to believe after deciding to implement a recommendation of the National Commission to Review the Working of the Constitution to limit the size of the council of ministers. But they have done violence to the recommendation to suit politicians. The NCRWC had recommended that jumbo ministries were prohibited by law and so the number of ministers should not exceed 10 per cent of the total strength of the elected House — which means 10 per cent of the strength of the legislative Assembly in the states and 10 per cent of the Lok Sabha at the Centre. This would have meant that in the era of coalition politics every small party or independent MLA or MP who supports the ruling government would not be able to extract its pound of flesh. Accepting the recommendation in its original form would have created problems in the first instance with the Vajpayee government which instead of inducting a couple more disgruntled elements of the NDA in the next Cabinet reshuffle, the Prime Minister would have had to drop about 22-23 existing ministers.

So a subterfuge was invented; to include the upper house in the calculations. In the case of the Centre where there is a well-filled Rajya Sabha, the council of ministers is safe in the numbers game. It also means that in states like Uttar Pradesh and Bihar which too have an upper house there is more room for manoeuvre, but not enough. For example the strength of the Bihar legislative Assembly is 244 and the legislative Council is 67, a total of 311. Ten per cent of this is only 31, but Rabri Devi currently has 70 ministers. Her husband Laloo Prasad Yadav had headed a council of 80 in 1995, the largest Bihar has seen. Uttar Pradesh is not much better, From the BJP to Samajwadi Party to BSP, they have all headed huge ministries. In fact Mayawati recently set a record by making all dissident MLAs, ministers to prevent them from trying to defect. The original recommendation of the NCRWC should have been implemented.

Are government working on a scheme to bail out states without an upper House? They could add the staff employed by the legislature! If the intention is to subvert the recommendation, considerations of propriety alone need not stand in the way!
