# Transfer Acharya case to another State: BJP

#### ည္ကမ်က္သိုင္တာ Do not politicise issue: Minister

NEW DELHI, DEC. 2. Amid continuous heckling from across the political spectrum, the arrest of the Kanchi Sankaracharya was raised in both Houses of Parliament today by the Bharatiya Janata Party. The party called for transfer of the case to another State and Central intervention to ensure proper treatment to the Acharya.

With the BJP alleging that the Congress-led Governments at the Centre and in Andhra Pradesh were involved in the arrest of the Acharya, Sri Jayendra Saraswathi, the Government asserted that neither had anything to do with the police action in Tamil Nadu.

In the Lok Sabha, the issue was raised by the Deputy Leader of the BJP in the House, V.K. Malhotra, as zero hour began. Allowing him to raise the matter that "pertains to a State" in view of the sentiments attached to the issue, the Speaker, Somnath Chatterjee, reprimanded members time and again for frequent interruptions.

#### 'Use Article 256'

Mr. Malhotra said the Centre should use Article 256 of the Constitution to issue directives to the State to ensure proper treatment to the Acharya. Further, he said, the case should be transferred out of Tamil Nadu, even as Mohammad Salim of the Communist Party of India (Marxist) said the arrest must not be politicised. Though only a couple of members spoke, the issue held up the proceedings for half-an-hour and much of what transpired was struck off the records.

The Leader of the House and Defence Minister, Pranab Mukherjee, said: "Neither the Centre nor the Andhra Pradesh Government had anything to do with the arrest; this is a matter exclusively within the purview of the Tamil Nadu Government."

Referring to the Prime Minister, Manmohan Singh's letter to the Tamil Nadu Chief Minister, Jayalalithaa — which was cited by Mr. Malhotra as the reason for raising the issue on the premise that it had ceased to be a State issue after the Prime Minister's intervention — he pointed out that Dr. Singh had underlined the need for the law to take its course.

The Minister of State for Parliamentary Affairs and Personnel, Suresh Pachouri, appealed to the Rajya Sabha members to refrain from politicising the arrest. Responding to an hourlong discussion during zero hour, Mr. Pachouri said that Dr. Singh in his letter to Ms. Jayalalithaa had observed that it was an "extremely important" case and emphasised that law must take its course. Ms. Jayalalithaa in. her reply had assured him that proper care was being taken while handling the case.

The Minister denied that the Andhra Pradesh Chief Minister, Y.S. Rajasekhara Reddy, had consulted either the Prime Minister or the Union Home Minister before the arrest in Mahbubnagar on November 11.

#### Assault on religious institution, says Sushma

Raising the issue, the senior BJP leader, Sushma Swaraj, said the Acharya had been ill-treated in custody and no arrangement had been made for him to offer his daily prayers or to give him proper food. She expressed anguish over the "assault" on the 2,500-year-old religious institution by the Tamil Nadu Govern-

ment and demanded that the Centre issue directions under Article 256 and 257 of the Constitution.

Ms. Swaraj, who had visited the Acharya in the Vellore Central Jail, said that it was regrettable that he was arrested on the eve of Diwali, the most important festival for Hindus. Even political leaders, eminent journalists and reputed businessmen were usually lodged in guesthouses.

#### AIADMK's stand

Refuting the BJP's charges, the AIADMK leader, P.G. Narayanan, said the State Government had the highest regard for the Kanchi Mutt and accused Ms. Swaraj of "misleading" the House. "The arrest of the Sankaracharya was a painful action undertaken by the State Government to uphold the rule of law. Is it the case of the BJP, which is the only party spearheading the protest, that no case should be pursued against the Shankaracharya? No political party can say that the accused in a murder case be let off just because he is holding a high religious position," he said.

Mr. Narayanan said that if the State Government had not taken the decision, it would have been charged with wilting under pressure from powerful people.

Mr. Narayanan also questioned the BJP president, L.K. Advani's demand for shifting the case outside Tamil Nadu, saying that law and order was a State subject and the Centre was more or less satisfied with the State Government's action.

Nilotpal Basu of the CPI(M) said the case was under judicial scrutiny and the right forum for such a discussion was the Tamil Nadu Assembly.

Chennai: The Madras high court on Saturday dismissed the bail application of Kanchi seer Jayendra Saraswathi who was taken into custody on November. 11 in connection with the murder of a temple official on September 3.

Giving his order on the bail plea, Justice R Balasubramaniam said, "I am dismissing the bail application at this stage."

The seer is likely to move the supreme court on Sunday challenging the rejection of his bail petitition. Sources said the seer's counsel would file a special leave petition and make a "mention" of

it in the SC on Monday.

Angered by the seer's police remand, the BJP on Saturday announced that it was severing its ties with the AIADMK. Criticising the J Jayalalithaa government for its handling of the case, BJP general secretary Rajnath Singh told mediapersons in Ranchi that it was unbecoming of a state government. "We will not have any relationship with the AIADMK from now," he said.

#### The sankaracharya's arrest has become inevitably politicized

# Print Trials of a pioneer 1911

onastic intrigues have been a source of macabre fascination for the laity. From Umberto Eco's Name of the Rose to Dan Brown's best-selling Da Vinci Code, tales of machinations of monks, cardinals and godmen have enthralled both believers and sceptics, not least because they have also provided valuable insights into a mysterious and cloistered world where theology, ambition and greed produce a volatile cocktail.

Over the past week, there has been considerable popular interest in the dramatic arrest of the sankaracharya of Kanchi on a charge of murder. Even as crime reporters and unnamed police sources have had a field day presenting some extremely fanciful theories to a hungry media, the case has become inevitably politicized. Passions have been further aroused by the public prosecutor's description of Sri Javendra Saraswati as a "criminal" who deserved no exceptional treatment. It has been suggested that the sankaracharya's arrest is a calculated assault on Hindu institutions and the Hindu religion. Conversely, in atheistic circles linked to the Dravidian movement in Tamil Nadu, there have been celebrations over the humiliation of a Brahminical bastion. The Dravida Munnetra Kazhagam chief, M. Karunanidhi, has even gone to the extent of demanding a government takeover of the Kanchi math whose assets have been estimated by the media to be worth some Rs 10,000 crore.

The arrest of the Kanchi sankaracharya is no ordinary event. While it has become woefully common for sundry sadhus, maulvis and padres to be charged with serious criminal offences, this is the first time in living memory that a person of such elevated standing has become embroiled in a murder case. The 69th sankaracharya of Kanchi is the living embodiment of a monastic order that was begun by Shankara at his final resting place in the 9th century. Along with the peeths in Sringeri, Dwarka, Puri and Badrinath, all established by Shankara in the course of his journey to revitalize the sanatan dharma, the Kanchi math constitutes one of the five pillars on which traditional Hinduism rests.

wever, the importance of the Kanchi sankaracharya extends beyond the range of the institution at Kancheepuram. While orthodoxy attaches greater importance to the other four maths, it is Jayendra Saraswati who has in many ways emerged as the public face of Hindu dharma. Since he took over from the revered Sri Chandrasekarendra Saraswati in 1994, the Kanchi seer has consciously broken from the tenets of the

dasanamisanyasi order that has defined the conduct of the Shankara orders. He has extended the activities of the math beyond meditation and spiritual quest to social activism. From campaigning against religious conversions and championing the unrestricted temple-entry of Dalits, he has involved the Kanchi math in grand projects centred on education and healthcare. Indeed, he has been a pioneer in steering an orthodox Hindu order to the type of activism that was the hallmark of Swami Vivekananda. He has even plunged headlong into the treacherous world of politics as evifallen out with the present dispensation, is still fiercely contested, there seems to be a grudging acknowledgment that a section of the math establishment did take the law into its own hands. Adding to the murkiness are whispers of an underlying power struggle involving the sankaracharya and his heir-apparent, Sri Vijayendra Saraswati. The observation of the Art of Living proponent, Sri Sri Ravi Shankar, that "saints should keep a watch on people around them" has struck a chord.

Regardless of how the legal battle proceeds, the entire incident has

dent from his deep involvement in attempts to find a negotiated settlement to the Ayodhya dispute.

The arrest of such a man, in circumstances that reek of government insensitivity, should, ideally, have triggered a monumental Hindu explosion. Yet, apart from an outpouring of Brahmin anger in Tamil Nadu, a bandh in Kerala, some camera-friendly demonstrations by Vishwa Hindu Parishad leaders and some strong words from the Swami Dayananda Saraswati-led Hindu Dharma Acharya Sabha, the reaction has been strangely muted. Despite Atal Bihari Vajpayee's expression of concern and Murli Manohar Joshi's show of solidarity, even the Bharatiya Janata Party has trod a cautious path.

It is conceivable that the nature of the charge against Jayendra Saraswati has prompted more concern than anger. Although the personal involvement of the sankaracharya in the murder of Sankara Raman, a former math functionary who had

been a colossal setback to Hindu activism in India. The absence of a backlash from those who revere the institution of the sankaracharya has underlined the serious limitations of a Hindu-right-or-wrong approach. The principle of equality before law, an important tenet in the process of secularization, has, it would seem, prevailed. Of course, if the sankaracharya is honourably acquitted, there may be an explosion of anger. However, its manifestation is likely to be electoral, and against the All India Anna Dravida Munnetra Kazhagam chief, J. Jayalalithaa, rather than sectarian. The faultlines are unlikely to be dharma versus adharma.

The relatively passive reaction of Hindus to the sankaracharya's arrest can also be smlained by caste. Despite attempts to reach out, the Kanchi seer's appeal remains confined to Tamil Nadu's beleaguered Brahmin minority. His pan-Indian importance, as a spokesman of religious Hindu interests, was

out of proportion to his social limitations in south India. No wonder the visible protests were organized by groups like the Rashtriya Swayamsevak Sangh, VHP and Hindu Munani, which have no stakes in electoral politics and, consequently, were not deterred by the awesome power of anti-Brahminism.

Interestingly, this is not the first time that the arrest of a sankaracharya has failed to generate a mass reaction. In 1990, the then Uttar Pradesh chief minister, Mulayam Singh Yadav, arrested the Dwarka sankaracharya, Swaroopanand Saraswati, for leading a march to Ayodhya. The Dwarka seer, who is favourably disposed to the Congress, was attempting to undercut the BJP and VHP on the temple issue.

The reluctance of Hindus to be spontaneously moved by those representing the traditional institutions of sanatan dharma has certain profound implications for the future of political Hinduism. It is more than likely that legal difficulties of the Kanchi sankaracharya will prompt a reordering of priorities in the math. Already criticized for adopting a public profile and confronted with the threat of a government take-over, it is entirely possible that Jayendra Saraswati and his successor will eschew activism for passive philanthropy and

f this retreat materializes, it is entirely possible that the advocacy and promotion of Hindu causes will pass almost exclusively to political and religious leaders who are less inhibited by tradition and more confident of their social clout. As things stand, the recent expansion of the Hindu social sector has not been heralded by the centres of orthodox religion or established players like the Ramakrishna Mission who have shed Hinduness for universalism. The initiatives have been taken by religious figures such as Sathya Sai Baba, Mata Amritanandamayi, Sri Sri Ravi Shankar, Swami Dayanand Saraswati, the Swaminarayan sect, individuals from the Aurobindo Ashram and lesser known figures like Swami Asheemananda in Gujarat. It is they who are giving the Hindu faith a new energy and new dynamism which is likely to overshadow the Brahminism of the traditional orders.

The likely eclipse, in unfortunate circumstances, of Jayendra Saraswati's overhaul of orthodoxy may pave the way for a more socially-committed, politically inclusive, creative and modern Hinduism. The hierarchy of the Kumbh Mela may yield way to the ratings on the Aastha channel and God TV. The change, in many ways, could resemble the transformation of the Christian faith in the United States of America. The consequences, too, may not be dissimilar.

# Jaya claims 'shocking' evidence against seer But report to Centre silent on details

**HT Correspondents** Chennai/ New Delhi, November 17

CHIEF MINISTER J. Jayalalithaa today told the state Assembly that the police had "shocking, but solid" evidence against Kanchi Sankaracharya Jayendra Saraswati's "direct involvement" in the murder of temple manager Sankararaman. She, however, did not reveal the evidence.

Central officials say the report Delhi has received from the Tamil Nadu government on the arrest, too, is abysmally short on details relating to evidence against the seer and the "circumstances" of the police action.

They said the Jayalalithaa regime had merely sent a chronology of its actions, including Jayendra Saraswati's detention in Mehboobnagar and his transportation to Chennai and then to Vellore. The state government is silent even on the procedure the police followed while carrying out the arrest in a state (Andhra Pradesh) where it

has no jurisdiction.

An official said the Centre won't seek further clarifications from Tamil Nadu: it would, instead, rely on its own intelligence channels to get the information it needs. Other than that, it will wait for the chargesheet to be filed in the court.

Jayalalithaa, however, told the Assembly, "The interrogation of two key accused -Kadhiravan and Rajni — has revealed that the seer was involved in the murder. A huge amount as fee for the murder

was paid from the mutt's bank account, five people were made to surrender to mislead the investigations and Saraswati staved in touch with the murderers.

She said the Sankaracharya was behind a similar attack on a mutt devotee, Radhakrishnan, in Chennai on September 20, 2002, as he suspected the latter to be behind some anonymous letters directed against him.

"Investigations have revealed that Jayendra Saraswati conspired and plotted with his henchmen to eliminate Radhakrishnan, though he was only injured. Since this case is similar to Sankararaman's murder, the same police team will investigate it," she said.

Jayalalithaa said the police were on the look out for two more accused - Ravi Subramaniam and Appu who along with Jayendra and Kadhiravan had planned the murder. She dismissed suggestions that the police had violated any norms while arresting the seer.

#### Kanchi focus shifts to seer junior

#### 'Tearful' acharya mum on arrest

Kancheepuram, Nov. 16: Political leaders from Delhi trooped to Vellore to meet acharya Jayendra Saraswati in jail today, but a subtle power shift was underway at the *ashram* in Kancheepuram.

The junior acharya, Vijayendra Saraswati, returned to the Kanchi Kamakoti Mutt this morning to be welcomed by devotees with cries of "Periyaval, Periyaval". Periyaval is an affectionate term so far reserved for Jayendra Saraswati.


Vijayendra Saraswati, who was on a tour with the Kanchi seer when he was arrested on Thursday night by Tamil Nadu police at Mehboobnagar near Hyderabad, drove back in a white Cielo that was followed by three *mutt* vans.

Devotees swarmed around the car as it reached the western entry point to the temple town. A brief reception to the chanting of Vedic *shlokas* and Poornakumbha followed.

For the junior acharya, the scene at Sarvatheertham — the large temple tank that is a border landmark here — when he was offered prasad from the Kamakshi Amman Temple would have been a throwback to 17 years ago. In 1987, Vijayendra Saraswati had received the Kanchi seer at the same synthem he returned after sudenly leaving the mutt. Jayendra Saraswati had been traced o Talai Cauvery in Karnataka und persuaded to come back.

Vijayendra Saraswati seened to be groping for a respone to the grief among followers nd devotees over the arrest of he seer on a murder charge.

For a while, it seemed he tight not speak at all to the raiting media contingent as wit manager Sundaresa Iyer nut the gates and said there as nothing the junior acharthad to say. But sensing that lence could be interpreted versely, the managers quick-arranged a brief media in-



teraction with Vijayendra Saraswati before he resumed his usual puja at the *mutt*.

Without mentioning the arrest, the junior acharya said: "I am in deep sorrow now. We should all join in an earnest prayer to the Lord." This was preceded and followed by Vijayendra Saraswati taking a deep breath and observing a minute's silence. He sat on a wooden stool during the meet.

Wiping a tear from his eye, Vijayendra got up and left after former chief election commissioner T.N. Seshan prodded him to wind up the interaction lest the media ask uncomfortable questions.

As questions were raised about why he did not condemn the arrest, a *mutt* devotee re-

torted: "Why should Sri Vijayendra condemn? It is for the acharya's followers to do it and the whole country is disturbed though there have hardly been any serious protests in Tamil Nadu so far..."

Only the Sangh parivar

Only the Sangh parivar and leaders of the BJP-led National Democratic Alliance have come out in protest against the arrest. BJP leader Murli Manohar Joshi and NDA convener George Fernandes separately called on Jayendra Saraswati in prison. Later, Joshi decried the acharya being treated like a "common criminal".

The former human resource development minister also called on Vijayendra Saraswati here in the afternoon. Later, Joshi said the seer had urged that wisdom and good sense should prevail and people should remain calm. Seeking police custody for the acharya was "preposterous", he said, alleging that police were trying to "concoct evidence".

But a kilometre from the *mutt* the Kancheepuram District People's Forum staged a demonstration against Jayendra Saraswati, demanding that the police should not grant bail to a "murderer".

High drama prevailed at the judicial magistrate's court here as the police were directed to produce Jayendra Saraswati on Thursday to hear his views on the prosecution's petition seeking police custody of the seer.

# Sangh, BJP see poll hope

New Delhi, Nov. 16: Have the Sangh parivar and the BJP found a new mascot in Jayendra Saraswati? Murli Manohar Joshi, K.N. Govindacharya, George Fernandes and the Vishwa Hindu Parishad — often sparring allies — have closed ranks to denounce the Kanchi acharya's arrest.

The Sangh scored a minor victory when it got Janata Dal (United) leader Fernandes to persuade the NDA to toe its line on the arrest.

Far from a conflagration, Jayendra Saraswati's arrest did not even cause a minor fire in Tamil Nadu, the seat of the Kanchi *mutt*. Why then are the Sangh parivar and Fernandes bristling in anger?

Observers believe that with the "Ayodhya card" subject to the law of diminishing returns and other Hindutva issues—a common civil code, conversions, illegal immigration from Bangladesh—not taking off, the arrest is a convenient plank to whip up the bogey of "Hinduism being under threat".

The VHP linked the arrest by Tamil Nadu police to Sonia Gandhi's rise in politics and suggested that nothing better could be expected of a "foreign" ruler.

But the Sangh parivar chose not to attack Tamil Nadu chief minister Jayalalithaa. Sources explained that she had been a "useful" ally of Hindutva, bucking the trend to support Narendra Modi, and could come handy in the future. "Moreover, if we start branding her as anti-Hindu, it won't cut ice because she dared to bring a law against religious conversions," said a BJP source.

BJP sources said while their protests against the arrest may not bear fruit in Tamil Nadu — where the acharya is worshipped by a tiny fraction of the minuscule Iyer community — the idea is to revive a pro-Hindu ambience in the heartland. "The seer has followers in Bihar and Uttar Pradesh among Shaivites. We have be-

en losing upper caste votes to the Congress. We have to check the defection," said a source. Brahmins like Atal Bihari Vajpayee and Joshi taking up cudgels for the seer, sources said, would go down well with the upper castes.

The only problem is that unlike Ram, a pan-Hindu figure, the Kanchi seer's "appeal" is limited to a sect. The best the BJP can hope to achieve is to remind people of the "role" he played in the Ayodhya "movement".

The Congress, always in a

The Congress, always in a quandary on religious matters, was over-cautious. Sonia, asked to comment, said the matter was *sub judice* and she would not speak on it.

#### South support

Several south Indian organisations today protested in Delhi against the arrest of the acharya and demanded his immediate release.



# PM denies role of Centre in Kanchi seer's arrest

the Kanchi Shankaracharya's arrest on the charges of murder threatening to snowball into a major political controversy, Prime Minister Manmohan Singh on Sunday was constrained to step in by making it clear that that the Centre had no role in the affair.

On a day when the RSS and its affiliates such as the VHP, Bajrang Dal and even the BJP stepped up their protests against the decision to lodge the Shankaracharya in judicial custody, the Prime Minister tried to steer clear of the controversy by asserting that the Centre had no role in the arrest, and dismissed the charge that the action against the seer was taken at the instance of the UPA government. "The Centre has no role in the arrest. It is not correct to say we had a role. To say the least, it is not our concern," Dr Singh said in Hyderabad on Sunday afternoon.

The Kanchi Shankaracharya was arrested on November 11 from Mehboobnagar in Andhra Pradesh in connection with the murder of a former employee of the Kanchi Mutt. The Prime Minister's statement only reflected the government's, and the Congress party's, concern over an adverse fallout of the Shankaracharya's arrest. While the Congress has limited itself to stating that it was wrong to have arrested him on the day Diwali was being celebrated, there is an apprehension in the party that the entire episode, if not handled properly and delicately, has the potential of dragging the party into it.

The principal Opposition party, the BJP, on the other hand, deplored the arrest, observing that the Tamil Nadu government,

while ordering the seer's arrest, appeared to have acted "in haste" or "under pressure". Supreme Court has set certain guidelines on whom to arrest or whom not to arrest for what offence. It seems the decisions (in Shankaracharya's case) taken are either hasty or taken under pressure," BJP president L.K. Advani told reporters in Amritsar. "He (the Shankaracharya) is not the kind of person who will go underground or vanish. As far as the facts are concerned, the case is in court and it is the court that has to decide," he said.

While the BJP has not taken a formal decision to join in the protests being organised by the Sangh parivar, it has, it appears, made it clear that its workers were free to participate in the ongoing agitation. This was evident from reports of BJP workers taking part in the protests across the country. The Jayalalitha government's decision to put the Shankaracharya behind bars, however, came in for some lefthanded compliment from the Left parties. While charging the VHP and other forces with trying to give the issue a political colour, the CPM politburo issued a statement asking the Tamil Nadu government not to give in to any pressure as the Shankaracharya was not above the law.

"While the case should be pursued with sensitivity keeping in mind the religious status of the individual concerned, it must be emphasised that this is not a religious matter," the statement said. Pointing out that the prosecution had stated that sufficient evidence existed in the case to proceed against him, the CPM said the judicial process should proceed unhindered. CPI national secretary D. Raja also wanted the law to take its own course.

### EC whip on religion in polls

HTC and Agencies New Delhi, September 10

THE ELECTION Commission today warned political parties against fanning religious passions in the run-up to the Maharashtra Assembly polls. Chief Election Commissioner T.S. Krishnamurthy said "adequate action" would be taken "if the need arose" during Uma Bharati's "Tiranga Yatra" that enters Maharashtra at the weekend.

Does he fear that Uma Bharti's yatra will vitiate the atmosphere? Krishnamurthy said: "The state has enough powers. We do not proceed on assumptions. When the problem comes, adequate action will be taken either by the state government or by the EC if there is need."

"Religious sentiments should not be used for political purposes. This applies to all political parties. There are enough provisions in the IPC to proceed against (violators) if religious celebrations are patently politicised," Krishnamurthy said.

The poll panel asked all parties to follow the model code of conduct during their campaigns and to desist from misusing religious sentiments for political purposes during Ganesh Chaturthi.

Stray complaints against the behaviour of some poll observers have been worrying Krishnamurthy. His advice to such officials was: "Be neutral and unbiased", and don't become a burden on the district authorities demean themselves and the system by seeking lavish hospitality.





#### Islamic clerics welcome RSS-Jamiat talks

FFORTS to spread the feel good factor on the Ayodhya front appear to be yielding some results at last, with a host of Islamic clerics welcoming the talks between RSS and Jamiat-i-Ulema-e-Hind.

Appreciating the dialogue process, All India Muslim Personal Law Board member Maulana Mohd Yaqub Bulandshahri said the talks between RSS and Jamiat would create goodwill between the two communities and help find a solution to the vexed mandir-masjid controversy.
