Mumbai, Dec. 22: Today, there were two Zahira Sheikhs - one in court and one outside. Just as when she first named the Best Bakery killers only to go back on her testimony later.

Asked four times in court to answer the charge that she had taken money to change her testimony. Zahira replied patiently — smiling each time - invoked Allah once, but did not either admit or deny.

Outside the special court in Mumbai, the 20-year-old was a picture of firmness, issuing outright denials while in Delhi a video was rolling where an associate of Zahira's one-time tormentor, Madhu Srivastava, said she had been paid Rs 18 lakh.

When public prosecutor Manjula Rao asked Zahira the first time if she had been promised a sum of Rs 35 lakh and had received Rs 18 lakh already, she replied: "Whatever I have said in court is true because I have taken the oath to speak the truth."

The prosecution repeated the question. Zahira said: "Nobody gives anything to another person."

When judge Abhay Thipse told her to explain what she meant, Zahira replied that social activist Teesta Setalvad —

whom she has charged with forcing her to accuse innocent men in the Best Bakery killings — had also made many promises, but did not keep them.


"She said she would help me and get my bakery repaired." Zahira said. Best Bakery was owned by Zahira's family and her uncle was among the 14 who died when it was set afire during the Gujarat riots. "Is this why you have taken the money beforehand this time?" the judge asked.

"I have sworn in court that I will not tell lies. Even after death, one has to show one's face to Allah. So how can I tell a lie?" Zahira asked in return.

*"Paisa liya kya?"* the judge asked again. Zahira said it should be made known to her who had allegedly promised the money. The prosecution would resume tomorrow with the question, but once outside the court, Zahira held an impromptu news conference where she said: "I did not take money."

Replying to a query about the Tehelka video that was shown today, Zahira said: "The allegations are false."

She put them down to a conspiracy between Setalvad and Chandrakant Batthoo Srivastava, Madhu's cousin who says on the video that Zahira was paid Rs 18 lakh.

New Delhi, Dec. 22: Zahira Sheikh, the key witness in the Best Bakery case, was paid off by associates of Gujarat chief minister Narendra Modi to change her testimony in court, the news portal Tehelka claimed today.

It produced secretly filmed footage to buttress its allegation at a news conference today.

The footage with poor audio shows Madhu Srivastava, a BJP legislator, and his cousin and Congress corporator Chandrakant Batthoo Srivastava telling another corporator, Nisar Bapu, that they had paid Zahira Rs 18 lakh.

In the footage, the charge that Zahira was paid off flows from a conversation between Batthoo and Bapu. Speaking partly in Gujarati and partly in Hindi, Batthoo is quoted in the subtitles as saying: "The whole family (Zahira's) would keep going to Madhu, time and again, time and again. Do this for us, do this, our bakery will get started again, this will happen. Drove us up the wall. Then finally Madhu took the decision that let us give her the money. First, it started from Rs 25 lakh and got stuck at Rs 18 to 20 lakh. Then after collecting cash from everyone, she was given Rs 18 lakh in cash."

does not show money actually changing hands. Nor was evidence produced that the assets of Zahira and her family had bloated unnaturally since the time she made her first statement as a witness.

Tehelka's editor-in-chief Tarun Tejpal claimed "we have a lot more footage".

On March 1, 2002, at the peak of the riots in Gujarat, a mob surrounded and torched Best Bakery in Vadodara. Zahira's uncle Quasar was among 14 people roasted to death.

First, in court Zahira named persons who she alleged were involved in the carnage. She had also said Madhu was threatening her to change her testimony. On May 17, 2003, in the first of her turnarounds. Zahira claimed she was hiding from a mob and therefore did not witness the violence. Her testimony led to 21 accused being acquitted.

Tehelka claimed that Zahira was paid even before she approached Teesta Setalvad, a social activist, for help. Her testimony was crucial to Setalvad, who says she is committed to fighting for riot victims.

Setalvad has now been dubbed a villain by Zahira, who has alleged that she had forced her to name the accused. Present at the news conference, Setalvad said: "We have approached the Supreme Court for

### Recall hostile witnesses: HC

HC sets aside trial court's order


IN YET another blow to the Narendra Modi government, Gujarat High Court has ordered the recall and reexamination of the seven witnesses who had turned hostile in a post-Godhra case of rape and murder in Eral village of Panchmahals district.

Justice C.K. Buch ordered re-examination of the witnesses setting aside a Dahod sessions court order, that had rejected the application filed by Madina Biwi, the main complainant, urging a re-examination of the witnesses, according to her advocate, Siraj Malik.

Hearing a petition filed by Madina Bibi, whose daughter and niece were raped and burnt along with five other relatives on March 2, 2002, a High Court Bench — headed by Justice C.K..Buch — on Tuesday ruled that the seven witnesses, including a police constable, be recalled and re-examined.

Madina Biwi's daughter, Shabana, and niece, Suhana, were raped in Eral village and then set on fire along with five others by a rampaging mob following the February 27 Godhra train inferno. Among the 42 accused, only three were arrested, while 39 others are absconding.

During the trial of the case in a

fast-track court in Godhra, police constable Babubhai and six other witnesses had turned hostile, but the prosecution counsel did not take cognisance of it.

Madina Biwi then approached the Godhra sessions court to demand a re-examination of the witnesses who had turned hostile.

The Godhra sessions court, too, declined to order a re-examination, following which Madina Biwi filed her petition in the High Court.

### Chandy sorry for 'Gujarat' Adeletion

THIRUVANANTHAPURAM, Sept. 17. — Kerala chief minister Mr Oommen Chandy today apologised for deletion of the word "Gujarat" from the National Anthem in some textbooks in the state. "The mistake in some of the textbooks was unfortunate. I am offering my apology on the government's behalf if anyone's feelings are hurt by the inadvertent error," Mr Chandy said here. As soon as the error was brought to his notice yesterday, a "correction erratum" was issued and circulars sent to all schools to include the missing word in the Anthem. New textbooks had been printed, a copy of which was sent to Gujarat chief minister Mr Narendra Modi. He said it was unfortunate that a false campaign about the state was going on in Delhi and Ahmedabad for the "admitted error" even after corrections were issued. Earlier, the RSS joined the Gujarat-omission issue with spokesman Mr Srikant Joshi in Coimbatore saying it was a "deliberate act". Miss Uma Bharati, in her Akola leg of the Tiranga Yatra, said the lapse reflected the damage Mrs Sonia Gandhi's nationality was inflicting on national interest. She also went on to say that the UPA government was being run by MNCs. Dismissing the BJP's salvo against the Kerala government for the omission of the word "Gujarat", the Congress today said the BJP's line "again betrayed its politics of deception".

IPS officer exposes Gujarat's ugly face

The Narendra Modi government is under increasing pressure and from quarters which they never expected. Modi believed he had the police force and the judiciary in Gujarat well under his thumb, and the political aspect in anti-Muslim pogroms would never come to light. But slowly the pieces of the jigsaw puzzle are coming together and the accusing finger is firmly pointing at Modi and his cohorts for instigating the murder and rape of about 2,000 Muslim victims in Gujarat. Modi and the BJP have used the Gujarat police force in both protecting the Hindu mobs while they committed murder and rape, and then helping to destroy evidence of the crimes with mass burnings and burials. The police have played a large part in hindering victims by refusing to accept FIRs or distorting them so that the real names are suppressed. Neither have they carried out proper investigations, so that a case would appear poor and get thrown out by courts. Thanks to the Supreme Court which has repeatedly indicted the police for their biased and improper action, more than 2000 cases which were closed due to lack of evidence have been forcibly reopened.

Now an upright officer of the IPS who headed the state's Intelligence department during the month long carnage has deputed before the Nanavati Commission giving explosive evidence of Modi and other BJP leaders' connivance in the pogrom. ADG Shreekumar has debunked the "conspiracy" theory of the Godhra train carnage — a "sudden" quarrel at the railway station. This was the initial explanation of the vendors of Godhra station but the BJP government refused to accept it, as they were looking for a "sinister" motive. Shreekumar makes the point and states that police inspectors were taking orders directly from political leaders, ignoring their senior officers. He has confirmed lack of proper recordings of investigations by lower level police officers. The picture that Shreekumar exposes of the Gujarat police is frightening. They are totally communalised and conspicuously lack any moral fibre to do their duty. The blame is due solely to the BJP which has virtually ruled Gujarat for a decade and a half.

### New probe to dig out Godhra truth

### Centre sets up panel parallel to Modi's

MORE THAN two-and-a-half years after the Godhra carnage, the UPA government today announced a high-level probe into the tragedy over and above the one set up by Narendra Modi. Railway Minister Laloo Prasad Yadav had promised such a probe; the final decision was taken at a Cabinet meeting chaired by Prime Minister Manmohan Singh.

The new inquiry into the fire on the Sabarmati Express that killed 59 people on February 27, 2002, will be headed by a retired Supreme Court judge, Justice U.C. Banerjee. The committee is to submit its findings within three months. It will examine all the aspects of the incident apart from ascertaining the precise cause of the fire in coach S-6. The panel will inquire into the acts of commission or omission responsible for the fire, and fix responsibility on railway officials and workers, including security staff, for neglect or default leading to large-scale loss of life and property. That apart, the probe panel is expected to inquire into the developments on the Sabarmati Express after it left Muzaffarpur on its way to Godhra.

Apparently, the Centre decided to set up a committee as against a commission of inquiry to pre-empt accusations of constituting a parallel commission. The Narendra Modi-led BJP government in Gujarat has already appointed the Nanavati Commission "to go into the facts, circumstances and course of events of the incidents that led to the setting on fire some of the coaches of the Sabarmati Express train".

sion's terms of reference more or less preclude an inquiry into whether the fire was an accident or whether enhanced railway safety measures might have prevented the fire from breaking out and spreading.

Significantly, Gujarat's Forensic Science Laboratory report, dated May 15, 2002, concluded that no inflammable fluid was thrown into coach S-6 from outside — neither "through the door of the bogie" nor through the windows, which "were closed during the time of the fire".

The Centre's latest move comes at a time when the Modi government has come in for a lot of flak from the apex court for its lackadaisical investigations into the riot cases that followed the Godhra killings.

Apex court picks prosecutor In Best Bakery killing case



THE Supreme Court on Monday appointed P.R. Vakil special public prosecutor in a Mumbai court in the Best Bakery case.

Mr Vakil was one of the four public prosecutors suggested by the Maharashtra government.

On April 12, the court had directed shifting of the trial in the bakery massacre case outside Gujarat, but the trial could not commence since there was a dispute between Maharashtra and Gujarat over appointment of public prosecutor.

The court shifted the case outside Gujarat on an application by Zahira Shaikh, one of the survivors of the mob attack on the Best Bakery at Vadodara during the post-Godhra riots in 2002. In the gruesome incident 14 people were killed, including nine family members of Zahira.

A Bench comprising judges Arijit Pasayat and H.K. Sema also appoint ed Manjula Rao as associate public prosecutor to assist Mr Vakil in conducting the trial. The Bench asked the Gujarat government to explain within four weeks its steps against those intimidating witnesses in the case. Finding that seven of the 21 accused had not yet surrendered before the trial court as per its April 12 judgement, the Bench also issued notice to them asking why it should not start contempt proceedings against them for not surrendering before the trial court.

Meanwhile, Gujarat's director general of police Arun Kumar stated in an affidavit that the process of attaching the properties of the seven absconding accused was on to secure their presence at the trial.

The affidavit was filed in response to a directive asking him to investigate the steps taken to arrest them. The police chief said despite sincere efforts by the state police, the accused could not be arrested and the police, therefore, decided to attach their properties. -IANS

Bilkis hopeful of justice now


AHMEDABAD, Aug. 8. — Accusing the Gujarat government of failing to protect Muslim women, Bilkis Bano, gangrape victim during the post-Godhra riots and sole witness to the massacre of her 14 relatives, today expressed hope that justice would be done now as the trial has been shifted to Mumbai by the Supreme Court.

In her first press conference since the incident occurred on 3 March 2002 in Dahod district, Bilkis claimed that there were cases similar to hers in the post-Godhra communal riots and that her case may pave way for them to seek justice.

"Was it not the state's responsibility to protect us and should it not compensate us for the incident? Now that the Supreme Court has taken up the matter, I hope the question about compensation and impunity for sexual violence will also be addressed," she said.

Bilkis said the main reason for her applying for the case to be transferred outside Gujarat was due to the threats received by her, her relatives and the witnesses.

On being asked why her police statements varied, as claimed by Gujarat police, and the reason cited by them for dropping investigation of the case, she said the police had taken her statement twice and warned her not to name anybody. "I gave my first police statement on 4 February and they said they were taking me to a doctor who might inject me with poison if I gave any names. Then I went to a relief camp and my statement was again recorded and my thumb impression taken. I am illiterate and do not know what they wrote in the complaint," she said.

Unlike the Best Bakery case, which has been caught in a legal web over which of the two state governments should appoint the public prosecutor, the Bilkis Bano case may face no such hurdles as the CBI would be the prosecutor in this case as per the apex court order.

VHP activists raped a pregnant Bilkis Bano and killed her 14 relatives in a village of Panchmahals district. The case was closed by the local police even after Bilkis identified her rapists and the killers. The police claimed that the accused named by her were "eminent people of the area" and that there were inconsistencies in her statements.

The case was reopened after the Supreme Court in December ordered a fresh probe by the CBI following intervention by the National Human Rights Commission (NHRC) at the insistence of some local NGOs. Within a month, the CBI unravelled the case and arrested about a dozen people, including policemen, who had connived with the accused in tampering evidence. One doctor couple was also among those arrested by the CBI for tampering evidence.

During its probe, the CBI recovered some beheaded skeletons from a riverbed and stumbled upon evidence that about 60 kg of salt were used in the burial to ensure speedy decomposition of the bodies.

The Supreme Court today also stayed the trial in cases pertaining to the massacre of 110 people in Naroda Gam and Naroda Patiya during the riots as a petition sought their transfer outside the state as well.

Movie models villain on Modi, gets banned

MICHAEL MOORE'S violently anti-Bush film Fahrenheit 9/11 made it past the censors to rule the box office across America. But the Indian censors have banned a Hindi film romance simply because the villain may have been modelled on Narendra Modi.

Set against the backdrop of the 2002 Gujarat violence, *Chand Bujh Gaya* depicts a morally challenged, violence-per-petrating chief minister, who even looks like Modi. That has been enough for the Central Board of Film Certification, commonly known as the censor board, to reject it.

With the Film Certification Appellate Tribunal agreeing with the board. the 140-minute movie which stars Aamir Khan's brother Faisal and is directed by Sharique Minhaj - is unlikely to

The filmmaker has decided to move court, but members of the tribunal say they are confident it will make no difference. "The entire film is an aberration. ### Questions of life and death

AHMEDABAD, JUNE 27. Almost a fortnight after the elimination of four alleged Lashkar-e-Taiba operatives in Ahmedabad, the big question isn't about their guilt or innocence. It is whether the encounter was a genuine response to an imminent attack — or a cold-blooded execution.

On the face of it, several parts of the Gujarat Police narrative on the June 15 encoundon't make sense. According to the Ahmedabad Crime Branch, the four suspects were interdicted at Himmatnagar, on the bypass that skirts Gujarat's principal city. The route is used by most traffic approaching Ahmedabad from Maharashtra. Assistant Commissioner of Police Narendra Amin, who led one of the ambush groups, later told journalists that the shootout lasted some 30 minutes.

Critics note that this account leaves several key questions unanswered. The light blue Indica car used by the four alleged terrorists would have taken at least four and a half hours to reach Ahmedabad from the Gujarat border. near Vapi. This leaves open the question of why the police waited to ambush the vehicle until it almost entered the city. Nor did the police find in the car the Rs. 5 coupon its occupants would have purchased to use the toll bridge near Sarkhej, just short of the city.

None of this, however, is conclusive. The Ahmedabad Crime Branch could have waited to execute the ambush in their own jurisdiction, reluctant to share credit with another police district. The toll coupon could have been thrown out of the window after purchase, something many drivers do. While ACP Amin's claims of a half-hour encounter seem overblown, since the first bullets directed at the Indica would have claimed the lives of those inside, those who have faced fire know the Juration of the engagement often appears longer than it actually

Whatever the truth, though, the fact is the Gujarat Police carry part of the blame for their current crisis of credibility. Thirteen suspects held in an earlier alleged assassination attempt on Chief Minister Narendra Modi were dis-

charged after the killing of key suspect Samirkhan Pathan, on whose confession the prosecution had been based. The Ahmedabad Crime Branch also faced embarrassment after the Jammu and Kashmir Police blew open its claims that several city residents had collaborated in the storming of the Akshardham Temple.

It is also true that since at least 1999, when the hijacking of Indian Airlines flight 814 to Kandahar forced India to release top terrorists Mohammad Masood Azhar, Sayyed Omar Sheikh and Mushtaq Zargar, police forces across India have been reluctant to take Pakistani nationals prisoner. In the absence of a political decision on not negotiating with hostage-takers, holding high value terrorists poses problems. Then, despite years of debate on police modernisation and reform, forces on

the ground do not have access to the kinds of technology needed to secure convictions.

On top of it all, India has no witness protection programme. As such, anyone deposing on a terrorist crime does so at considerable risk to his or her life. All of this has manifested itself in a dismal conviction rate in terrorismrelated offences: less than 50 people have been convicted for the tens of thousands of civilian deaths in Jammu and Kashmir and Punjab. "Policemen on the ground are finding that law and order are sometimes in opposition," argues a senior official, "but no one seems to be talking about the structural reforms that are so desperately needed.'

What is known about the Ahmedabad case does not enable an unequivocal finding of fact. Advanced forensics could settle the questions: tests exist, for example, which could establish whether any of the four accused fired a weapon during the shootout.

What the controversy has underlined is the need for a transformation of the criminal justice system: a process that needs both cash and political will, commodities conspicuous by their absence.

### Lashkar fishes in troubled waters

AHMEDABAD, JUNE 26. Like most young people her age, Ishrat Jehan Raza occasionally Jehan Raza occasionally cruised the internet. If the Gujarat police are right and the Mumbai college student who was killed in Ahmedabad on June 15 was a Lashkar-e-Taiba operative, she would most certainly have seen a graphic imon the organisation's website: riot survivor Qutu-buddin Ansari begging for his life. Underneath the image, the Lashkar's site designer added a slogan: "don't you think he should have a gun?"

Like most things to do with the organisation, the Lashkar's plans for Gujarat are no secret. Ever since the pogrom of 2002, the organisation has been publicly calling on Indian Muslims to join its lihad.

In an article published that year on the Lashkar website, its political head, Hafiz Mo-hammad Sayeed, asked "the Muslims of India that they themselves rise up for their protection."

"Only Jihad," he continued, "is the defence of the op-pressed Muslims. The riots have proved that the Hindus are fully armed but the Mus-lims are badly ill-equipped to cope with such a situation."

Almost two weeks after the controversial encounter that

By Praveen Swami claimed Ishrat's life, along Javed Sheikh and two Pakistani nationals, it is still unclear just what motivated the young college student to join the ranks of the Lashkar. That she did so, in at least some peripheral form, seems probable. Evidence has emerged that Ishrat maintained telephone contact with Javed, and that code-names entered in her diary match those in a separate register maintained by her associ-

targets, offer at least some clues to her motivation. Leaders widely believed to be at the cutting edge of anti-Muslim political mobilisation received particularly venomous no-menclature. Bajrang Dal leader Vinay Katiyar is referred to as 'Kutta,' or dog; Vishwa Hindu Parishad demagogue Dr. Praveen Togadia as 'Tingu,' or dwarf. Guiarat Chief Minister Narendra Modi is coded 'Mubarak,' or congratulations — a reference, perhaps, to the sentiments the Lashkar would pass on to his assassins.

Ishrat's sentiments mirror those of some youth who were failure to deliver justice during or after the violence in Gujarat. Mr. Sayeed's article taps this anger, arguing that "the only way for the Muslims of India is to organise their movements [sic.] for liberation. There is no other way out." "Why to die other way out." "Why to die helplessly?" the Lashkar chief asks. Some have been listening. Since the Gujarat riots, evidence has emerged that the Lashkar has succeeded recruiting several — perhaps dozens — of young people from the State and elsewhere.

Apart from six men known to have trained with the Lashkar in Poonch, the investiga-tion into the assassination of former Gujarat Home Minister Haren Pandva threw up a mass of evidence on recruitment by Islamist groups in Gujarat. Residents of the State working in West Asia are major targets.

Key figures in such recruitment include Abdul Bari, a Hyderabad resident last seen in Saudi Arabia operating under the nom de guerre Abu Hamza.

Javed, like several of those involved in recent terrorist crime, is believed to have been recruited on the second of two visits to Oman.


It would, however, be facile to link recent recruitment only to the Gujarat pogrom. Lash-kar recruitment outside Jam-

mu and Kashmir dates back to the immediate aftermath of the demolition of the Babri Masjid in 1992, when the organisation won several recruits.

Ishrat's neighbourhood, the Thane ghetto of Mumbra, has a strong subterranean tradition of support for the Lashkar, underpinned by the influence of local Ahl-e-Hadis seminary the sect from which the ter rorist groups derives its religious legitimacy. As early as 2000, four top Lashkar terrorists were arrested in Mumbra. along with local sympathisers.

Religious organisations such as the Tabligh-i-Jamaat and the Ahl-e-Hadis have cashed in on the climate of fear generated by decades of anti-Muslim violence, emphasising communal separateness.

From this ideological foundation, violence is for some just a small step away.



### **Gujarat Lashkar conspiracy was infiltrated by Intelligence mole**

AHMEDABAD, JUNE 25. Claims by the Gujarat Police that four Lashkar-e-Taiba terrorists killed in an encounter last week intended to execute an attack on the Chief Minister, Narendra Modi, may have been overblown. An investigation by The Hindu has found that the group was indeed engaged in reconnaissance for a suicide-squad attack on Hindu fundamentalist leaders — but the mission was monitored by intelligence agencies at each stage and infiltrated from its outset.

Last week's encounter on the outskirts of Ahmedabad, along with a separate encounter in Mumbai which claimed the lives of alleged Lashkar operatives, Adnan Kirmani and Anwar Illahi, was the outcome of a four-month-long covert operation by the Intelligence Bureau. The operation was sparked by a letter discovered on the person of the Lashkar commander, Ehsan Illahi, who was eliminated along with six other terrorists in a shootout at Andarwali Dhoke in Arai, in the border district of Poonch, on February 20 last.

Authored by Haji Sadiq Ahmad, a Poonch resident held in the Ahmedabad Central Jail for his role in a related 2003 terrorism-crime, the letter provided the Intelligence Bureau considerable insight into the Lashkar's pan-India apparatus. In the light-blue inland letter, written in Urdu, Mr. Sadiq Ahmad asked for Rs. 2 lakhs "to get ourselves freed from here." He proceeded to name suspected Intelligence Bureau sources in Poonch, and asked Ehsan Illahi for his intercession to

help four Lashkar recruits from Hyderabad to escape a police dragnet.

Most important of all, though, Mr. Sadiq Ahmad's letter mentioned the name of a key member of the Lashkar's support network in Gujarat — a lawyer. It turned out he was peripherally involved in transporting six Ahmedabad men to Poonch for training with the Lashkar in 2003. One of the six, Munir Ahmad, died in an encounter while the others made their way across the Line of Control. A Poonch resident who operated a transport business in Gujarat, Latif Khan, was subse-

quently held for his role in the affair,

It turned out that the lawyer's elderly mother had passed on information, during questioning, to the Ahmedabad Crime Branch on the group of six. Mr. Sadiq Ahmad's letter made it clear that the Lashkar knew of this betrayal. It is most likely that the Ahmedabad police told the lawyer that the score would be settled. After some persuasion, he turned and began cooperating with the intelligence agency. The Intelligence Bureau's Ahmedabad station now took charge of their new-found mole, and began using him to lure Lashkar cadre to Gujarat.

In essence, the operation was simple. The lawyer was instructed to tell Javed Sheikh, a Pune resident who was among those killed on June 16, that the infrastructure was in place to execute an attack on Mr. Modi. Much of their subsequent

dealing was conducted through Ishrat Jehan Raza, a Mumbai college student whose killing sparked off furious protests. Police officials in Ahmedabad now have in their possession records of several calls she had made to Javed from Tavakkal Communications, a public telephone centre in Mumbra, where she resided.

By early May, Javed had requisitioned two suicide-squad members to launch the actual attack. The Border Security Force's in-house intelligence wing, the General Branch, picked up signs of the movement in mid-May. Its signals intelligence staff intercepted coded wireless communications asking two Lashkar cadre to report to a handler in Udhampur, near Jammu, and then proceed to their final destinations. New Delhi was referred to as Rajdhani, and the final destination, Ahmedabad, as Manzil.

Informed official sources say that both suicide-squad volunteers had served upwards of a year in Jammu and Kashmir. Jishan Johar, a resident of Gujaranwala in Pakistan, had operated in the Bandipora area while Amjadali Rana, who hailed from Sargodha, worked with a Lashkar unit in the Reasi area. Rana also held fake identification papers issued by an executive magistrate from the mountain town of Mahore. Like the Lashkar operatives who carried out the earlier attack on the Akshardham temple in Gandhinagar, the terrorists probably hoped to reach Ahmedabad just days or hours before the intended assault.

In this case, however, there was no target: just a police ambush.

### Gujarat cops find terror trace in 'Ishrat diary'

THE CONTROVERSY over the "encounter death" of 19-year-old Ishrat has taken a new turn with the Gujarat police coming up with "Ishrat's diary", claiming it contains clinching evidence of her terrorist links.

Analysis of some coded entries in the diary and subsequent checks have conclusively proved that Ishrat had been to Ahmedabad at least once before and had received money to pass it on to terrorists, assistant commissioner of police D.G. Vanjara said. Ishrat and Javed had reached the old city on May 15 and checked in at Shiv Ganga Hotel under assumed names, he claimed. Interrogation of the hotel receptionist,

who was shown photographs of the slain "terrorists" had revealed they had checked in as "Abdul Rehman and wife". They had visited the city for a reconnaissance of the houses and offices of "target VVIPs" mentioned in the diary in a coded form, Vanjara added.

Recovered from the "terrorists' car", the diary apparently indicates Ishrat had received Rs 4.80 lakh, from which she gave Rs 1.06 lakh to Salim, one of the two "terrorists" of supposed Pakistani origin.

Asked why the police

took so much time to come up with the "evidence" though the diary

had been found on June 15 itself, Vanjara said, "We can't reveal every-

thing until investigations are complete."

The police also backed up the "evidence" with a taped "confession" of Ishrat's mother Shamima, grilled by the crime branch when she had come to collect her daughter's body. Shamima has already claimed she made her statement under pressure.

The Congress on Friday sought to link the timing of the encounter with the political predictions of chief minister Narendra Modi. The central leadership which was inclined to go with the Gujarat PCC's stand on the issue also sought the intervention of the National Human Rights Commission.

### Plot' to kill Modi foiled

THE CITY police today claimed it had foiled an imminent attempt on Chief Minister Narendra Modi's life by gunning down four persons, including a woman, allegedly linked to the Lashkar-e-Tayeeba (LeT).

Joint commissioner of police P.P. Pandey said two of the slain militants, Jishan Johar and Amzad Ali, were Pakistanis, while the third, Javed, hailed from Pune. The identity of the woman has not yet been established. But the commissioner hinted that she might be an Indian.

An AK-56 rifle, two imported pistols, a satellite telephone, two mobile phones, cartridges, magazines and more than Rs 2 lakh in cash were recovered from the slain persons' car.

On what led the police to believe the gang's mission was to eliminate Modi, Pandey said it was based on intelligence inputs. He refused to answer a question on why there was an encounter whenever Modi faced a politi-

city on being tipped off that the militants were likely to head for Gandhinagar from Vadodara. As soon as the Indica car was spotted at the Narol crossing around 4.30 in the morning, the police gave it a hot chase. It was stopped at a barricade set up on the way to the airport.

The militants opened fire on the police vehicles blocking the road towards Gandhi-

nagar, as the policemen hot on their chase shot at the Indi-ca's tyres, Pandey said. Soon afterwards, the mili-

tants were surrounded from all sides and killed after gunfire. Interestingly, no policeman sustained injuries in the crossfire.

Pandey also said that the terrorists had reportedly done a recce of the chief minister's residence, office and the routes he usually takes.

### BJP weighing sack for Modi, says Atal HT Correspondent & PTI New Delhi, June 13

A DAY after admitting the Gujarat riots had led to the poll debacle, A.B. Vajpayee today dropped another bombshell by saying next week's BJP national executive meeting in Mumbai will discuss sacking Narendra Modi as chief minister.


The former Prime Minister also confirmed what had been widely speculated earlier: that he wanted to sack Modi but had yielded to the hawks in the Sangh Parivar.

Indications are that the BJP leadership may be toying with the idea of removing Modi before the Assembly polls in Maharashtra in September.

"We are thinking afresh on the situa-tion in Gujarat. The matter will be considered at the Mumbai meeting (on June 23-24) of the national executive. All kinds of decisions can be taken," Vajpayee said. Asked if the BJP could rethink the issue of sacking Modi, he said, "We have to see what will be the losses and gains in that. We will have to have new policies.'

Vajpayee confirmed that after the ris, "there were two opinions (in the BJP) on the question of removal of Modi. Some people wanted his removal. I was of the same opinion. But the entire responsibility was put on me and I had to take a decision keeping in mind all shades of opinion. I felt that holding elections would be more beneficial.

Asked if the decision not to sack Modi had been the wrong one - and if the party had suffered because of it—the former PM replied, "On this also there were different opinions. But we did not realise that this strategy would be exploited so much outside Gujarat. The kind of films that were distributed... the



whole thing was run like a campaign.

He agreed it would have been better to have sacked Modi. "But after the event, such debates are academic in nature and it does not change the situation."

### Prosecutor row hits Bakery retrial

THE BEST Bakery retrial, shifted to Maharashtra from Gujarat by the Supreme Court, was adjourned for two weeks hours after it opened today as the two state governments fought over which of them should appoint the public prosecutor.

Late at night, Gujarat appointed a prosecutor of its choice without it being immediately clear whether Maharashtra or the trial court would accept the appointment. Nor was it clear whether the state had sought the opinion of the riot witnesses on the appointment, as directed by the Supreme Court. The apex court had earlier said the prosecutor at the original trial in a Gujarat court had

At the opening of the retrial this morning before Mumbai sessions judge Abhay Thipsay, both Gujarat

and Maharashtra sought time to appoint a public prosecutor, interpreting the Supreme Court directive in their own way.

Thipsay, appointed to hear the case by Bombay High Court, observed that "there cannot be two prosecutors for one case". He adjourned the hearing till June 21 and asked the two states to settle the issue between themselves by then. He reminded them of the Supreme Court directive that the opinion of the witnesses must be sought on this.

Later in the evening, Gujarat unilaterally announced the appointment of Vadodara-based lawyer Atul Mehta as public prosecutor in the case. State Law Minister Ashok Bhatt told HT that Mumbai-based lawyer T.S. Nanavati will assist Mehta.


THE BJP top brass today virtually put Narendra Modi on notice though it publicly backed the Gujarat chief minister and warned the rebels

### Modi threatens to resign in bid to quell dissent

Gandhinagar: In a bid to arrest the dissidence, which has now assumed gigantic proportions, Narendra Modi on Wednesday threatened to resign and recommend dissolution of the state assembly. The threat was delivered just after the weekly cabinet meeting ended with most ministers still within earshot and carried further when Modi met MLAs individually later.

Referring to the large number of MLAs meeting state BJP chief Rajendrasinh Rana in Ahmedabad to complain against him, Modi was quoted angrily asking the ministers, "What is all this happening? If the MLAs do not have confidence in me, then I will resign". A senior BJP MLA said Modi repeated the threat later during a meeting with MLAs individually, pointing out that many of them had been elected because of him.

Dissidence has been mounting after the results of the Lok Sabha polls were announced and has gained momentum during the last three days. Matters came to a head on Monday evening, when Modi abruptly closed a BJP legislature committee meeting after 25 MLAs stood up to air their grievances. BJP MLAs have been virtually behaving as opposition legislators in the state assembly whose session is presently on.

Rumblings in the state assembly began immediately after the cabinet meeting ended. There were also reports that ministers I K Jadeja, Ashok Bhatt and Amit Shah, who are Modi's men had been given the job of obtaining signatures from MLAs in support of Modi.

Throughout the day, very few BJP

Throughout the day, very few BJP MLAs were present in the state assembly. Finance minister Vajubhai Vala had to send frequent reminders to both ministers and MLAs to listen to the debate on the budget but none seemed interested. In the last few days, BJP MLAs were behaving as if they were opposition legislators during assembly proceedings.

The MLAs on Wednesday were huddled together at various places, including the chamber of BJP chief whip Jitendra Sukhadia, MLAs' lounge and MLAs' quarters. Some of them were also seen at the Circuit House annexe in Ahmedabad to meet state party chief Rajendrasinh Rana. According to one BJP MLA, on Tuesday alone about 35 MLAs had met Rana, taking the total number to 85.

Wednesday's developments took shape after senior BJP leaders Suresh Mehta, Kashiram Rana and Rajendrasinh Rana held a meeting at Keshubhai's residence late on

Tuesday evening to discuss the political developments and whether it was time to further step up the offensive against Modi.

Mehta is leaving for Delhi to apprise the central leadership about the deepening political crisis. On the other side, some Modi loyalists have started collecting signatures of MLAs in favour of the chief minister.



### Modi socked again, SC calls him arrogant

HE Supreme Court deliverd another blow to the Narendra Modi government in Gujarat when it said, "it appears to be arrogance on the part of the state" to seek a review of the Best Bakery judgement.

The remarks came while the apex court reserved its verdict on the maintainability of Gujarat government's plea seeking review of an earlier judgement transferring the Best Bakery case trial to a Maharashtra court. Miffed at the plea of the state that the apex court did not have jurisidiction to transfer the trial suo motu, a bench comprising Justice Doraiswamy Raju and Justice Arijit Pasayat came down heavily on the government and questioned its plea to expunge certain remarks against the state.

Additional solicitor-general Mukul Rohtagi, who appeared for the state, was at loss of words as both the judges went on castigating the manner in which the applica tion seeking review was drafted. The Bench had in its judgement had compared the Gujarat government officials to the modern day Neros, who looked the other way when the innocent were burning during the trial. The state is seeking expungement of this and similar other observations of the court in the judgement. The Bench said "we never tried to identify the persons. It is after the judgement that they are trying to identify them-seves with the act. This is a case of arrogance on the part of the state. When Rohtagi apologised for "hurting the sentiments" of the Judges, there was more in store for him. "If at all you have hurt something, it is this institution and the profession.'

The court wanted to know from the government as to who has filed the affidavit along with the review application as it had been averred that the Court did not give proper opportunity to the State and also whether he was present during the hearing of the appeals filed by the State and key witness Zahira Shaikh. Warning the state that it cannot "browbeat the Supreme Court like this", the Bench said: "If this happens to the SC, we shudder to think what will happen to the High Court or the subordinate courts."

### Too late to check jailbirds: Apex court

THE SUPREME Court today stayed a Patna High Court order directing the Election Commission to countermand polls in constituencies where candidates have been disenfranchised due to their being in jail, saying it was too late to be implemented.

"When the elections have reached the last stage, the directions of the high court are not practicably implementable," observed a three-judge bench of the apex court headed by Chief Justice S Rajendra Babu while admitting EC's appeal against the April 30 high court order.

However, the court agreed to consider the basic question of whether an



whether an undertrial prisoner, who has no right to vote, can contest an election. Appearing for the EC, counsel K K Venugopal assailed the Patna high court order saving

### Best Bakery case: Gujarat

**NEW DELHI, APRIL 21.** The Gujarat Government today moved the Supreme Court seeking modification of the April 12 judgment shifting the Best Bakery case for retrial to Maharashtra.

In the light of this development, the Additional Solicitor-General, Mukul Rohatgi, appearing for the Gujarat Government, pleaded before a three-Judge comprising the Chief Justice V.N. Khare, Justice S.B. Sinha and Justice S.H. Kapadia for deferring the hearing of the petitions seeking transfer of other post-Godhra riot cases for hearing outside Gujarat.

The Bench acceded to the request and posted the petitions filed by the National Human Rights Commission (NHRC) and some others seeking transfer of 12 most sensitive cases for hearing on August 3. The Bench issued fresh notice to the accused in these cases and asked the office of the Director-General of Police, Gujarat, to ensure

that the notice was served on all the accused. Notice was also directed to be served on those who had not been served so far in pursuance to an earlier notice issued by the court. The Bench gave four weeks to the accused to respond.

Mr. Rohatgi submitted that unless the modification application of the State Government was heard and disposed of, the plea of transfer in respect of 12 sensitive cases had to be deferred. He submitted that in the appeals before a Bench of Justice Doraiswamy Raju and Justice Arijit Pasayat, the issue of transfer of trial outside the State was never prayed for nor argued. He said the Bench went beyond the scope of the prayer in both the appeals while shifting the trial to Maharashtra.

In the application, the Government submitted that the only question that was argued before the Bench was whether or not the Gujarat High Court should have permitted the Government to adduce additional evidence for acciding the culpability of the

21 accused in relation to the death of 14 people. While so the Bench had ordered shifting of the case to Maharashtra.

The application also sought expunging of certain portions of the judgment, which said, "the modern day Neros were looking elsewhere when Best Bakery and innocent children and helpless women were burning and were probably deliberating the perpetrators of crime could be saved or protected."

The application prayed for shifting the case back to the same sessions court in Vadodara or some other sessions court and the Chief Justice of the Gujarat High Court could monitor the re-trial.

The Bench headed by the CJI also issued notice to all the States and Union Territories on the question of witness protection returnable by July 12. The court asked the Centre to come out with a draft scheme for providing protection to witnesses, who often turned hostile when threatened or coerced, resulting in miscarriage of justice.

### Large number of summary investigations in Gujarat riot cases

The Supreme Court's direction on Monday ordering a fresh investigation and trial outside Gujarat in the Best Bakery case might open a can of worms for the Gujarat Government. Already under severe pressure from the Supreme Court and the National Human Rights Commission, the State Government had submitted an affidavit to the Supreme Court on January 28, 2004, admitting that the total number of riot cases registered were 4,256 as against 3,912 mentioned in the intervention application filed on December 12, 2003 by Harsh Mandar in the NHRC vs. the State of Gujarat case (Writ Petition No. (CRI.) 109 of 2003).

In the affidavit, the Gujarat Government denied that there was "any attempt, planned, systematic or otherwise... to deny justice to the victims of the widespread communal riots that had engulfed the State in the aftermath of the Godhra incident." The document argues that it would not be judicious to shift the cases outside Gujarat because of the quantum of cases, as well as the poor financial condition of the people accused. It points to the "social implications"

cern to the apex court as well as human rights organisations is the large number of summary investigations against the cases registered. The affidavit admits that the correct number of such cases was 2,108 out of a total of 4.256. In certain cities, the number of summary investigations is almost half the number of cases registered. For example, out of the 961 cases registered in Ahmedabad city, summary reports were filed for 427 cases. In Vadodara city, 206 out of 617 cases were instances of summary investigations, while in Vadodara rural, 152 summary reports were submitted for the 242 cases registered. The statistics in Bhavnagar weigh in favour of summary reports that number 267 against the 310 cases registered.

In the case of summary reports, the Gujarat Government maintains in the affidavit that "conviction or acquittal depends on the nature of evidence furnished by the prosecution and defence witnesses, and a low conviction rate *per se* cannot lead to an inference of faulty investigation and/or weak prosecution, and certainly cannot be the ba-

sis for transferring the riot cases outside the State of Gujarat." The document also dismisses allegations of intimidation and enticing of witnesses as something not "on record" and hence not worthy of investigation.

Another reason given in the affidavit for not registering and investigating cases, especially under Section 120-B of the Indian Penal Code, was that conspiracy to riot in many instances could not be established. This was so because the "communal backlash was marked by spontaneity in response to the gruesome incident of the Sabarmati Express at Godhra."

Similarly, in cases involving members and leaders of the Bharatiya Janata Party and the Bajrang Dal, the affidavit speaks of lack of "independent and sufficient evidence."

The Supreme Court on Monday thought otherwise and indicted the judicial criminal administration system in Gujarat while transferring the Best Bakery trial to Maharashtra.

The fate of the other cases in the absence of a free and fair trial within Gujarat is a question that will eventually have to concern the Supreme Court.





### Riot retrial away from 'Neros' glare

New Delhi, April 12: The Supreme Court today brought a sledgehammer down on the Guiarat government, issuing a series of unparalleled directives that nudged the riots of 2002 back to centrestage a week before elections.

By the time the court was through this afternoon, the acquittals in the Best Bakery carnage stood quashed, a retrial was ordered outside Gujarat and those who looked the other way were labelled "modern-day Neros".

Indicting the Gujarat government of "subversion of the jus-

tice delivery system", the division bench of Justices Doraiswamy Raju and Arijit Passayat ordered the fresh trial in a "competent court" in Maharashtra.

"Keeping in view the peculiar circumstances of the case and the ample evidence on record glaringly demonstrating subversion of the justice delivery system with no congenial and conducive atmosphere still prevailing, we direct that the retrial shall be done by a court under the jurisdiction of Bombay High Court," the bench said.

The judges added: "The modern-day Neros were looking elsewhere when Best Bakery and innocent children and helpless women were burning, and were probably deliberating how the perpetrators of the crime can be saved or protected.'

The damning comments compelled the Congress to revive the demand for chief minister Narendra Modi's dismissal. The Congress has been smarting under Modi's persistent attacks on Sonia Gandhi but the party was somewhat reluctant to make the riots a campaign issue in the light of the polarisation that handed the BJP a landslide in the Gujarat Assembly election.

The Congress sought to take the issue beyond Modi and said it would cite the court censure to corner the chief minister's "patrons"—a veiled reference to the BJP's central leadership.

The BJP stood by Modi, refusing to acknowledge the judgment as an "indictment" of the Modi government. "If a witness turns hostile and alleges that she has been pressurised, how can you drag the chief minister into it?" party spokesperson Arun Jaitley asked.

Modi, who ironically was in Godhra - the fountainhead of the Gujarat carnage — was not in a pleasant mood this evening. Jignesh Parikh, a Gujarat journalist, said he was "pushed roughly" by the chief minister when approached for a reaction to the court's comments.

The Supreme Court also called into question the public prosecutor's role, removed the official and directed Maharashtra to appoint a new prosecutor.

The judgment marked a first in the history of Indian jurisprudence. The bench gave the "affected persons" the option to suggest a new public prosecutor.

"Though the witnesses or the victims do not have any choice in the normal course to have a say in the matter of appointment of a public prosecutor, in view of the unusual factors noticed in this case, to accord such liberties to the complainants' party would be appropriate," the judges said.

The judges also expunged "irresponsible" remarks made by the high court against activist Teesta Setalvad and the National Human Rights Commission. Both were instrumental in helping Zahira Sheikh, the key witness whose family members were among the 14 killed in the bakery riot, move the Supreme Court and declare that threats made her lie in the high court.

নর্মদা বাঁধের উচ্চতা ১১০ মিটার করার দাবি নর্মদা কন্ট্রোল অথরিটি মেনে নেওয়ার পর আজ নর্মদা পূজন যাত্রা শুরু করেন মোদী। যদিও শর্তাধীন অনুমতি দেওয়ার সঙ্গে সঙ্গে অথরিটি বলেছে, এই निरंग विकर्माष्त्रव कता यास्य नहीं। नरतन মোদী এই যাত্রাকে রাজ্যের উন্নয়নের সঙ্গে যুক্ত করতে চাইলেও আজ সক্মালৈ এই যাত্রার প্রারম্ভিক অনুষ্ঠানে যে ভাবে যজ্ঞ হয়েছে তা দেখে বিরোধী দলগুলি নির্বাচন কমিশনের কাছে নালিশ জানায়। অভিযোগ জানান নর্মদা বাঁচাও আন্দোলনের নেত্রী মেধা পটেকরও। এর পরই, অথরিটির দেওয়া শর্ত লঙ্খিত হচ্ছে এই যুক্তিতে গুজরাত সরকারকে নর্মদা পূজন যাত্রা বন্ধ করার নির্দেশ দেয় নির্বাচন কমিশন।

### Election Commission stops Modi in his tracks

### Angry Gujarat CM lashes out at 'Miyan Musharraf'

New Delhi/Gandhinagar: The Election Commission on Saturday suo moto banned Gujarat chief minister Narendra Modi's Narmada Pujan Yatra on the ground that the exercise verged on the misuse of official machinery for the BJP's partisan ends. The yatra, ostensibly taken out to "celebrate" the recent decision of the Narmada Control Authority on increasing the dam height, started from Ahmedabad on Saturday morning and had to be stopped about 50 km from the dam site.

An angry Modi later said the yatra had only

been suspended, not cancelled and emphasised that it would be held after the elections. "We will definitely offer our prayers to the Narmada," he said. He accused the Congress of taking the help of NBA leader Medha Patkar to stall the rally. Halted in his tracks by an Election Commission order banning his 'Narmada Pujan Yatra' on Saturday afternoon, just about 50 kms from the dam site at Kewadia Colony, an angry Chief Minister Narendra Modi ac-

cused the Congress of taking Narmada Bachao Andolan leader Medha Patkar's help to have the rally stalled midway. He again made a reference to 'Miyan Mussharraf' and referred to the Congress president as 'Begum Sonia'.

Speaking to reporters after terminating the rally at Dabhoi, Modi, who had commenced the yatra early on Saturday morning from Ahmedabad to celebrate the clearance given to the raising of the height of the dam by 10 meters, he said "we are a responsible political party and we have decided to suspend the rally for the time being as we don't want to create more trouble for the Commission." Modi emphasised that the rally had not been cancelled. "We have only suspended it and after the lection the party will surely hold it again at an op-

rtune moment. We will definitely go and offer

our prayers to Narmada after the elections.

Apparently, Modi was expecting the decision of the EC which had already warned against use of the issue for electoral gains, while approving earlier this week the Narmada Control Authority's decision to allow the height of the dam to be raised to 110 meters. There was no flutter of surprise in the cavalcade when the EC's decision was disclosed to the party members.

The chief minister also revived some of his 'Gaurav Yatra' days by attacking Sonia Gandhi

and Pakistan president Pervez Musharaf in the same breath. "There are only two persons who are not feeling good today when the rest of the world is - Miyan Musharraf and Sonia Gandhi," he told a large public gathering at Dabhoi.

He even referred to the Congress chief as Begum Sonia. "Begum Sonia came to Gujarat recently to find out what beautiful roads Prime Minister Vajpayee has built for the people of Gujarat," he said. He said

the Congress president knew that Gujarat had received approval to increase the height of the Narmada dam to 110 metres but she did not find it necessary to congratulate the people of the state.

Government oficials said the EC asked chief secretary P.K. Laheri in the afternoon to tell the chief minister to stop the yatra forthwith as it contains a political message, violating the model code of conduct. Laheri, who was busy in a meeting in Ahmedabad, told the CM about the EC order. "We received the telephone call from Laheri requesting us not to do any prayers at the Naramda dam site. We discussed the matter on receiving the telephone call. The entire Cabinet was present when this happened. The EC order was acceptable to us. We decided to wind up the yatra worthwith", said Cabinet minister Bhupendrasinh Chudasma. TNN

### Another riot mother stands up, HC listens MADINABIBI | Saw daughter raped, killed, accuses public prosecutor of bias

AFTER Zaheera Sheikh, Bilkis Yaqoob Rasool, it's Madinabibi Shaikh-slowly, Gujarat riot victims are standing up to ask for justice. And the courts are stepping in.

Madinabibi, who hid in a field with her son the whole night of March 2, 2002, and says she saw her daughter and niece being raped and later murdered along with five more relatives in Eral village of Panchama-

fals, moved the Gujarat High Court today accusing the public prosecutor of bias and requesting that the witnesses be examined again.



She told the court that the prosecutor should have declared the witnesses as having turned hostile when they suppressed information or deposed in a manner that helped the accused.

Allowing Madinabibi to produce xerox copies of the depositions of seven witnesses along with xerox copies of their statements, Justice CK Buch, while fixing the hearing for March 8, stayed ongoing proceedings before the sessions court.

The judge also asked the prosecutor to be present before the court on March 8 "so that this court can put certain questions as to his role...(in the) conduct of the trial.'

### SC order to lift, Mallika curbs

New Delhi, Feb. 16: The Supreme Court today expressed displeasure over the Gujarat government initiating criminal cases against danseuse Mallika Sarabhai "simply because she filed a petition" against the state government in the riot cases.

A three-judge bench of Chief Justice V.N. Khare and Justices A.R. Lakshmanan and S.H. Kapadia advised the state government to "see to it" that restrictions imposed on her foreign travel and surrender of passport "are removed by February 23".

The judges fixed February 27 for further hearings in the Godhra train burning case and other riot cases.

Petitions seeking transfer of riot cases outside Gujarat for trial will also be taken up for hearing on that day.

"She is not a criminal. It appears you are prosecuting her simply because she filed a petition here," Khare said.

Appearing for the Gujarat government, additional solicitor-general Mukul Rohtagi told the court that it was the trial court that had imposed the restrictions and the state government had nothing to do with it

Criminal proceedings were

initiated against Sarabhai on a complaint that she had duped several students of her dance institute in Gujarat.

Senior counsel Kapil Sibal, appearing for Sarabhai, told the court that she was being harassed by local police and "even day before yesterday, policemen went to her residence telling that either she obtained a stay from a court or the orders were to arrest her".

Expressing happiness over the apex court's order, Sarabhai said the verdict ended the "horror" she had experienced during the last few months.

"The whole case was a horror and the last two to three months was hell... It is wonderful that the Supreme Court came up with this decision without my going to it," Sarabhai said.

She said the whole case was a "horror for someone who has been working for 23 years for Gujarat and been responsible for building the state".

Taking a dig at the state government, she said that "this case was realisation of what was happening in the fascist front and how people can be nullified by terror tactics and fear".

The bench also issued a notice to the Gujarat government on a petition filed by Citizens for Justice and Peace, seeking transfer of the Godhra train carnage case outside the state.
