11 Gujarat riot accused sent to jail for life

Fast-Track Court Hands 10 Years' RI To Three Others, Acquits 18

Vadodara: A fast-track court in Godhra on Wednesday sentenced 11 people to life imprisonment for killing 11 members of a minority community in Anjanwa village of Panchmahals district during the post-Godhra riots. But 18 accused were acquitted for lack of evidence.

Fast-track court judge R D Thackar sentenced prime accused Dalpa Baria and 10 others—Kalu Soma, Kalu Sana, Bana Fata, Raising Fula, Dhana Rupa, Salam Aba, Balvant Jeeva, Natwar Kalu, Ratna Kalu and Rupa Soma—for life.

Three others—Raising Punja, Bharat Punja and Dhana Rupa—were sentenced to 10 years rigorous imprisonment for arson and rioting.

The court examined 80 witnesses before delivering the verdict. Two separate offences were registered regarding the incident. The first FIR was registered regarding arson and rioting at

Anjanwa village, the second was regarding the massacre. The case pertains to the attack on a group of members of the minority community on March 5, 2002.

The victims, represented by advocate Shiraj Malik, had



left their homes on March 3, 2002, after a mob attacked the village. The mob torched houses and shops in the village where about 40 Muslim families lived. Three women and five children were killed by the mob near the sarpanch's house and were thrown into his well.

Another woman was killed by throwing her into a dry well in the vicinity while two elderly men were burnt alive by the mob.

Gohana: Protests during bandh, parties seek probe

EVEN as violence broke out today during the Dalitsponsored Haryana bandh in response to Wednesday's arson in Gohana, political parties demanded a probe into the incident.

Some CPI(M) politburo members and the BSP chief Mayawati, who visited the site, demanded a CBI inquiry.

Led by Rajya Sabha member Brinda Karat, the CPI(M) leaders later met home minister Shivraj Patil and demanded immediate action against the police for connivance with the perpetrators of the crime.

"We have asked for immediate action against the police superintendent and the district commissioner who remained mute spectators while over 50 Dalit houses were being burnt down in Gohana," Karat told reporters.

The Scheduled Caste Commission has summoned the DGP and IG police to depose before it on September 5.

Patil promises probe

NEW DELHI: The Centre said it will "thorough ly investigate" the incide int and assured all help, including adequate compensation, to the victims. "I will spreak to the state government and the matter will be the roughly investigated," home minister Shivraj Patil said after meeting a delegation of Dellit leaders led by CPI(M) leader Brinda Karat.

Meanwhile in Panchkula, a mob attacked three buses and the national highway was blocked at several places in the state. The Sonepat-Purkhas road was blocked for an hour.

In Ambala, too, protesters demanding compensation for the victims and the dismissal of the Hooda government blocked the national highway.

In Hansi, shops and commercial establishments stayed closed and the Delhi-Hisar highway was blocked.

In Gohana, the situation limped back to normal today under strict police vigil. At the Balmiki Colony, where 30 houses were burned on Wednesday, the victims started returning to their homes and banks and business establishments reopened.

A panchayat of people belonging to the Jat and other communities demanded the withdrawal of cases against the 23 people and action against the killers of the Jat youth, Baljit Singh. The latter's death had sparked off the arson.

Gujarat rebels see hope

THE GUJARAT rebels, who have been depressed since BJP president L.K. Advani's praise of Gujarat chief minister Narendra Modi, had reasons to cheer on Tuesday, the last day of Parliament's monsoon session.

Advani invited their leader, Keshubhai Patel, for lunch, which was followed by a second round of discussions between the two leaders after Parliament adjourned sine die.

Advani's discussions with Patel came ahead of the BJP chief's meeting with Modi, who is to attend Wednesday's meeting of the Na-

tional Integration Council.

Both Advani and Patel declined to speak to the media on the issue. Advani was said to be working on a solution that might not see the exit of Modi, but certainly ensure that the decision-making process in Gujarat was made in consultation with other BJP leaders. A party-government coordination mechanism could also be considered, party sources said.

Patel is said to have explained to Advani why the MLAs were upset with Modi and what needed to be done to tone up the party affairs in Gujarat if it wished to avoid an electoral setback. Patel has been leading

the campaign against Modi, along with several dissident MLAs, who had earlier come to Delhi to air their grievances.

They had met former Prime Minister A.B. Vajpayee, senior leader Murli Manohar Joshi and some other leaders, but returned to Gujarat without meeting Advani.

Advani upset the rebels by praising Modi during his visit to Gujarat recently, although he visited Patel's residence along with Modi to inquire about his wife's health. BJP MP Kashiram Rana, who is against Modi, met party general secretary Pramod Mahajan to discuss the issue.

'Sulking' Modi minister offers to quit, BJP says Q

Comes To Party Office in Ambulance, Says He Is Mentally Tortured

Ahmedabad: The Khanpur headquarters of the Gujarat BJP on Monday evening became the venue of a political drama when the minister of state for sports, youth and cultural affairs, Bavkubhai Unghad, came in an ambulance to seek permission to resign from the Narendra Modi ministry.

After receiving Ungad's resignation, BJP president Vajubhai Vala asked Narendra Modi to drop Unghad from the cabinet.

Unghad was hospitalised after being pulled up by

chief minister at Wednesday's cabinet meeting for attending the rebels' show-of-strength at Keshubhai Patel's residence the

previous day.

However, the BJP unit chief said he had checked Unghad's allegations that he was subjected to "mental torture" at the cabinet meeting and found them to be false.

A die-hard Keshubhai supporter, Unghad became the second person to resign from the Modi cabinet.

Earlier, Gordhan Zadaphia had refused to be the part of the expanded ministry on August 1.

Unghad suffered a mild had undergone heart surheart attack after he got a dressing down from Modi at the cabinet meeting.

On Monday, he came to the BJP office in the ambulance belonging to BJP MP Harin Pathak's Madhuram Trust. Unghad's sealed letter was submitted by his nephew, Dilip Patel, to the party's office secretary Paresh Patel, as the minister preferred to stay in the ambulance.

It is learnt that the minister, in his letter, wrote: "I felt that it was my duty to visit Keshubhai's residence and enquire about the health of his ailing wife Leelaben who gery in Chicago. I have committed no crime in doing so.'

He said all the ministers and even chief minister Modi and president Advani had gone to Patel's residence and therefore it was improper for Modi and other seniors to scold him for the same

Unghad said it was painful for him to continue in the ministry in such adverse circumstances and it would be better if he was relieved of his responsibilities. The minister also sent copies of his letter to the CM and national BJP general secretary Om Mathur.

Rebels insist on Modiscalp Keshubhai leads dissidents, meets Vajpayee but skips Advani


Taking strong exception to Mathur's statement that dis-

Honda official attacked

NEW DELHI, July 29. — Close on the heels of the violence that rocked Gurgaon for two days, following clashes between workers of Honda Motorcycles and Scooters India Limited and policemen, a senior Honda engineer was assaulted today and a showroom containing the company's motorcycles was attacked.

Mr Anil Kumar Yadav, a maintenance engineer at the company's Manesar factory, was beaten up by a group of people in Sector 14 of the satellite town, the Gurgaon deputy commissioner Mr Sudhir Rajpal said. An FIR has been registered against several employees of the company. They were charged under various sections of the Indian Penal Code. No arrests had been made till late in the evening.

At least six motorcycles in a Honda showroom in Kaithal town were damaged by a group that stormed into its premises after smashing the window panes. A passerby overpowered one of the attackers while they were escaping and handed him over to the police. The arrested person is being interrogated, said police superintendent. The police is conducting raids in the town to arrest the other five involved in the attack who are reported to be from Kaithal and the adjoining Jind district.

Immediately after the attack, seven

other automobile showrooms in Kaithal downed their shutters.

The Honda workers had fought pitched battles with the police on Monday. They were agitating against the dismissal of four employees and the suspension of 50 others. Various political parties had protested against what they termed police high-handedness and alleged that many union leaders had gone missing after the police lathicharge. The Gurgaon violence, which continued for two days, has prompted the Japanese ambassador to express reservations about FDI investment in India.

In Geneva today, on the sidelines of the meeting of the WTO General Council, the commerce and industry minister, Mr Kamal Nath, and Japan's economy, trade and industry minister, Mr Shoichi Nakagawa, discussed the issue.

Mr Kamal Nath assured the Japanese minister that the Gurgaon incident is an isolated case. Mr Nakagawa said this oneoff incident would not affect Japanese investment in India. In this context, he emphasised that Japanese companies were investing in West Bengal in a big way.

Mr Kamal Nath also referred to the Special Economic Zone (SEZ) Act passed recently by Parliament and requested the Japanese government to encourage their enterprises to invest in these zones.



700 workers, several policemen injured in pitched battles in Gurgaon; strong political protests, probe ordered

GURGAON: Scores of employees of Honda Motorcycle and Scooters (HMSI) Limited fell to police blows near the Gurgaon Mini Secretariat on Monday in a crackdown that followed a violent labour protest.

Tension prevailed in Haryana as several hospitals were packed with the injured, most of them bleeding profusely.

The incident triggered strong reactions from politicans, with the Left and the BJP declaring they would raise it in Parliament on Tuesday.

HMSI workers had been on a strike for a month over wagerelated demands until most of them joined duty after an agreement with the management.

Monday's protest was by the workers who were still dissatisfied with the deal.

Earlier in the day, a clash left several policeman, including Deputy Superintendent of Police J.P. Dahiya, seriously injured after police tried to stop the stone-pelting workers from taking out a protest march, according to eyewitnesses.

Property damaged

An SDM vehicle was also set on fire by mobs, which damaged government and public property before additional police forces in riot gear pushed them back.

Protesters accused the police of high-handedness, saving they were surrounded and beaten mercilessly while they were on their way to the Mini Secretariat to hand over a memorandum to the administration.



Lathis rain on Honda workers


IN WHAT could come as a major embarrassment for the UPA government at the beginning of the monsoon session of Parliament, the Haryana police brutally lathicharged and injured more than 1,000 workers of Japanese auto giant Honda's two-wheeler unit at Manesar in Gurgaon on Monday afternoon. The employees were protesting the company's decision to retrench some workers. In the mayhem, the protesters set fire to the sub-divisional magistrate's car, a police motorcycle and attacked senior cops who tried to stop them. A DSP and six policemen were also injured.

Trouble began around 12.45 pm when the police tried to stop a protest march by around 5,000 Honda staffers. Some of them started pelting stones at the SDM's car and when the cops on duty tried to intervene, they too were attacked. The situation soon went out of hand and the police fled the scene.

Later, a posse of about 500 arrived on the scene led by SSP Yogender S Nehra. They surrounded the protesters from all sides and started beating them up brutally. In a matter of 20 minutes, over 1,000 workers lay bleeding. The injured were then packed in buses and sent to hospital.

CPI MP Gurudas Das Gupta, who reached the hospital to meet the injured workers, was manhandled by the cops. He flashed his identity card and yelled repeatedly that he was a sitting MP, but the policemen dragged him away.

Murmurs of the incident soon reached Delhi. Leader of the Opposition in the Lok Sabha, L.K. Advani, took up the issue with home minister Shivraj Patil. Congress president Sonia Gandhi, too, spoke to Patil on the issue. Later in the evening. Haryana chief minister B.S. Hooda ordered a magisterial inquiry into the incident and promised to punish the guilty policemen.

Focus on relief work in rain-hit areas

Breather for central Gujarat; heavy rain in north Gujarat and Saurashtra

GANDHINAGAR: With the flood situation showing considerable improvement in central Gujarat since Saturday, the attention is now diverted towards relief work and prevention of possible outbreak of epidemics in the hitherto waterlogged areas.

However, Bulsar, Navsari, Suat and Dangs districts in south Jujarat, Mehsana and Sabarantha districts in north Gujarat and Surendranagar and Amreli districts in the Saurashtra region continued to receive heavy rainfall (between 100 mm and 200 mm) since Saturday night. Though the water level receded in some parts of Vadodara city and some of the main thoroughfares reopened for traffic, Padra and Karjan towns in the district continued to remain under water. 6 more helicopters for relief operations

NEW DELHI: The Centre on Saturday pressed six more Air Force helicopters into service for rescue and relief operations in flood-hit areas of Gujarat.

While 150 personnel of the Central Reserve Police Force (CRPF) have been deployed in Kheda, 400 more personnel are in the process of being deployed.

A meeting of the high-level inter ministerial committee, presided over by Home Secretary V. K. Duggal was held here to re-

view the flood situation. The meeting was informed that flights between Vadodara and other parts of the country resumed on Saturday. Production in the Baroda refinery had also resumed. Nine Army columns have been deployed in the floodhit areas to assist the civil administration. Attempts are also being made to make the Express Highway operational at the ear-liest. The latest report put the death toll at 108. President A.P.J. Abdul Kalam has conveyed his condolences to Gujarat Chief Minister Narendra Modi and the people of Gujarat following the loss of lives in the floods.

Crocodiles missing from Vadodara zoo

VADODARA: As if the floods were not enough, the woes of the city's residents seem to be only increasing with crocodiles missing from the Vadodara zoo.

Even though the water started receding on Saturday, zoo officials discovered during a headcount that at least seven crocodiles, four deer and a blue bull (neelgai) were missing. The floodwaters of the Vishwamitri river had engulfed the Kamatibag

Garden on Friday. The blue bull, which jumped the fence, was sighted at a nearby hospital complex. One sambhar, which had escaped from its cage, was caught.

The Vadodara Municipal Corporation, which maintains the zoo, had to shift several birds from their cages yesterday. Some non-governmental organisations are assisting the zoo authorities in their search for the missing animals. - UNI

Gujarat rejects Pota panel's observations

AHMEDABAD, June 10. — The Gujarat government today rejected the observations of the Central Pota Review Committee (CPRC) that had recommended dropping Pota charges against all the accused in the Godhra train carnage case.

Filing its reply before the special Pota court, the state government's counsel, Mr HM Dhruv, said: "Not only there is a prima facie case under provisions of Pota but there is also more than sufficient material evidence to attract its provisions."


"Under these circumstances, I request the court to proceed further against the accused for all the alleged offences against them," special public prosecutor told the additional Pota court judge Mr BS Parikh. Detailed arguments on this reply filed by the Gujarat government would be held on 13 June.

The government's stand on the train carnage case got a jolt when the CPRC recommended that there was no need to apply the anti-terrorism law on all the accused as there did not appear to be any conspiracy and they could be tried under sections of the IPC and CrPC.

The public prosecutor stated that after careful examination of CPRC's opinion, he came to the conclusion that there is a "strong prima facie case to attract provisions of Pota in view of the relevant material on record" against the accused. He said the review committee "has not considered in detail and in true perspective the confessional statements of some of the accused given as per Section 32 of Pota" which is admissible as evidence under Pota.

Five accused identified in Bilkis case

A child witness in the case of alleged gangrape of Bilkis Bano and murder of her family members today identified five of the 12 accused in the special court during an in-camera trial, adds PTI from Mumbai. Special public prosecutor Mr RK Shah said Saddam (11), who was only eight at the time of incident, told Special Judge Mr UD Salvi that the accused were from Randhirpur and that he had seen them.




Rane to be sworn in as Goa CM today

PANAJI, June 6. — Newlyelected Congress Legislature Party leader Mr Pratapsinh Rane will be sworn in as chief minister of Goa tomorrow morning after he presented a letter of support from Congress allies, the NCP and the MGP, to the Governor, Mr SC Jamir, this evening.

"We have presented letters of support from the NCP and the MGP to His Excellency this evening and staked our claim to form the government. The swearing-in ceremony will be held tomorrow at 10 a.m.," Mr Rane told reporters outside Raj Bhavan as he and PCC chief Mr Ravi Naik emerged from their meeting with Mr Jamir.

Mr Rane parried questions on who would be included in the ministry tomorrow along with him, saying: "You will know tomorrow." The names doing the rounds for possible ministerial berths tomorrow are NCP chief Mr Wilfred d'Souza who is likely to be given the post of deputy chief minister and his partymate Mr Francisco "Mikky" Pacheco. Earlier, the AICC general secretary in-charge of Goa affairs, Mrs Margaret Alva, said the Centre would revoke President's Rule and revive the Goa Assembly, currently under sus-

pended animation, by tomorrow morning.

"We informed the Governor of the position yesterday and he asked us to go ahead and choose a leader because he had already sent a report to the Union home ministry regarding the changed situation in Goa," she added.

BJP MLAs challenge disqualification in SC

Meanwhile, two BJP leaders Mr Rajender Arlekar and Mr Dayanand Mandrekar from Goa today approached the Supreme Court challenging the Bombay High Court judgment disqualifying them as MLAs, a report from New Delhi adds.

Senior advocate Mr Mukul Rohatgi mentioned the petition on behalf of the two leaders before a Bench comprising Mr Justice PV Reddi and Mr Justice Arijit Pasayat, which said the matter will be considered before the vacation Bench.

The Panaji Bench of Bombay High Court had set aside the election of the two BJP MLAs on grounds of holding office of profit during the May 2002 Assembly polls.

Goa in Cong kitty, SP enters South

NEW DELHI, June 5. — Congress today stormed back to power in Goa, where it had come under attack during the turmoilset off by the resignations of three BJP MLAs three months ago, and made a clean sweep of the three by-elections in Haryana, but suffered a rude shock at the hands of the Left in Kerala, the TDP in Andhra Pradesh, and the Samajwadi Party in Uttar Pradesh and Karnataka. The SP opened its account in the southern state by winning the Shimoga Lok Sabha constituency where its candidate, former chief minister Mr S Bangarappa, defeated his nearest Congress rival by a margin of 16,633 votes.

Winning three of the five seats that went to the by-polls and with ally NCP bagging another, the Congressled United Legislature Party raised its tally to 21 in a House of 39 in Goa. BJP won the fifth seat and raised its tally to 17. It also has the support of an UGDP MLA. The CLP will meet tomorrow in Panaji to elect its new leader. Mr Pratapsinh Rane, Mr Ravi 'Third alternative'

LUCKNOW, June 5. - A buoyant Samajwadi Party president today exhorted the Left parties to provide an alternative to the voters by combining with the regional parties after the SP and its ally, the RLD, swept the by-polls in UP and opened its account in south India. Mr Mulayam Singh Yadav said the results showed that the voters had lost faith in the Congress and the BJP. - SNS

In Chamrajpet Assembly constituency in Karnataka, vacated by former chief minister Mr SM Krishna, the Congress lost to its coalition partner, the JD-S, when its candidate Mr RV Devaraj was humbled by Mr Jamir Ahmed Khan by 3,278 votes.

In Andhra Pradesh, the TDP's Ms P Sunita defeated Mr B Sriramulu of the Congress by 18,850 votes in the Penukonda Assembly constituency. She also rode a sympathy wave generated by the killing of her husband Paritala Ravi, a TDP MLA, late last year in the faction-ridden Rayalaseema region of the state.

In Kerala, both the Congress and its ally, the CMP, lost the by-elections to the CPI-M in Koothuparamba and Azhikode Assembly constituencies with record margins of defeat. The LDF improved on its performance in the 2001 Assembly polls.

Haryana waives arrears for farmers

CHANDIGARH, June 17. The Haryana government today decided to waive off arrears of electricity bills of both domestic and tube wells, of rural sector amounting to over Rs.1600 crore, as on date and also announced a package of incentive for all those rural consumers who had been paying their bills

regularly.

Chief minister Mr Bhupinder Singh Hooda, who was talking to media persons after making a statement on the floor of the House said that farmers and all rural households would be permanently freed from this burden of past arrears. He said that this comprehensive package would begin a new era in the history of Haryana. He sought cooperation of all sections of the society including concerned officers and farmers to implement this decision in letter and spirit. He said that it had been decided that entire outstanding arrears of each individual would be divided in 10 equal installments spread over a period of 20 months. On payment of every current bill, 10 per cent of the arrears would be waived automatically. Thus, on payment of 10 current bills uninterruptedly starting from today, the entire arrears would be waived. While referring to those who were paying their bills regularly, he said that the government was equally aware of the feelings of such large number of villagers. "We have not forgotten their concerns and we have provided for unique incentive to such loyal bill payers."

Modi & his aides ordered 'elimination' of minorities CM Also Wanted Phones Tapped, Alleges Top Cop

Ahmedabad: In an explosive submission to the Central Administrative Tribunal (CAT) where he has challenged his recent supersession, additional director general of Guiarat police R B Sreekumar has revealed how chief minister Narendra Modi and his bureaucrats issued illegal orders like "elimination" of minorities and distorted facts about the actual situation in the state dur-

ing his tenure as state intelligence chief.

He also revealed how Modi himself issued instructions to keep a watch on and tap the phones of state Congress chief Shankersinh Vaghela, his former cabinet minister Haren Pandya and certain Muslim police officers and municipal corporators.

Sreekumar, whose revelations earlier also created a furore. has made these revelations in a blow-byblow account contained in a "semi-official" diary annexed to his petition before the CAT. This diary contains details of his interactions as additional DGP (intelligence) between April 16 and September 19, 2002 with Modi and many others in the state government.

An entry of June 28. 2002 says that after a meeting to discuss preparations for the forthcoming rath yatra, then chief secretary G Subbarao told Sreekumar, "if someone is trying to dis-

turb the rath yatra or planning to spoil the same, that person be eliminated". He added that "this is the policy and well-considered decision of the chief minister, Narendra and asked him to tap the phone.

Modi". When Sreekumar objected saying it was illegal, Subbarao told him that "such action can be taken on the basis of situational logic". Subbarao was not available for his comments.

In the entries Sreekumar notes that right from day one, Modi wanted him to keep tabs on Vaghela. Modi first told him on April 16, 2002 to tap Vaghela's phones, then on 26 July to watch his movements as GPCC chief, and

Sreekumar notes how top bureaucrats in the state did not like his candid presentation before chief election commissioner J M Lyngdoh on the prevailing scenario in the state. He was even admonished for giving a reply that did not conform to that given by deputy PM L K Advani before Parliament.

One entry of April 17, 2002 notes how Modi asked director general of police K Chakravarthi to book a few Muslim leaders who were like-

ly to disturb the holding of board examinations beginning the following day. Modi apparently suggested that "such persons be booked for some pending cases under investigation". The same day, Modi asked Sreekumar to keep a watch on police inspector Y A Shaikh. then in CID (crime), Congress corporator Hasan Lala and other Congress leaders "who are allegedly instigating the Muslims to attack the Hindus".

Sreekumar that Modi rubbished a note prepared by him on the communal situation at a meeting on May 7, 2002, and asked him to concentrate on "Muslim militants". He told him "not to concentrate on the Sangh Parivar as they are not doing anything illegal". In fact Modi said he would provide him intelligence on the Sangh Parivar. Modi was not available to reply to Sreekumar's charges.

Sreekumar transferred out of the intelligence branch in

Cong seeks Modi's ouster

Ahmedabad: The Congress in Gujarat on Thursday demanded the ouster of chief minister Narendra Modi over the application filed by additional DGP R B Sreekumar before the Central Administrative Tribunal (CA-T) accusing the government of denying him promotion for "politically motivated" reasons.

'Modi had asked the police officer to eliminate minorities in Gujarat and protect Sangh parivar leaders. This exposes his criminal mind and we demand his immediate ouster by the BJP high command," GPCC president B K Ghadvi said.

The CAT had on Wednes-

day issued notices to Modi and other government officials after Sreekumar filed an application alleging that the government's decision of "not promoting him was politically motivated and prejudiced, as he had exposed the government's role during the post-Godhra riots". The CAT had asked them to reply by May 9.

'Sreekumar's statements before the CAT that Modi had also instructed him to tap phones of senior Congress leader Shankersinh Vaghela and slain BJP leader Haren Pandya is also appalling and that he (Modi) could be booked for such offences and instructions to policemen," Ghadvi said. PTI

Legality of denying visa

N 1964, Peter Griffiths became the Member of Parliament from Smethwick in England after an ignominious racist campaign won him his election. In response, the then British Prime Minister famously retorted that Mr. Griffith would "serve the rest of his term (in Parliament) ... as a parliamentary leper." Those politicians responsible for genocidal violence, fascism and communal strife are political outcasts — both in and out of the country in which they live. Many people feel that Narendra Modi falls in this class of politicians and deserves to be treated as such.

This view is not shared by the BJP and others who revere Mr. Modi as an electoral mascot. Since the Gujarat riots of 2002, report after report criticised his Government for inaction, indifference and complicity whilst Gujarat witnessed riots, arson, pillage and murder. The view was supported by the National Human Rights Commission, which did not get responsible responses from the Gujarat Government. Nothing could have been more embarrassing for Mr. Modi than the Supreme Court speaking of 'modern-day Neros' when it transferred the Best Bakery case to Maharashtra because it believed Gujarat could not provide justice in the case in which Muslims were torched alive. Despite this, the BJP stood by Mr. Modi. When the young BJP politician, Smriti Irani, raised the banner of revolt in 2004 to demand Mr. Modi's removal, she had to withdraw her demand within 12 hours of making it! But although many believe that Mr. Modi and his Government have brought shame to both Guiarat and India, the BIP maintains that as Chief Minister of a BJP-ruled State, he is officially entitled to universal respect and concern.

The present controversy has arisen because on March 18, 2005, Mr. Modi was denied a visa for a private visit to the United States on the invitation of the Asian-American Hotel Owners Association. As far as the Indian law is concerned, even after Maneka Gandhi's case (1978), the right to travel abroad has not been recognised as fundamental. American authorities maintain they according to law. Under Section 214(b) of the Immigration and Nationality Act, Mr. Modi was denied a diplomatic visa because he was on a private visit. Likewise, Section 212(a) (2)(g) obliges the U.S. immigration the same day, the House of Repre-

authorities to deny a visa to "any government official who was responsible for, or directly carried out, at any time, particularly severe violations of religious freedom." The law is unusually phrased, but is not, by itself, unusual. Instead of the general category of 'undesirable alien,' this provision is specific and concerned with the complicity of government officials in severe violations of religious freedom." Since Mr. Modi was not on a diplomatic visit, this clause applied.

How is a U.S. official to go about his business of enforcing such a law? Can he ignore it? Or must he make a

reasonable decision on the material availon the material available to him? Should the U.S. Embassy in India have asked Mr. Modi to present himself for interrogation? Or left this for his arrival in New York? On March 18, Mr. Modi asked: "On what judicial evidence has the U.S. based its conclusion about the violation of religious freedom?" But judicial evidence is not necessary in such cases.

In 1998, the U.S. set up an official Commission under the International Religious Freedom Act which reports on denial of religious freedom throughout the world. Whether the U.S. should become the moral policeman of the world is another matter. The Report of the U.S. Religious Commission of 2002 concluded that the Gujarat Government's complicity in perpetrating religious atrocities "was tacit if not explicit.

In 2003, the U.S. Commission drew further conclusions on further actions and inactions in Gujarat. In May 2004, the Commission criticised Mr. Modi by name and even called upon the BJP to denounce the RSS and anti-religious policies to recommend that India be treated as a 'Country of Particular Concern. These reports have to be read with the U.S. Department of State's Country Reports on Human Rights in India from 2002 — specifically referring to Gujarat and Mr. Modi's "disrespectful remarks about Muslims" in his speeches. On March 15, 2005, the U.S. Religious Commission sent a special report advising against Mr. Modi's visit. More significantly, on sentatives passed a resolution saying it "condemns the conduct of Chief Minister Narendra Modi for condoning or inciting bigotry and intolerance against any religious group in India, including people of the Christian and Islamic faiths." This is a resolution by one of the Houses of the highest legislature in America.

Indians may not like these reports. Significantly, for the years 2002-04, neither the NDA Government at the Centre nor Mr. Modi made a public issue of these reports or the indictments in them. In any event, no U.S. immigration official discharging his

tion Act could possibly ignore these reports. And if they are taken into account, there can be little doubt that under the American law, the decision to deny Mr. Modi entry into the United States was valid and proper.

Now can it be argued that there was a serious violation of international law and policy? The preamble to the Vienna Convention on Diplomatic Relations, 1961, emphasises that "the purpose of (diplomatic) ... privileges and immunities is not to benefit individuals but to ensure the efficient performance of the function of diplomatic missions as representing (nation) states." Quite apart from the fact that diplomatic status could have been refused, Mr. Modi has no special privileges as an individual and was not representing India. He was not even on an official or trade mission. He was merely an individual on a private visit.

However, under pressure from the BJP and its chorus of voices, on March 18, the Centre protested saying the U.S. Government's action 'displays lack of courtesy and sensitivity towards a constitutionally elected Chief Minister of a State in India." Is this really an international discourtesy? All countries retain the right to ostracise both individuals and countries who they feel are unworthy. By limiting its boycott to the denial of an individual visa, America has stayed within diplomatic limits to enforce its immigration law. Mr. Modi's view that this was an insult to the Indian Constitution is not even shared by many Indians who believe

that it is Mr. Modi's Government that has undermined constitutional governance in India.

America's decision on Mr. Modi does not necessarily open up a diplomatic Pandora's Box. India too retains the right to deny entry to such government officials of other countries whose entry it considers undesirable. This is one moral right that every nation is obliged to retain. Some states go further. They have passed extra-territorial laws to try dictators for international crimes against human rights even if committed outside the territories of these

These laws were invoked against President Augusto Pinochet who sought cover of extradition procedures. Apart from its Alien Tort Claims Act of 1789, the U.S. also enacted the extra-territorial Torture Victim Protection Act, 1992. India claims jurisdiction over its own citizens abroad and wants to extend this to various classes of international criminals. Along with America, India has not objected to the various international tribunals on atrocities in Rwanda and former Yugoslavia but refuses to accede to the jurisdiction of the International Criminal Court.

India is answerable to various human rights committees set up by the United Nations to which periodic reports are submitted by the Government. In other words, India broadly accepts that there are valid international law norms that can be taken into account while adjudging the quality of a nation's governance. India is not answerable to America for what it does but it is answerable to the peoples of the world. There are moral humanitarian issues on which all peoples and all nations are entitled to take a stand.

The controversy over the U.S. denial of a visa to Mr. Modi cannot be raised to the level of an international crisis. It is just another reminder to the politicians of the world that they are not just accountable to their own electorates but to the peoples and nations of the world who must eventually decide who must be ostracised as a political outcast and who must not. America's denial of a visa to Mr. Modi was neither a constitutional affront nor a diplomatic insult to India. Mr. Modi has no social, political or diplomatic immunity to shield him from what the global community thinks of him. Mr. Modi is out of line. not the U.S. Government.

Jindal, Bansi's son killed Chopper crashes FALLING FROM THE CHIEFE

in Saharanpur

Utpal Parashar and Agencies Mahmgi (Saharanpur), March 31

TWO HARYANA cabinet ministers were killed in a helicopter crash at Mahmgi village, 45 km from Saharanpur in Uttar Pradesh on Thursday afternoon. The pilot too died.

The two ministers — power minister Om Prakash Jindal (also a noted industrialist) and agriculture minister Surender Singh (son of former Haryana chief minister Bansi Lal) - were killed on the spot. The pilot, T.S. Chauhan, died on the way to hospital. Two others injured — Ved Goyal, a relative of Jindal, and head constable Vinod Yadav — were admitted to the Saharanpur district hospital.

The accident took place around 1 pm when the five-seat Eurocopter Colibri EC 120B chopper "fell from the sky" into a wheat field near the village. Official sources in Chandigarh said the victims were going from Chandigarh to Delhi.

Preliminary reports suggest that the accident occurred due to some technical fault. Sources reported Goyal as saying 30 minutes into the flight, at 2,000 ft: "The engine has failed, sir." He tried to control the chopper, but it crashed within the next 45 seconds — indicating that the pilot got very little time. The helicopter tilted and fell on the pilot's side. Goyal and Yadav survived by virtue of being the other side.

The scene at the accident site suggested the chopper did not catch fire upon crashing. However, the entire left side of the craft was mangled.

"We saw the aircraft falling rapidly while flying over our village," said Ajaib Singh, a resident of Mahmgi. "At first we thought it would fall right into the middle of the village, but it veered off and crashed in a field at the last minute.

The bodies of Surender Singh (59) and Jindal (75) were taken to the civil hospital. The cremations will take place on Friday.

Both of them had been inducted into the Hoo-

da cabinet after the Congress returned to power in Haryana after nine years.

Jindal had been elected to the state assembly for the third time from Hissar. He was elected MP from Kurukshetra in 1996. Father of Lok Sabha MP Navin Jindal, he was elected three times to the Haryana Assembly — in 1991, 2000 and 2005.

Surender Singh, younger brother of BCCI president Ranbir Mahendra, returned to the assembly as agriculture minister after 22 years.

The Directorate General of Civil Aviation has ordered an inquiry into the crash.

The US gives India with one hand to take away with another

Why Modi piped down

arendra Modi's tantrums would have been of little account if private hankering for the United States of America were not now also an essential — and, perhaps, necessary — part of public diplomacy. Sign of changing times, while a defiant Hiren Mukherjee was once content to sit it out at New York airport without a visa, a grateful Jyoti Basu promised not to indulge in politics in the US if they granted him a visa.

Modi's loss is the government's grievance, now that Condoleeza Rice's mission has reminded us again that support for Pakistan, irrespective of the regime there, is the one constant in the flux of American policy changes. In spite of bus and cricket bonhomie. India's political relations with a neighbour basking in the glow of the US secretary of state's approbation are destined for a rough patch. Encouraged by his mentor, Pervez Musharraf is already returning to a strident posture on Kashmir while his foreign minister accuses India of reneging on an agreement on Siachen. Nor can the smaller countries of south Asia fail to draw a lesson from Rice's compliments to Pakistan's military ruler as America's sturdy ally against the forces of terror, with only a token mention of the democracy that is supposed to lie at the heart of George W. Bush's global

Jawaharlal Nehru might have retorted "Just as well!" to the refusal to grant Modi a visa. But that would not have honestly reflected Indian thinking even then. "When I call on cabinet ministers, the president or governors, they all love to talk about their sons, sons-in-law and daughters in the US and how well they're doing and how well they like things," mused William B. Saxbe, American ambassador in the Seventies. "The next day I read in the papers the very same people are denouncing the US as a totally dif-ferent kind of country." With people like Modi setting such high store by the connection, and almost every educated urban Indian a potential green card petitioner, Oscar Wilde's aphorism about good Americans and Paris can be adapted to read that good Indians go to New York before they die.

hat is why, unconstrained by any sense of self-respect, Modi piped down when he addressed expatriate Gujaratis via satellite. Forgetting earlier bluster, he praised Uncle Sam and blamed only wicked non-resident Indians. But though the US state department has assured India that this petty controversy has no bearing on bilateral relations, the denial does reek of the moral high ground that the US claims for itself. It reflects America's self-image as "emperor of the

world", to cite George Fernandes, and its understanding of its global responsibilities.

That might have been more convincing if the Americans themselves had not rejected the concept of universal justice enshrined in the International Criminal Court. Otherwise, it might have been argued that the law dispensed with political boundaries long before economic globalization just as the trade union movement was a torchbearer of internationalism. I recall an occasion when print-workers in a Fleet Street office downed tools the moment a Sri Lankan newspaper

might refer to an applicant's domestic credentials but cannot be bound by them. Otherwise, someone like Slobodan Milosevic would be entitled to demand admission to any country in the world. Though some of history's worst tyrants boast the *imprimatur* of the hustings, electoral legitimacy proves nothing in this age of money and muscle manipulation.

What concerns India is how the US uses its power in the unipolar world it commands. In the past, it used that power to keep India in what Americans no doubt thought of as its place. The origins of that


Larry Pressler, the former republican senator from South Dakota who thwarted the sale of 28 F-16s to Pakistan, attributes this to the continuing influence of what Dwight D. Eisenhower called "the military-industrial complex". That ties in with A.B. Rosenthal's analysis in the New York Times that many US officials prefer Pakistan to India not despite its militarism but because of it. "Man, the military fellows can get things done for you.' With Pakistan remaining central to all American calculations, US planners advance different reasons at different times for continuing the same policy.

First, it was the Soviet threat, then securing Afghanistan for the free world, then getting rid of the taliban, and now the war against Osama bin Laden and Al Qaida. Those military fellows can get it done, even if the evidence suggests otherwise.

o much then for the constantly repeated claim that the world's oldest and largest democracies are natural allies. Values have never played any part in the hard reality of US foreign policy but it should be enough for India that a coalescence of national interests has brought the two countries closer. But Rice's reiteration of her boss's promise during his first term to remove the "hyphen" between the two countries is a facile public relations exercise that exploits Indian gullibility. Whether or not the US hyphenates its relations with the two neighbours, everything it does in relation to Pakistan resonates in

Bush first praised Musharraf even before his election. Colin Powell then anointed Pakistan America's "major non-Nato ally." Rice has now promised to sell the F-16s for which Pakistan has been clamouring since the Eighties. They will be of no use against shadowy jihadis. But as with all the sophisticated hardware (especially tanks and submarines) the US has given Pakistan over the years, they can - and will — be deployed against India. Even if they are not, the possibility will compel New Delhi to squander money on similar or better fighters. Bush is sparking another arms race in the subcontinent.

It bears repeating in this context that Pakistan's GDP is one-eighth of India's. It has one-seventh the population and one-fifth the area. Thanks to the US and China, only its military strength enables it to claim parity with India. Irrespective of the Modi fracas, there will be no stability in south Asia as long as that pretension lasts; and the pretension will continue as long as it suits the Americans to give India with one hand and take it away with the other.

Apparently, the Sri Lankan newspaper had behaved badly with its London correspondent (a Sri Lankan) who had complained to the National Union of Journalists, of which he was a member. The NUJ instructed all its units to display their disapproval of the Sri Lankan organization's conduct. Understandably, perhaps, the US shrinks from such ret-

ributive reaction.

All the same, the Bharatiya Janata Party's need for a tub to thump or the eternal search for slights by notoriously thin-skinned Indians should not be allowed to inflate the importance of the Modi affair. Manmohan Singh rightly acknowledged the US's "sovereign right" to refuse entry to anyone it chooses. All countries exercise that right, often without giving a reason. India does so too. Sovereignty cannot be accountable to an external authority.

It is neither here nor there that Modi holds elective office or that the charges against him have not been proved. A visa-granting authority

Modi sings new tune

NEW DELHI, March 27.

— First, Mr Narendra Modi was denied a visa to go to the USA. Then he had to cancel his UK trip. As a face-saver, it was said that the Prime Minister and the Union home minister had requested him not to go ahead with his visit to Britain owing to security reasons.

The PMO strongly denied this saying no such request was made. What was meant to be a face-saver, left the BJP squirming. And today, the Gujarat chief minister was heard singing a different tune.

Mr Modi told a TV channel that whatever had happened after Godhra "did not do credit to any civilised society". He added that he was not against Islam but against jihad and terrorism. No true Hindu can be against Islam because Hinduism teaches equality of all religions, he said. But when asked if he felt that he had become an international symbol of hate, Mr Modi replied: "It is not for me to analyse (this) but for my critics to do so."

Asked whether the US action was a slap on him and whether he would take corrective measures, Mr Modi, in an oblique criticism of Washington, said there was no judicial system in the world in which the same person can level the charge and also pass judgment. He also suggested that the denial of a visa to him was like President George W Bush taking a leaf from RJD chief Mr Lalu Prasad's criticism of him to project a secular face.

The Gujarat chief minister also attacked "five-star

activists" in the country for indulging in acts that tarnish the image of India, only to bag international awards and aid.

The denial from the PMO in connection with the cancellation of Mr Modi's UK trip and the Congress accusing him of politicising the issue has put the BJP on the defensive. "It does not matter who called up whom, the fact is that the Government of India expressed its fears on Mr Modi's visit to London and asked him to reconsider his decision," BJP spokesperson Mr VK Malhotra said today.

But for the Congress it was an opportunity to criticise the chief minister. "Mr Modi unnecessarily dragged the PMO and politicised the issue to serve his vested interests," said Congress leader Mrs Ambika Soni.

On video, Modi goes mild

Gandhinagar, March 21: Trademark arrogance missing and face not betraying any signs of rancour, Narendra Modi today came across as almost too large-hearted as words of praise for the US flowed over satellite to his Gujarati friends overseas.


"India and the US are the two largest democracies of the world. They are tied together by many common traditions and beliefs," he said cheerfully, addressing the Indian-American crowd at Madison Square Garden in New York as though the visa refusal row had not happened.

Studiously avoiding any America-bashing during the teleconference and being all praises for Indo-US friendship instead, he appeared to be proving a point as he refused

to retaliate to the visa snub.

"I have no grievance against the US or the people of that country over the visa denial...

I have no reaction, I believe only in action," Modi, dressed in an orange kurta, said.

"I take inspiration from Gandhiji and believe in Gandhian methods to fight injustice"

But the chief minister insisted his "brothers and sisters" in faraway US should ensure that "opinion about your motherland is not formed on the basis of propaganda and the contention of a handful of vested interests". There should be verification of facts, he said.

Going on to liberally tug at

the heartstrings of the 5,000strong community, he said the reason Indo-US friendship was flourishing was the Gujarati diaspora in that country.

Whether he was in New York or not, "my heart is there at your function", Modi said. "Gujarat remains yours as it ever was."

Dubbing Gujarat the "growth engine of India", he said the state represented the "very best" of India and was among "the most progressive and promising".

"I will see to it that Gujarat becomes a global destination where some day Americans will line up for visa."

Modi said the best way an overseas Gujarati could contribute to his motherland was by motivating at least five families to visit India. If 5 lakh Gujaratis motivated 25 lakh families, the tourism industry would get a big boost, he said.

Stirring national pride as he fielded a query on brain drain, he said: "Let Indian brain reach every nook and corner of the world. There is no dearth of brain in India."

The only occasion Modi was a trifle critical about the US was when he said it was given to treating military dictators rather too well.

The teleconference began in the hall of the chief minister's official residence at 5 am. Since 3 am, Modi's additional principal secretary A.K. Sharma and IT secretary J.N. Singh were seen busily instructing technicians to set up a link that would not crash midway.



AHMEDABAD/NEW DELHI, March 18. — "The one-sided US decision amounts to an insult to India's Constitution and selfrespect," was Mr Narendra Modi's reaction to the US move. It only exposes Washington's attempt to show this country in "poor light". He intends to write to the Prime Minister.

Mr Modi pointed out that "no court had given any decision" against his government or himself on the Gujarat riots. He had received the "political clearance" from the Prime Minister before applying for the visa two months ago. "No country can impose its laws on the citizens of another country while granting visas. If an American citizen wants to come to India, are we going to question what the Americans did in Iraq and deny him visa?"

He questioned the decision to revoke his tourist/business visa. issued in 1998, just two days before his visit to the USA. "What happened in Gujarat was in 2002. Why didn't they cancel my visa earlier?"



The decision clearly shows that the US intention is only to insult and downgrade India. If an American citizen wants to come to India, are we going to question what the Americans did in Iraq and deny him visa?

"The decision is totally democracy, human against rights, and is a violation of judicial norms," he said. "This clearly shows that the intention of America is only to insult and downgrade India.

The BJP, the Congress and the CPI criticised the US decision. Congress spokesman Mr Anand Sharma said the issue should be looked at beyond politics. "Mr Modi holds a constitutional post, and he should not be denied the diplomatic visa. He is a chief minister and he has every right to go on a diplomatic visa.

BJP praised the Centre's "prompt action" and criticised the USA's "intruding into our domestic affairs". CPI's Mr Gurudas Dasgupta called the action a "discourtesy". CPI-M MP Mr Nilotpal Basu remarked: "BJP leaders like Jaswant Singh and Yashwant Sinha are better equipped to offer explanations as their relations with Washington are very good."

Purely legal matter: State Department

WASHINGTON, March 18. — The USA today described its decision to deny a visa to Mr Narendra Modi as a purely legal matter and not a reflection on India's political or judicial system.

This was the first time the US law under which Mr Modi was denied the visa had been used, said State Department official Mr Len Scensny. "The law is relatively new. Our job is to carry out the US law," Mr Scensny said. Asked if the decision had been taken by Ms Condoleeza Rice, Mr Scensny said: "It's not the secretary's job to make this decision, but she's aware of it. We sent out the instructions to our Delhi office last night and told

Modi's people this morning." The US law used to deny Mr Modi a visa has been in existence for several years. But before December 2004, it applied to religious rights violations committed in the two-year period prior to a person's applying for a visa. A December 2004 revision removed the two-year provision and it now applies to anyone who had anything to do with severe religious persecution, regardless of when that occurred. So when Mr Modi applied, though it was just a little over two years since the Gujarat violence occurred, he was held accountable. "We looked at the law and the judgment we made in our own

human rights report," Mr Scensnv said. "The law says 'any foreign government official who was responsible for or directly carried out, at any time, particularly severe violations of religious freedom,' is ineligible for a visa to the USA," he said. Mr Modi had applied for a diplomatic visa and was denied that because he was not coming on a diplomatic visit. "But he also had a Bvisa and we cancelled that as well," he said. Asked whether it was a well-thought-out move, Mr Scensny said: "I think a lot of thought went into this." However, Mr Scensny emphasised: "This is not an attempt by the US to intervene in India's justice system." - IANS

A RACE TO THE BOTTOM

IT HAS BEEN a competitive debasement of values in Goa over the last four weeks, with not just the Congress and the BJP but the two constitutional functionaries — the Speaker and the Governor using more foul means than fair to shape government formation. The Bharatiya Janata Party, desperate to keep the Parrikar Government alive, called to its aid the Speaker who could not save the Government but could make it impossible for the Congress to hold on to power. And if the Congress was successful in pushing the BJP regime out, its attempt to take office through the agency of former Congressman, Governor S.C. Jamir, has turned out to be a botched deal - it has been tainted by the same type of manipulated voting that brought about the dismissal of the Parrikar Government. Politically, it has been a virtual replay of the confidence vote the Parrikar Government sought, and the BJP cannot really complain against the tables being turned now. In constitutional terms, however, if an outcome manipulated by a partisan Speaker could not be taken as a true indication of the support for the Parrikar regime within the Assembly last time, it cannot legitimise the Rane Government either. Whatever Mr. Jamir's predilections in the situation, the Centre could not allow double standards to be applied and in imposing President's Rule without waiting for his recommendation, the right thing has at last been done. The invoking of Article 356 will now have to go before Parliament, with the State Assembly suspended, and it remains to be seen how the politics of approval will play out in the Lok Sabha and the Rajya Sabha. The prospects of forming a viable government out of the Assembly as it stands seem quite remote. At least five byelections brought on by resignations of MLAs in recent weeks are due to be held and if they can be completed within the time taken for Parliament to consider the situation, one or the other side may gain a majority. The much better course, which is likely to have a wholesome and cleansing effect in an atmosphere of all round venality, will be for Parliament to approve the proclamation, after which the Assembly can be dissolved and elections held to bring in a new House.

It all started with the fragile situation the BJP-led Government, formed after the elections of

2002 with the support of smaller parties and independents, was placed in, and even a routine change of portfolio of a Minister could spark a major revolt, with four supporting legislators resigning from the Assembly. The resignations themselves, obviously induced by the Congress, are the more drastic alternatives to the party splits that have been barred along with outright defections under the amended anti-defection law. Faced with a loss of majority, the BJP sought to disqualify an independent MLA who had declared his support for the Congress on the ground that he had joined the BJP earlier. Even before the disqualification petition could be decided upon, the Speaker in a blatantly partisan move had the MLA physically removed during the vote, prompting the Congress to walk out. As though that were not enough, the presiding officer counted an Opposition legislator for the Government, before pronouncing it had won the vote. The Parrikar Government could not legitimately be allowed to continue on the basis of such a blatantly manipulated floor test.

Act II turned out to be equally murky, with the Governor swearing in Pratapsinh Rane hurriedly and not even setting a date for him to prove his majority support. In a bid to tilt the numbers in its favour, the Congress persuaded a BJP MLA to resign from the Assembly, but with the Speaker disqualifying a Congress supporter and then resigning along with the Deputy Speaker, the numbers were distinctly unfavourable to the Rane Government, with both sides tied at 17. It was in this situation that Mr. Rane "won" the vote after the pro tem Speaker prevented an MLA facing a disqualification petition from voting and used his own vote to break the 16-16 tie. In all, it has been a no-holds-barred, sordid story of induced resignations, blatantly partisan disqualifications, vote manipulation, swearing in a new government in indecent haste in the dead of night — and clearly, in terms of political decency, a race to the bottom. As in the case of the drama now being played out in Jharkhand, Goa is an object lesson in the havoc political partisans in constitutional offices that call for a fair and impartial enforcement of the rules of the game can inflict in situations of narrow and shifting majorities.

President's rule was only option: BJP 103

NEW DELHI, MARCH 4. Imposition of President's Rule in Goa was the "only option" left to the Centre after its Government failed to pass the confidence test on the floor of the Assembly, 'despite all kinds of manoeuvres', the Bharatiya Janata Party said here today.

The general secretary, Pramod Mahajan, said he hoped that when Parliament meets the Government would suggest early elections in Goa so that a popularly-elected government can once again be formed.

"We can hardly welcome the imposition of President's Rule, but it was the only option before the Centre. The Congress changed the Governor and then used him to destabilise our government," Mr. Mahajan said, charging that defections were engineered, the anti-defection law was circumvented, a duly-elected Chief Minister, Manohar Parrikar, was

was made to legitimise the Pratapsinh, Rane Government. "When all that failed they imposed President's Rule."

"A fraud"

Earlier, the party described the vote of confidence 'won' by the Congress-led Rane Government in Goa as a "fraud on the Constitution" and "thoroughly shameful."

The party demanded and this was what happened a few hours later that the Governor, S.C. Jamir, not give his approval to the vote of confidence and was hoping that President's Rule would be imposed and early elections called.

The BJP said before the trust vote the Governor had assured its leaders that the pro tem Speaker had been specifically told that no other business should be taken up except the vote of confidence. They were angry that while the pro tem Speaker did not dis-

dismissed, and an attempt qualify Mr. Saldanha, his action of not taking into account his vote had the same effect. "How could he have not allowed a legitimate member of the Assembly to vote ... this was shameful," they said.

They pointed out that the Goa issue was already before the Supreme Court and was expected to come up on Monday, March 7, when lawyers of Mr. Parrikar, would bring up this latest development to the notice of the court. The party would decide its further strategy on Goa after the Supreme Court gave its view.

The BJP had considered asking all its MLAs and those supporting it to resign from the Assembly in the event of the Centre not imposing President's Rule.

Earlier the BJP had favoured restoration of the Parrikar Government, but today the mood was for early elections, a demand made a few days back by former Prime Minister, Atal Bihari Vajpayee.

Speaker seals Goa vote

Panaji/New Delhi, March 4: Goa's acting Speaker used his casting vote today to save the month-old Congress government only to have the Centre impose President's rule, calling the proceedings "wrong".

Acting Speaker Francisco Sardinha moved the motion after ruling that UGDP legislator Matanhy Saldanha, who is backing the BJP against his party's diktat, was not entitled to vote. Saldanha is facing a disqualification petition that Congress's Jitendra Deshprabhu has filed.

Amid loud BJP protests, ousted chief minister Manohar Parrikar asked Saldanha to stand and be counted. The parties, with an effective strength of 34 in the 40-member House, were tied at 16-16 following the disqualification.

The acting Speaker, elected as a Congress member, said he would use his casting vote in favour of the confidence motion, thus helping the Pratapsinh Rane government win.

Three hours later, however, the Union cabinet "took suo motu action without waiting for any recommendation from the governor" to "impose President's rule in Goa and keep the Assembly in suspended animation".

"It was not proper not to allow one member to vote and then get the confidence motion passed with a casting vote given by the Speaker. This is exactly what was done by the previous government. If that is wrong, this is also wrong," home minister Shivraj Patil

said after the cabinet meeting.

Parrikar called the vote a "sham" and contended that Sardinha had no right to bar a legislator from voting. His party said an acting Speaker has no power to "requalify or disqualify" a member.

The Constitution allows an acting Speaker all the powers of a Speaker and his actions inside the House are as valid as that of the latter. "All powers of the Speaker are vested in acting Speaker," said Shanti Bhushan, constitutional lawyer and former Union law minister.

He defended the "letter of governor S.C. Jamir" that had "pointed out that Sardinha would discharge the functions of the Speaker on an acting basis during the vote of confidence".

Bhushan said a member of the House had to be appointed to the chair in the absence of the Speaker and the deputy speaker, both of whom had resigned in Goa.

The Speaker's decision, however, can be challenged in a court of law M.N. Krishnamani, former president of the Supreme Court Bar Association, said the acting Speaker's action could thus be legally challenged as it "1s questionable". This, he added, "is certain to be reflected on Monday when the Supreme Court takes up the issue for further hearings".

The court, on Parrikar's petition challenging his regime's dismissal, today said it would watch the Goa developments and hear the matter on Monday.

Dissolve Goa Assembly, says Vajpayee

NEW DELHI, MARCH 1. The former Prime Minister, Atal Bihari Vajpayee, said today that the Goa Assembly should be dissolved and new elections ordered to end the political stalemate there. He criticised the Governor, S.C. Jamir, for "dismissing an elected BJP Government" and "crossing the limits of his powers."

He was addressing a meeting of the BJP par-

liamentary party here.

The Goa issue was raised by the BJP through an adjournment motion in the Lok Sabha this morning, but was disallowed by the Speaker on the ground that the matter was in court and that it concerned a Governor.

The BJP decided at the parliamentary party meeting that it would press for the adjournment motion. Later, there were uproarious scenes in the House when the issue was not

taken up, forcing the Speaker to adjourn the House for the day.

Mr. Vajpayee told reporters that "democracy has been murdered in Goa ... this is not a good precedent ... the Governor crossed the limits of his powers." At the start of the Goa crisis, the BJP had demanded that the Governor be recalled and the Parrikar Government be reinstated. But today Mr. Vajpayee demanded the dissolution of the Assembly.

The change in stand is apparently due to the changed circumstances — one more BJP MLA has resigned (the resignation by four MLAs earlier had triggered the Goa crisis) and party strategists had asked the Speaker, Vishwas Satarkar, to resign yesterday when the Rane Government was to move a motion of confidence. Since the Speaker does not vote, his resignation helped the BJP add one more to its falling strength. At present, the BJP and its supporters do not seem to have the numbers with them, hence a change of stand.

Rane to seek vote before budget

PANAJI, MARCH 1. The Goa Chief Minister, Pratapsinh Rane, who could not seek a vote of confidence on Monday, following resignations of the Speaker and the Deputy Speaker, today said he would present the budget on March 28. He said "very soon' he would seek the vote of confidence well before the budget.

After the Cabinet meeting here today, Mr. Rane told reporters that as the House was adjourned sine die on Monday, it has to be prorogued by the Governor and reconvened at a later date. He said that the Government would urge the Election Commission to hold early by elections for the five constituencies that became vacant due. to the resignation of BJP MLAs.

Asked about the disruption of Parliament proceedings by NDA members today, Mr. Rane said there was nothing new in it. "Every time they do it." He said the Government was functioning and the full Cabinet was taking decisions.

'Intimidatory tactics'

The ousted Chief Minister, Manohar Parrikar, alleged that the Rane Government resorted to intimidatory tactics by pressuring the police to investigate the alleged forgery case and arrest the petitioner and MLA, Sa-

Mr. Parrikan told reporters here today that fresh summons had been issued on Mr. Tanvade asking him to appear before the police for investigation and cautioned the Government that the BJP would fight it on every possible forum.

He said he was surprised by the Director-General of Police's justification that he had taken advice from the Advocate-General (AG) and the Law Secretary. He said the DGP should have sought the advice of the Secretary-General of the Lok Sabha and not that of the AG, "who has

been a lawyer of the Congress.'

"By doing all these, they are digging their own grave," he said. He said it was an "illegitimate government" as no notification declaring that Mr. Neri, who has been disqualified, ceased to be a Minister under Article 164 (1) (b) of the Constitution, has so far been issued. The Speaker had already informed the Election Commission about the vacancy in the Goa Assembly and the disqualification order was irreversible,

Reiterating his demand for the dismissal of the Rane Government, Mr. Parrikar said Mr. Rane was afraid of facing the Assembly since he was in minority. The House could have been convened at short notice as it has only been adjourned sine die, he claimed.

Lodges police complaint

Francisco Sardinha, who was appointed the pro tem Speaker by the Governor, S.C. Jamir, on Monday, has lodged a police complaint that the files regarding the Deputy Chief Minister

were missing from the Speaker's office. Mr. Sardinha, who assumed office this afternoon, told The Hindu that he had to get the lockers forcibly opened in the presence of the police and the Legislature Secretary as the former Speaker did not hand over the keys till late evening.

PANAJI, Feb. 28. — Hours after the resignations of the Speaker and the Deputy Speaker of Goa Assembly led to the cancellation of the confidence vote to be sought by the Congress-led government today, Congress MLA Mr Francisco Sardinha was sworn in as the pro-tem Speaker of the House. "The appointment letter was issued this evening," Goa Congress chief Mr Luisinho Faleiro said.

Mr Faleiro. a minister in the Pratapsinh Rane government, said the Cabinet would meet later to decide on recommending proroguing of the House to the Governor. "We will be meeting tonight to recommend that the House be prorogued as that is constitutionally required," he said.

Mr Faleiro, however, denied that the Cabinet would recommend a fresh date for the vote of confidence, saying: "The 4 March deadline does not stand now as the situation has changed, nor is it our fault that the vote of confidence was not held. The Governor should give us a fresh date. In fact, we feel that we have already won the vote of confidence," he said.



NEW DELHI, MARCH 4. Bhupinder Singh Hooda, MP from Rohtak, was today elected leader of the Haryana Congress Legislature Party. The CLP meeting, which was held here, was boycotted by 20 of the 67 newly elected party legislators owing allegiance to the senior party leader, Bhajan Lal.

Trains stopped, buses stoned

CHANDIGARH, MAR. 4. Violence erupted in the Hisar district of Haryana while there was tension in Panchkula district as angry supporters of former Chief Minister, Bhajan Lal, came out on the streets and reportedly stopped trains and broke window panes of buses, according to reports reaching the State headquarters here. 
His assurance came after Mr Hooda met Mr Lal at his residence this morning and sought his cooperation. "The Hooda government will be completely stable. I

HOODA FOR HARYANA

IF THE RESULTS of the recent Assembly elections did little for the self-image of the Congress in Bihar and Jharkhand, it was an embarrassment of riches for the party in Haryana. It was not just the abundance of seats - 67 against nine for the Indian National Lok Dal in a House of 90. With the massive victory came a host of Chief Ministerial hopefuls. Bhupinder Singh Hooda, who eventually emerged as the choice of the 'high command,' was in the race with such heavyweights as thrice Chief Minister and present Pradesh Congress Committee chief Bhajan Lal; former PCC chief S.S. Surjewala (not to mention his son Randeep Surjewala); former Haryana Vikas Party leaders, Surinder Singh and Ranbir Singh; Member of Parliament Choudhary Birendra Singh; and finally Union Minister of State Kumari Shelja. While the other contenders were somewhat coy about their ambition, Mr. Bhajan Lal was upfront. The 74-year-old Harvana warhorse told the media that he considered his formal election to the post a mere formality. That he had good reason to be confident about his strength is borne out by a postpoll survey done by the Centre for the Study of Developing Societies with the support of The Hindu . Asked to choose from among Mr. Bhajan Lal, Mr. Birendra Singh, and Mr. Hooda in the event of the Congress forming the next Government, 42 per cent of the respondents opted for Mr. Bhajan Lal and only 15 per cent for Mr. Hooda.

With the event materialising, Mr. Bhajan Lal threw a little tantrum at Mr. Hooda's election as the Haryana Congress legislature party leader (he 'resigned' in a huff from the PCC chief's post and he and his supporters boycotted the legislature party meet). However, such is the persuasive power of the 'high command' in the Congress that Mr. Bhajan Lal was soon on benevolent hand-shaking terms with the new incumbent and offering to abide by "Soniaji's wishes." So why did the Congress president pre-

fer the less popular Mr. Hooda to Mr. Bhajan Lal? At 57, Mr. Hooda is among the younger leaders of the State and arguably qualifies as the future face of the Congress. More importantly, his selection appears to have been influenced by the presumed role of the Jat factor in Haryana politics. As a Jat, Mr. Hooda was thought to be in a position to leverage the influence and clout of the community. The CSDS survey shows that many of these assumptions have no valid basis. For a start, the Jats account for only about a quarter of Harvana's electorate. Secondly, the community (like any other community or section of society) has never voted en bloc for any one party, as is popularly believed; even at the peak of its popularity, the INLD polled less than 50 per cent of the Jat vote. This time, contrary to the presumption that the INLD's defeat was brought about by the 'desertion' of the Jat vote, about 40 per cent of voters from this mega-caste group voted for it as against a quarter each for the Congress and independents.

This is a heady moment for the Congress in Haryana. The Janata wave of 1977 and the Lok Dal-Bharatiya Janata Party landslide of 1987 aside, no party has ever triumphed on this scale in the State. The Congress sweep cut across the various regions and caste groups. Nonetheless the INLD remains a serious player, a party that is down but far from out. The CSDS post-poll survey's basic finding is that the Congress' superlative performance came not so much by snatching votes directly from its chief adversary or through alliance arithmetic as by capitalising on a strong wave of popular resentment against the Chautala regime's perceived heavy-handedness, nepotism, and corruption. Interestingly, 73 per cent of voters surveyed agreed with the statement that "despite shortcomings, [the] Chautala Government has worked for [the] development of the State." There is a politico-moral lesson in this for all parties, not just for the INLD and the Congress.

PANAJI, FEB. 26. A tussle between the Speaker and the Pratapsinh Rane Government appears imminent on Monday when Mr. Rane seeks a vote of confidence in the Assembly as the Congress today claimed that the Speaker has not made separate seating arrangements despite Rane's written request.



Rane questions judicial review

THE CONGRESS-LED Goa government has defended the Governor's decision to dismiss the erstwhile BJP government on the ground that such dismissal was well within his



"It is well-settled that in the appointment and dismissal of a chief minister, the Governor is the best judge... as he alone is in possession of relevant information and material on the basis of which he acts...exercise of this discretion is not amenable to judicial review," an affidavit filed by the Pratap Sinh Rane government in the Supreme Court said.

The affidavit stated that the Parrikar government had already lost its majority and cited a January 31 letter, written to Governor S.C. Jamir, in which the Congress-led ULP had staked its claim to form a new government claiming it enjoyed a majority of 18 in the 38-member house.

It dubbed the happenings of February 2 in which the Parrikar government won a trust vote in the House as "pre-planned action" designed solely to deprive "Independent" MLA Filip Neri Rodrigues of his vote so as to "falsely present a majority".

The Speaker had on that day disqualified Rodrigues from voting for "unruly" conduct. The affidavit stated that the MLA had not displayed any unruly conduct to justify such action. Goa: NDA threatens to stall Parliament

NEW DELHI, FEB. 8. Continuing their protest against the dismissal of the Manohar Parrikar Government of Goa, The National Democratic Alliance (NDA) partners today took to the streets, threatening to stall the Parliament proceedings during the budget session against, what they alleged, a conspiracy by the Central Government to oust a duly elected Government.

Led by the former Prime Minister, Atal Bihari Vajpayee, and the BJP president, L.K. Advani, the NDA leaders staged a day-long dharna at Jantar Mantar. They accused the United Progressive Alliance Government of orchestrating the dismissal of the Parrikar Government. The BJP is demanding that its government be reinstated and the Governor

By Our Staff Reporter KD be recalled and sacked.

The BJP's State units across the country held similar protests. From tomorrow the scene will shift to Goa where for a week the party will stage protests to focus the people's attention on the issue. The party's leader in the Rajya Sabha, Jaswant Singh, will lead the protests there.

Senior NDA leaders, including its convener, George Fernandes, and the BJP Chief Ministers of Gujarat, Madhya Pradesh, Rajasthan and Chhattisgarh participated in the dharna here. Mr. Parrikar was also present. The Trinamool Congress, the Akali Dal, the Biju Janata Dal and the Shiv Sena were also represented.

Party leaders said they want to use the Goa issue to "consolidate" not only the NDA but alnon-Congress "other parties" and caution them

against Congress designs. "This is a larger issue, which is not confined to what happened or will happen in Goa ... the legal alternative will be explored, but we want to fight the issue politically," the party vice-president, Mukhtar Abbas Naqvi,

Kalam urged to intervene

Taking part in the protest at the fag end of the day, Mr. Vajpayee urged the President, A.P. J. Abdul Kalam, to intervene and restore the Manohar Parrikar Government. Warning that the NDA would not remain a mute spectator to such "arbitrary" actions of the Centre, Mr. Vajpayee said the nationwide agitation would continue till the BJP-led Government in Goa was re-instated. The dismissal of the Goa Government was a warning to the other non-Congress ruled States, he said.

Mr. Advani said: "The Congress never believed in democracy and this agitation is to save and show the power of democracy." The Goa Governor, S.C.Jamir, had set a "dangerous precedent." The Constitutionframers had never imagined that Article 164, which states that a State government can remain in power only at the pleasure of the Governor, would be misused in such a manner, he said.

He claimed that the direction to dismiss the government was given in advance by the Congress leadership, even before the trial of strength on the floor of the House. The BJP general secretary, Sushma Swaraj, hinted that in the present situation it would not be possible to ensure normal functioning of Parliament during the budget session.

PANAJI, FEB. 7. The Goa Governor, S.C. Jamir, has asked the Chief Minister, Pratapsinh Rane, who was sworn in on February 2, to seek a vote of confidence on the floor of the Assembly on or before March 4.

Sebastian Zumvu, Officer on Special Duty (OSD) to the Governor, who is in Delhi along with Mr. Jamir, told The Hindu over the phone that Mr. Rane had been given 30 days' time from the date of swearing-in to prove his majority.

When contacted, Mr. Rane said he would hold a press conference but did not specify any

date

Though there were reports of allocation of portfolios to his ministerial colleagues by Mr. Rane, no official announcement was made till late this evening. Mr. Rane expanded his Cabinet on February 3, taking its strength to eight and keeping four more berths vacant. The Goa Pradesh Congress chief, Luizinho Faleiro, who has just returned from Delhi, said he was not aware of the allocation of portfolios.

The Union Home Ministry has relieved the Goa Chief Secretary, D.S. Negi, of his duties and has asked him to report to the Andaman and Nicobar Islands as its Chief Secretary by February 9. Mr. Negi, who received the transfer order just before the political crisis broke out last week, stayed back due to the political developments.

Confirming that he had received the relieving order, Mr. Negi told *The Hindu* that he would ask the State Government to relieve him while saying that Mr. Rane was asking him to stay back.

In another development, the Government has relieved the Director of Information, Dilip Deshpande, of his duties and asked Menino Peres, earlier a Joint Director in the Department, to take over.

Goa Speaker should

NEW DELHI, FEB. 5. The newly installed Goa Chief Minister, Pratapsinh Rane, said today that the Legislative Assembly Speaker, Vishwas Satarkar, should step down from the post, failing which he would be removed.

Questioning the Speaker's conduct during the vote of confidence sought by the previous Manohar Parrikar Government this week, Mr. Rane said thata notice expressing no confidence in Mr. Satarkar and the Deputy Speaker, had been submitted to the Governor, S.C. Jamir.

Mr. Rane, who was here to consult the party's central leadership, said that he was sure his Government would win the confidence vote. He had already requested the Governor to set a timeframe for the new Government to prove its majority on the floor of the House.

At a press conference, Mr.

Rane, along with the Goa Congress chief, Luizinho Faleiro, and the All-India Congress Committee general secretary, Margaret Alva, in-charge of party affairs in the State, denied that dissidence had surfaced in the 15-member Congress Legislature Party after the expansion that led to the inclusion of three allies and two former BJP members, who had since rejoined the Congress.

"There is no problem absolutely... the majority of our MLAs were not asking for posts. They are glad the Government [of Mr. Parrikar] has gone. We are sure all the Congress workers are united and there would be more desertions in the BJP camp," they said.

Narrating the sequence of events since the resignation of the four BJP MLAs up to the dismissal of the BJP-led Government, Mr. Rane and Mr. Faleiro, now a Minister, accused the Speaker of being in league with

They said the vote of confidence was taken by head count when plainclothes policemen were inside the Assembly to evict the Independent MLA, Filipe Neri Rodrigues, now the Deputy Chief Minister.

"In the melee, the then Chief Minister tells the Speaker to announce the results, and never before has it happened that voting goes on when strangers are present on the floor of the House. People who do not believe in democracy talk of its murder," Mr. Faleiro said.

NEW DELHI, FEB. 4. The Bharatiya Janata Party has decided to fight the Goa case both legally and politically for it believes that the Governor's action in dismissing the Manohar Parrikar Government was "illegal

unconstitutional."

At a meeting this morning, chaired by the BJP president, L.K. Advani, it was decided that while the dismissed Chief Minister, Manohar Parrikar, would explore the legal avenues through a petition in the Bombay High Court, the party cadre would be galvanised to hold demonstrations throughout the country on February 8, to be observed as "Save Democracy, Sack Governor Jamir" day.

"Even if the Speaker had done something wrong, there were only two options open to the aggrieved party: remove the Speaker through a no-confidence motion or move the court against the Speaker's ruling."

"The Speaker's wrong cannot be righted by the Governor's wrong," she maintained. If the Speaker had done wrong by not allowing an MLA to vote, the Governor had no power to dismiss the Government ignoring the Speaker's ruling that the Parrikar Government had won the trust vote.

Rane's career is a saga of political survival

Panaji: It is not always easy for a chief minister to stay afloat for about 33 years in active politics. Many retire or simply tire out. But why would Pratapsingh Rane, who loves the ranches and has a passion for horse riding?

The Congress chief minister, who did his MBA in Texas, worked for the TATA in Jamshedpur before being handpicked by the first chief minister of Goa to lead the state as the longestserving chief minister never fails to introduce himself first as a farmer. Down but not out since 1998, when his government was brought tumbling down by the state NCP president and sole MLA of his party in the present assembly, Wilfred D' Souza, the seniormost Congress leader has risen like the proverbial phoenix.

Rane always remembers D B Bandodkar, Goa's first chief minister who was the undisputed leader of the MGP and came to power in the first election after Goa's liberation in 1961. He did not fail his mentor who too had a long stint until he died in the early 1970's.

Suave, very watchful and one who is respected by leaders across the political spectrum, Rane bounced back when he was sworn in by the governor on Wednesday night. The mantle of leading a Congress-led government fell on him as it was an open secret that he was the only consensus candidate.

His is a known face to the governor, S C Jamir who too served long as the Congress chief minister of Nagaland before taking up the gubernatorial posting in Goa for the first time. Both shook hands and exchanged a knowing nod soon after the elderly governor was over

with the swearing in, a few hours after he had dismissed the Parrikar government.

Becoming a chief minister, though, does not excite Rane. Well, you know I have been into politics for a very long period. This is the sixth time, including the time when the state was a Union territory." Soon after he signed the papers, Rane said his priority would be rural development and finding out avenues for providing employment. His ancestral house in Sattari in north Goa, considered a little remote from the capital is a ready reference when it comes to defining development.

Drinking water is still a problem, he says, while describing the backward area where farmers engage in cultivation. Urban slum problem, running the hospitals in a hospitable way and education are some of the priority issues of the new government. And Rane said he would devote much of his time to pull out the state from its present time warp as about 50 per cent of the small population of Goa live in the villages and by any stretch of imagination shall continue to do so owing to the peculiarity of the townvillage concept of life.

NEW DELHI, Feb. 3. — The BJP is contemplating moving the court after the Goa Governor's decision to dismiss the Manohar Parrikar government. While some leaders are optimistic about a favourable court ruling. others believe they should defeat the Congress-led Pratap Singh Rane government during the confidence vote.

Former Goa chief minister Mr Manohar Parrikar, whom senior BJP leader Mrs Sushma Swaraj addressed as the chief minister, paraded 17 MLAs, including the UGDP MLA, Mr Mathany Saldanha, before the media at the BJP office today. Goa Speaker Mr Vishwas Satharkar was not there.

Later, the delegation met the President and submitted a memorandum demanding recall of Governor M/SC

ernment. "The Governor has no powers to annul the Speaker's ruling. Judiciary is the sole forum before which an appeal can be made against Spea-ker's ruling," it said. Mr Atal Behari Vajpayee, Mr LK Advani and former Goa Governor Lt-Gen. (Retd) JFR Jacob were also present. The BJP brass will discuss its strategy tomorrow.

The BJP said the Governor's messenger arrived at the Assembly with the dismissal letter at 5.45 p.m. "as per Assembly records" whereas the Speaker adjourned the Assembly at 5.45 p.m. "It takes at least 15 minutes to drive from the Raj Bhavan to the Assembly," Mr Parrikar said. "This means the Governor had prepared and signed the letter of dismissal before the outcome of the trial of strength and before receiving an official report from the Speaker," he said. "I already set in motion efforts to destabilise my government under directions from Congress high command, he said. That the Governor asked him to prove his majority immediately but gave 30 days to Mr Rane to do so has also upset Mr Parrikar.

The BJP is awaiting the disqualification of Independent MLA Mr Phillip Neri Rodrigues, who was elected

A FARCICAL VOTE OF CONFIDENCE

THE SUDDEN POLITICAL convulsions that gripped Goa have seen the emergence of its 14th Chief Minister since 1990 under circumstances that are bound to be debated fiercely between the main protagonists, the Bharatiya Janata Party and the Congress, and possibly in the courts as well. Things seemed to be following the constitutionally ordained course, with Governor S.C. Jamir asking Chief Minister Manohar Parrikar to demonstrate his support in the Legislative Assembly and the State Cabinet opting for an early session to seek a vote of confidence. Yet the floor test turned out to be an exercise tainted by the Speaker's partisan act of keeping an independent MLA (who failed to appear before him for an enquiry on his disqualification) out of the House for "disorderly conduct" in an attempt to manage a majority for the Parrikar Government. The Speaker also counted an opposition Maharashtrawadi Gomantak Party MLA as a ruling camp supporter before declaring that the Government had the support of 18 members in a House of 36, down from 40 after the resignation of four BJP MLAs. In the end, the highly desirable democratic exercise was turned into a farce, with a supposedly neutral and fair constitutional functionary displaying blatant partisanship and prompting the Governor to disregard the vote and dismiss the Government.

This is not the first time that voting within a legislature has been turned into a charade with the Speaker changing the rules of the game and manipulating the outcome. A blatant instance was witnessed in the Tamil Nadu Assembly in 1988 when a large section of the Opposition was evicted from the House and the Janaki Ramachandran regime was declared to have won the confidence vote — the vote was discounted and the Government dismissed by the Governor. In Meghalaya in 1991, the Speaker disallowed the votes of four independent MLAs against whom

disqualification petitions had been filed, even in the face of a Supreme Court directive staying his enquiry on the petitions, declared a tie, and cast his vote to "defeat" the Government. The Supreme Court in the S.R. Bommai case held that the dismissal of the Meghalaya Government on the basis of such manipulated voting was clearly unconstitutional:

If the Congress Government headed by Pratap Singh Rane assumes office under circumstances that are controversial, his hurried swearing in probably reflects the desire of the Congress Party to keep the focus on the Governor and within the State, and avoid the imposition of President's rule that would take the issue to Parliament and to the national level. The 15-member Congress Party has additionally the support of three other members — one each from the MGP and the Nationalist Congress Party, and one independent — while the BJP combine has the same strength of 18 including the Speaker. Managing the numbers is going to be a difficult task for Mr. Rane, particularly if the Speaker has to be replaced by someone from the Congress ranks. The options before him are not quite edifying - persuading the United Goans Democratic Party legislator now aligned with the BJP to cross over or persuading some of the BJP MLAs to resign (party splits even with one third or more of the members no longer being allowed under the amended anti-defection law). Goa Speaker's order was the trigger

PANAJI, FEB. 3. The crisis in the Goa Legislature on Wednesday when the Manohar Parrikar Government faced the vote of confidence was triggered by the Speaker's order to an Independent MLA — whose vote was crucial for the Congressled coalition to defeat the Government - to withdraw from the House for "disorderly behaviour.

With swift political developments since Saturday, the strength of ruling BJP had come down from 24 to 17 not including the Speaker (after four BJP MLAs resigned and two Independents withdrew support) and that of the Congress had increased to 18 (Congress 15, NCP Maharashtrawadi Gor Gomantak Party 1 and Independent 1). Unless the Parrikar Government won over either the MGP MLA or the Independent MLA, it could not have ensured a tie during voting. A tie would have enabled the Speaker (who is from the BJP) to exercise his

When the Parrikar Government could not get the support of the MGP MLA, Ramakrishna Dhavlikar, whose party had issued him a whip, it attempted to win over the Independent MLA, Filipe Neri Rodrigues. Mr. Neri was with the Congress MLAs in the run-up to the voting. A BJP MLA then filed a disqualification petition against Mr. Neri on the grounds that he had become an associate member of the BJP in October 2002.

The Speaker issued notice to Mr. Neri and summoned him to his office thrice on Wednesday. Mr. Neri reportedly said he would meet him after the session. Congress legislators had already met the Governor on Wednesday afternoon apprehending disqualification of Mr. Neri by the Speaker. However, the Speaker, Vishwas Satarkar, had reportedly assured the Governor that he would allow all the 36 members to enter the House.

The session started smoothly with Mr. Parrikar tabling the one-line motion and the Oppo-

sition leader, Pratapsinh Rane, initiating the discussion. After the House reassembled at 5 p.m. on Wednesday, Mr. Satarkar ordered Mr. Neri to with-draw from the House under Rule 289 (disorderly behaviour) drawing strong protests from the Congress members. When Mr. Neri was ordered to be physically removed, the Congress members rushed to his rescue. The Speaker's plea to continue the debate went unheeded; he then put the motion to vote.

During the head count, Mr. Dhavlikar, who apparently stood up to protect Mr. Neri, was also counted "in favour" of the motion. This took the total number in favour to 18 and those against were counted as six, as some Congress members were not in their seats

On counting Mr. Dhavlikar "in favour" of the motion, Mr. Satarkar said Mr. Dhavlikar stood up when he asked those in favour to say "aye," and that he did not know about his withdrawal of support to the Parikkar Government.

He said the Governor, who had asked the Speaker to conduct the special Assembly session and send a report immediately, did not even wait for the report. "He not only disregarded the House, but also his own words,' he added.

Mr. Parrikar said the action was pre-meditated as none of the Congress members was prepared to attend the session and went to the Governor in the afternoon.

'It was probably cooked up in the afternoon when they went to [the] Raj Bhavan in the afternoon, where [the] senior Congress leader, Priyaranjan Das Munshi, was also present, and



Parrikar Government wins trust vote

PANAII, FEB. 2. The Manohar Parrikar Government in Goa won the vote of confidence amid high drama that unfolded in the State Assembly soon after tea break here today. According to the Speaker, Vishwas Satarkar, the motion moved by Mr. Parrikar seeking confidence of the House on his Government was passed by 18 to six votes.

Everything was going on smoothly when the House met at 2.30 p.m. at the Assembly Complex at Porvorim near here, after the Governor, S.C. Jamir, convened an emergency session directing Mr. Parrikar to seek a vote of confidence.

The Speaker had reportedly assured the Governor that all the 36 members would be allowed to enter the House, amid reports that the independent MLA, Filipe Neri Rodrigues, against whom a disqualification petition was pending, would be disqualified before the House assembled.

When the House reassembled at 5 pm, Mr. Satarkar asked Mr. Neri to withdraw from the House under Rule 289 of the Business Rules, prompting the entire Opposition to protest in a single voice. When the Speaker repeated his order and directed the Marshal to physically remove Mr. Neri, some Congress members formed a human fort around Mr. Neri to protect him, while some other members were seen pushing the Marshals

In the melee, Mr. Satarkar announced that he would put the motion to vote, making the Congress members to rush back to their seat.

However, they again came back to protect Mr. Neri who was being taken out of the House and the Speaker declared that the motion was passed by the House before adjourning it.

Neri defied Speaker's

Mr. Satarkar later told The Hindu that Mr. Neri persistently disobeyed his order to make a personal appearance before him in connection with a disqualification petition filed against the latter. "I had called him at 10 am, 2 pm and 4.30 pm to my Chamber and he did not turn up," he said.

turn up," he said.
"As such, I considered it as disorderly behaviour on the

premises of the House and asked him to withdraw from the House," Mr. Satarkar maintained.

He further said Congress members resorted to violence and assault on the marshal and affected the conduct of the House.

There was no way but to put the motion to vote, as they did not heed to my request to maintain decorum of the House, he said.

He did not pass any order disqualifying Mr. Neri nor directed him to abstain from voting, he said. Mr. Satarkar further maintained that Speaker was supreme as far as the legislature was concerned.

'Democratic norms flouted'

The Congress members maintained that the action of the Speaker was in violation of the set principles of democracy. They said Mr. Satarkar had thrown all norms to the winds and allowed himself to be manipulated by the ruling front. "Democracy has been trampled in the House," they shouted and rushed to the Raj Bhavan to complain to the Governor.

Centre feels relieved

NEW DELHI, FEB. 2. Though the Centre had not given any instruction to the Goa Governor, S.C.Jamir, there is a sense of satisfaction in the ruling political establishment that the Goa Assembly Speaker, Vishwas Satarkar, finally over-played his hand and provided the Governor sufficient justification to use his gubernatorial discretion to withdraw his pleasure from the Chief Minister, Manohar Parrikar.

When the governmental crisis erupted first a few days ago, the Union Home Ministry is believed to have advised the Governor that the floor of the Assembly should be the forum to determine whether the Manohar Parrikar Government had lost its majority.

While the political judgment was that the BJP Government had been reduced to a minority, the decision still was to let the events unfold themselves in Panaji. There was no enthusiasm for invoking the Article 356, given the Left parties' as well as the allies' distaste for using the emergency provisions of the Constitution.

At the same time, the calculation was that the BJP's national and State-level leaders would raise the decibel level about the Governor's alleged partisanship in the hope that when the Speaker did play a partisan role it would not get noticed. Mr. Satarkar played as per the Congress script. His role in denying the independent MLA, Filipe Neri Rodrigues, a vote after letting him attend the debate for three hours was clearly seen as abuse of the Chair's authority. The BJP bluff got called by the Governor, thereby sparing the Centre the difficult choice of having to take a decision

EPF rate hiked

NEW DELHI, FEB. 2. The Government today raised the rate of interest on the Employees Provident Fund (EPF) to 9.5 per cent for the year 2004-05.

The Finance Minister, P. Chidambaram, announced this after a meeting with the Prime Minister, Manmohan Singh, today. The interest rate had been under review for a long time and the Left parties had strongly protested against the decrease in the rates announced by the Labour Ministry in August when the interim interest rate had been fixed at 8.5 per cent.

An official notification would be issued by the Finance Ministry tomorrow, Mr. Chidambaram told reporters after the meeting. The rate of interest for the year 2002-03 had been fixed at 9.5 per cent while it was decreased to 9 per cent in the following year with a one-time bonus of 0.5 per cent to mark the Golden Jubilee year of the EPF Organisation Board of Trustees. However, these rates were yet to be notified.

Goa: BJP may go to court

NEW DELHI, FEB. 2. Both the Bharatiya Janata Party and the Congress today described the political events in Goa leading to the dismissal of the Parrikar Government by the Governor as "murder of democracy," even as the BJP president, L.K. Advani, did not rule out the possibility of his party challenging the Governor's decision in court. As the news of the Goa Governor's decision reached here, the BJP went into a huddle with Mr. Advani calling an emergency meeting of the central party office-bearers to discuss the options.

The former Prime Minister, Atal Bihari Vajpayee, also attended this meeting. The BJP demanded that the Governor be recalled and the Parrikar Government re-instated.

The Congress leader, Ahmed Patel, who is political secretary to the Congress president, said the independent MLA, Philip Neri Rodrigues, had participated in the discussion leading to the Government seeking a vote of confidence. It was after the tea break just before the vote was to be cast that the

Speaker disqualified him, Mr. Patel said, adding that "this was blatantly unconstitutional."

Another party leader commented that the Governor had no option but to dismiss the Government after the "unconstitutional act" of the Speaker denying an MLA the right to vote. Mr. Advani told reporters at a press conference that "even if the Governor suspected some irregularity in the Speaker's decision he should have awaited a report on the incident before taking a decision." He said the vote of confidence was cast at 5.40 p.m. and within 30 minutes, the Governor's report was ready and he sent off a letter to the Chief Minister, Manohar Parrikar, that he was "withdrawing his pleasure" and dismissing his Government. No reasons were given in that letter, according to Mr. Advani.

Mr. Advani said, "it was clear that the Governor had already made up his mind to dismiss the State Government ... I cannot find words to criticise his action." The BJP has decided to call on the President tomorrow and seek his intervention.

Congress stakes claim to form Goa government

'MAJORITY DESPITE 3 MLAs READY TO QUIT'

EVEN AS three Congress MLAs were understood to be close to resigning from the Assembly, Congress leaders in Goa on staked their claim to form the government on Monday, citing majority in the state assembly, GPCC chief Luisinho Faleiro said.

After meeting the Governor, Faleiro said that the newly formed United Legislative Front had elected Pratap Singh Rane as their leader.

Goa has been locked in a political stalemate after resignation of four BJP MLAs and the withdrawal of support of two legislators of the regional parties supporting the BJP-led state government.

The BJP, however, said it was close to finalising a deal with the three disgruntled Congress MLAs that could significantly dent Congress' bid to form a new government after the Parrikar ministry was reduced to a minority.


Congress has 15 MLAs of its own and has claimed the support of four more MLAs of Maharashtra Gomantak Party, UGDP, Independent and NCP to claim the support of 19 MLAs in the 40-member House with an effective strength of 37.

The AICC has, for the moment, adopted a "wait-and-watch" stand even as the rival parties in Goa prepare for the big fight, presumably on the floor of the House. But sources say the party can form a stable government. AICC general secretary Margaret Alva, has already held discussions with the high command.

However, chief minister Manohar Parikkar today claimed that the Speaker had accepted the resignation of BJP MLA Pandurang Madkaikar, while Tourism Minister Mathany Saldhana, whose party has extended support to the Congress, expressed his backing to the BJP government.

With the acceptance of Madkaikar's resignation BJP now has 17 members in the Assembly and with Saldhana's support the ruling party reaches the halfway mark.

The state Cabinet, which met this morning, decided to recommend to the Governor that the Assembly session be convened on February 3, the chief

He met the chief minister and other BJP leaders and assured them of his support. Meanwhile, cautioning Congress against daring to "destabilise" an



Pakistan today said it has invited Prime Minister Manmohan Singh for a state visit and the invitation has been accepted in principle. "We had suggested March," Pakistan foreign office spokesman Masood Khan said. "But we do not have any confirmation of when he would actually come."

New Delhi, Jan. 3 (PTI): Zahi- ment on December ra Sheikh today told the Supreme Court that no affidavit sworn by her was ever filed in the court, based on which the Best Bakery trial was shifted from Gujarat to Mumbai and the acquittal of 21 accused quashed.

The bakery witness' latest affidavit came in response to an apex court notice on an anplication filed by Teesta Setalvad, a social activist whom Zahira has accused of pressuring her to implicate innocent people in the case.

In her application to the Supreme Court, Setalvad sought a CBI probe into Zahira's frequent flip-flops.

The apex court, taking cognisance of Setalvad's application, had issued notices to Zahira and the Gujarat govern6. The bench of Justices Arijit Passayat and H.K. Sema wanted to know if Zahira's latest statement in favour of the accused did not amount to filing a false affidavit and hence be seen as a contempt of court.

In retaliation through counsel D.K. Garg, Zahira today just stopped short of accusing Setalvad of filing a forged affidavit on her behalf.

"All these matters contain an affidavit supposed to have been filed by me in September 2003. I do not recall having made any such affidavit because this one 'compulsive document', which is found in every

writ or application or appeal does not contain any evidence of my having sworn it as it does not bear my signature, nor is there any sign of having been sworn to or affirmed before any authority competent to administer oath," the affidavit said.

Zahira termed the so-called affidavits filed on her behalf and another in her sister's name by Setalvad's NGO as "leaflets", as they had no official authentication on it.

"Surprisingly, also annexed with this affidavit is another so-called affidavit dated August 2003, supposed to have been filed by my sister Saira Banu, and this so called affidavit is neither addressed to any court nor to any authority, nor does it bear the signatures of any authority or person who is competent to administer oath. These two documents appear to be leaflets, distributed for free," she said.

Zahira termed the Tehelka sting operation - which pointed fingers at BJP MLA Bablu Srivastava for allegedly bribing her to change her statement — as "blatant falsehood".

The witness said Setalvad had "incited so much hatred against me that the Muslim Tyohar Committee... issued a fatwa, excommunicating me.' She reiterated her allegation that "Setalvad and her agents" had pressured her in the name of "religion" to falsely implicate persons in the case.

With the Governor, S.C. Jamir, reportedly considering the options available to him and with only information on withdrawal of support of regional parties' MLAs to the Government coming out of Raj Bhavan, everyone was kept guessing.

While the Congress, along with the Maharshtrawadi Gomantak Party (MGP), the United Goan Democratic Party (UGDP) and an independent formed the United Legislature Party (ULP) and demanded the dismissal of the BJP-led Government, the Chief Minister, Mr. Manohar Parrikar, maintained that he would prove his majority on the floor of the

House. Some Opposition leaders today met the Governor.

Parrikar defiant

Mr. Parrikar told *The Hindu* that he was putting up a great fight to save the State from the hands of "undeserving" people after having put it on the path of development. He said that the Tourism Minister Matanhy Saldanha, whose support Mr. Saldanha's party, the UGDP, claimed to have withdrawn, was still with him. In fact, he had sent a fax from an undisclosed location (presently he is out of country) extending his "unqualified and unconditional" support to the Government, Mr. Parrikar said and added that it had been handed over to the Governor.

The State BJP chief, Rajendra Arlekar, said that he welcomed the reported decision of the Governor to convene an emergency Assembly session to test the strength of the Government.

Crisis in Goa as three BJP MLAs quit

Ready to prove majority: Parrikar

PANAJI, VAN. 29. In a day of swift political developments, three MLAs from the ruling Bharatiya Janata Party put in their papers, reducing it to a minority in the 40-member Assembly. Three Ministers belonging to regional parties also withdrew their support to the 32-month-old Manohar Parrikar Government. The BJP now has 18 MLAs.

The three BJP MLAs and two Ministers met the Governor. S.C. Jamir, who cut short his visit to his home State and arrived here this morning.

The BJP MLAs who resigned included the Taleigao MLA, Atansio alias Babush Monserrate, who resigned from the Council of Ministers on Friday after being stripped of the Town and Country Planning Department portfolio, the Poinguinim MLA, Isidore Fernandes, who recently won the by-election on the BJP ticket after resigning from the Assembly as a Congress MLA, and Francisco alias Micky Pacheco, who had merged his United Goan Democratic Party (UGDP-Micky) with the BJP on Thursday.

The Maharashtrawadi Gomantak Party MLA, Ramakrishna alias Sudin Dhavlikar, the ha was still with him and added

Rodrigues, both Ministers, met the Governor and conveyed their decision to withdraw their support. The UGDP general secretary, Radharao Gracias, submitted a letter withdrawing his party's support, while its lone MLA and Tourism Minister, Matanhy Saldanha, was out of the country.

The Governor was learnt to have said that he would have to step in to ensure a stable government, while expressing displeasure over the BJP's "attitude of inducting MLAs from other parties by various means.

However, Mr. Parrikar claimed that he was still the Chief Minister, saying that the Rai Bhavan lawns were not the place to prove the majority and that he was prepared to prove it on the floor of the Assembly. He had the required numbers and was in a comfortable position, he claimed.

He told presspersons that Mr. Jamir was "acting like a Congressman." He said that the two Ministers had not submitted the resignation letters to him. which was mandatory.
