Decline and fall of the RJD

ifteen years after he took Bihar by storm, Lalu Prasad has been handed a drubbing so severe it has stunned pundit and pollster alike. That the sun was setting on the 15-year reign of the Rashtriya Janata

Dal was obvious enough. Yet neither the exit polls nor reports emerging from the field captured the scale of voter dissatisfaction with what, in the final months, came to be seen as the Lalu-Buta regime. In the event, it was a clean sweep for the Janata Dal (United)-Bharatiya Janata Party combine spearheaded by Nitish Kumar. Of the 243 seats on offer, the JD (U)-BJP has mopped up 143, leaving 65 to the RJD-Congress-Communist Party of India (Marxist) alliance. As expected, the Ram Vilas Paswan-led Lok Janshakti Party-Communist Party of India alliance finished at the bottom of the pile with 13 seats. Without any doubt the election belongs to Mr. Kumar. Working determinedly among the people, the JD(U) leader capitalised on the many follies of Governor's rule. A key strategy was to woo oppressed caste groups long neglected by the RJD. The addition of a good chunk of the votes of Most Backward Classes to the JD (U)-BJP's kurmi-upper caste base appears to have tilted the balance against the RJD. Who would believe that 18 months ago, Mr. Prasad's party with its allies, the Congress and the LJP, made short work of the National Democratic Alliance, capturing 29 of Bihar's 40 Lok Sabha seats on a 44.4 per cent vote share?

This picture-perfect alliance was in tatters by February 2005. With the Congress opting to go with Mr. Paswan, the RJD lost that Assembly election. But it was still the single largest party, with 75 seats and a vote share of 25.05 per cent. Since then, it has lost 21 seats and a couple of percentage points in vote share. This is a huge decline from the 30.7 per cent the RJD polled in the May 2004 Lok Sabha election. The RJD-Congress-CPI(M) alliance seemed to have conventional arithmetic on its side but what is clear is that this cannot overcome swings in the popular mood. Two factors appear to have done in the alliance. The first was the perception that Mr. Prasad was a proxy ruler who manipulated the Raj Bhavan and refused to play fair. The second factor was the Union Cabinet's midnight decision to dissolve the House. The Supreme Court's verdict holding this act to be unconstitutional sealed Mr. Prasad's fate. The RJD chief is not one to be underestimated: he retains considerable support among the deprived. Meanwhile, there is a need for serious reflection on the recent trend of low voter turnout in Bihar. It declined from 46.5 per cent in February 2005 itself a massive drop from 2000 - to 45.5 per cent this time. Such evidence of voter apathy is all the more intriguing considering the nature and size of the JD(U)-BJP victory. A high voter turnout, signifying protest on the one side and enthusiasm on the other, was a feature of recent elections that delivered emphatic mandates - in Madhya Pradesh, Rajasthan, Andhra Pradesh, and Haryana. Nitish Kumar's triumph is a significant break from this pattern.

Bad day for RJD Siwan don snared in Delhi



NEW DELHI, Nov. 5. — The Rashtriya Janata Dal MP, Mohammad Shahabuddin Khan, wanted in about three dozen criminal cases, was arrested today. The MP from Siwan was picked by Bihar police from his official residence at 5 Bishambhar Das Road. The officers, camping in the Capital, had been tipped off by Delhi Police.

The MP from Siwan was not even allowed a change of clothes, brought to Parliament Street police station by an aide. A five-member Bihar Police team led by sub-inspector Gauri of Hussainganj police station raided Md Shahabuddin's residence around 1 p.m. today. The RJD leader had apparently arrived there late last night. Bihar police are seeking transit remand of Md Shahabuddin to take him to Siwan. The MP was first taken to Ram Manohar Lohia Hospital for a checkup after he complained of chest pain. "He will be produced at the court of the designated magistrate hearing the transit remand plea later," a Bihar officer said.

Md Shahabuddin had been evading arrest since eight non-bailable warrants were issued against him. A nation-wide alert was sent out in August by Bihar Police after it was accused not doing much to nab the RJD leader. The MP has as many as 34 criminal cases and eight non-bailable arrest warrants pertaining to seizure of foreign-made arms, ammunition and currency, pending against him.

The Siwan district and sessions judge, Mr Abhijit Sinha, had rejected Md Shahabuddin's anticipatory bail plea on 24 October. He was hearing a case in which the MP had been accused of falsify-

ing the number of cases pending against him in the affidavit affixed to his nomination papers submitted ahead of the Lok Sabha polls last year.

On the instructions of the then district magistrate of Siwan, Mr CK Anil, a case had been registered against Md Shahabuddin for putting down the number of cases pending against him as 19 when it was in reality 34. Mr Sinha again rejected the MP's anticipatory bail petition on 28 October in a case pertaining to recovery of firearms of foreign make during raids on his house in April 2005. At that time, automatic pistols of German make and cartridges made in Pakistan had been recovered.

The RJD MP, who has never lost an election in his life, was externed from the district last month until 20 December by district magistrate Mr SK Mal in apprehension of a breach of the peace during the Bihar elections.



Denying that her party was responsible for a division in the Left Front in the state ahead of the polls, she said the CPI-M and the CPI had contested assembly election separately in the last edition.

Third front by Sept 23?

LJP leader Ram Vilas Paswan said efforts were on to have a perfect seat-sharing arrangement among UPA partners minus the RJD in Bihar. However, Paswan said the picture of the third front, comprising the LJP, CPI and CPI-ML (Liberation), was likely to get clearer by September 23 when the Election Commission notifies elections in constituencies going to polls in the first phase, on October 18.

Referring to CPI-ML general secretary Dipankar Bhattacharya's statement advising Paswan to break ranks with the UPA and strive for "a broader front" against the RJD and NDA, Paswan said though the LJP had not initiated any talks with the CPI-ML, CPI leaders were in touch with the latter.

"The CPI-ML's anti-Congress and anti-RJD stand is known. The CPI-ML cannot join hands with any party having a poll pact with either of the two parties," he said, hinting at the possibility of seat-adjustments with the CPI-ML. PTI

Congress issues Sept 23 deadline to Paswan

THE Congress on Wednesday gave a deadline to LJP chief Ram Vilas Paswan upto September 23 to decide whether it wanted to come with RJD-led UPA in the coming Bihar

Assembly polls.

"It cannot be open ended, the obvious deadline is September 23 when the notification for the polls will be issued," AICC gener-al secretary Digvijay Singh told reporters after Mr Paswan had an hour-long meeting with Sonia Gandhi. Ms Gandhi told the LJP leader that "we cannot wait for-

ever", according to Mr Singh.
Mr Singh said during the
meeting Mr Paswan conceded that if a third front is floated it would obviously benefit the BJP-led NDA. Mr Digvijay Singh, who is in charge of Congress affairs in Bihar, said Mr Paswan had sought some time and his party wanted the LJP chief to decide about his position as early as possible.

"You tell me is it viable?" Mr Singh shot back at a questioner when told Mr Paswan was still insisting on an "anti-RJD, anti-BJP formulation" for the coming



polls. He merely said it was not for him but for the UPA to decide whether Mr Paswan could remain in the alliance at the Centre if he failed to be with it in Bihar.

Asked whether the Congress was exasperated with Mr Paswan and making efforts to rope him in the UPA in Bihar, Mr Singh said it



was not so. "One has to have patience. The Congress president has immense patience," he said.

Mr Singh dismissed it as hypo thetical, a query whether Mr Paswan had agreed to help the UPA form the next government in Bihar if the assembly throws up a hung verdict.

CM SHOULD BE A MUSLIM, INSISTS LJP CHIEF

NEW DELHI/RANCHI May 22. - Following the rebellious mood of the Lok Janashakti Party MLAs, its chief, Mr Ram Vilas Paswan, today gave tacit consent to the process of an RJD-led government formation in Bihar — provided the chief minister is

from a minority community.

The government formation process was accelerated today after a majority of LJP MLAs came out openly against Mr Paswan. Worried over a possible split, the LJP chief today met the Union home minister, Mr Shivraj Patil and the AICC leader in-charge of Bihar, Mr Harikesh Bahadur.

Mr Paswan paraded 10 of his 29 MLAs before Mr Bahadur and claimed that he had the support of two more MLAs who are in jail.

He reportedly accepted Mr Bahadur's "formula" of an RJD-led government minus Mr Lalu Prasad's family. Mr Patil also met Mr Prasad after which he reportedly sought a detailed report from the Governor, Mr Buta Singh.

Mr Paswan said that he had no objection whether RJD gave outside support or joined the proposed government in Bihar. "My only demand is that the chief minister should be a Muslim and Mr Prasad's family should not take part in the government," he said.

The leader of the LJP rebel MLAs, Mr Narendra Singh, however, said most of the MLAs were in favour of a non-RJD government. Ruling out possibility of a split, Mr Singh said that it was only because of Mr Paswan's stubbornness that LJP MLAs were in rebellious mood.

Also today, the dissident LJP MLAs who had shifted base from Chandil to Ghatshila threatened to split the party if Mr Paswan does not join hands with the NDA. The 12 LJP MLÅs and five from the JD-U were today joined by three more legislators - Mr Munna Shukla (LJP), Mr Lallan Singh (JD-U) and Mr Jagdish Sharma who is the leader of the 17 Independent legislators in Bihar.

Patna bandobast fuels speculation

PATNA, May 22. - Amid the political high drama. all roads leading to Raj Bhavan in Patna have been sealed, fuelling speculation. The police have been put on maximum alert. In addition, four companies of RAF have been deployed in and around Raj Bhavan and the state government has sought another 50 companies of paramilitary forces from the Centre. The Bihar Governor, Mr Buta Singh, is in New Delhi. Two theories are doing the rounds. Some one from among the "secular" parties may be administered the oath as Bihar CM. This will spoil the NDA's chances of causing a split in the LJP and staking claim to form the government. Second, the Governor may dissolve the state Assembly kept in suspended animation. — SNS

Taraiyya MLA Mr Janak Singh said that Mr Paswan should give up his rigid stand. He claimed the support of 22 LJP MLAs and said that it is now left to Mr Paswan to join them. However, another legislator, on condition of anonymity, said that the LJP was still well short of 20 MLAs. With Mr Munna Shukla's arrival, the number of LJP MLAs camping in Ghatshila has gone upto 13. There were reports that some senior JD-U leaders were also heading to Ghatshila to meet the dissident LJP MLAs.

Lalu threatens to file FIR

Mr Lalu Prasad today threatened to file an FIR against "horse-trading" and "wrongful confinement" of MLAs, adds PTI. "I will file an FIR against the horse-trading and wrongful confinement of legislators in Bihar." Mr Prasad said just as cattle were sold and purchased at the Sonepur cattle fair in Bihar, MLAs were being bought. He, however, remained non-committal on the issue of government formation in Bihar when asked whether his party would stake claim.

Crisis for Paswan as Nagmani quits LJP

Rumours Of Talks Between Several Party MLAs, JD(U)

Patna/New Delhi: The Ram Vilas Paswan-led Lok Janshakti Party (LJP), which holds the key to power in Bihar, was thrown into turmoil on Saturday when party secretary-general Nagmani resigned amid claims that a section of LJP MLAs were "holding talks" with the Nitish Kumar-led Janatal Dal(U) over the formation of the state's government.

of the state's government.

Nagmani, who quit the primary membership of the party, accused Paswan in Patna of "intransigence" on the issue of supporting the BJP-led NDA and claimed a revolt by LJP MLAs was imminent.

Paswan, whose party has 29 MLAs in the 243-member house, told reporters in Delhi that attempts to split his party would not succeed even as he hinted at the involvement of both the NDA and Lala Prasad's Rashtriya Janata Dal (RJD) in Nagmani's move.



The RJD, which lost power in the assembly polls over two months back, has 75 MLAs while the NDA has 92—JD(U) 55 and BJP 37. The Congress, which has thrown in its lot with the RJD, has 10 members, the CPI-ML seven, Samajwadi Party four, the NCP and CPI three each, the BSP two and CPI(M) one. In addition, there are 17 independents.

Nagmani himself maintained that at present there was no revolt

and dismissed as "rumours" reports that a sizeable number of LJP MLAs were in Jamshedpur to explore with the JD(U) the possibility of installing a popular government in Bihar. However, his wife Suchitra Sinha, an LJP MLA, said if Paswan was not becoming the chief minister, the only option was Nitish Kumar.

Amid speculations of a split in the 29-member LJP legislature party, president of the party's dissolved Bihar unit Narendra Singh urged Paswan to offer support to Nitish Kumar to form a non-RJD government.

Meanwhile, Bihar governor Buta Singh had a 30-minute meeting with Union home minister Shivraj Patil on Saturday after which he said he was keeping a constant watch on the situation and would intervene at the "right moment"

LJP rebels root for JD-U

Paswan's LJP tottered on the verge of a split on Saturday with at least a dozen MLAs revolting in favour of a government led by JD(U) leader Nitish Kumar.

Munna Shukla, the donturned-MLA, galvanising the pro-NDA elements within the LJP, told Express that Paswan must now see reason and support Kumar in forming a government. Shukla, however, denied his involvement in ferrying MLAs out of Bihar. "MLAs are doing it on their own and I am unaware of the developments. I spent time in the LJP office even today. But I do request to Ramvilasji that he come around in support of a Nitish government," Shukla said.

Though there are versions on how many MLAs have crossed over — it varies from 12 to 17 — it is already clear that a larger number of LJP MLAs are in support of the NDA government. Sources in

the rebel camp, dominated by upper caste MLAs, said they read Paswan's recent moves as reaching out to the RJD. "We could not tolerate it any longer. At this rate, he (Paswan) would have supported a Rabri government soon. And under Governor's rule, it has been Laloo's wishes that get implemented," an MLA said.

Sources said more than a dozen LJP MLAs had reached Jharkhand and were in the "safe custody" of a BJP-led government in the state. Four other MLAs languishing

in jails were also learnt to have extended written support for the JD(U) government. Except four, the rest of the 29 LJP MLAs now appear to be susceptible. Though the operation engineered by the NDA was on for some time, the move was busted after the MLAs landed in Jharkhand. Coinciding with this development was the resignation of LJP's national general secretary Nagmani from the party. At a press meet here, he declared that he had chosen to resign to form an anti-RJD government led by Kumar. His wife is an LJP MLA. Along with him LJP state president Narendra Singh too spoke in favour of a Kumar-led government.

NDA leaders claimed they had mustered more than the magic figure of 122. In the 243-member Assembly, the NDA has a strength of 92 — 55 of JD(U) and 37 of BJP. Of the 17 Independents, 15 had extended their written support in favour of a JD(U)-led government. But the support of LJP MLAs was needed to garner a simple majority.

Another rap on Lalu

Charges framed against 39 in fodder case

Ranchi, May 17

A SPECIAL CBI court on Tuesday framed charges against railway minister Lalu Prasad Yadav in yet another fodder scam case in connection with the fraudulent withdrawal of Rs 3.13 crore from a government treasury after rejecting his discharge plea.

This is the second fodder scam case in over a fortnight in which charges have been framed against Lalu.

The charges were read out in the court of CBI special judge Sanjay Prasad in the presence of former Bihar chief minister Jagannath Mishra and 37 others in connection with the case pertaining to the illegal withdrawal of funds from Dumka treasury between

December 1995 and January 1996

Forty-nine people were accused in the case. While six have died, three have turned approver.

On April 25, a special CBI court of Umashankar Prasad had framed charges against Prasad, Mishra and 68 others in a case relating to fraudulent withdrawal of Rs 37 crore in 1996 from Chaibasa treasury, now in Jharkhand.

The CBI has filed

The CBI has filed chargesheets in 60 cases, out of which 53 are being tried in the courts at Ranchi and seven in the courts at Patna.

The Rs 950-crore fodder scam was unearthed in Bihar in 1996 when Lalu was chief minister. He had resigned from the post in 1997 after a court issued a

warrant in one of the cas-

After the creation of Jharkhand in 2000, 39 of the 61 cases were transferred to the new state.

Meanwhile, with a special CBI court framing charges against Lalu, the BJP stepped up its offensive demanding his dismissal from the Union Cabinet.

"Charges have been framed against Lalu for the second time in a fortnight for cheating, conspiracy and under the Prevention of Corruption Act and not for involvement in any political movement. He should resign on moral grounds, or else the Prime Minister should dismiss him", party spokesman Prakash Javadekar said.

Quit, demand RSP, FB


"In view of the fresh charges against him, the second in over a fortnight, Lalu must resign (from the UPA government) on moral grounds", Forward Bloc MP Debabrata Biswas told reporters after a 90minute meeting of the four Left parties ahead of Wednesday's UPA coordination committee meeting.

He said that, till the time Lalu came out clean, he should not join the government.

NEW DELHI, May 11. — Amidst continuing unease, created by his charges against the Election Commission, the railway minister, Mr Lalu Prasad, today stuck to his demand for the dismissal of the two election commissioners even after meeting the Prime Minister, Dr Manmohan Singh, who had only yesterday said the Constitutional Authority (EC) should be respected.

"I still hold the view that the two election commissioners, Mr BB Tandon and Mr N Gopalaswamy, should step down," Mr Prasad said after his meet-

ing with Dr Singh.
"I met him as he returned from his foreign visit. I inquired about his well being," the Bihar strong-man said, refusing to give further details.

Mr Prasad has been demanding resignation of functionaries after the IAS officer, Mr LV Saptharishi, who was the commission's observer for the Chapra Lok Sabha poll last year, had alleged that the two election commissioners had acted at the behest of BJP leader and the then home minister, Mr LK Advani, regarding the decision on countermanding the poll.

During the day, a petition was filed in Delhi High Court for removal of the two election commissioners.

National interest, no less

A day after being given a show-cause notice by the personnel department, Mr Saptharishi said he had done what he had done in the national interest as it was the duty of IAS officers to "protect" the Constitution. The rural development minister, Mr Raghuvansh Prasad Singh, has said that Mr Saptharishi wrote to the law minister, Mr HR Bhardwai, and held a briefing for the press "keeping the Constitution in view. Mr Saptharishi's reply has been sent to the personnel department, Mr Singh said.

Last week, the controversial IAS officer of the West Bengal cadre wrote to Mr Bhardwaj saying that the two election commissioners had attempted to get the poll in Chapra, where the railway minister was a candidate, countermanded. The rail minister is also Mr Raghuvansh Prasad Singh's party boss. Outgoing CEC Mr TS

Krishnamurthy called on Dr Manmohan Singh here this evening, adds PTI.

Describing his meeting as a "courtesy call" Mr Krishnamurthy, term ends on Sunday, said the Prime Minister was appreciative of the EC's role in conducting polls.



Advani and Rajiv Pratap Singh Rudy [BJP candidate] after the poll was over."

Mr. Prasad, RJD candidate in the constituency, defeated Mr. Rudy in the repoll.

Mr. Prasad released copies of the four-page letter written by Mr. Saptharishi, now Director-General of the Council for Advancement of People's Action and Rural Technology, to Union Law Minister H.R. Bhardhwai on Friday, charging the Election Commissioners with bias.

Mr. Prasad said the BJP, the Rashtriya Swayamsevak Singh and the Vishwa Hindu Parishad had "conspired" to prevent him from entering the Lok Sabha. NEW DELHI: The Bharatiya Janata Party has described as "politically motivated" the charges of bias during Bihar elections levelled by a senior bureaucrat against Election Commissioners B.B. Tandon and N. Gopalaswamy. Mr. Tandon is to take over as next Chief Election Commissioner.

"It appears that L.V. Saptharishi has done this at someone's behest or else why should he have kept silent for almost a year," BJP national vice-president Sushil Kumar Modi told reporters here on Saturday. He felt the reason could also be personal rivalry. Mr. Saptharishi, who was Special Observer for Bihar in the last Lok Sabha election, on Friday wrote to the Union Law Minister, alleging that attempts were made by the two Election Commissioners to countermand the election in Chapra.

Rajiv Pratap Rudy, who was the BJP candidate in Chapra, said it was for the Election Commission to come out with details of the reports based on which it had ordered repoll.

Mr. Rudy asked how Mr. Saptharishi could suggest that

the election was peaceful when 10 persons were killed on the polling day and the entire media reported about booth capturing. The Election Commission would have had its own understanding of the situation based on facts and figures before ordering repoll.

Mr. Rudy said that it appeared the episode was aimed at achieving a "post-retirement resettlement". "Why else should he [Mr. Saptharishi] have kept quite for 11 months when the issue could have been taken up as soon as the UPA Government took over," he asked.



Charges framed against Lalu, 69 others in fodder scam case

Lalu, Jagannath Mishra plead innocence, to move the Jharkhand High Court

RANCHI: A special court of the Central Bureau of Investigation on Monday framed charges against the Railway Minister and Rashtriya Janata Dal president, Lalu Prasad, in a case relating to the multi-crore fodder scam.

Besides Mr. Prasad, charges were also framed against the former Bihar Chief Minister, Dr. Jagannath Mishra, the former Union Minister Chandradeo Prasad Verma and 67 others under various Sections of the Indian Penal Code, including 420 (cheating) and 120B (criminal conspiracy).

Mr. Lalu Prasad, Dr. Mishra and 68 other accused were present when the Sections were read out in the special court of the CBI Judge IV (CBI animal husbandry scam cases), Uma Shankar Prasad Sinha.

Conspiracy cases

Mr. Lalu Prasad, who was Chief Minister of Bihar when the scam surfaced, also appeared in another CBI court in a separate fodder scam case. Both Mr. Lalu Prasad and Dr. Mishra pleaded innocence. Their lawyers said they would move the Jharkhand High Court against the CBI court's framing of charges. Mr. Lalu Prasad is also facing corruption charges in six other conspiracy angle cases of the Rs. 950-crore fodder scam.

The trial in the disproportionate assets case against him and his wife, the former Chief Minister, Rabri Devi, is in the final stage of hearing. The disproportionate assets case, an offshoot of the fodder scam, charges Mr. Lalu Prasad with having accumulated assets worth over Rs. 46 lakhs disproportionate to his

known sources of income when he was Chief Minister.

The CBI has filed chargesheets in the six cases, while charges have been framed against Mr. Lalu Prasad and others in two cases — (RC 20(a)/1996 and RC 68(a)/96). While RC 20(a) relates to "fraudulent withdrawals" of Rs. 37 crores from the Chaibasa treasury, the other case relates to "fraudulent and

excessive withdrawals" of more than Rs. 37 crores from the same treasury by Animal Husbandry Department officials through "forged and fake" bills.

Four other cases against the RJD leader deal with "fraudulent withdrawal of Rs. 3 crores from Dumka, Rs. 182 crores from Doranda, Rs. 3 crores from Dumka and Rs. 47 lakhs from the Bhagalpur treasuries." Mr. Lalu

Prasad resigned as Chief Minister on July 25, 1997 after the Supreme Court rejected his anticipatory bail plea and asked him to surrender in case no. RC 20(a)/96.

Those against whom the charges were filed included R.K. Rana, MP, MLA Jagdish Sharma, the former minister, Rajo Singh and Shajjal Chakarvorty, IAS.

Mr. Lalu Prasad said the

charges framed against him were "false". Dr. Mishra also contested the charge, saying he was "innocent." After hearing the accused, the Judge said their version would be included in the proceedings of the court.

A total of 76 were accused. Of them, three have died including a former Minister, while three others turned Government witnesses. — PTI, UNI

Lalu attacked at crash site, blames Modi

HT Correspondents Vadodara/New Delhi, April 21

RAILWAY MINISTER Lalu Prasad Yadav's car was stoned on Thursday when he arrived at the site of the train accident. The attackers are believed to be BJP and Bajrang Dal activists; Lalu accused chief minister Narendra Modi of trying to "eliminate" him and demanded the dismissal of the Gujarat government.

Lalu was unhurt but his car's windowpanes were broken in the stoning by slogan-shouting activists. Even when Lalu visited the injured at a hospital, some VHP activists booed him. They also tried to torch his car, Lalu alleged in an FIR.

Lalu met Prime Minister Manmohan Singh to demand the immediate dismissal of Modi's government. "I apprised the Prime Minister of the situation and the attack, and demanded dismissal of the Modi government and imposition of President's rule," he said after meeting Singh. He has also complained to Lok Sabha Speaker Somnath Chatterjee and vowed to take up the matter with the President.

In fact, Lalu wanted to make a statement in the Lok Sabha on Thursday itself, but by the time he reached Delhi, both Houses had been adjourned for the day. But though he could not make it to the floor of Parliament, his party MPs took up the cudgels on his behalf. Blaming Modi for the "attempt on Lalu's life", RJD members prevented transaction of all business in both Houses of Parliament.

Lalu has demanded an apology from BJP chief L.K. Advani. He charged the "biased" Gujarat government with cooking up exaggerated figures of the dead to give the UPA government a bad name.

"At the hospital, I saw some people with petrol cans. They wanted to set the entire floor on fire," Lalu said, adding: "When I was leaving, some people dropped large ice chunks and water cans on my car. The vehicle was badly damaged."

Nitish Kumar woos Paswan



PATNA, APRIL 2. The senior Janata Dal (United) leader, Nitish Kumar, today began a fresh exercise to form a minority government in Bihar. He sought the support of six political parties and 17 independents. This effort comes almost a month after the failed attempts of the Rashtriya Janata Dal to form a government and the imposition of President's rule in the State.

Mr. Kumar made his plan to form a non-RJD, non-Congress Government public after meeting the Lok Jan Shakti Party (LJP) chief and the Union Steel Minister, Ram Vilas Paswan, at the residence of the Bihar chief of the Samajwadi Party, Daddan Pahelwan, here this morning. According to Mr. Kumar, they have decided to hold parleys in Delhi from April 3 to 5 to work out the modalities for a government minus the Bharatiya Janata Party.

Mr. Kumar has written to the LJP, the Communist Party of India, the Communist Party of India (Marxist-Leninist), the Samajwadi Party, the Nationalist Congress Party, the Bahujan Samaj Party and the 17 independents seeking their support for the 16-point common minimum programme that he has outlined on the basis of the salient features contained in the manifestoes of these parties.

He said the BJP had not been sidelined; it had been taken into confidence while drawing up the blueprint to break the deadlock that had stalled the formation of a government. His idea was clear — the BJP would sup-

port the new dispensation from outside.Mr. Kumar said he was unwilling to seek the support of the Congress as it had been part of the RJD-led coalition that had been defeated by the people.

However, Mr. Paswan continues to maintain that he is opposed to the formation of any government, which has even the indirect support of the RJD or the BJP. He also insists on having a Muslim as Chief Minister. The BJP vice-president, S.K. Modi, however, is of the view that Mr. Paswan has since softened his stand.

The BSP and the CPI(ML)

have made it clear that they would not support any ministry that would have even the outside support of the BJP. The RJD chief and Railway Minister, Lalu Prasad, said the move was a mere "eyewash."

After 15 yrs, MY turn their back on Laloo

HE formidable MY (Muslim-Yadav) combination that had been the bedrock of Laloo Prasad Yadav's empire cracked for the first time in 15 years. The results show that in several regions across the state, the RJD is no longer the sole choice for either the Muslims or the Yadav voters.

Though the details are still trickling in, the erosion of Laloo's support in some areas considered the bastion of Yadav political assertion is more than evident. In Madhepura, the RJD's sitting MLA lost and finished third. The winner is M.K. Mandal, son of B.P. Mandal of Mandal Commission fame. Of the district's five seats, the RJD lost four. In Alam Nagar, the RJD finished third; sitting MLA Ravindra Charan Yadav lost in Kishenganj. In Purnea, as the Yadavs rallied behind the Samajwadi Party, the BJP emerged the winner. In Darbhanga, the RJD lost the Keoti seat because the Yadavs preferred the BJP's Yadav candidate to the RJD's. Amar Yadav lost in Champaran's Chanpatia for the same reason.

In Gopalganj, the RJD' president's home district, the party lost to the BSP as Sadhu Yadav's wife entered the fray as an Independent candidate. Such infighting between competing sections of Yadavs cost the RJD dear across the state. And Laloo admitted as much this evening — "it is infighting among ourselves which has turned out to be our problem". Pappu Yadav, Laloo's foe-turned-friend-turned-foe harmed the RJD no end in the entire Kosi region --- the RJD won only one seat out

Politics, back to student days

■ NEW DELHI: The blood feud between the leading lights of the RJD, Congress and NDA has a history to it. In an interesting coincidence, many of the top players in Bihar were part of Patna student politics three decades ago, at the cusp of the JP Movement. Laloo Prasad Yadav's hostility to Ram Jatan Sinha, now president of the Bihar Congress unit, can be traced back to 1971. That year, Laloo filed his nomination for the presidency of the Patna University Students' Union (PUSU). Sinha, a Bhumihar, put together an upper caste alliance and defeated Laloo.

Two years later, Laloo hit back, tying up, with the ABVP. The combined "opposition" defeated the Congress nominees and, in 1973, Laloo became president of the PUSU. His general secretary was Sushil Modi, while Ravi Shankar Prasad was elected joint secretary. Both are now senior BJP leaders. In 1973 too, the Patna Engineering College Students' Union threw up a backward caste president — Nitish Kumar. Nitish and Laloo became close friends. In 2005, of course, it's another story.

Muslims constitute 16.5 per cent of the state's population and Yadavs 13 per cent, and both have voted for Laloo in the last 15 years. While a marginal section of the Yadavs had strayed ear-

lier too, Muslims had always rallied behind the RJD. This time, trouble had already begun for Laloo when more and more Yadavs started clamouring for Assembly seats. And Ram Vilas Paswan added to the RJD's woes by questioning his credentials in protecting the interests of Muslims.



REVOLT IN JD(S)

THE REVOLT IN Karnataka by four second-rung leaders of the Janata Dal(Secular) against the party president, H.D. Deve Gowda, might have been prompted by their sense of alienation within the organisation. But the issues raised in this process deserve serious consideration. The four, led by Vaijnath Patil, a Member of the Legislative Assembly, have faulted Mr. Gowda for promoting his relatively inexperienced son, H.D. Kumaraswamy, as the working president of the State unit of the party and for taking unilateral decisions. Ouite evidently, these dissenters had great expectations after the JD(S) formed a coalition Government with the Congress following the fractured verdict of the 2004 general election. With the party returning to power after a gap of five years, senior functionaries of the JD(S) were hoping to have a say in the running of the new Government. Not surprisingly, some of those left out of the recent Cabinet expansion felt that Mr. Gowda had betrayed them. The elevation of Mr. Kumaraswamy merely provided an opportunity for Mr. Patil, a former Minister, to bring together other disgruntled leaders against Mr. Gowda. As denial of ministerial berths could not have been projected as an issue of public importance, the "dynastic succession" in the party became the rallying point.

Differences within the JD(S) were earlier activated by the nomination of an industrialist from Tamil Nadu as the party candidate for the Rajya Sabha. The giving away of the seat to a nonmember of the party, that too from outside the State, did not go down well with middle level leaders, who were already aggrieved that seniority in the organisation was being bypassed. The dissenters have cited this as another instance of Mr. Gowda taking unilateral decisions guided by personal motives. Not surprisingly, the main de-

mand of the dissident group, which includes former Minister A. Laxmisagar, former Member of Parliament P. Kodandaramaiah, and former Member of Legislative Council A.K. Subbaiah, is the formation of a collective leadership. The group is also threatening to open up old wounds by blaming Mr. Gowda for yielding the chief ministership to the Congress. The argument of the rebels is that Mr. Gowda did not want the party's candidate, Siddaramaiah, to become the Chief Minister as that would have affected the prospects of Mr. Kumaraswamy over the long term.

Dynastic succession is, of course, not unique to the JD(S). Most political parties in India — the Bharatiya Janata Party and the Left parties, at the two ends of the political spectrum, are exceptions - openly promote dynastic succession, with sons or daughters or close relatives taking the place of the parent figure in the hierarchy. Almost inevitably, family-centred politics creates disaffection at all levels, besides thwarting inner-party democracy, and encouraging sycophancy and personal loyalties at the cost of democratic debate and discussion. Mr. Gowda. who ran a good campaign in the last election and brought his party back into contention for power after it was swept out in the 1999 election, should know better than to run the organisation as a family enterprise. If the party is to expand its support base beyond caste affinities and grow in the northern parts of Karnataka, it must become more representative by giving second-rung leaders their due. Although it might be too late for a patch-up with the dissident group, the JD(S) leadership must henceforth adopt an accommodative approach and learn to carry along all sections of the party. Otherwise, the efforts of the last couple of years will be undone, and the JD(S) might be pushed into the wilderness again.

LALU LIST FOR BIHAR, JHARKHAND MAY MAR POLL EQUATIONS

Secular parties play spoilsport

A JD chief Lalu Prasad Yadav on Monday released the list of party candidates for the first phase of Assembly polls in Bihar and Jharkhand. Clearly, the discord among the UPA partners has come out in the open with RJD deciding to field candidates in 21 out of the 24 seats going to polls in the first phase in Jharkhand.

Again, for the first phase of polls in Bihar, RJD has decided to contest in 58 out of 64 constituencies, leaving three constituencies to CPI, two to CPM and just one to Congress. The RJD decision to contest from 21 seats will inevitably lead to division of the so called "secular" votes in Jharkhand. In the last Lok Sabha elections, "secular" parties, including JMM, Constitution of the so called "secular" parties, including JMM, Constitutions of the social constitutions of t

gress, RJD and the Left parties had notched up a far more credible alliance at the ground level and this accounted for a spectacular electoral performance. The "secular" alliance then won 13 seats and BJP could manage to win just one seat in Jharkhand.

But JMM and Congress this

But JMM and Congress this time firmed up a seat sharing pact among themselves leaving RJD in the "lurch". As part of the pact, Congress got 33 and JMM

35 seats leaving the 13 remaining seats to RJD and the Left. This was, however, unacceptable to Lalu who, if Monday's list is any indication, has decided to play free in Jharkhand in a bid to mainly target JMM. No doubt, RJD will cut into the "secular" votes at the expense of the other UPA partners. This in turn will boost the electoral prospect of BJP-JD(U) nominees.

It remains to be seen how

many more seats RJD will contest from the remaining 57 seats. Even the alliance between JMM and Congress is plagued by confusion as both the parties are headed for friendly bouts in a number of seats. Opposed to the UPA partners, both BJP and JD(U) amicably agreed on the seat sharing formula.

IRJD has decided to field the former Congress chief of united Bihar Sarfraz Ahmad from Gandey in Jharkhand. The other prominent candidates include Gautam Sagar Rana (Hazaribagh), Girinath Singh (Garhwa), Annapurna Devi (Koderma), Mohammad Yasin Ansari (Bhawnathpur) etc. Altogether, the party has fielded five candidates belonging to the Yadav community and three from the minorities.

HE Election Commission (EC) on Monday severely reprimanded railway minister Lalu Prasad Yadav for violating the model code of conduct by bribing voters. However, the EC let him off the hook in the wake of assurances by Mr Yadav that he and his party would do nothing that amounted to an offence under the electoral laws.

Rejecting Mr Yadav's explanation that he was only distributing money to some ladies to buy sweets on his having become a Union minister, the EC ruled that even the gratification in the form of treating, which would include giving of mithai or giving of

"giving money after nearly seven months of his assumption of office...and that too when the election to the Bihar Legislative Assembly is so imminently close... cannot but have only one in-escapable inference that the same was for inducing the voters".

According to the commission, the general perception in the minds of the voting public, and not strict rules of evidence, apply in the matter of violation of model code of conduct.

"It is an undeniable fact that the whole nation's conscience felt disturbed on seeing, in the print and electronic media, Mr Lalu Prasad Yadav openly hold-

admits," the EC said while indicting the minister of violating Section 171(b) of the IPC and Section 123(A)(1) of the Representation of People's Act, 1951, with the corrupt practice of bribing voters on election eve.

As for the derecognition proceedings initiated by the poll watchdog against the RJD in the bribery case, the EC took a lenient view. Accepting assurances made by Mr Yadav in his reply to the show-cause notice served on the party that he and his party were committed to abiding by the poll code, the EC said it did not want to pursue the matter any further against the party.

New Delhi, Jan. 10: It was billed as a "dream" show of the kind of spectacle the BJP-Janata Dal (United) would have wanted to mount before the 2000 elections but could not and swallowed the ignominy of watching Rabri

Devi come back to power.

Today, 20 netas — big, bigger and biggest — sat cheek by jowl against the backdrop of a poster which proclaimed "15 saal, bura haal, sarkar badlo, Bihar badlega (15 years, terrible plight, change the government, Bihar's face will automatically change)" and had the BJP's lotus and the Dal (U)'s arrow symbols.

From Nitish Kumar, Sharad Yadav, Digvijay Singh, K.C. Tyagi, Prabhunath Singh and the Dal (U)'s latest acquisition, Jagannath Mishra, to Arun Jaitley, Ravi Shankar Prasad,

Gopal Narain Singh and Sushil Modi — the leadership embraced virtually Bihar's caste gamut but excluded the minorities. Dal (U) president George Fernandes was away in Mumbai for a medical check-up while the BJP's minority poster boy, Shahnawaz Hussain, was absent.
Nitish announced that the

Dal (U) will contest 138 seats in Bihar and the BJP 105. In Jharkhand, the BJP would play the senior partner and fight 63 seats and the Dal (U) 17. As if to underline the "unity" theme, Jaitley said: "If we have to decide who will be our chief minister, we will be able to decide without a problem." Nitish, however, clarified he was not a contender.

Despite the leaders' claim that their alliance would get a clear majority because the "anti-RJD vote was stronger than the pro-RJD vote", Nitish made it clear that the Lok Janshakti Party, headed by Ram Vilas Paswan, was still welcome to join the alliance. "We cannot indefinitely wait for Paswan because the polls were notified today and the process of filing of nominations has begun. But if the LJP is really against the RJD, it should reconsider its strategy."

Asked how the seats would be redistributed if Paswan changed his mind and crossed over to the NDA, he said: "Bo-th of us (the Dal and the BJP) will give up some of our seats." Nitish also said even if Paswan fought solo, the Dal (U)-BJP would not attack him in their campaign, indicating that the LJP was welcome as a post-poll ally. "Our campaign is against only the RJD and Laloo Prasad Yadav and no other individual," he stressed.

JD-U keeps BJP waiting

Jan. 9. — In the absence of a green light from the Janata Dal-United for seat-sharing arrangements in Bihar, the BJP could not take up the list of candidates for the Bihar assembly polls in its central election committee meeting held today. The JD-U continues to explore its options of having an alliance with Mr Ram Vilas Paswan's Lok Jan Shakti Party as well as the Congress.

The BJP has no other option except to wait for the JD-U to make the first move. Senior BJP leaders said they were still hopeful that the latter might be able to win over the LJP for an alliance considering that the Rashtriya Janata Dal and the Congress were getting back on "friendly" terms once again.

However, a strong section of BJP leaders term it as a remote possibility given Mr Paswan's compulsions to keep away from the saffron brigade to keep his Muslim support base intact but possibility of a tacit understanding is not ruled out.

The BJP general secretary, Mr Shivraj Singh Chauhan, today said the party would finalise its candidates for the Bihar assembly polls on 11 January. He had said yesterday that the party would announce its candidates for the Bihar polls today.

BJP sources said it is clear that in the next 48 hours the JD-U would would have to make its stand clear vis-a-vis the alliance with the BJP. Till then the BJP would have to wait. BJP sources also said once the air clears over this issue then only any "concrete" talks on seat-sharing arrangement in Bihar would begin.

Meanwhile, the BJP today left two more seats for the JD-U in Jharkhand as it announced the second list of 12 candidates for the assembly polls in the state.

Jharkhand rebels attack BJP office

RANCHI, Jan. 9. - In the first sign of dissension among a section of party workers after the BJP announced the first list of candidates for next month's assembly elections in Jharkhand omitting six sitting MLAs, a mob today pelted stones at the party office here in protest against the omission. The six sitting MLAs dropped by the party include Mr Arun Mandal (Rajmahal), Mr Phulchand Mandal (Sindri), Mr RC Naik (Kankey), Mr Dinesh Oraon (Sesai), Mr AR Tuddu (Serai Kalan) and Mr Chunna Oraon (Chakradharpur). It was not clear whose supporters resorted to violence near the party office, police said. Normalcy could be restored after police dispersed the mob. The former Jharkhand chief minister, Mr Babulal Marandi's name also did not figure in the first list of party candidates for Assembly elections in the state released yesterday in Delhi by the party general secretary, Mr Shivraj Singh Chauhan. The list of 52 candidates included names of incumbent chief minister, Mr Arjun Munda, and the former Union minister, Mr Karia Munda. — PTI

The party has now announced candidates for all 63 seats it is contesting in Jharkhand. It has denied tickets to nine sitting MLAs while 22 legislators would contest for another term.

Contrary to the signals given earlier, the party has not fielded former chief minister and sitting MP Mr Babu Lal Marandi from any of the seats. "He would be asked to campaign throughout the state," said Mr Chauhan while releasing the list of candidates for Jharkhand. The party today also released a list of candidates for 36 assembly seats in Haryana. The candidates for the rest of the 15 seats would be announced on 11 January.

EC model code shadow on Lalu

PATNA, Jan. 6. — Powered by the Election Commission's instructions to realise penalties from the parties that defaced railway property for publicising their rallies, East-Central Railways has served a notice on Mr Prasad's RJD yesterday asking the latter to pay a fine of Rs 15,000 by 12 January.

The notice has been served on the RJD for its workers' attempts to deface the premises of Patna junction by pasting banners, posters and putting up hoardings for their proposed Kisan-Mazdoor Maharailla which was earlier scheduled for 23 December.

Till recently, the entire railway department was dancing to the tune of the railway minister, Mr Lalu Prasad. None of the railway officials could muster courage to refuse when the RJD approached them for arranging special trains for their rally. The trains appeared to have become the "free" and favourite mode of transport for his party colleagues.

Thanks to the model code now in force, the entire situation has seen a reversal. The usual sight of officials apparently at the beck and call of the railway minister has changed, both at 1, Anne Marg, his official residence sharing the boundary with that of his chief minister wife Mrs Rabri Devi or at the Patna railway junction.

The much-publicised Maharailla was called off in the aftermath of the EC threatening to de-recognise the RJD and sending its legal advisor Mr KJ Rao to probe the blatant violation of the model code. Based on Mr Rao's reports, the EC directed the Railway Board chairman to realise penalty from defaulters.

It was due to this order that the RJD was asked to deposit the fine with the Hajipur zonal office. As
